#### REMEMBRANCE OF VICTIMS OF 9/11 TRAGEDY

##### REMARKS BY SPEAKER

The SPEAKER. Prior to the start of today's opening ceremonies, the Speaker would like to recognize the significance and the remembrance of 9/11, so I will ask all members to please take their seats.

This is the first time that our chamber has convened this month, so I think it is important to recognize the 20th anniversary of the attacks on our nation that occurred on September 11, 2001. For many of us of a certain age, it remains a defining moment in our lifetimes. I am sure every one of us can remember exactly where we were, what we were doing, and what happened later that morning when we first heard the news. I am sure that many of you sitting here today, those moments are even partially responsible for leading you directly to where you are seated now.

In the hours, days, and weeks that followed, as we learned the stories of those who lost their lives in New York, the Pentagon, and in Somerset County right here in our great Commonwealth, each of us felt compelled to make changes in our own lives. We know of countless stories of Americans who joined the branches of our military following the attacks. Some of those great veterans are seated here in this chamber today, and I would like to ask everyone who is a veteran on the war on terror and Operation Enduring Freedom to please stand and be recognized by the House. Thank you for your service.

Many of us found ways to give back in our own communities, helping the less fortunate or giving back to those who made other sacrifices. And nearly all of us reached out to friends, neighbors, and family to let each other know we were there and willing to support each other in our time of need. However, two decades later I continue to find comfort in the sense of hope that came in the days after the attack, a time when Americans would not let the things that separate us define us as a nation. We are all Americans. We all stand for freedom, prosperity, and liberty. Those ideals are not split along partisan political lines. They are values that define what makes this the greatest nation in the world. I know that each of you in this room can reach back and feel those very same emotions from September 11, and I also know that we can continue to build upon the things that brought

us together in the days that followed, and I look forward to continuing to carry that spirit into the important work on behalf of the people of our great Commonwealth.

Prior to the offering of today's opening prayer, I would like to request that all members and guests please rise for a moment of silence in observance of the 20th anniversary of the tragic events of September 11, 2001, including every hero on Flight 93 who so gallantly prevented further infliction of death and destruction upon our nation's capital. Members and guests, please rise.

Mr. Speaker, thank you so much for the opportunity to offer the opening prayer on the first day that we have been back in session since the commemoration of September 11, 2001, a fateful day in our nation. For many of us who served, it was a very stark reminder of a very sad day.

I would like to dedicate this prayer, if it is acceptable to everyone, to the children and to the families of those who were lost that day and in the war on terrorism.

Heavenly Father, protect us in our daily activities and guide us as we work to serve those we represent, especially the servicemen and servicewomen of our nation, our first responders, and our health-care workers, as well as their families who gave so much to all of us after that fateful day in September 2001. Our heartfelt condolences go out to all those who died or who were wounded physically and mentally by this war, and may their wounds, and may the wounds and the emotional wounds of their families heal in such a way that the injury is replaced with compassion, understanding, acceptance, and not replaced as a scar sowing the seeds of future conflict.

I ask You to please especially pray for Levi Rylee Rose, the newborn daughter of Lance Cpl. Rylee McCollum, who was killed that day in Afghanistan in Kabul; and for the other children born after their parent passed away – who will never know their father – while their fathers and parents were serving in harm's way. May they know that we will be there for them always, today and tomorrow.

Heavenly Father, please protect us, guide us, and hold us in the palm of Your hand and give us the strength and fortitude to make the difficult decisions that we need to make to serve You, our Heavenly Father.

In Your name we pray. Amen.

## COMMUNICATION FROM GOVERNOR

### VETO OF HOUSE BILL

The Speaker laid before the House a communication in writing from the office of His Excellency, the Governor of the Commonwealth, advising that the following House bill had been vetoed by the Governor:

#### HB 1300, PN 1869

TO THE HONORABLE HOUSE OF REPRESENTATIVES OF THE COMMONWEALTH OF PENNSYLVANIA

Pursuant to Article IV, Section 15 of the Pennsylvania Constitution, I am returning herewith, without my approval, House Bill 1300, Printer's Number 1869.

Pennsylvania had a free, fair, and secure election in November 2020 with record turnout, in which people embraced mail-in voting, and the results have been confirmed by two statewide audits. These results are a testament to the robustness of our existing election system, but also the many hard working local officials who conduct our elections in an earnest and transparent way. While the bill includes some potential areas of improvement – such as giving counties more time to pre-canvass, increasing poll worker pay, and expanding the use of electronic poll books – the legislation is incurably riddled with unacceptable barriers to voting, including:

- Imposing additional voter identification restrictions similar to those already found unconstitutional by Pennsylvania courts;
- Limiting mail-in voting by creating excessive and burdensome requirements;
- Requiring an arbitrary signature match for mail-in ballots without a thorough system to cure; and
- Eliminating the use of ballot drop boxes by creating onerous requirements on ballot delivery locations with which counties will be unable to comply.

The legislation also rolls back significant bipartisan improvements made in Act 77 of 2019, the landmark election reform enacted last session, by:

- Reducing the number of days to register to vote by moving the deadline back to 30 days before an election, which would be among the most restrictive deadlines in the nation;

- Eliminating the convenient annual option to be sent a mail-in ballot for each election; and
- Eliminating the option to go to a county election office and apply for and receive a mail-in ballot in the same visit.

This bill is ultimately not about improving access to voting or election security, but about restricting the freedom to vote. If adopted, it would threaten to disrupt election administration, undermine faith in government, and invite costly, time-consuming, and destabilizing litigation. Instead of trying to silence the votes of some Pennsylvanians, we should build on the bipartisan achievements of Act 77 of 2019. To that end, I am willing to engage in good faith to refine our shared priorities, and work to find common ground in areas where we do not currently have agreement. I am committed to working sincerely towards legislation that supports voter access and can be passed on a bipartisan basis in the fall.

Until that time, for the reasons set forth above, I must withhold my signature from House Bill 1300, Printer's Number 1869.

HB 1657 closes a loophole in the Child Protective Services Law relating to children and meth houses. However, the law is inexplicably silent on allowing or even forcing a child to be present while the same dangerous activity is taking place. I cannot imagine that this discrepancy was intentional, and I respectfully ask for my colleagues' affirmative vote on closing this loophole. Thank you.

Mr. VITALI. Mr. Speaker, this resolution just came into the public realm at 2:35. I am still trying to read through it. I am wondering if we can just pause for, let us say, 10 minutes so we can get through, actually read the text of this.

### MOTION TO POSTPONE

The SPEAKER. It is the Chair's belief that you have made a statement. If you wish to speak on the bill or make a motion, you could be recognized to do such.

Mr. VITALI. I would like to make a motion then.

The SPEAKER. The gentleman is in order and you may state your motion.

Mr. VITALI. I move that we pass over this until 3 o'clock.

The SPEAKER. The gentleman, Representative Vitali, has made a motion to postpone until 3 o'clock the consideration of HR 141. We will have the clerk put that motion on the board.

Mr. VITALI. I am going to withdraw that motion and speak on the resolution, after consultation with leadership.

The SPEAKER. You are in order to speak on the resolution.

Mr. VITALI. Mr. Speaker, let me interrogate the maker first just to make sure I have my facts straight, because I have not fully read it. I was looking at the previous—

The SPEAKER. The gentleman will please suspend.

The gentleman, the majority leader, indicates he will stand for interrogation. You are in order and may proceed.

Mr. VITALI. When I read the previous rules, temporary rules, which I am told this was very similar to, I took note that with regard to bills on final passage, any bills on final passage in this chamber could be voted on after 3 hours after the bill and any amendatory language come into the public realm. Is that still the case in HR 141, that 3-hour notice requirement for bills on final passage?

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

Nothing is changing other than the date of when we are allowed to continue to utilize remote voting for committee and House floor exercises subsequent of it sunshining at the end of August. So this will go to the end of January 2021.

Mr. VITALI. Okay. Thank you. That concludes my interrogation—

Mr. BENNINGHOFF. Excuse me, Mr. Speaker.

Mr. VITALI.—and I would like to speak on the resolution.

Mr. BENNINGHOFF. Just for edification, I had my dates wrong.

The SPEAKER. The gentleman will please suspend.

For what purpose does the majority leader seek recognition?

Mr. BENNINGHOFF. I was incorrect on the date of year. It goes to the end of January 2022. Thank you.

The SPEAKER. The Speaker appreciates that correction.

The gentleman, Representative Vitali, indicates he has concluded his interrogation. You are in order and may proceed on the resolution.

Mr. VITALI. And I have no concerns with regard to voting by designation or remote voting or any provisions relating to that. My concerns go to the amount of notice required to the public and to members with regard to bills we will be considering. I am most concerned with the fact that bills on final passage only need 3 hours consideration. Traditionally, traditionally it has been a 24-hour notice. And this is important not only to the members, but also to the public and the other stakeholders following this.

You know, Mr. Speaker, all sorts of— Well, I would say this: First and foremost, every member of this chamber is entitled to cast an informed, knowing vote, knowing what is in the bill and knowing the consequences of the language in each bill. And it is very important that we have at least an overnight so that during the course of the day, in the swirl of session when we have debate and committee meetings and caucus, there frequently is not enough time to study the implications of certain bills which will be coming before us in 3 hours. If we had 24 hours, as we have traditionally had, at least there would be that opportunity at the end of the session day to take a careful look at what we will be voting on so we could cast a knowing vote.

Also, in addition to our eyes going over the language itself, we need expert eyes. If we rely on an education expert or a transportation expert—or in my case, an environmental expert—we need them to sort of give us input on the import of technical language in bills. You simply do not get that if we are only giving 3 hours' notice from the time this language comes into the public realm.

Mr. Speaker, we need that overnight. This is more about— This is more— This is beyond just us. This is about giving the public the opportunity to see what is happening. It is transparency. So this is just too short a time period for bills on final passage and also for bills on concurrent vote.

This should not be the norm. I fear that this shortening of notice, which we are using the excuse of COVID to shorten, is becoming the norm. We initially passed this 3-hour notice in a much different circumstance. We were fearful for our lives being

on the House floor. We know a lot— We know a lot different now. We know how it is transmitted and how it is not. Everyone who has had the opportunity to be vaccinated can be vaccinated. It is a whole different circumstance. We are much more casual. The exigent circumstances justifying just 3 hours, just 3 hours—that is such a small amount of time for the massive and important bills that could come before us—it is no longer justified by the current circumstance. And if there are in fact these exigent circumstances where we do need that time, we as a body can simply suspend the rules, we can suspend the rules by a two-thirds vote and vote on anything we want in 3 hours or 2 hours or 1 hour.

This is just— This is not good government. And honestly, this is not a Democrat or a Republican issue. It is a rank-and-file versus leadership issue, because leadership generally, this is less of a concern to leadership because they are in the negotiations for the big bills. They know what is in them. It is the rank and file who really might only find out days, weeks later what some obscure passage in a bill—in an important, let us say, environmental bill—what its import really is. What company was behind it? Who is getting an unintended benefit?

So I just wanted to—I understand this resolution is going to pass, but I wanted to put my objections on the record so people would understand why I am voting "no" for this. Thank you.
