The House proceeded to third consideration of **HB 2293**, **PN 3344**, entitled:

An Act amending the act of July 19, 1979 (P.L.130, No.48), known as the Health Care Facilities Act, providing for temporary health care services agencies.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

And on that question, the Chair recognizes the gentleman, Representative Bonner.

Mr. BONNER. Thank you, Mr. Speaker.

Nursing homes are a friend and partner of State government. They provide for our families in the final days of many of our loved ones' lives. But nursing homes are in deep trouble and they need our help. Forty percent of the nursing homes who were surveyed indicated they cannot continue operations for another year under current conditions. Seventy percent of nursing homes have said that they face serious staffing shortages and they have had to turn to temporary staffing agencies to meet their employment needs.

I appear today before you to ask for your support of HB 2293, which would require temporary nursing staffing agencies to register annually with the Department of Health and provide important background information that Pennsylvania now lacks regarding their operation. They would be required to present to nursing homes, where they are supplying nurses, proper

credentials for those nurses, criminal background checks, malpractice insurance of at least \$500,000 per nurse, and due process rights in the event of any alleged violation of the registration law.

Staffing agencies across the nation are big business. Prior to the pandemic, they dominated the staffing of nursing homes nationwide. They are now a \$16 billion business in our country. There are approximately 40 of these agencies that control 70 percent of the market in the United States, and they affect the operations of all nursing homes in Pennsylvania and they jeopardize their existence because they are charging nursing homes 200 to 400 percent the normal cost of nursing assistance. Pennsylvania nursing homes have very little tools to combat these increases because Pennsylvania is paid through the State Medicaid program. Seventy percent of all nursing home costs are paid through the State Medicaid program, which does not begin to reimburse nursing homes for their actual costs of operations. Pennsylvania State government has a vital connection to these nursing homes to ensure that they remain open. Governments across the United States and in Congress are now investigating the predatory temporary staffing agencies, particularly their pricing mechanisms, and Pennsylvania needs to take a close look at this issue as well.

The bill that I am sponsoring is a reasonable approach in Pennsylvania to bring some order to this chaos. It will designate the Department of Health to be the central repository agency for gathering data on temporary staffing agencies. It will provide important information, oversight of these agencies, and provide a due process system for any complaints that are alleged against them.

On behalf of the nursing homes in Pennsylvania, our friends and partners, I would ask for your support for HB 2293. We have a friend in need and we can help meet that need by passing that legislation. Thank you for your time, your attention, and your vote.

The SPEAKER. The Chair thanks the gentleman and recognizes the good gentleman, Representative Frankel, on final passage.

Mr. FRANKEL. Thank you, Mr. Speaker.

I appreciate all the work the gentleman from Butler and Lawrence Counties has done on this issue. We have all heard about the difficulties of care providers right now, and many of them boil down to the same thing, staffing; the relentless challenge of finding new staff. Relying on temporary staffing agencies; being forced to pay new staff and temporary staff significantly more than the long-term employees who have been with the agencies forever; staff turnover; employees poached by agencies, that then come back to work for 10 times the price.

We all want and need to do something for our nursing homes and long-term care providers. What we need is a framework that is predictable and takes care of the professionals who we rely on to take care of our loved ones. This bill is a solution negotiated between SEIU (Service Employees International Union) and PHCA (Pennsylvania Heath Care Association) to create an oversight for temporary staffing agencies. It requires that the agencies register and provides minimal requirements for business. This will benefit businesses, ensuring that the entities they contract with are working above board. But it also benefits workers, who will be able to take jobs they want, when they want, and not be locked into contracts.

I know that the Department of Health and the administration are opposed, currently, to this bill. And they think it needs work, and they are likely right; however, I believe that this issue is important enough that I am going to vote for this bill in the hopes of continuing conversations over the summer that will get it in the shape that it needs to address many of the concerns that the health-care industry, that they see as a serious problem, and get the administration on board as well. So I urge our members to vote in favor of this piece of legislation.

An Act amending Titles 42 (Judiciary and Judicial Procedure) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in forfeiture of assets, further providing for asset forfeiture; in miscellaneous provisions, providing for off-road vehicles in urban municipalities; and, in snowmobiles and all-terrain vehicles, further providing for definitions.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

Is the gentleman, Representative Smith, seeking recognition? As a reminder to the members, I would ask you to please stand up next to a microphone as we are rolling through bills.

The gentleman, Representative Smith, is recognized on final passage. You are in order and may proceed, sir.

Mr. SMITH. Thank you, Mr. Speaker.

I rise to speak against this bill. I understand the frustration and the need to figure out how to curb this illegal activity in the streets of our cities. We already have laws that make riding unlicensed and uninsured vehicles on the road of Pennsylvania illegal. To add forfeiture to the law is unconstitutional and goes against every belief I have in being here and standing up for the

Constitution. We all took this oath. To take someone's property for a summary offense is wrong. Instead of taking this route, why do we not look for ways to open riding areas in and around the cities? This would give them an alternative to the city streets and could possibly curb most of the illegal activity.

All of the surveys that I have seen from our State agencies that deal with tourism that ask the question "What are the top activities that you would like to try or see increased opportunities available?" UTV (utility task vehicle), ATV (all-terrain vehicle), and dirt bike accessibility are always on the top three of the list.

We should be working for the people and not against them. I respectfully ask for a "no" vote.

Thank you, Mr. Speaker.

BILLS ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 2157, PN 3332,** entitled:

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, providing for fireworks; and making a related repeal.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. Moved by the gentleman, Representative Farry, that the House do concur in amendments inserted by the Senate

The Chair now recognizes Representative Farry for a brief description of Senate amendments.

Mr. FARRY. Thank you, Mr. Speaker.

The Senate amendments included a technical change to the legislation. I had also provided further clarifications to facility licensing and renewals and provided express authority for the Department of Ag to suspend a facility's license. In addition, it included funding for an accredited bomb squad to seek reimbursement for the costs associated with the removal, storage, and disposal of fireworks. It also reduced the criminal grading of some of the offenses. And lastly, it will remove restrictions on the times in which consumer fireworks can be used, making it a responsibility of the municipality to pass a local ordinance to restrict those times.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman, Representative Moul, on concurrence.

Mr. MOUL. Thank you, Mr. Speaker.

May I please interrogate the maker of the bill?

The SPEAKER. The gentleman indicates he will stand for interrogation. You are in order and may proceed, sir.

Mr. MOUL. Thank you, Mr. Speaker.

Mr. Speaker, I note that there are some new setback distances established in section 1107 for facilities that sell consumer fireworks. I believe these setbacks are only intended to apply to facilities that are issued a new license after the effective date of this act. In other words, the facilities that have a license to sell consumer fireworks under the existing provisions of law would not have to comply with the new setback distances. Is that accurate?

Mr. FARRY. Mr. Speaker, the answer is yes. There was quite a bit of deliberation during the drafting of this legislation. Specifically, at the bottom of page 6 of the bill, in section 1106(a)(2), we draw a distinction between the initial license and a renewal license by making references to section 1108 (A) or (E). Section 1108(A) relates to the issuance of initial licenses, and subsection (E) relates to the renewal of licenses.

In section 1106(a)(9), there is a reference to licenses issued under the entirety of section 1108, which would mean both the initial license and a renewal license.

In section 1108.1, there is a specific reference to, quote, a license "ISSUED OR RENEWED," thereby making a distinction between the two types of licenses.

Section 1109 relates to the conditions for facilities and deliberately does not distinguish between initial and renewal licenses.

In section 1112(c), there is a specific reference to licenses issued under the renewals under section 1108.

In section 1114(2), penalties are applicable to licenses issued under section 1108. This means that when we refer to a license, we are very deliberate when we make a reference to either an initial license, a renewal license, or both.

So in summary, yes; the specific references in section 1108(a) only in section 1107, paragraphs (4) and (5) means the setbacks defined are only applicable to facilities issued an initial license after the effective date of this legislation.

Thank you, Mr. Speaker.

Mr. MOUL. Thank you, Mr. Speaker.

That clarifies it for me. Thank you.

The SPEAKER. The Chair thanks the gentleman.

I have great respect for the good gentleman from Bucks County and the intent of this bill and the problem he is trying to solve, but I have reservations about the bill, and I actually rise in opposition to the bill.

I do not believe that we should be enacting a law that gives municipalities the ability to require a permit to set off fireworks. I think we are going in the wrong direction here. I mean, this week we are expanding civil asset forfeiture, we are creating new felons, we are creating new criminals now. And on the eve of July 4 weekend, on the eve of Independence Day, we are going to now create new classes of criminals because people did not follow basic fireworks rules that may have been by mistake. I just think these are harsh penalties. I think that requiring permits to set off fireworks – it is just a bridge too far.

I think we are going in the wrong direction this week, and I would urge a "no" vote on this bill.

Thank you, Mr. Speaker.

In reference to HB 331 on concurrence, this bill left our chamber and it created an incentive-based savings program that allowed financial institutions to conduct savings promotion programs. This would allow financial institutions to have a program in which the sole consideration for a prize is via deposit of a specified amount into a specified account or savings program. The Senate then amended it to authorize financial institutions and insurers to provide services to legitimate cannabis-related businesses, and prohibits any adverse actions. These financial institutions and insurers are still to follow the rules and regulations applicable to all their other customers and consumer protection laws in the Commonwealth. Currently there is no law for the protection of banking or funds or protection for insurers for the legitimate cannabis businesses in the Commonwealth.

Ms. BOBACK. Thank you, Mr. Speaker.

My legislation amends Act 166 of 1978, known as the Flood Plain Management Act, by transferring certain powers and duties from DCED (Department of Community and Economic Development) to the Pennsylvania Emergency Management Agency, and this would be in managing the National Flood Insurance Program with the Commonwealth.

Mr. Speaker, I am a rural legislator, and flooding in Pennsylvania – not only in rural PA, but all over the State – has and will continue to be an issue for all of us. I, as well as many of the members, have experienced the problems that result from flooding in our home districts. This legislation would not only address the concerns FEMA (Federal Emergency Management Agency) has expressed to the Commonwealth relating to the approval of the State's enhanced hazard mitigation plan, but also, this will provide the Commonwealth with the ability to increase its percentage of Federal hazard mitigation funding from approximately 15 percent to 20 percent for any federally declared disaster emergency involving public assistance due to that particular emergency.
