An Act amending the act of November 29, 2006 (P.L.1471, No.165), known as the Sexual Assault Testing and Evidence Collection Act, further providing for sexual assault evidence collection program.

HB 2271, PN 2634

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in sexual offenses, further providing for the offense of sexual extortion.

SB 251, PN 1842

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, repealing provisions relating to fertilizer; providing for fertilizer; in soil and plant amendment, further providing for disposition of funds; in seed, further providing for disposition of funds; establishing the Agronomic Regulatory Account within the General Fund; imposing duties on the Department of Agriculture; and making conforming amendments.

SB 275, PN 1163

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in preemptions, providing for restrictions on utility services prohibited.

SB 588, PN 648

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for when prosecution barred by former prosecution for different offense.

SB 814, PN 1822

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in obstructing governmental operations, providing for the offense of evading arrest or detention on foot and for the offense of harming a police animal while evading arrest or detention.

SB 1094, PN 1806

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, providing for apportioned registration renewal; in commercial drivers, further providing for commercial driver's license; in miscellaneous provisions, repealing provisions relating to snow and ice dislodged or falling from moving vehicle and providing for snow and ice; and, in motor carrier safety, repealing provisions relating to findings and declaration of policy and further providing for definitions and for Motor Carrier Safety Advisory Committee.

SB 1105, PN 1763

An Act making appropriations to the Trustees of the University of Pennsylvania.

SB 1183, PN 1841

An Act amending Titles 42 (Judiciary and Judicial Procedure) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in forfeiture of assets, further providing for asset forfeiture; in miscellaneous provisions,

providing for off-road vehicles in urban municipalities; and, in snowmobiles and all-terrain vehicles, further providing for definitions.

SB 1235, PN 1649

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in comprehensive health care for uninsured children, further providing for contracts and coverage packages.

in threat assessment, further providing for threat assessment teams; in school health services, further providing for health services; in Drug and Alcohol Recovery High School Pilot Program, further providing for definitions, for establishment of Drug and Alcohol Recovery High School Pilot Program and for scope of program and selection of students, repealing provisions relating to term of Drug and Alcohol Recovery High School Pilot Program and further providing for reporting; in terms and courses of study, further providing for agreements with institutions of higher education; providing for talent recruitment and establishing the Committee on Education Talent Recruitment, the Talent Recruitment Grant Program and the Talent Recruitment Account; providing for educational and professional development online course initiative, establishing the Online Course Clearinghouse Account and imposing penalties; in charter schools, providing for abolition of rulemaking and further providing for regulations; The bill now revises the definitions of "CRIME" and "PERSONAL INJURY CRIME," while adding a new definition for "PERSONAL INJURY RIGHTS CRIME." These definitions each relate to matters for which the victim receives notice of events during the criminal justice process, rights to provide testimony or input, and offenses for which the victim's compensation may be awarded. For compensation claims, the bill makes a number of changes to increase victims' compensation and to make it easier for victims to seek compensation. The bill also enhances crime victims' confidentiality by updating the Address Confidentiality Program for domestic and sexual violence victims.

HB 430, PN 2274

An Act amending the act of May 25, 1945 (P.L.1050, No.394), known as the Local Tax Collection Law, further providing for effect of failure to receive tax notice.

HB 940, PN 3285

An Act amending Titles 18 (Crimes and Offenses), 35 (Health and Safety), 42 (Judiciary and Judiciary Procedure) and 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in burglary and other criminal intrusion, further providing for definitions, for the offense of burglary and for the offense of criminal trespass; in cruelty to animals, further providing for police animals; in emergency medical services system, providing for injured police animals; in immunities generally, further providing for emergency response provider and bystander good Samaritan civil immunity; and, in employees, providing for canine training standards for police officers.

HB 975, PN 3363

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, further providing for definitions; and, in sexual offenses, further providing for the offense of institutional sexual assault.

HB 1867, PN 3325

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, providing for Purple Star School Program.

HB 2464, PN 3326

An Act amending the act of November 24, 1998 (P.L.882, No.111), known as the Crime Victims Act, in preliminary provisions, further providing for definitions; in crime victims, further providing for rights, for responsibilities of victims of crime under basic bill of rights, for responsibilities of State and local law enforcement agencies, for responsibilities of prosecutor's office, for responsibilities of department, local correctional facilities and board and for responsibilities of juvenile probation office and providing for legal standing; in administration, further providing for office, for powers and duties of victim advocate and for powers and duties of Office of Victims' Services; in compensation, further providing for persons eligible for compensation, providing for counseling services for victims of sexual abuse and further providing for filing of claims for compensation, for minimum allowable claim, for determination of claims, for emergency awards, for awards and for confidentiality of records; in services, further providing for eligibility of victims; in financial matters, further providing for costs and for costs for offender supervision programs; in enforcement, further providing for subrogation and for revictimization relief; transferring money from the Crime Victim's Compensation Fund; providing for applicability; and making a related repeal.

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **SB 1100**, **PN 1852**, entitled:

An Act to provide appropriations from the General Fund for the expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, the public debt and the public schools for the fiscal year July 1, 2022, to June 30, 2023, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2022; to provide appropriations from special funds and accounts to the Executive and Judicial Departments for the fiscal year July 1, 2022, to June 30, 2023, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2022; to provide for the appropriation of Federal funds to the Executive and Judicial Departments for the fiscal year July 1, 2022, to June 30, 2023, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2022; and to provide for the additional appropriation of Federal and State funds to the Executive and Legislative Departments for the fiscal year July 1, 2021, to June 30, 2022, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2021.

On the question,

Will the House agree to the bill on third consideration?

The SPEAKER. As a general reminder to the members, this is an Appropriations bill, which will have a 5-minute time limit on it except for the leaders.

On the question recurring,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

And on that question, the Chair recognizes the good gentleman, Representative Saylor.

Mr. SAYLOR. Thank you, Mr. Speaker.

Today I rise to present my final budget before I leave the House. It is SB 1100. While SB 1100 is the General Appropriation Act, in reality, the State budget is about all the component parts of a budget year.

What we will have the opportunity to vote on today is the most comprehensive package that I have experienced in a long time. It puts Pennsylvania in a better fiscal situation. It contains historic tax cuts that make Pennsylvania more competitive in job creation, provides for leave to working families and seniors, and makes targeted investments in the people of Pennsylvania.

We committed early on and delivered on sending an additional \$2.1 billion to the Rainy Day Fund. That will take our Rainy Day Fund to \$5 billion – historic first.

Mr. Speaker, the budget leaves the General Assembly in sound fiscal order with a projected \$3.6 billion balance at the end of this coming fiscal year, which is based upon the Independent Fiscal Office's projections and conservative estimates. It could be more.

We also did the prudent thing and we are paying down \$2 billion worth of prior budget borrowing. We have the money thanks to the fiscal decisions we have made in this General Assembly, so now we should pay off our bills and pay them on time

This budget also provides relief for Pennsylvanians who are struggling with Biden inflation. We will be establishing a first-ever child-care tax credit that will supplement the Federal credit for working families. We will fund a one-time 70-percent enhancement of the property tax and rent rebate program for our seniors in Pennsylvania. And we set aside money for LIHEAP (Low-Income Home Energy Assistance Program) to prepare for the high utility bills of this coming winter.

This budget sets us up on a path to be more attractive to our job creators large and small. We will be passing the first reduction in the corporate net income tax since 1995 and will make it easier for our small businesses to grow here in Pennsylvania.

This is a budget that prioritizes investments in people, not in growing government, starting with our education system. This budget makes historic investments in public schools, a historic investment in school choice, and makes new investments in school safety and mental health. We are committed to our safe communities, and this budget reflects exactly that funding for violence prevention, gun violence investigation, prosecution, and law enforcement support for grants going forward.

We are supporting our agricultural community also by providing relief for the avian flu, along with additional testing capacity to combat threats to our meat and our poultry supplies.

We are going to make the largest investment in the environment in a decade through additional funding for clean streams, clean water; parks, forests, infrastructure repair; and additional resources for our conservation districts. And, Mr. Speaker, we are going to do it without the order of an EPA (Environmental Protection Agency) telling us how to do it. We are doing it ourselves – cleaning up the Chesapeake Bay, cleaning up our streams, and making Pennsylvania a better place to live.

And lastly, this budget helps our most vulnerable and those that we all care about the most. It increases rates for nursing homes and personal care homes, serving more people with intellectual disabilities and supporting rate increases there as well.

It increases EMS (emergency medical services) rates to help our ambulance companies throughout our Commonwealth.

And it increases support for child-care providers, including funds to address the child-care cliff for working families.

Mr. Speaker, no matter what budget year you are in, it is always easy to criticize a budget. It spends too much. It does not spend enough. The line item I wanted did not get what it should have gotten. No one here, nor in Washington, gets everything they want in a budget – not the Governor, not the President, and not the Speaker or the pro tem of the Senate. It is a compromise. This budget was a compromise work of a Governor, House and Senate Republicans and Democrats.

Today I want to also compliment the Governor, and I want to compliment all four caucuses for working to be in the position to put Pennsylvania squarely in a fiscally responsible manner moving forward for the next session.

Mr. Speaker, this bill, SB 1100, is exactly the medicine this Commonwealth needs to right ourselves and be the most competitive State in this nation and to return us to the Keystone State we should be.

As I said before, this is a comprehensive budget that puts the needs of people before the needs of the government. I am proud to be standing here today in support of this effort and encourage everyone to vote "yes," Mr. Speaker. Thank you.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman, Representative Bradford, on final passage.

Mr. BRADFORD. Thank you, Mr. Speaker.

I, too, rise in favor of SB 1100. This is our budget for next year, and this is really a path forward for Pennsylvania.

I want to associate myself with much of the words by the prior speaker. Chairman Saylor has been a gentleman to work for for years, and he has been at the forefront of fighting for things he believes in for 30 years in this building. This budget has his fingerprints all over it and there is much for which he can be proud.

Now, I would be remiss if I did not say as a Democrat – and he said, rightfully, that not everyone is going to like this budget – there is much in this budget that we would see to do different if we were in the majority. But we recognize elections have consequences and the will of the voter must be heard. But even in divided government, which we have here in the Commonwealth, there are opportunities for real bipartisan compromise. And once in a while – sometimes a week late – but once in a while, we are able to strike the right balance. This budget, in my opinion, is that balance.

I give credit to my Republican friend for talking about fiscal responsibility. For some time, our caucus has spoken about cycle rolls and things that seemed very esoteric and not really important to the average daily lives of Pennsylvanians. But the reality, when we would budget for 11 months of payments when we knew 12 months would come, was probably not prudent fiscal management. This budget reverses that trend. In fact, it pays off these cycle rolls. It is something that anyone who calls themselves a conservative, Democrat or Republican, should be proud to support.

Five billion dollars in the Rainy Day Fund – and I appreciate the gentleman recognizing the leadership of the Governor. When Governor Wolf came into office, our Rainy Day Fund was \$200,000. After last year, it was \$3 billion; after this year, it will be \$5 billion. Some can argue that is too much, but the reality is, for those of us who want to make important investments – sustainable long-term investments in things like education and child care and so many of the positive things that are in this budget – if you want to make these investments, I would say to my most strident Democratic friend, you must be able to sustain them in economic downturns that inevitably come with any business cycle. This budget, because we pay down cycle rolls, because we put \$5 billion in the Rainy Day Fund, says we can sustain these investments, if we show the political will, in any recession that is to come our way.

Now, my counterpart in the Senate, Pat Browne, has spoken for some time about our long-term demographic challenges in this Commonwealth. And some of us who recognize – from the southeast, where our population has grown and business has been attracted – that all the Commonwealth has not shared in that bubble; in fact, there are parts of the Commonwealth that continue to lose population and see business hemorrhage.

Now, there will be some who will disagree on the corporate net income tax reductions that Governor Wolf has championed for years, and our caucus has joined in that chorus of voices. Some will say the cut is too far. Some will say the base-broadening is not great enough, and I may actually share that concern. But the fact that Democrats and Republicans are going to link arms and say for the next Governor of Pennsylvania that he can go out throughout this country and say Pennsylvania is on a path to cut its corporate net income tax — a corporate net income tax that by any judgment was simply too high — Democrats and Republicans should all recognize that.

Now, were there too many loopholes? Absolutely. Would I argue we have not done enough to cut every one of those loopholes? Absolutely. But this is what bipartisan compromise looks like on an issue that has confounded this chamber for literally decades. What we are doing is historic in the CNI (corporate net income). It may not be in this bill, but if you believe the long-term demographic challenges of this Commonwealth can be turned around, then you must believe in educating our children and you must believe in bringing investments and business to this Commonwealth. This budget plants those seeds; in fact, it plants a flag. It says we can educate our kids in a fiscally sustainable way and we can create a tax rate that will attract business.

Now, I have mentioned education, and this caucus, this Democratic Caucus, whether Wilkes-Barre or Norristown or Scranton or our city of the first class or southeast Delco or Reading, has seen cripplingly high property taxes that are a result of school districts that are put in a position to tax their tax base to say, "I will go anywhere but here," who are literally pitting seniors against students, and have shortchanged the very ability of those communities to make the investments that we need in a workforce of tomorrow.

Historically, last year this chamber worked together in a bipartisan way to do Level Up funding. This year we will more than double that Level Up to \$225 million. We will also put through a fair funding formula, that had bipartisan support not that long ago, over an additional half a billion dollars. When you look what these increases mean for Harrisburg, what they mean for Norristown, what they mean for the property tax payers in those communities, it is historic and it is an opportunity for these communities, like Coatesville, to finally do right by their students without the cost of taxing their property tax payers to run for the exits.

This is the right thing to do in any budget, but in a budget with the historic surpluses that we have, it is the most appropriate year we have ever had to do it and it is right to do it. And I want to thank Democrats and Republicans, but especially this Democratic Caucus, for constantly harping on the need to do right by our students.

And there is ARPA (American Rescue Plan Act) spend. We are thankful for the one-time Federal money we have received. These investments in affordable housing that many in our caucus have championed. We recognize the challenge of public safety in our Commonwealth is more acute than it has ever been in recent years, and we will make one-time investments there. I again want to thank Chairman Saylor for talking about the challenge of mental health. We recognize that this body, as currently constituted, is incapable of passing meaningful gun safety legislation. The argument has been that we should put more money in mental health. This budget puts \$100 million into school mental health. It will put another \$100 million of ARPA

money into adult mental health. We will come back in a year and the challenge will be, what have we done to move the ball on gun safety across this Commonwealth? We are trying the path of the current majority. Let us see what results we have a year forward from now.

Also, on the challenge of child care. We need to get people back in the workforce. Too many people are on the sidelines. This budget opens the door – not as robust as this caucus would like, but towards a child tax credit. For too long, the Tax Code in this Commonwealth has been a playground of corporate special interests. For the first time, we are trying to create a tax credit for actual working people, and in many cases, working moms who disproportionately bear the challenge of child-care costs that are too high and keep some of our most talented workers out of the workforce. At a time where we need more folks in the workforce, this credit and these one-time ARPA dollars pave the way.

This is a budget of compromise, but there is much here for which we should be proud and thankful. Thankful to our leaders, both Democrat and Republican, who have stood path and worked together – Democrat and Republican, House and Senate – with a Governor. Many of us have different parties and different views, but I believe, even if a week late, the product is worthy of a "yes" vote.

Again I want to thank the good chairman for his decades of service to this Commonwealth, for the budget that is in front of us, and I suggest we all unanimously support this budget. Thank you, Chairman.

And there is even a performance-based budgeting model here to ensure that some of our largest higher educational institutions are being held accountable, as well as expanding dual enrollment for our high schoolers that were previously excluded from being able to access those programs just because they attended a public charter school. Professional development extensions are included for our teachers, and additional training for our school safety and security.

And finally, this bill has historic investment in the EITC (educational improvement tax credit) program to the tune of a \$125 million increase over the prior year's budget item. This also includes an increase in scholarships for our disadvantaged schoolchildren, and this bill obviously prioritizes our children and helps to protect Pennsylvania students by making these historic investments, again, not only for today, but for the future of our children and this Commonwealth.

I ask for bipartisan support for HB 1642. Thank you. The SPEAKER. The Chair thanks the lady.

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, providing for oil and gas well plugging oversight; in development, further providing for bonding and for well plugging funds; establishing the Oil and Gas Well Plugging Grant Program; and making a related repeal.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. Moved by the gentleman, Representative Causer, that the House concur in the amendments inserted by the Senate.

The Chair does now recognize the gentleman for a brief description of Senate amendments.

Mr. CAUSER. Thank you, Mr. Speaker.

Mr. Speaker, the Senate amended HB 2644 with technical language dealing with the bonding section of the bill. The amendment clearly states that only the General Assembly can adjust the bonding levels for conventional wells for the next 10 years. So I would appreciate support for the legislation.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman, Representative Vitali, on concurrence. Mr. VITALI. Thank you, Mr. Speaker.

I would urge nonconcurrence. As the House will recall, 90 members opposed this bill very recently. It is estimated that there are about 2,000 orphaned and abandoned wells in the Commonwealth, and these cause environmental problems such as methane leakage, pollution of streams, risk of explosions. And we have learned recently that this is not only a legacy issue, these 2,000 orphaned, abandoned wells, but it is a continuing problem. And in fact, it has been called a standard operating procedure by the conventional gas industry to abandon wells, and the reason they do that is because of inadequate bonding. Wells drilled before 1985 do not require any bonds, and currently only \$2500 bond is required, and this bill – the worst part of this bill – would freeze it at that level. Now, that is just unacceptable.

Mr. Speaker, the amendment to this bill was simply window dressing. The bill is opposed by the Department of Environmental Protection. They say, "This legislation is not necessary" because the Department of Environmental Protection already "has existing statutory authority to create a well plugging program." They say, the DEP says, "The well bonding language is unnecessary and would be a step backwards." They make it a point that it costs, on average, "...\$33,000 to plug a well...," yet this bill freezes it at \$2500. DEP also makes the point that "The conventional industry has gotten over 4,000 notices of violation" – 4,000 – "4,000 notices of violation over the last five years for trying to illegally abandon wells...," Mr. Speaker. And if we freeze this bonding level, if we freeze this bonding level at this low point, it will just perpetuate this problem.

They point out that "This legislation provides extremely broad immunity" to well pluggers and "...exempts them from...regulations." This bill is also opposed by the Trial Lawyers, the Pennsylvania Association for Justice. They say, "Removing the opportunity for recourse and denying consequences for negligent actions that may cause harm to the environment and workers...."

This bill is opposed by PEC (Pennsylvania Environmental Council). It is opposed by the Environmental Defense Fund. They say, quote, "What makes this even more egregious" – "egregious" is their word – "...the legislation appears to prevent DEP from being able to deny the award of remediation dollars to operators who have outstanding compliance issues."

It is opposed by Clean Water Action. They mention "...the provisions that prevent DEP from denying a" well "plugging grant based on compliance,..."

It is opposed by the Clean Air Council. They mention the civil immunity procedure; they mention the enactment of bonding levels. Sierra Club opposes.

You know, this is just a bad piece of legislation. We, as legislators who care about the environment, sometimes look at the coal industry and all our polluted streams because of acid mine drainage and we wonder how could a legislator, how could the population allow acid mine drainage to continue and happen? Well, you know what? Look at this moment, because if this bill is passed, we are creating that same legacy problem for well plugging. This is how it happens, at moments like this. So if we pass a bill like this and the Governor fails to veto it, this is how it happens.

So I urge a "no" vote.

THE SPEAKER PRO TEMPORE (JOHN A. LAWRENCE) PRESIDING

The SPEAKER pro tempore. The Speaker thanks the gentleman.

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

I rise in support of this, and I have actually been out to see some of these abandoned wells, and I think we need to appreciate that this is not something that just happened in the last 5, 10, 15 years; many of these wells are well over 100 years old. Many of these are popped up in streamlines, these have trees growing out of the bottom of them.

At the end of the day, this is an environmental cleanup bill. We want to help people get this done. And frankly, the conventional well drillers in our State are very talented, knowledgeable, many of them are multigenerational families, small operations that have been doing this at their own expense. When you are talking probably 200,000 of these wells and these men and women have been working very, very hard to do that.

If we truly care about the environment, Mr. Speaker, I believe we have an obligation to provide some assistance. This appropriates Federal dollars to help plug and clean these things up, creates a grant-style program to do this. And, Mr. Speaker, why would we want to wait any longer? I think 100 years is long enough. And even some of the ones that are not as old, they need cleaned up. These people are willing to do it but they deserve a little bit of expenses compensated to do that because it is very difficult, very timely, and takes a lot of work to get them done, and they have tools and the talent.

I would ask for unanimous support of HB 2644. Thank you.

The SPEAKER pro tempore. The Speaker thanks the gentleman.

Seeing no other members looking to speak on the bill, we will return to the maker of the bill, Representative Causer.

The gentleman is in order and may proceed.

Mr. CAUSER. Thank you, Mr. Speaker.

Mr. Speaker, there is a lot of misinformation and I think, actually, the comments by the gentleman from Delaware are insulting.

Mr. Speaker, as someone who comes from northwestern Pennsylvania, where most of these wells exist – the gentleman stated there were 2,000 of them; there are well over 200,000 of these wells. What we are doing with this legislation is we are trying to solve the problem. We are using Federal funds that are coming to this State to maximize the plugging of these wells. We are using this funding to get as many of these orphaned, abandoned wells plugged as we can, and that is the major component of this legislation.

In addition to that, we are setting the bonding limit for conventional wells at what it is today, \$2500. And we are stating that going forward, for the next 10 years, the General Assembly will decide what these bonding limits are. Only the General Assembly can set bonding limits. After 10 years, that can be done by the department or the Environmental Quality Board.

Mr. Speaker, this is a bill that solves a problem. It is a bill that will do a lot to get these wells plugged, and I would ask for support and concurrence on HB 2644.

BILLS ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence on Senate amendments to **HB 1342, PN 3370,** entitled:

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in sales and use tax, further providing for definitions, for exclusions from tax and for licenses; in personal income tax, further providing for classes of income and repealing provisions relating to COVID-19 emergency finance and tax provision; in corporate net income tax, further providing for definitions and for imposition of tax; in insurance premiums tax, further providing for imposition of tax and for credits for assessments paid; in vehicle rental tax, further providing for definitions and for vehicle rental tax; in research and development tax credit, further providing for limitation on credits; in entertainment production tax credit, further providing for definitions, for credit for qualified film production expenses, for limitations, for reissuance of film production tax credits and for limitations; in Waterfront Development Tax Credit, further providing for limitations; in City Revitalization and Improvement Zones, further providing for reports, for restrictions and for confidentiality; in Innovate in PA tax credit, further providing for duties; in Neighborhood Improvement Zones, further providing for confidentiality; in Keystone Opportunity Zones, Keystone Opportunity Expansion Zones and Keystone Opportunity Improvement Zones, further providing for extension for new job creation or new capital investment and for additional keystone opportunity expansion zones; providing for airport land development zones and for Pennsylvania child and dependent care enhancement program and for tax credit; in inheritance tax, further providing for transfers not subject to tax; in Public Transportation Assistance Fund, further providing for Public Transportation Assistance Fund; in table game taxes, providing for General Fund deposit; in Computer Data Center Equipment Incentive Program, further providing for definitions, for sales and use tax exemption, for eligibility requirements and for revocation of certification; in general provisions, providing for allocation of tax credits; making transfers; and making related repeals.

The Chair now recognizes the gentleman for a brief description of Senate amendments.

Mr. DUNBAR. Thank you, Mr. Speaker.

Originally HB 1342 was an inheritance tax exemption for decedent and active military members. It was amended in the Senate with various changes to our Tax Code; amongst them, it institutes a PA child and development care credit, a refundable tax credit that is equal to 30 percent of the Federal tax credit. It also was amended to ensure stability in the Fire Insurance Tax Fund and Municipal Pension Aid Fund to transfers to special funds. It extended the computer data center sales tax exemption from 15 years to 25 years. It also contains language for the peer-to-peer car sharing, clarifying language for that. Also, it increased the section 179 deduction limits for Pennsylvania taxpayers to match those of Federal limits.

In addition, it also allows for the deferral of gains and losses from section 1031, "Like-Kind Exchanges," with us being the last State to ever to do that. It also reduces our corporate net income tax from 9.99 to 8.99 in 2023, and a half a percent thereafter every year until it reduces to 4.99 in 2031.

In addition to that, there were various changes to our tax credits: a \$5 million increase to the research and development tax credit, a \$30 million increase to the film production tax credit, a \$16 million increase to the Entertainment Economic Enhancement Program, a \$3.5 million increase to the waterfront development tax credit, and also established an airport land development zone tax credit program and instituted a 3-year freeze on all of these five tax credits cap amounts.

With that, I would ask for an affirmative vote on HB 1342 on some landmark legislation and changes to our tax laws.

An Act amending the act of June 13, 1967 (P.L.31, No.21), known the Human Services Code, in general powers and duties of the Department of Public Welfare, providing for COVID-19 mental health public awareness campaign; in public assistance, further providing for eligibility and for medical assistance payments for institutional care and providing for resident care and related costs and for pharmacy benefits manager audit and obligations; in the aged, further providing for LIFE program and providing for agency with choice; in children and youth, further providing for limits on reimbursements to counties; in nursing facility assessments, further providing for time periods; in managed care organization assessments, further providing for assessment amount; providing for innovative health care delivery models; abrogating regulations; and making a related repeal.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. Moved by the gentlewoman, Representative Thomas, that the House concur in the amendments inserted by the Senate.

The Chair now recognizes her for a brief description of Senate amendments.

Mrs. THOMAS. Thank you, Mr. Speaker. Good evening, everyone. Everybody awake?

The Senate amendments that were added to this bill are the provisions of the Human Services Code. The original underlying bill was our Healthcare Heroes Act to let our health-care heroes know that, after the years they helped us during COVID, we care about them and they need to take care of themselves through the mental health services that are available to them.

The bill now includes the Human Services Code, which includes extending nursing care assessments, providing for increases in State supplemental assistance payments, and capitation payment increases for direct residential care.

I ask my colleagues to support this code and the amendment. Thank you, Mr. Speaker.

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in sales and use tax, further providing for definitions, for exclusions from tax and for licenses; in personal income tax, further providing for classes of income and repealing provisions relating to COVID-19 emergency finance and tax provision; in corporate net income tax, further providing for definitions and for imposition of tax; in insurance premiums tax, further providing for imposition of tax and for credits for assessments paid; in vehicle rental tax, further providing for definitions and for vehicle rental tax; in research and development tax credit, further providing for limitation on credits; in entertainment production tax credit, further providing for definitions, for credit for qualified film production expenses, for limitations, for reissuance of film production tax credits and for limitations; in Waterfront Development Tax Credit, further providing for limitations; in City Revitalization and Improvement Zones, further providing for reports, for restrictions and for confidentiality; in Innovate in PA tax credit, further providing for duties; in Neighborhood Improvement Zones, further providing for confidentiality; in Keystone Opportunity Zones, Keystone Opportunity Expansion Zones and Keystone Opportunity Improvement Zones, further providing for extension for new job creation or new capital investment and for additional keystone opportunity expansion zones; providing for airport land development zones and for Pennsylvania child and dependent care enhancement program and for tax credit; in inheritance tax, further providing for transfers not subject to tax; in Public Transportation Assistance Fund, further providing for Public Transportation Assistance Fund; in table game taxes, providing for General Fund deposit; in Computer Data Center Equipment Incentive Program, further providing for definitions, for sales and use tax exemption, for eligibility requirements and for revocation of certification; in general provisions, providing for allocation of tax credits; making transfers; and making related repeals.

HB 1420, PN 3371

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in general powers and duties of the Department of Public Welfare, providing for COVID-19 mental health public awareness campaign; in public assistance, further providing for eligibility and for medical assistance payments for institutional care and providing for resident care and related costs and for pharmacy benefits manager audit and obligations; in the aged, further providing for LIFE program and providing for agency with choice; in children and youth, further providing for limits on reimbursements to counties; in nursing facility assessments, further providing for time periods; in managed care organization assessments, further providing for assessment amount; providing for innovative health care delivery models; abrogating regulations; and making a related repeal.

HB 1594, PN 3373

An Act amending the act of December 17, 1968 (P.L.1224, No.387), known as the Unfair Trade Practices and Consumer Protection Law, providing for collection, verification and disclosure of information by online marketplaces to inform consumers.

HB 1614, PN 2938

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, in ballots, further providing for number of ballots to be printed and specimen ballots.

HB 1615, PN 3365

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for breweries, for renewal of licenses and temporary provisions for licensees in armed service and for rights of municipalities preserved.

HB 2644, PN 3364

An Act amending Title 58 (Oil and Gas) of the Pennsylvania Consolidated Statutes, providing for oil and gas well plugging oversight; in development, further providing for bonding and for well plugging funds; establishing the Oil and Gas Well Plugging Grant Program; and making a related repeal.
