To our troublemaking Rep group, plus one Senator – you know who you are, but the rest of you do not, so I am going to tell you. Helping people is what we are all about as public servants. I am a product of immigrants. Both sets of my grandparents came to this country to make a better life for their families. They wanted the American dream. I watched my parents work hard to give their children a better opportunity than they had. My father died when I was a junior in high school, and my senior year, my mother suffered a massive stroke. Those events certainly changed my life. But I always stop and think, if they were here to see their baby girl hold a seat in the Pennsylvania House of Representatives, they would not have believed it and they would have been so proud. We need to remember that our job is to leave it better and safer and healthier for the next generation.

I am grateful that while a member of this body, I was able to keep our corrections officers safer when the pepper spray bill was signed into law. FAREWELL ADDRESS BY MR. HERSHEY

The SPEAKER. We will ask Representative Hershey to please approach the rostrum.

Representative Hershey was first elected to serve as a Representative for the 82d Legislative District. He currently serves as a member of the Ag and Rural Affairs Committee, Government Oversight, Health, Appropriations, and Judiciary Committees.

He is a graduate of Messiah College with magna cum laude honors. He earned a bachelor's degree with a double major in economics and politics with international relations concentration.

Prior to being a Representative, John worked for a microfinance nonprofit organization for family farmers in East Africa as an administrator and fundraiser. He later served as a legislative assistant to Representative Charlie Dent. John and his wife – whom I know he will be introducing here shortly – reside in Walnut, Pennsylvania.

Mr. HERSHEY. Thank you, Mr. Speaker. It feels odd that this is likely my last time saying that, after only 4 years in the legislature.

One line from a former colleague's speech has really stuck with me as he was giving his farewell remarks. And I wrote this speech early last week, but it is actually even more apt after learning of his untimely passing last week. When he was giving his remarks, Chairman Pyle reminded us to "be who you told them you are."

When I first ran, I decided to run as someone who knows the issues and was not going to get into partisan grandstanding while sticking to my values. I also chose to focus on my record and what I can bring to the table rather than tearing opponents down, which I can hold my head high and say we accomplished, even when some opponents have not afforded the same respect. I hope my constituents believe that I have lived up to the standard that I said I would when I ran, and like Chairman Pyle recommended, that I was the same person here in Harrisburg that I was at home in the Juniata Valley.

The original person who made this possible, who I feel was the exact person in Harrisburg as he was back home in Chester County – and hopefully, Representative Lawrence would attest to that – is known by many of you as Representative Hershey, but to me as Papa, who is over here to the left of the rostrum, as you already know. I am grateful he could be here today because he is the first person who showed what good this job can do for folks back home. He showed this through extra legislative pursuits like clearing skunks from underneath his neighbors' porches, but also showed the power of consensus in enacting good public policy. He was the driving force behind many programs we still discuss in the agriculture and environmental spaces today, and has left a lasting legacy on this Commonwealth that I have been able to use as a model. He showed me that there is always a path forward for even the most difficult subjects that we might face under this dome.

Like Representative Silvis mentioned the other day, the district I was proud to represent was the victim of the reapportionment process. My only comment about that is that when we let partisan goals get in the way of fair representation for the people we love back home, it is the people who end up losing and not the politicians. Though I know legislators like Leader Benninghoff, Representative Rowe, and Representative Irvin are going to do a wonderful job representing the people that I love, tearing apart counties that have been together in a legislative district for decades does not do the people any favors, and it only creates confusion and chaos in the process.

Other than former Representative Hershey, I have a lot of people to thank. The first is my lovely wife, Wendy, to the left of the rostrum. Wendy knew what she was signing up for because we were only dating in my first campaign, but she chose this life anyway. During the most recent campaign, she has offered a steady attitude, a needed laugh, and maybe a shoulder to cry on one or two times. She is my best friend, and I am so grateful that she could do all of this with me.

To my parents, who are as interested and passionate about my campaign as I was myself, also to the left of the rostrum, I would not be here without your help. I have called Dad my campaign manager for the last 4 years, but he has called himself sign guy. Obviously, we have our differences in opinions sometimes, but without him and my mom helping with the walk lists, the books, and all other manner of things that are needed with a campaign, I would not have made it here in 2018.

To the friends and family back home I have called the broader Team Hershey – in May 2018, that included titans of campaigning like Jim Bob Neimond, Carol Whitesel, Cristine Peachey, Steve Dunkle, Lisa Nancollas, and Ed Fike – some of those folks are quite familiar with campaigns, but others consider themselves friends from church or work, thank you. Many of you took a chance on, at the time, a 24-year-old that you did not know from Adam – literally, in this case, because my predecessor's name was Adam – and I hope I have made you and the Juniata Valley proud.

My siblings and extended family also devoted countless hours to ensuring my success in that first campaign, and without them, I would not have been here either.

Legislatively speaking, there are a lot of people to thank in this realm who have helped with a lot of success: four bills signed by a Democratic Governor in 4 years, Fiscal Code language in three of four budgets, and a few grants for my constituents. But as everyone here knows, good legislation only gets accomplished by being in the right place at the right time and building the right relationships. Notably, my most proud legislative accomplishments can be traced back to tangible issues that people were having back home, which is the way I think good legislation should be accomplished.

I have spent much of my time here focused on agriculture and conservation issues and other issues faced by my rural community, since ag and agribusiness are my background, and I am immensely proud of the conservation funding we were able include in this year's budget. This funding was originally conceptualized in a bill that was introduced by myself and Senator Yaw, but it got huge boosts from Speaker Cutler and Chairman Saylor in the end, and I am really grateful for your help.

My legislative record benefited immensely from Leader Benninghoff being my district neighbor and Senate Pro Tem Corman being my Senator. Thank you, both of you, for running my bills, and particularly Senator Corman for showing me what the levers of power here in Harrisburg can accomplish, which were great things for the people back home.

Senator Ward deserves a mention as well – who is able to join us, also to the left of the rostrum – who wins the award for the amount of times constituents in a very remote part of both of our districts told me that they wish that they saw me as much as they saw their State Senator, which is embarrassing considering I represent significantly less people than she does.

Speaker Cutler, you have been a great mentor as well, and many research staff and chairmen have been a great help with even my craziest of ideas. I have also benefited from many bipartisan friendships under this dome with other legislators, many either in my class of 2018 or the famous – or infamous – Soup Caucus, who have either benefited my career immensely or have become lifelong friends. I look forward to many of those friendships, on both sides of this aisle, continuing outside of this chamber.

Outside of this building – although he is in this building today – I would like to thank Congressman Fred Keller, a former colleague to many of us, for his friendship and steadfast advocacy for the Juniata Valley and our rural slice of Pennsylvania. I would also like to thank former Congressman Charlie Dent, my former boss, for allowing me and encouraging me to run in the first place. For those of you who know Congressman Dent, some of you his former colleagues here in the State House, I am sure he found a lot of enjoyment – to use a word in both of our native Pennsylvania Dutch, "schadenfreude" – at the fact that he was hired on CNN to become a critic of his own party at the same time I was trying to find my way in a Republican primary. Like my grandfather, Congressman Dent served as a wonderful example of building consensus around important issues, and not only having good ideas, but executing them in the legislative process.

Finally, staff, without whom I would not have gotten off the ground, let alone been successful, and they are all joining us in the gallery today. Dan Auker started with me in 2018. Dan, you have brightened the office with your encouragement and your willingness to serve, and I can honestly say that you have become a best friend throughout this entire process. Renee Fry has gone above and beyond to get me in front of as many people as possible, and between her and Dan, their knowledge of all people, places, and things Juniata County approaches near 100 percent.

Briette Treaster was also an enthusiastic Mifflin County addition, who could not be here today, but became an invaluable part of the team. Jenn Fitch not only made me look good in public and to the press, but also offered a confidant to whom I could express my most vexing frustrations with this building. Representative Schroeder, my office partner, and I stole Pam Albert from Whip Oberlander a few years ago, and she has become an amazing part of this team – never without a kind word and with a heart as big as this building. I would be remiss if I did not mention and thank Sue Burkholder and Colton Fogleman as well, who started with me in the district and really helped me get the district office off to a running start.

Most importantly, I want to thank the wonderful people of Juniata, Mifflin, and almost Perry Counties, soon to be the former 82d District, for giving me this opportunity. It was the opportunity of a lifetime, and I am humbled to have been able to serve you in the State legislature.

This sounds cliche, but I have told dozens of people many times for years that my favorite part of this job were all of the really neat people I have met back home accomplishing amazing things that I would not have met if I were not serving in the State legislature. That remains true. It has been a tough few years with COVID, and a difficult Presidential election behind us, but I am so thankful that those folks back home have given me this opportunity. I hope that you back home can confidently say that I served you like the person I told you I was — again, like Representative Pyle recommended — and that I served you to the best of my ability.

To close, I am going to borrow a couple lines from former Representative Hershey's farewell speech that he gave in November 2008 after 26 years of dedicated service in this body. He reminded this body many times during his speech to be good stewards of this Commonwealth's resources, which he meant from both a natural perspective – as many of you know, he was a dairy farmer and longtime Ag chairman in this chamber – but also from a financial perspective. I think that continues to be increasingly important.

And he also brought up Scripture, which was the Proverb that reads: "Trust in the Lord with all your heart, and lean not on your own understanding; in all your ways acknowledge Him, and He shall direct your paths." I know this is an important verse to him because he also inscribed it in his Bible he gave me after I was able to attend his 2005 swearing-in, and I think this verse is the most apt for the next stage of my career.

I have been struck by the number of legislators giving their farewell speeches that have been here for 4 years or less like me, many of us victims of this reapportionment process, on both sides of the aisle. And I think we can all confidently lean into the next phase of our careers or our retirements knowing that our ways are not God's ways, and that great opportunity lies ahead. Thank you, and God bless.

The SPEAKER. Thank you for those words of wisdom, Representative Hershey.

And I think we would all agree that the sage advice of Representative Pyle, to be who you told him you would be, really spoke to his own authenticity, which we saw demonstrated time and time again with you and your character and your service.

I would also offer, the Bible tells us that we will be known for our fruits, and you have had a very fruitful legislative career. You were a man who stood tall with your character, and you were a good and humble servant to those back home. So thank you.

Prior to being a Representative, Wendi worked for a small start-up company in the health-care industry that grew into a national firm. Wendi and her husband, John, reside in Northampton Township. They have three children: John III, Justin, and Stephanie.

Wendi, welcome.

Mrs. THOMAS. Thank you, Speaker Cutler.

To my colleagues and your staffs, I want to let you know that I have learned so much from you. We have worked together to make a difference for Pennsylvania. We should be proud of the work we have done. For me, that especially includes the mental

health area. It has been so rewarding. I could not have done this without all of you. There are many individuals I would like to name, but the Speaker said I only have 5 minutes. Hershey took too much time. Just kidding, John. Just kidding, John. But I do want to give a shout-out to my #BucksTeam here in the front, especially my little big brother, Farry.

To my district, it has been the honor of my life to serve as your State Representative. Several of you have written to me to say thank you, but it is really I who owe you a thank you. Each of you whom I have interacted with over these last few years has had a huge impact on my life; many times you might not even know that. Like the birthday celebration I attended for a 100-year-old veteran. I was honored to attend and recognize him, and while most in the room were celebrating, he quietly raised the American flag he had been given and kissed it. That moved me to tears.

To my staff, each of you has embodied the word "team." I recognize that it is my name on the door, but honestly, you make me better. I do not know that I can properly express how much I appreciate all you have done. Every time I am out publicly in the district, someone says, Thank you. I called your office and I got help." And I think, that was not me, that was my wonderful staff. Truly amazing work, and I would like to take a moment and recognize you. When I say your name, please stand, and then if we could have a round of applause at the end.

From Harrisburg: Dawn Pelletier and Barb Ramsey, both of you have been incredibly helpful legislatively, and I am pretty sure that I would still be walking around this building in circles if it was not for Dawn. From my district: Pat Caimano, my office manager, who I think knows every constituent in my district personally. Courtney Shaya, who never believes you can let an email go unanswered for more than one minute. She is incredible. Linda Ouimet, who helped us make headway in New Hope and Solebury and have a good, strong office presence there. And Madison Buckley, who every senior who comes to my office loves. Everybody loves Maddy. I would also like to recognize my writer, Dave Foster – I am not sure where he might be; there he is – because honestly, he felt like part of our district team, and I truly appreciate his work. If we could have a round of applause for these guys.

To my family: my dad and Kathy; my husband, J.T.; my children, John and Lauren, Justin and Jen, and Stephanie. None of these people know that we are broadcast on PCN (Pennsylvania Cable Network). They have never seen me speak on the House floor. But their unwavering support, advice, and love means the world to me.

Finally, I want to thank someone special, whom I asked to attend today. Her name is Denean Young. She does not know it, but she has had a tremendously positive impact on me. We in this building live very busy lives. We have hundreds of things to do each day. I know that when I get to the Capitol, most days between 7 and 7:30, my head is thinking about all of my to-dos, and I often feel like I am carrying the weight of the world on my shoulders. I am stressed. And about 7:30 or 7:45, I go to the cafeteria – I pass the morning breakfast men's club, who have often invited me to join them; thank you – and I get coffee. When I am there, every single time I am there for the past 4 years, I am greeted by a smile, and that smile is joined with positive words – you look great today; it is going to be a great day – always positive. Denean not only has positive words for me, but for every person she sees in our cafeteria and for all of her coworkers. She

works all the time, going around talking to everyone, has a smile on her face. So I have asked her to join me today, and I want to publicly thank her because she made a huge difference in my life. Denean Young.

Lastly, I would like to leave you with a quote from Ronald Reagan that I hope in some small way can be true for me: "Whatever else history may say about me when I'm gone, I hope it will record that I appealed to your best hopes, not your worst fears; to your confidence rather than your doubts. My dream is that you...travel the road ahead with liberty's lamp guiding your steps and opportunity's arm steadying your way."

The House proceeded to third consideration of **HB 1419**, **PN 3470**, entitled:

An Act amending Title 61 (Prisons and Parole) of the Pennsylvania Consolidated Statutes, in general administration, further providing for State recording system for application of restraints to pregnant prisoners or detainees; in county correctional institutions, further providing for county recording system for application of restraints to pregnant prisoners or detainees; and, in miscellaneous provisions, further providing for healthy birth for incarcerated women and providing for restrictive housing prohibited for pregnant or postpartum incarcerated individuals and detainees, for cavity search and inspection restrictions, for training and education requirement, for family consideration in placement and visitation, for feminine hygiene and incontinence products and for postpartum recovery.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the good lady, Representative Mizgorski.

Mrs. MIZGORSKI. Thank you, Mr. Speaker.

Before I begin, I want to thank all the supporters who are up in the gallery today.

Today I rise in favor of HB 1419, Dignity for Incarcerated Women. In recent decades, Pennsylvanians have seen an increase in the number of incarcerated women. While we believe in supporting a system that serves justice, women who are incarcerated face unique challenges regarding their health and the health of their children. Despite being incarcerated, these women are still mothers, wives, sisters, daughters, and it is in everyone's best interest that we treat them with dignity.

This legislation is the result of several years of work by House members from both sides of the aisle. Through collaboration with the State Department of Corrections, county wardens, corrections officers, advocacy groups, and formerly incarcerated women, best practices were identified and included in this legislation. Many of these practices are already in place, so the intent of the legislation is to memorialize these best and reasonable practices in statute.

Additionally, HB 1419 supports healthy parent-child relationships by maintaining visitation for custodial parents and requires correctional institution employees who have contact with pregnant women to undergo professional training related to pregnancy, postpartum, and trauma-informed care.

By passing this legislation, we can have a positive impact on the lives of incarcerated women, which in turn can impact their lives for the better when they return to their families and communities. For this reason I respectfully ask you to vote "yes" for HB 1419, Dignity for Incarcerated Women. Thank you.

The SPEAKER. The Chair thanks the good lady and recognizes the gentlewoman, Representative Davis, on final passage.

Mrs. DAVIS. Thank you, Mr. Speaker.

Thank you to my colleagues for your support, and hopefully your passage, of HB 1419 today, also known as the Dignity for Incarcerated Women bill. This is a culmination of efforts over several legislative sessions. What began as a subcommittee of the Pennsylvania Legislative Black Caucus has become an incredible step toward treating incarcerated women with the respect and dignity they deserve.

With the passage of this bill, pregnant people will no longer be shackled in prison and will no longer be subject to solitary confinement. They will be able to bond with their babies after birth. Corrections officers they interact with will be properly trained to provide care to pregnant and postpartum people. It is important to mention that this will not only protect pregnant people in our facilities, but with the passage of this legislation, women will no longer be subject to full-body searches performed by male guards. Feminine hygiene products will be provided at no charge.

I am so grateful to my colleagues – the gentlewoman from Allegheny County, the gentlewoman from Philadelphia County, and the gentleman from York County – as well as all my fellow Democratic members who helped put this over the finish line. Thank you.

The SPEAKER. The Chair thanks the lady and recognizes the gentleman, Representative Jones, on final passage.

Mr. JONES. Thank you, Mr. Speaker.

I want to thank the maker of the bill. Without her, we would not be here today, so thank you.

You know, a lot of bipartisan efforts are bipartisan because they are easy, but a lot of them take a lot of work, and every once in a while we have a true bipartisan effort, that I am confident will soon get a unanimous vote, and I want to thank my colleagues, Representative Cephas and Representative Davis. I want to acknowledge and thank Kandia Milton, who is with us today from Dream.org; Kaitlin Owens from American Conservative Union; and the great Tonie Willis, my dear friend, from Ardella's House in Philadelphia.

This is a women's issue, so my comments will be brief. This has nothing to do with being easy on crime. It just has everything to do with treating women — our mothers, our sisters, our daughters — with the dignity that all women deserve, and it does a lot to protect their unborn children and their minor children so that we can minimize the disruption on their lives as innocent children.

Lastly, when it comes to criminal justice reform, I sort of like to put it this way. I am a businessman, an American, and a Christian. As a businessman, this bill is good policy. Ninety-five percent of those that are incarcerated will get out and we do not want them going back. If we can treat these ladies with dignity, it increases the chances of that occurring. As an American, this is a land of second chances and opportunity, and none of us want to be judged on our worst day. And as a Christian, rest assured we are all in need of redemption. I know that I certainly am.

I thank all the great women for giving me the opportunity and the privilege to play a small role in this bill, and I encourage a "yes" vote.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentlewoman, Representative Cephas, on final passage.

Miss CEPHAS. Thank you, Mr. Speaker.

I, too, would like to thank my colleagues, as well as the staff from both sides of the aisle, for getting this bill to a place where it is not only bipartisan, but the administration is in support of it, and also the advocates that have been on the ground. I also want to thank the leadership of the Legislative Black Caucus, as well as the Subcommittee for Women and Girls of Color for the Black Caucus, for making this a priority each and every legislative cycle, not just by offering legislation, but also by going to Muncy, as well as Cambridge, to listen to their voices and ensure that the families were heard throughout this entire process.

Lastly, but certainly not least – and my colleagues acknowledged a lot of the advocacy groups that worked alongside us during this entire process – but I really want to highlight my constituent, one, because I would not get her vote if I do not, but Tonie Willis, who is up in the balcony today, from Ardella's House. Not only does she bring this issue to the forefront from a legislative perspective, but she also shared her story and how her time during her incarceration impacted her, as well as her family as well as the community around her, and you know, I am so grateful for her to bring her pain into progress and into policy and really have an opportunity to affect those that are coming behind her.

As we oftentimes have this conversation as it relates to criminal justice reform, we tend to leave out the idea of women and girls. And you know what this bill truly does is acknowledges that they have unique circumstances, that they are the fastest growing population in our prison system, but they also come to us as mothers, sisters, taking care of young people, being heads of households, but also 80 percent having suffered some type of physical or sexual abuse, having some type of substance abuse challenges, but also face particularly daunting obstacles when they return to society.

My colleagues talked about the substances of the bill. It ensures trauma-informed care for training for officers to help reduce recidivism, help incarcerated women reenter into society, but it also makes sure that we are taking care of pregnant and postpartum women while they are incarcerated so we do not add to our maternal mortality and maternal morbidity rate.

So again I want to thank the staff. I want to thank the colleagues who made this a priority again this legislative cycle. But I specifically want to thank the advocates for your calls, joining as many meetings that we have had to get this across the finish line. And again, we would not be able to do this without you and without it being a bipartisan effort, so thank you very much.

Mr. Speaker, my bill is designed to remove an antiquated provision of law. Namely, the bill repeals Act 49 of 1933, known as the Sunday Baseball and Football Law, in its entirety. Originally, this act prohibited individuals and associations from playing or engaging in baseball or football games before 2 p.m. and after 6 p.m. on Sundays.

Mr. Speaker, just to provide some background. Dating back to at least 1794, the General Assembly has limited certain activities on Sunday. But beginning in the 1970s, between court cases and with other changes, we began to move away from blue laws like these here in Pennsylvania. Therefore, Mr. Speaker, it is important to repeal laws like Act 49 of 1933 not only because it is no longer utilized, but also to streamline our existing laws to make sure they are as up to date as possible.

I would encourage members for a "yes" vote on HB 391. Thank you, Mr. Speaker.
