# REMARKS BY MAJ. GEN. MARK SCHINDLER

The SPEAKER. At this time we will invite the Adjutant General to approach the rostrum.

MAJOR GENERAL SCHINDLER. Good morning, Speaker Cutler, members of the House, distinguished guests, and friends of the Department of Military and Veterans Affairs and the Pennsylvania National Guard.

It has been over 2 years since we last had the honor to address this distinguished House of Representatives. In that period, much was asked of the Pennsylvania National Guard, and I am proud to say we successfully accomplished every State and Federal mission assigned.

Our DMVA State employees met every challenge as well: caring for the residents of our six veterans homes, delivering programs and supporting veterans in need, keeping the facilities operating, and supporting our Guard. Among those recognized today are our Airmen of the Year. We recognized several Army noncommissioned officers who help to prepare our units to deploy around the world; nurses from our State veterans homes who selflessly care for our most vulnerable veterans; operations officers who are the vital link with State agencies during times of emergencies; the senior team leader at our newly opened Keystone State Challenge Academy, who inspires cadets to achieve more than they ever thought possible; and though not a member of the Pennsylvania National Guard per se, yet certainly part of the Pennsylvania National Guard family, our State partnership liaison from the Lithuanian Armed Forces. These individuals are just a sampling of the diverse and dedicated talent in the Department of Military and Veterans Affairs. Together they serve our communities, our Commonwealth, and our nation. They are always ready and always there.

And so are you.

You have helped to provide our soldiers, airmen, employees, veterans, and their families with the benefits they have earned, as well as the care that they deserve. # FAREWELL ADDRESS BY MR. ROTHMAN

The SPEAKER. Representative Rothman will now approach the rostrum. We will transition to some of the retirement speeches.

Representative Rothman was elected to represent the 87th Legislative District in a special election in 2015. Greg is a graduate of Cumberland Valley High School and holds an undergraduate degree in political science from the University of Massachusetts Amherst and a master of science degree in real estate from Johns Hopkins University. In 1989 he started as a real estate sales agent at RSR Realtors and advanced to now serves as president and CEO (chief executive officer).

Prior to his real estate career, he enlisted in the Marine Corps during Operation Desert Storm. He served nearly 10 years in the Marine Corps Reserve, rising to the rank of staff sergeant before being honorably discharged in 2001. And Representative Rothman is the proud father of five children.

Representative Rothman, welcome.

Mr. ROTHMAN. Thank you, Mr. Speaker, and thank you for putting up with me these 7 years.

Representative Pennycuick, who is also moving to the Senate, said to me yesterday, "Why are you giving a speech? You're just moving across the hall. You don't have to say goodbye," and I said, "Well, I've got some things I've got to get off my chest."

No.

You know, despite most of my life living within a few miles from the Capitol, before I was elected, I had only been in this building maybe four or five times, and that included my third grade class trip in 1975, when both of my parents were chaperones. And we have a black-and-white picture of it.

But I knew a little bit about politics. I knew a lot about real estate and a little bit about campaigns, but I knew very little about what this legislature did. My 4-year-old daughter, Abigail, was asked by her older sister, "What is session?" and she replied, quote, "They get together in June and make sure everyone talks a lot."

You know, Yogi Berra said, "You can observe a lot by just watching," so here are some of my observations, and maybe, some advice.

Each one of you are outstanding leaders from your communities; you are leaders here, and leadership is about encouragement. So I urge you to encourage each other. Words do matter. Be kind to each other. I believe the greatest threat to democracy is the lack of civility amongst the people in this business.

You know, in the Marine Corps, when you were promoted, you not only learned your new job, but you learned the job of the person that was above you, and you trained the person below you to your job in case anything happened. That attitude too often is missing in politics and government.

Be a mentor and allow yourself to be mentored. I am grateful for the great mentors I have had, both in and out of this building, and I expect great things from those who let me mentor them: Kail, Lewis, Kerwin, Owlett, Kaufer, Mercuri, Ecker, Rowe. I expect great things from all of you.

As I have done everywhere I have gone in life, I came here to try to make friends. As a young real estate salesman, my father told me to find what you had in common with your prospective client as quickly as possible. I recommend that method; it works.

We built our 50-plus-year real estate business on multiplication and addition, not division and subtraction. We should respect our differences, but make sure we celebrate what we have in common. We are all Americans living in the greatest country in the history of the world, in the State, the Keystone State, which had more to do with the birth and growth of this nation than any other, occupied by the best people in the country – the hardest workers, the bravest veterans and first responders, the smartest, the best and the brightest – and that includes all of you in this room.

The friendships that I have made here have been genuine and life-changing. I am grateful for all of you.

But to my South Central Caucus and my rows, thank you for literally and figuratively having my back. We share a geographical area, not just in the Commonwealth, but in this building and in this room. Stambaugh, Gleim, Keefer, and my soul sister, Sheryl Delozier, thank you. Klunk.

And to the Southwest Caucus, who would not recognize that Mother Cumberland County was actually the gateway to the west and would not let me join your caucus, but befriended me nonetheless. Of course, Jesse Topper can be a member of both the Southeast and the Southwest Caucus, why can I not join? Just kidding, Jesse. You know I love you.

Since my friend, Leader McClinton, is not here, someone suggested I address this to the acting minority leader; I do not see him, either. Leader McClinton, thank you for your friendship and kindness to my children, especially my daughter, Eleanor, who once texted us that she and her NYU friends thought we should run for Governor and Lieutenant Governor together on an unconventional bipartisan ticket. I asked who would be Governor and she texted back immediately: "Duh, Dad, Joanna."

Leader Benninghoff, your empathy and compassion for those you serve is inspiring and aspiring. I am grateful for your kindness to me and for your friendship.

I am grateful for my outstanding staff in the Capitol and district office: Sharon, Kaytee, Kris, John, and Mike. You made me look good and took care of the people of the 87th District.

And to my political guru and best friend, Vince Galko, thank you.

My mother and father, Bill and Susannah Rothman, who are here today and who taught me how to work hard; taught me about kindness, service, and humility.

I want to thank my children: Nicholas, Eleanor, Mia, Elena, and Abigail, who as children of a public figure often suffer, as all of you with children know. I thank you, kids, and I love you.

The Republican leadership – Whip Oberlander et al. – thank you for your confidence in me and for your service to more than just your constituents, but also to your colleagues.

And finally, to Representative Steve Kinsey, who used to introduce me to people as his best Republican friend until I said, "Well, you don't know any other Republicans," and to be clear, let us be clear: Our voting records are complete opposites. Where I get 100 percent, he gets a zero; where I get F's, he gets A's. But

nonetheless, one day he started introducing me to people as his best friend in the legislature, and I agree. Representative Kinsey is an amazing person and leader, and I have seen him shine as a father, son, and brother. And I have told freshmen Republicans, "Find a Kinsey to befriend."

The greatest commandment in my faith is to love others. You can have convictions side by side with compassion. The Scripture is clear over and over again: be humble, love others as you love yourself.

Our system of government is of, for, and by the people. Remember, we govern based on the consent of the governed. We do not rule the people; we do not have subjects. And never forget that we are a Republic. The money we spend here, that came from those people we govern. Be good stewards of that money, and maybe let them keep some of it.

Americans are cynical about government because the way government treats them, but they are cynical about politics because of the way we treat each other. So join me in promoting civility and kindness.

May God bless the Commonwealth of Pennsylvania, and may God bless all of you.

# FAREWELL ADDRESS BY MR. LEWIS

The SPEAKER. We will invite Representative Andrew Lewis to the rostrum.

Representative Andrew Lewis was elected to represent the 105th Legislative District in 2018. After high school, Andrew enlisted in the Army, where he served for almost 10 years on active duty. He then went on to serve in the Pennsylvania Army National Guard for 5 years. Utilizing the GI Bill, he earned a bachelor's degree in political science from Thomas Edison State college, a graduate certificate in public policy from Liberty University, a master's degree in legislative affairs from George Washington University, and a master's of business administration from Temple University.

Andrew and his wife live in Lower Paxton Township with their three sons. Welcome.

Mr. LEWIS. Thank you, Mr. Speaker.

My remarks today will be exactly like my political career: somewhat inspiring, mildly turbulent, and incredibly brief.

One of the first things I learned about this job was both the importance and volatility of constituent services. A few days into my first term – like day 2 – our district office received a call from a constituent about a rabid fox – the animal, fox – that was apparently destroying their backyard. Our team kicked into high gear. We called the legislative liaison at the Game Commission. We brainstormed solutions. We tried to figure out exactly how to help this poor constituent who was in a panic. But then we checked the address and realized that it was a prank call from my predecessor, Ron Marsico, who apparently had nothing better to

do in retirement than help introduce me to the duties and challenges of solving constituent dilemmas from the district office. Thank you for that, Ron.

On a serious note, though, constituent services are incredibly important, and I found that we can often most directly impact the lives of those we serve by providing excellent services from our district offices. So I want to thank Keara Weltmer, who is here today, who leads my district office team — one of the most dedicated staff members I have ever had the privilege to work with. She goes above and beyond for our constituents. I have been immensely lucky to have Keara leading our district office team. Thank you, Keara.

I also want to thank Katelyn, Kevin, Allison, and the various interns and staffers who have augmented our team from day one, providing excellent services to the 105th. Here in the Capitol, I have also been blessed with tremendous staff who have helped me in my legislative duties: Debby Garger, over here, my Capitol secretary, who has been with me since day one of my first term, both assisting me and serving our constituents. One of Debby's superpowers is the ability to make guests feel welcome at the Capitol, especially visiting students, and she has inspired so many youth and students by preparing educational packets for them and making them feel welcome during their visits. Thank you, Debby.

Jen Fitch, my writer back here, has done an amazing job helping me communicate with my constituents. Each of our writers, but especially Jen, are talented communicators, whose skills range from speechwriting to photography to a variety of social media platforms. It is a tough job, but Jen excels at it, and I am lucky to have her on my team. Thank you, Jen.

I want to thank freedom row down here, this quadrant, also known as the freedom team, for making session days both interesting and fun. A great group of colleagues down here. Speaking of Rowe, when former Speaker Turzai assigned Dave Rowe and I to sit together on the House floor, he had no idea we had known each other since about 12. We grew up in the same homeschool community. I know we have a homeschool co-op here today. Do not grow up to be socially awkward like Rep Rowe. You can be normal and be homeschooled. All right.

But sitting together has been a grand opportunity to strategize, scheme, plot our next freedom endeavor. Some people unfairly call us the Chaos Caucus – not true – due to our at-times unconventional approach. I have heard we caused the leader to lose a few strands of hair every session day. God knows he cannot afford to lose too many more strands of hair.

Do not worry, sir, I promise to keep the leader jokes short, but that is honestly probably why we do not have a barber back there anymore, for those of you wondering. The leader walked past him every day and was bitterly reminded he will never need a barber again, and so, poof, no more barber. Thank you, Mr. Leader.

I want to thank the Speaker for teaching me many things, but one of the most important lessons I learned from the Speaker is to never judge a book by its cover. Let me explain. This led to me learning about a CrossFit workout called the Murph, named in honor of a Navy Seal who fell in the line of duty. The Murph, as it turns out, is a fairly intense workout consisting of a 1-mile run, 100 push-ups, 200 sit-ups, 300 squats, then another 1-mile run, and you have to wear a 20-pound vest, weighted, the whole time.

When I learned it was a timed event, I assured the Speaker I could totally beat whatever his time was, and mind you, I was solely going off outward appearances, being that I was a combat veteran who had done like 27,000 push-ups in my day, and being that the Speaker has no visible evidence of any upper body strength whatsoever. I figured there was no way this guy could beat me at anything, let alone a timed Murph competition.

So we agreed to have a little contest, starting with just a half-Murph. We met at Dave Rowe's CrossFit gym out there in Lewisburg on a hot July day, and before you know it, we donned our weighted vests, started the clock, and kicked off the competition. So we get through the run first and started on the other workouts. Now, I was about 25 percent through my workouts -25 percent - when to my shock, I see the Speaker wrap up his last set of squats and bolt out the door for his final run.

Now, I always knew Speaker Cutler as a diplomatic, highly respectful, gracious, magnanimous individual, but apparently when it comes to fitness competitions, all that goes right out the window, because apparently, and unbeknownst to me, the Speaker has been a triathlete since he was, like, 7 years old, and he thrives on these types of competitions. So he gets back from the run, completing the competition, and I was still only about halfway done with my push-ups and squats, and next thing you know, Speaker Cutler begins to mock me mercilessly as I suffered through my workout. I was just getting over my surprise, and I looked around wondering what had happened to our gracious and magnanimous Speaker, when he then proceeded to take out his cell phone and began recording my misery. The worst thing was, he did not even get any videographic evidence of me working out because the footage was all of me resting between sets catching my breath, because I was genuinely about to die. As if that was not bad enough, the man had packed a cooler full of ice-cold, refreshing beverages, because apparently when you are from Peach Bottom, every event you go to is some kind of covered-dish fellowship event, so he obviously came prepared. Much to my chagrin, the Speaker procured an ice-cold beverage from his cooler and began to drink it in front of me as I suffered through my final workouts. When it finally came time for me to finish out with the last run, the Speaker not only yelled at me for starting out my run slowly – I was walking, to be fair – he then ran beside me, and I think he actually ran backwards just to underscore the point.

So I totally lost that competition. Now, I did win a ropeclimbing competition before we started, but then later I realized he probably just did that one to wear me out for the main event, which was an effective strategy.

Despite my bitter loss that day, I did learn never to judge a book by its cover. It is something most of us are taught as kids, but it really sank in that day. You never know, the guy who literally looks like his entire diet consists of jelly donuts and Klondike bars may secretly be an endurance athlete. Who knew?

So I guess the moral of the story is, never judge a book by its cover.

And by the way, I deserved all the ribbing that I got because in our group text leading up to the event, I was so confident I was going to win that I dubbed myself #murphcrusher, and then when he beat me, he came back with #murphcrushercrusher. It was pretty painful.

So I guess the moral of the story is never judge a book by its cover. Never judge your colleagues by that first impression or floor speech or Facebook post. Get to know each other. There may be a unique fact or a common bond or story somewhere that provides a connection and leads to a working relationship. In my case, it was just a painful and humiliating loss, but in your case, it may lead to legislative progress or even a lifelong relationship.

Despite that loss, I do want to thank the Speaker for his leadership, mentorship, and unwavering integrity. All joking aside, he has been a true example of statesmanship, which is exceedingly rare in today's political environment.

I also want to thank the leader, who is both humble and kind. During my first term, when my family was going through a challenging time, the leader literally called me to check in and offered to come mow my lawn on the weekend. He is a true gentleman and servant leader.

I want to thank each member of this chamber, and specifically, some of those who mentored, helped, or worked with me on various initiatives: Chairman Kauffman, Chairman Grove, Dawn Keefer, Barb Gleim, Dave Rowe, Clint Owlett, Greg Rothman, Frank Ryan, Josh Kail, and so many others.

On the Democratic side of the aisle, there are some I would thank by name, but I do not want it to come back and hurt you in a primary. I would never want to name you as being awesome to work with and then it is used against you later, so I will just thank Chairman Bradford for all he has done — tremendous public servant. I am kidding. I have a lot of respect for the chairman.

On a final note, I want to thank my constituents in the 105th District for giving me the honor of a lifetime: to serve in this building and try to carry your voices to the Capitol. This never was my seat; it was your seat. And you let me be a steward of your seat for a full 4 years, and I thank you from the bottom of my heart.

Colleagues, I will submit the remainder of my remarks for the record, which apparently did not turn out to be so brief. Thanks to each of you for all you do to advocate for your constituents, all of whom make up the fabric of this great Commonwealth.

God bless you, and God bless Pennsylvania. Thank you.

# REMARKS SUBMITTED FOR THE RECORD

Mr. LEWIS submitted the following remarks for the Legislative Journal:

When I first walked into this chamber as a member, I felt the profound responsibility given to me by my constituents – that they wanted me to vote in line with their values and the principles I had run on, and do what I could to fight corruption, advance liberty, and minimize the impact government has in their day-to-day lives. I have remained mindful of that responsibility every time I crossed the threshold into this chamber.

My successes in the past few years have come from advancing ideas – helping meaningful concepts and initiatives get traction. It was especially important for me to advocate for curriculum transparency so that parents could know what is being taught in their children's classrooms. While the Governor disappointingly vetoed HB 1332, the strong support it received in both the House and Senate tells me this fight is not over and we will soon be able to better empower families.

Oversight into education and school funding is among our most important roles. We have been entrusted to guide younger generations to future success. Remember to never take this authority lightly. The children looking to us today will be the ones who lead us tomorrow. They all deserve access to the best educational resources that meet their specific needs. As we vote to provide funding for educational programs, we must always endeavor to fund students, not systems, and we must remember that a world-class education – whether through public, private, charter, or homeschool – is the gateway to the American dream.

Being an elected leader has allowed me to meet so many people living and working in the awesome 105th District, and I will never forget them. I have enjoyed connecting with them at outreach events, particularly one of my personal favorites, which has been the Veterans Day lunch. It is such a privilege to look my fellow veterans in the eye and thank them individually for their service. I will never forget those experiences.

I need to thank my staff for putting those outreach events together and for keeping me organized every day. It is a phenomenal team, unparalleled in the level of service provided.

I want to also thank my family members who have supported me tirelessly during my 4 years in office – my amazing wife, Ranae, and my sons, Jeffrey, Jason, and Jeremy. I want to thank my parents, John and Julie Lewis, for raising me with old-fashioned Pennsylvania values, and for being there for me always. Finally, I want to thank each of my siblings, friends, and supporters who have cheered me on and helped so faithfully during my time in office.

In front of each of you on this House floor is a desk, and that desk is made from mahogany wood. And that mahogany wood comes from a tiny country in Central America formerly known as British Honduras, but today is called Belize. You know it as a tourist destination, but behind the facade of the Ambergris Caye is a series of villages that dot the Belizean landscape.

I spent my formative teenage years in those villages, living alongside the Belizean people and learning about their stories and struggles – families who, though they lived just miles away from the cruise line ports, had never had a vacation in their lives. My family and I worked for a faith-based nonprofit, and the village we lived in had just received electricity 3 years prior to our arrival. Roads were still unpaved, and bicycles and horses were still major modes of transportation. We had no running water. Growing up there and learning about the challenges of my fellow villagers, though unseen and unheard, gave me a unique perspective on the struggles faced by those behind the scenes, even at a popular tourist destination country like Belize.

Those experiences, after having spent my childhood growing up on a Perry County farm in a blue-collar family, taught me to hear – to listen to and value – the voices and stories of people you never see in the news, who have no prominence, position, or financial means to gain a seat at the table.

Then when I joined the Army at 18, I enlisted as a private and made my way through the ranks – shoulder to shoulder once again with people who never made the news, who did not get the fancy Pentagon assignments, who just did their jobs, day in and day out, behind the scenes. And once again, this experience influenced my understanding of the world and those who shape it – those who are often unseen and unheard, yet who create tremendous value for our communities.

Because whether it is a desk we write on or a home we live in or a meal we eat or a beach town we travel to on vacation or simply our peaceful way of life we take for granted each day, everything we enjoy as a society was crafted by the carpenter, the builder, the blue-collar worker, the farmer, the frontline worker – all protected by the soldier – the folks behind the scenes who make it all possible. Their stories are often unknown, but their lives hold incredible value. And every day I have served in this chamber, I have tried to remember their faces and stories, and have done my best to carry their voices into this chamber.

Because at the end of the day, those of us serving in this chamber are sometimes the last hope these people have to be heard, to be fought for, to have their circumstances changed for the better. I urge you to remember the unseen, unheard constituents you serve, and to always bring their voices to this chamber.

Remember that each vote you take in here affects someone – whether it is a business owner already facing way too many regulations; a parent trying to raise children in the best manner possible; a volunteer fire chief trying to add personnel to his ranks; a veteran being stonewalled as he or she tries to access the services they deserve. Every vote matters to someone.

And finally, never forget that history tells us time and time again that excessive government always results in misery and tyranny. I have long believed that less government is equal to better government, and that more freedom is equal to more opportunity. When our nation was founded, it was the first time in human history that the individual was held as sovereign, the government was held as subject, and free enterprise was held as sacred – and the collision of those ideals launched us from horse carts to spaceships in less than 200 years. That is America.

So please always remember that America is best when government is limited, and people are most prosperous when they are free. And please work to preserve these ideals for generations to come.

Thank you to my constituents for the opportunity to serve in this body, and thank you, colleagues, for your service to our Commonwealth.

The SPEAKER. The gentleman, Representative Webster, had two amendments. It is the Chair's understanding that the gentleman, Representative Webster, wishes to withdraw amendment 5520 and would prefer to offer 5521? The Chair thanks the gentleman.

Mr. **WEBSTER** offered the following amendment No. **A05521**:

Amend Bill, page 1, line 9, by inserting after "<u>veteran-owned</u>" small

Amend Bill, page 1, lines 10 through 12, by striking out " $\underline{\mathbf{A}}$  veteran-owned business shall not be required to seek" in line 10 and all of lines 11 and 12 and inserting

A veteran-owned small business shall submit verification of service-disabled veteran ownership from the United States Department of Veterans Affairs to the Department of General Services to be considered a small diverse business.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the gentleman, Representative Webster.

Mr. WEBSTER. Thank you, Mr. Speaker.

I stand before this body today to support the bill. I want to make sure that everyone understands, this bill will allow veteran-owned businesses to be considered a small diverse business, and we should do that. And I want to thank the maker of the bill for going in that direction.

But there should be some changes in the language because of the way that it equitably impacts other veteran-owned small businesses. Those that are currently considered to be service-disabled veteran business enterprises will be under this language, forced to compete in a much bigger, a much bigger market than they currently do. So there are advantages to this bill and there are some disadvantages for other veterans groups at the same time. And we could go through all the different categories – it is a little bit like alphabet soup – but I think it is important to get this right, and I would request some support for this amendment so that the language does not favor some veterans and disfavor others. It needs to be comprehensive and support all veterans.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman, Representative Lewis, on the amendment.

Mr. LEWIS. Thank you, Mr. Speaker.

I rise in opposition to this amendment. As a veteran who is also in the construction industry – very familiar with SDBs (small diverse businesses) and VBEs (veteran-owned business enterprises) – there is no way that you would adopt this amendment and still support the underlying bill, because almost every veteran-owned business I know of would much rather be classified as an "SDB" because 15 percent of State contracts have to go to SDBs; only 3 percent have to go to VBEs. So all this bill says is that if you are a veteran and you have served your country, you would qualify as an SDB, which is much more desirable. What this amendment would do is it basically completely invalidates the underlying bill and says you have to be a service-disabled veteran to get SDB status. So it takes us back to square one.

I just want to note that a couple years ago, every veteran-owned business qualified for SDB status. That was just changed in the last couple of years. For whatever reason – I do not know why DGS (Department of General Services) would oppose this, but it makes no sense; Department of Veterans Affairs supports this. And to support this amendment is to completely not support the underlying bill. So I urge a "no" vote on the amendment.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman, Representative Rowe, on the amendment.

Mr. ROWE. Thank you very much, Mr. Speaker.

I join the previous speaker in asking for a "no" vote on this amendment. The intent of the bill – which I am very glad to hear the maker of the amendment supports. I am looking forward to a "yes" vote on the bill as unamended – but the intent of the bill was to restore the small diverse business status that the administration unilaterally removed in 2015. We have countless veterans who own small businesses across the Commonwealth who had their status, and the prime contracting opportunities that come with that, yanked away without any sort of explanation or opportunity for recourse. So this bill will address that by reinstating the small diverse business status to make sure that our veterans have the opportunity to compete for those prime contracts.

To implement this amendment, which would require them to match the standard that the Governor and the DGS attempted to meet by forcing them to qualify as another member of the SDB list, to require them to do that I think, Mr. Speaker, really minimizes their contributions. These men and women who have served in our Armed Forces have put their life on the line. They have written a blank check with a value up to and equal their life in order to serve our country, and for us to say to them, well, that does not count unless you are a disabled veteran, I think minimizes their contributions.

And, Mr. Speaker, for that reason I would ask for a "no" vote. The SPEAKER. The Chair thanks the gentleman and recognizes the gentlewoman, Representative Bullock, on the amendment.

Mrs. BULLOCK. Thank you, Mr. Speaker.

I rise in support of this amendment. I believe that the effort by the gentleman here is to clearly identify what exactly is a small diverse business, and simply because you are a veteran does not make you a small diverse or disadvantaged business. And because of that, I do think that we need to focus on those veterans who are service-disabled and put them in a class with other disadvantaged businesses such as minority-owned businesses and women-owned businesses. And I just do not think that there is a historical perspective to include all veteran businesses in that definition.

And for this reason, as chair of the Pennsylvania Legislative Black Caucus, I believe that the underlying bill dilutes the purpose of actually uplifting those businesses that have been disadvantaged here in the Commonwealth.

Thank you very much, and I ask for a "yes" vote on the amendment.

The SPEAKER. The Chair thanks the lady.

Seeing no one else seeking recognition, we will recognize the prime sponsor, Representative Rowe, for the second time on the amendment, prior to recognizing the leaders.

Mr. ROWE. Thank you, Mr. Speaker.

Just to clarify, prior to 2015, prior to the Governor's Executive order, veterans in Pennsylvania enjoyed small diverse business status. This is hardly an unprecedented action here. All we are doing is reverting to the system that was in place prior to the Governor's Executive order that removed small diverse business status from the veterans that owned small businesses.

Mr. Speaker, I think to say that veterans are not part of that demographic that we need to be doing everything to assist really does a disservice. Mr. Speaker, it is not a secret – it is in fact a tragically well-known fact – that 22 veterans a day commit suicide, whether it has to deal with mental health issues or issues simply readjusting to civilian life. To say that those veterans who have come back, that they have to be disabled to qualify for our gratitude, again, minimizes their contributions, Mr. Speaker.

We can do better. They deserve better. Please vote "no." The SPEAKER. The Chair thanks the gentleman.
