NOMINATIONS FOR SPEAKER

The CHIEF CLERK. The Chair rescinds its announcement that the election of Speaker was over temporarily and now returns to the nominations of Speaker.

The Chair recognizes the gentleman from Blair County, Representative Gregory.

Mr. GREGORY. Thank you, Madam Chair.

I rise today to nominate Representative Mark Rozzi from Berks County for our next Speaker of the House.

At first blush, I know many might be wondering why a Republican is standing up to nominate a member of the Democratic Caucus. The answer is really very simple. We must have a Speaker that reflects the realities that we have before us. For me, Representative Rozzi has proven himself to be an independent voice. I believe that he will continue to forge that independent path and remain a fair arbiter of the business of this chamber. In choosing that person, there can be no better place to start than with someone who already has shown a record of putting the needs of Pennsylvanians before expedient political outcomes. Representative Rozzi has a record of meeting that ideal and he has done so with class, with statesmanship, and with an ability to forge friendships on both sides of the aisle.

The last few weeks – the last few years, really – have seen this chamber engage in some of the most bitter of partisan fights, but we have also risen above the occasion to successfully solve some of the most challenging problems to face us as a Commonwealth and as a legislature. The Chair recognizes the gentleman from Washington County, Representative O'Neal.

Mr. O'NEAL. Thank you, Madam Chair.

I rise to second the nomination for the good gentleman from Berks County, Representative Mark Rozzi, for Pennsylvania Speaker of the House.

We need an independent voice and an independent mind, and that is what we are going to get with Representative Mark Rozzi. I think that is what the people ask for, I think that is what the people want, and that is why I am seconding the nomination for Mark Rozzi. Thank you.

The CHIEF CLERK. The gentleman from Washington County, Representative O'Neal, seconds the nomination of the Honorable Mark Rozzi for the office of Speaker.

Are there any other nominations?

The Chair recognizes Leader McClinton.

Ms. McCLINTON. Thank you, Madam Chair.

I rise at this time to also agree that the gentleman from the 126th Legislative District out of Berks County, from the Commonwealth of Pennsylvania, is a true leader among us, and my caucus supports the nomination for Speaker of Representative Mark Rozzi.

Thank you, Madam Chair.

The CHIEF CLERK. Are there any other nominations?

The Chair recognizes the gentlelady from Berks County, Representative Cepeda-Freytiz.

Representative Cepeda-Freytiz moves that the nominations be closed.

On the question,

Will the House agree to the motion?

The CHIEF CLERK. Those in favor say "aye"; opposed, "no"—

For what purpose does the gentleman, Mr. Dunbar, rise.

Mr. DUNBAR. To make a nomination.

The CHIEF CLERK. The House will be at ease.

Will the leaders please approach the rostrum.

(Conference held at Speaker's podium.)

The CHIEF CLERK. The House returns to order.

Unfortunately, the motion to close the nominations was made and instructions given to those in favor will say "aye'; opposed, "no."

Because the vote had already started, it was too late for Representative Dunbar to be recognized.

POINT OF ORDER

Mr. CUTLER. Point of order, Madam Chair. Point of order. The CHIEF CLERK. The Chair recognizes the Republican

Mr. CUTLER. The Chair thanks the good lady.

Madam Chair, I believe that section 549, on the "Motion to Close Nominations," in Mason's Manual, says, "A motion to close nominations is not in order as long as a member entitled to make a further nomination desires to do so." The desire was clear. And then it does say, "except that a member must be reasonably prompt in claiming that right." The gentleman was coming to the microphone to make that.

Additionally, we have precedent from 2007 when the nominations were still open at that time.

RULING OF CHAIR APPEALED

Mr. CUTLER. I would like to appeal the ruling of the Chair that the nominations were closed.

On the question,

Shall the decision of the Chair stand as the judgment of the House?

The CHIEF CLERK. For what purpose does Leader McClinton rise?

Ms. McCLINTON. Thank you, Madam Chair.

Just to state for the record that the precedent set by the prior Speaker is clear: once the vote begins there is no interruption.

Thank you, Madam Chair.

The CHIEF CLERK. The Chair recognizes Representative Cutler.

Mr. CUTLER. The Chair thanks the good lady.

Respectfully, and I think this is an important piece, the good leader is referring to precedent that I set regarding the following phrase: "members will proceed to vote." The good gentleman was seeking recognition prior to that phrase being uttered, and I believe if we are going to err on the side of one way or the other, it should always be on the side of allowing members to have an opportunity to nominate whomever they would like prior to the closing of nominations.

I would respectfully appeal the ruling of the Chair because we had not in fact proceeded to voting.

Please place your left hand and raise your right hand and repeat after me: I, Mark Rozzi, do solemnly swear that I will support, obey, and defend the Constitution of the United States and the Constitution of this Commonwealth, and that I will discharge the duties of my office with fidelity.

(Speaker-elect Rozzi asserted oath.)

JUDGE BROBSON. Congratulations, Mr. Speaker.

THE SPEAKER (MARK ROZZI) PRESIDING

ADDRESS BY SPEAKER

The SPEAKER. I am sure a lot of you did not expect or see this coming today.

I have a few remarks down here, but before I do get into my written remarks, the last Speaker of the House from Berks County, his name was Wilson G. Sarig, and I grew up about a block away from a school that they named after him. And he was the 117th Speaker of the House, and it was back in 1935, and today I am going to be bringing the Speaker back to Berks County where it belongs right now.

I want to thank you, Madam Chief Clerk, and I also want to thank the members for your support today. We have heard from the people of Pennsylvania, the press, and even members in this own building about how we need to find a new path forward. My entire career I believe I have worked to find that path, and I am honored to have your trust today to serve as Speaker.

Pennsylvania is the birthplace of independence. We have Independence Hall in Philadelphia, where the Declaration of Independence was signed. The heart of the American Revolution beat right here in this Commonwealth. That independence continually renewed here at Valley Forge, at Gettysburg, and the subsequent address by Abraham Lincoln, which charged "...to be here dedicated to the great task remaining before us..." and ensuring that a "...government of the people, by the people, for the people, shall not perish from the earth."

As many of you know, I have never been an idealogue. Like many of you, I continue to run to serve in this chamber, to help the people in the 126th District. I have always sought, and I believe my record reflects, the virtue that uniquely defines Pennsylvania's independence, that puts the good of the people above party or above self-interest. I find it less than ironic that as we enter 2023, the fastest growing voting coalition is Independents, and we continue to be the deciders in our closely divided Commonwealth. I believe those voters - and those that hold true to the principle that doing right by their fellow man starts with putting their fellow man first – deserve a true voice in this Commonwealth, and while there have been a lot of discussions about making history with today's vote, I do not want to disappoint. The Commonwealth that is home to Independence Hall will now be home to this Commonwealth's first independent Speaker of the House.

I pledge to caucus with neither the Republicans nor the Democrats. My staff will be made up of people from both parties. I pledge my allegiance and my loyalty to no interest in this building, to no interest in our politics. I pledge my loyalty to the people of the Commonwealth – the people who are tired of the hyperpartisanship from both parties, the people who are tired of middle-of-the-right legislating, the people who are tired of backroom dealmaking, the people who are tired of dysfunction and obstruction, the people who feel as though their voice is not heard, and if they want to be heard, they must choose a side. Those folks deserve a seat at the table, and that seat is now the Speaker's chair.

We have a unique situation before us. Never has this House been so divided, not just by numbers, but by beliefs. In carrying out the functions of this office, I pledge to put people above politics and the institution before ideology. I will tolerate no caucus and no member trying to outmaneuver the other. I will not tolerate incivility or a lack of decorum. Sometimes Republicans will win; sometimes Democrats will win. And that is fine so long as the beneficiaries are the people of this Commonwealth.

Today, together, we have taken a step in removing such negativity from this chamber. We have taken the first step on the path towards restoring trust in the people's House. But we cannot stop here today. To again harken back to the Gettysburg Address, we must "be dedicated...to the unfinished work" others started.

I trust and I pray that God will continue to guide us and grant us the wisdom and strength to work together for the Commonwealth we all love so dear. Thank you.
