RESOLUTION AUTHORIZING APPOINTMENT OF INAUGURAL COMMITTEE

The clerk of the Senate, being introduced, presented the following extract from the Journal of the Senate, which was read as follows:

In the Senate,
January 3, 2023

RESOLVED, (the House of Representatives concurring), That the President Pro Tempore of the Senate is hereby authorized to appoint a committee of sixteen Senators to act in conjunction with a committee of twenty-one Members of the House of Representatives, to be appointed by the Speaker, to make necessary arrangements for the inauguration of the Governor-elect to wait upon His Excellency; and be it further

RESOLVED, That the inaugural ceremonies take place at twelve o'clock noon on the third Tuesday of January, the seventeenth instant, 2023, on the Rear Plaza of the Main Capitol Building.

Ordered, That the clerk present the same to the House of Representatives for its concurrence.

On the question,

Will the House concur in the resolution of the Senate?

Resolution was concurred in.

Ordered, That the clerk inform the Senate accordingly.

PROCLAMATION OF SPECIAL SESSION AND EXTRAORDINARY SESSION

By virtue of the authority vested in me by Article II, Section 4; Article IV, Section 12; and Article III, Section 12, of the Constitution, I, Tom Wolf, Governor of the Commonwealth of Pennsylvania, do hereby convene the General Assembly in Special and Extraordinary Session, to meet in the Capitol at Harrisburg, on January 9, 2023, at 12 noon, to consider the subject of whether an individual for whom a statutory limitations period has already expired, or whose claim would otherwise be barred or limited by a statutory cap on damages, sovereign immunity or by governmental or official immunity, should have a period of two years, without bar or limitation by such caps or immunities, to commence an action arising from childhood sexual abuse, in such cases as provided by law.
