#### PRAYER

HON. JOSEPH C. HOHENSTEIN, member of the House of Representatives, offered the following prayer:

Thank you, Madam Speaker.

I have been asked to present the prayer as a member of the Religious Society of Friends. The Quakers founded Pennsylvania on concepts of religious tolerance and inclusiveness. Quakers worship in silence and we will enter silent worship in just a moment.

But before we do, I want to lift up a word, and that word is "healing." Whether we are engaged in a process of healing from centuries of slavery and racism, healing over decades as survivors of childhood sexual abuse, or healing from whatever physical, spiritual, or emotional pain that we feel in this moment, healing is a way for humans to connect with their Divine Creator. Religions across the world have different names for the creator. Quakers call it the inner light.

So I am going to have everyone sit down and we will settle into silent worship, and I warn you, this will be a little bit more than the normal silence you get before a football game. I will ask that you focus on the healing we all need in our personal and professional lives.

For my part, my personal intention will be as the proud father of Mars Mazick Hohenstein, and holding them in the light as they heal from taking a huge step toward becoming the human being that they were born to be. And my professional intention will be for all of us here in this chamber, elected members, staff, and everyone who put us here. I pray that we can listen in silence for the voice of our creator and heal from the rifts, violations, and betrayals that divide us, or at the very least, hold the possibility of such healing in the light so that we can move closer to the vision of William Penn's Holy Experiment for Pennsylvania.

## REMARKS BY MR. GROVE

The SPEAKER. And for what purpose does the gentleman rise?

Dave Donley has served the Commonwealth for 36-plus years, with almost 11 of those years with the House Republican Appropriations Committee. Starting in the mideighties, Dave served his country and his Commonwealth as a member of the United States Army as an artillery fire direction specialist and served in the National Guard as – wait for it – a finance specialist. Dave is a graduate of Penn State University with a bachelor of science in finance. He had started his career with the Commonwealth as a budget analyst/accountant and auditor for the Pennsylvania Commission on Crime and Delinquency. Dave's superior budgetary and analytical skills drew the attention of Governor Ridge's team, and he went to work as a budget analyst at the Governor's Budget Office. Dave's attention for detail, thoroughness, and vigorous work ethic propelled him to various management roles within the Governor's Budget Office, spanning three administrations: for Governors Ridge/Schweiker, Governor Rendell, and Governor Corbett.

Dave left the Governor's Budget Office to take the helm of House Republican Appropriations and has served in that position as executive director under three chairmen: Representatives Bill Adolph, Stan Saylor, and myself. I have had the pleasure to work with Dave as a member of the Appropriations Committee and now chairman and his ability to recall information and know each line item of a \$40-plus billion budget is nothing short of impressive.

Described by his staff: Dave is kind, quiet, brilliant, and a trivia genius. Despite the massive clutter on and around his desk, Dave is the model employee, respected by members and staff on both sides of the aisle, and I rise today to congratulate him on his well-deserved retirement from the Pennsylvania House of Representatives.

I would also mention as a fellow diehard fan of all Philadelphia sports teams, my favorite 2 minutes of the day on the Appropriations Committee was catching up on the tail end of a committee hearing, where Dave and I – and unfortunately, too few voices in the Republican Caucus joined us with equal support and fervent support of Philadelphia sports teams, but truly one of the classy guys in this building. He will be sorely missed for so many reasons.

So all the best on your retirement, sir.

To Mr. Donley, and your family, I just want to thank you for your many years of service. I know, as we have worked through each of the different budgets, I knew that I could always get a quick and thorough answer from you, and I always appreciated that. Despite the claims of a messy desk, I think it is the sign of a great mind and that meant that you had everything else in order, and I certainly appreciated it.

To your family, I want to thank you for sharing him with us for so long. I recognize the sacrifices that you too made in terms of many of those late budget nights – that would sometimes turn into late budget weeks, which would turn into late budget months – at different points throughout his career. So thank you too, and well wishes to a retirement well deserved.

### CALENDAR

#### BILL ON SECOND CONSIDERATION

The House proceeded to second consideration of **HB 2, PN 5**, entitled:

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in limitation of time, further providing for infancy, insanity or imprisonment; in matters affecting government units, further providing for exceptions to sovereign immunity and for exceptions to governmental immunity; and making a repeal.

On the question,

Will the House agree to the bill on second consideration?

The SPEAKER. The Chair rules that amendment A00150 is out of order for being violative of the single-subject rule.

On the question recurring,

Will the House agree to the bill on second consideration?

Mr. **B. MILLER** offered the following amendment No. **A00149**:

Amend Bill, page 6, line 27, by striking out "immediately." and inserting

immediately upon passage by the electorate of a Constitutional amendment relating to the revival of civil actions arising from childhood sexual abuse where the statutory limitations period has already expired.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes Representative Brett Miller.

Mr. B. MILLER. Thank you.

I had spoken on this issue last week when the bill was before us during the special session, and at that time I attempted to offer an amendment to fix what I believed and still believe was and is a deficiency in that bill. Though that amendment was ruled out of order, I am offering amendment A00149, which is intended to remedy the same significant deficiency in the bill that is before us today. My comments here today will be a summary of what I offered previously on this topic.

As each of you knows, the underlying bill seeks to statutorily revive expired claims for victims of childhood sex abuse. What this amendment does is to make the underlying intent of the bill go into effect immediately upon passage by the electorate of a constitutional amendment relating to the revival of civil actions arising from childhood sexual abuse where the statute of limitations period has already expired. I contend that without this amendment, HB 2 will be found to be unconstitutional, as being in violation of Article I, section 11, of the Pennsylvania Constitution, which says, "§ 11. Courts to be open; suits against



the Commonwealth. All courts shall be open; and every man for an injury done him in his lands, goods, person or reputation shall have remedy by due course of law, and right and justice administered without sale, denial or delay. Suits may be brought against the Commonwealth in such manner, in such courts and in such cases as the Legislature may by law direct."

Our Constitution provides a remedy for those who have been aggrieved under our law. The rights that are once given by the people of Pennsylvania are vested rights and they cannot be taken away. This tenet of law is commonly known as the remedies clause. The remedies clause is not a new provision, having been a long-standing understood tenet of constitutional law for well over 150 years.

Additionally, the courts have considered the remedies clause multiple times in the past and have deemed that the legislature cannot eliminate these fixed rights. Several of these cases include *Lewis v. Pennsylvania Railroad Company* in 1908, in which the Pennsylvania Supreme Court ruled that the remedies clause provides a "vested right." The PA Superior Court applied *Lewis* in the *Overmiller* 1960 and *Maycock* 1984 cases, finding that the remedies clause does not permit the legislature to revive time-barred claims. And as recently as 2008, in *Konidaris v. Portnoff Law Associates*, the Pennsylvania Supreme Court determined that it could not take away, quote, "an affirmative defense against an accrued cause of action," closed quote, because it is a vested right protected by the remedies clause.

In summary, the running of the statute of limitations is an affirmative defense, and therefore protected by the remedies clause from retroactive elimination through statute. If HB 2 passes without the amendment, HB 2 will do exactly that: it will statutorily eliminate this constitutionally protected vested right, which I believe will result in the bill being struck down. By passing A00149, we will be able to accomplish two things. Number one, we will be able to advance the underlying intent of HB 2 free from a constitutional deficiency; and two, we will be able to uphold our oaths to the Constitution by making the bill go into effect upon the people of Pennsylvania changing the supreme law of the land – that is, the Constitution of Pennsylvania.

We could accomplish both with an affirmative vote on this amendment. I urge a "yes" vote on A00149. Thank you.

The SPEAKER. The Chair recognizes the minority leader.

Mr. CUTLER. Thank you, Madam Speaker.

Madam Speaker, I think the good gentleman from Lancaster County has outlined what I have raised as an issue for this bill in prior sessions. He is correct: when we took the oath of office on the Constitutions, we took that oath on all the parts that were included therein. And I recognize that we do have a difference of opinion here in the chamber, but I think that the good gentleman's amendment makes it very clear that in conjunction with the constitutional amendment – one that we have passed many times before – with this change, we would protect the bill from any constitutional challenges that might arise.

I would urge a "yes" vote on the amendment, and I appreciate the good gentleman's work.

Thank you, Madam Speaker.

The SPEAKER. The Chair recognizes the gentleman from Berks County, Representative Rozzi.

Mr. ROZZI. Thank you, Madam Speaker.

I rise to oppose amendment A00149. I think we heard this phrase over and over last week. I think the gentelady from Allegheny used this reference that "justice delayed is justice denied." We can get this bill passed this week and the Senate can

move it the following week, and we can actually get justice for survivors instead of having to actually wait until the November ballot.

And this thing about this unconstitutionality of this has really never been ruled upon by our Supreme Court. We can hear all these cases from 1901 and vested rights, even though that case in the vested rights deals with the criminal side. The one thing that when I look at this body, I do not see a title of "judge" next to anybody here; I see a title of "State Representative." And I think that this ultimately has to be decided by the courts and that is what their job is to do is to rule whether this is constitutional or unconstitutional at that level. We all can have our opinions, but the fact is, I believe that this is constitutional but ultimately will be decided by the courts, and that is their job.

I oppose this amendment, and I urge the members to vote "no."

The SPEAKER. The Chair thanks the gentleman.
