An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in nuisances, further providing for the offense of scattering rubbish.

An Act amending Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, in dispositions independent of letters, family exemption, probate of wills and grant of letters, further providing for payments to family and funeral directors.

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school health services, providing for eating disorder awareness and education.

An Act amending the act of July 19, 1979 (P.L.130, No.48), known as the Health Care Facilities Act, in licensing of health care facilities, further providing for consumer protections; and abrogating a regulation.

##### HB 301, PN 954 (Amended) By Rep. SCHWEYER

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, making editorial changes.

EDUCATION.

##### HB 394, PN 361 By Rep. BRIGGS

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in human trafficking, further providing for civil causes of action.

JUDICIARY.

##### HB 494, PN 952 (Amended) By Rep. FRANKEL

An Act providing standards for carbon monoxide alarms in child care centers and family child care homes; and imposing penalties.

##### HB 507, PN 953 (Amended) By Rep. FRANKEL

An Act amending the act of March 20, 2002 (P.L.154, No.13), known as the Medical Care Availability and Reduction of Error (Mcare) Act, in medical professional liability, providing for informed consent in pelvic, rectal and prostate examinations.

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in pupils and attendance, further providing for residence and right to free school privileges.

An Act amending the act of May 28, 1937 (P.L.955, No.265), referred to as the Housing Authorities Law, further providing for organization of an authority.

**HB 668, PN 956 (Amended)**

By Rep. SCHWEYER

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in fostering independence through education, further providing for definitions, for fostering independence waiver program, for outreach and for report.

EDUCATION.

**HB 900, PN 959 (Amended)**

By Rep. BRIGGS

An Act amending Title 61 (Prisons and Parole) of the Pennsylvania Consolidated Statutes, in general administration, further providing for State recording system for application of restraints to pregnant prisoners or detainees; in county correctional institutions, further providing for county recording system for application of restraints to pregnant prisoners or detainees; providing for Department of Human Services facilities; and, in miscellaneous provisions, further providing for healthy birth for incarcerated women and providing for restrictive housing prohibited for pregnant or postpartum incarcerated individuals and detainees, for cavity search and inspection restrictions, for training and education requirement, for feminine hygiene and incontinence products and for postpartum recovery.
