And then it also takes the language out that references recent, you know, changes in Commonwealth law. There have not been any. There was a court decision clear back in 2002 clarifying that once you are out of prison, you can register to vote and register – you can register to vote or you can vote if you were already registered.

So my amendment just makes the resolution more accurate, and I urge a "yes" vote.

Ms. KAZEEM. Thank you, Madam Speaker.

The SPEAKER. On that question, the Chair recognizes the maker of the amendment, Representative Keefer.

Mrs. KEEFER. Thank you, Madam Speaker.

We all have election priorities. This priority is on convicted felons and the rights to vote, and ours is on election security and unlawful voting. So in 2021 we held a plethora of hearings with the House State Government Committee where we uncovered numerous occasions of unlawful activity. There was discrimination, different types of voters being treated differently; there was disenfranchisement. Voters in York County were not able to cure or fix their ballots, while voters in Lehigh and many other counties were able to fix their ballots, or cure them. Then there is reconciliation: 47 counties failed to actually reconcile their elections in 2020 and that continues today.

It would be easy to point the finger, actually, at the counties, but the Department of State issued guidance, many guidance up until the day before – actually, the night before the elections – that exacerbated and instilled chaos, and many of these guidance orders that were issued conflicted or contradicted State election law as well as Federal law, which contributed all to this problem. To date, there has been no change whatsoever. There are chain of custody issues that remain. Counties cannot figure out how much paper they should have for an election. In York County in 2021, my voters stood in line for up to 4 hours just waiting to cast a ballot because they ran out of ballots. Nothing has been done.

My amendment would simply say that the Joint State Government Commission does not issue a report regarding the prevalence or the habits of convicted felons in voting before they issue a report on election security and the prevalence of unlawful

voting. So I would implore my colleagues to support this amendment, which would help to reinstill integrity in our elections.

MERITORIOUS SERVICE SUPPLEMENTAL PAYMENTS

Section 1211-B. Teacher merit pay. (a) Duty of school districts.-For the 2023-2024 school year, the governing board of a school entity shall provide for recognition of teachers who have contributed outstanding and meritorious service, as provided in this section, by adopting rules establishing and regulating a

meritorious service supplementary payment program. (b) Eligibility for financial assistance.-In order to receive financial assistance under this subarticle for the purpose of awarding teacher merit pay under section 1212-B, a school entity must demonstrate a comprehensive career progression plan that includes an opportunity for teachers:

(1) To advance in both status and pay based on demonstrated competence and job-embedded collaborative professional learning time schedule during the contractual school day.

(2) To develop the capacity of other teachers.

(c) Construction.-This section shall not require, and shall not be construed to require, the modification, renegotiation or reopening of any contract or agreement in effect on the effective date of this section between a public employer and a public employee or employee organization pursuant to the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act.

Section 1212-B. Supplemental payments on account of meritorious awards.

(a) General year.-For the 2023-2024 school year and each school year thereafter beginning before the expiration of the term of a contract or agreement in effect on or before the effective date of this section between a public employer and a public employee or employee organization pursuant to the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act, each school entity that elects to provide a meritorious service supplementary payment program under section 1211-B shall be paid in the manner provided in subsection (b), in addition to other payments to which the school entity is entitled, a special payment to cover the cost of implementing section 1211-B.

(b) Amount of payments.-The amount paid to a school entity under this subarticle shall be the difference between the salary paid to each teacher of the school entity at the beginning of the 2023-2024 school year and an amount equal to the meritorious service supplementary payment.

(c) Funding source.-

(1) For each school year for which a school entity qualifies for a special payment under subsection (a), the entire employer's share of contributions to the Public School Employe's Retirement Fund and Social Security attributable to the salary increase implemented under section 1142.1 shall be paid for each school entity out of funds appropriated to the department for such purposes.

(2) The department shall pay payments under subsection (a) and paragraph (1) from the Teacher Merit Pay Fund. Section 1213-B. Teacher Merit Pay Fund.

(a) Establishment.-The Teacher Merit Pay Fund is established in the State Treasury. All interest and earnings received from investment or deposit of the money in the fund shall be paid into the fund and used for the purposes authorized by this subarticle. Any unexpended money and interest or earnings on the money in the fund may not be transferred or revert to the General Fund but shall remain in the fund.

(b) Funding.-The fund shall consist of money that is appropriated or transferred from the General Fund, special funds, Federal funds and other sources of revenue made available to it.

(c) Use.-The fund shall be used to make payments under section <u>1212</u>-B.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes Representative Topper.

Mr. TOPPER. Thank you, Madam Speaker.

As I have toured schools throughout both my district and the Commonwealth as a whole, educators have consistently brought up to me the idea of merit pay. I think it is time that we start to recognize that we have an opportunity to potentially empower our local districts to reward, through financial incentives, those teachers who are exemplary and who have chosen to stay in fields that are very difficult to recruit into. We have heard, and we had a hearing on, the teacher shortage crisis, but specifically, where we have a shortage are in certain areas of instruction. It is very difficult, for instance, to retain and recruit those in the secondary STEM fields. I believe that last year there were seven physics certifications in the entire Commonwealth. So I believe that we do have an opportunity here as we discuss this shortage over the next few months and continue to work on public policy that would not just recruit teachers, but retain the ones that we have. I believe that this could be a model.

There was a study done by Vanderbilt University that found that the overall, that the presence of a merit pay program was associated with a statistically significant positive effect on student scores. Emerging studies also suggest that merit pay can improve teacher recruitment and retention, which has been found to contribute to many positive outcomes for students, particularly those in low-income areas. The author of the study suggests that continued investigation in the teacher labor market outcomes, especially effects of pay incentives on mobility patterns of highly effective teachers and the exit decisions of traditionally low-performing teachers, this could be something that truly raises this profession and the bar of this profession to recruit and retain more candidates.

I understand that the underlying bill is something that I support and I believe needs to get done, but I do believe that we also need to look at other ways to retain and recruit educators, particularly in the fields that I believe that we are short in. When the Education Committee held a hearing in April on the current employee shortage that we are faced with, at the hearing, this was also something that was brought up as one of the many suggestions that was made to improve the morale among current employees in our schools. And if you tour the schools within your district, you know that there is a morale problem among our educators. The idea that we could incentivize exemplary candidates and educators financially, and allow our districts to come up with programs that reward these educators who succeed each and every day at a very high level, I believe is something worth considering, and if not in this bill, then hopefully, in bills in the future.

Mr. KINSEY. Thank you, Madam Speaker.

Madam Speaker, HB 580, the Fresh Food Financing bill, is designed to increase the availability of fresh and nutritious food all across the Commonwealth. Madam Speaker, I think it is important that we recognize that Pennsylvania is a major producer of milk, eggs, poultry, and fruits, including peaches, grapes, cherries, and apples. This Fresh Food Financing Initiative will stimulate capital, it will increase job creation, and more importantly, strengthen local systems and increase market opportunities for Pennsylvania farmers, all while providing fresh foods in underserved low-income or moderate-income communities throughout our Commonwealth.

I would be remiss if I did not mention a former member, Congressman Dwight Evans, who initiated this program back in 2004, in which this body was able to help create markets and stores in areas that were previously known as food deserts.

Madam Speaker, I ask the members to support HB 580, and let us help the people of our agricultural industry right here in Pennsylvania by making fresh foods obtainable to all of our constituents.

Thank you, Madam Speaker. The SPEAKER. The Chair thanks the gentleman.

This legislation would add the State Long-Term Care ombudsman to the PA Long-Term Care Council. The Pennsylvania Long-Term Care Council was established by Act 64 in 2015 and revised in Act 63 in 2021. The office is federally required under the Older Americans Act.

"Ombudsman" comes from the Swedish word "ombuds," which means advocate. Pennsylvania's Long-Term Care ombudsman works to resolve concerns expressed by older adults in long-term care settings, such as nursing homes, assisted living facilities, and personal care homes. Unfortunately, we do not think about long-term until it happens to one of our loved ones. Adding the ombudsman will enrich the council's work by providing a voice to seniors and a focus to the challenges that they encounter. This will especially be valuable as the Department of Aging develops a master plan on aging.

Thank you, and I would respectfully request your support on HB 1300.
