An Act authorizing the Department of General Services, with the approval of the Pennsylvania Historical and Museum Commission and the Governor, to grant and convey certain easements through and across lands of the Commonwealth of Pennsylvania in the Township of Manheim, County of Lancaster, for purposes of a road realignment project and to accept from the Township of Manheim existing right-ofway to be abandoned as part of the road realignment project; authorizing the Department of General Services, with the approval of the Department of Military and Veterans Affairs and the Governor, to grant and convey to Drexel University, permanent easement encumbering certain lands situate in the City and County of Philadelphia; authorizing the Department of General Services, with the approval of the Governor, to grant and convey to the City of Philadelphia certain land, buildings and improvements situated in the 40th ward of the City of Philadelphia, Philadelphia County; authorizing the release of Project 70 restrictions on certain land owned by Lower Salford Township, Montgomery County, in return for the development of a hiking trail and scenic viewing area in Lower Salford Township, Montgomery County; revoking a use restriction; and making repeals.

- (i) The amendment of the definition of "oral communication" in 18 Pa.C.S. § 5702.
  - (ii) The addition of 18 Pa.C.S. § 5704(20).

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the maker of the amendment, Representative Bonner.

Mr. BONNER. Thank you, Madam Speaker.

It is my understanding that this is an agreed-to amendment.

The SPEAKER. The gentleman must give a brief explanation of the amendment.

Mr. BONNER. Madam Speaker, 38 States have a provision that only one party to a telephone conversation needs to give consent for that conversation to be recorded. Pennsylvania is one of the 12 States that says you have to have both parties' permission to record such a statement. The amendment will set forth an exception under the Wiretap Act that will allow a homeowner to record the statement of a telemarketer, if that homeowner believes that fraudulent activity is occurring in that phone call.

In the United States, we lose \$40 billion a year to telemarketer scammers, who routinely record the phone calls that they make. This will level the playing field and give our citizens an opportunity to also record the telescammer to provide evidence, then, to law enforcement officials.

I would ask, then, for your support of this amendment that will bring a more level playing field and cause much distress with telemarketers.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentleman from Mercer County.

On that question, the Chair recognizes the maker of the bill, the gentleman from Chester County, Representative Pielli.

Mr. PIELLI. Thank you, Madam Chair, and thank you, Representative Bonner.

I wholeheartedly support amendment 1835. It is my understanding that this ran as a bill separately and got unanimous support from this chamber. It is creating an exception, as the good Representative said.

Many of our seniors are being scammed by these telemarketers. This is a really good amendment. It makes HB 1278 a much better bill, so I urge my colleagues, please, to vote "yes" on this amendment. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the gentleman from Chester and Delaware Counties, Representative Craig Williams.

Mr. C. WILLIAMS. Thank you, Madam Speaker.

I rise today in support of amendment 1835 and I would like to briefly tell you why.

As was noted previously, it is a crime in Pennsylvania for you to record a conversation with someone else without their consent. I would like to play for you just one example where this could come to play in your personal life and that of your constituents.

My son was online and got one of those alerts that said, if you do not click this link right now, your computer is going to be seized. At 12 years old he believed it, and by the end of an hour of trying to problem-solve with somebody halfway across the world about what he thought was the only way to save the data on his computer, he was in a phone conversation with someone. We had no ability for, in that moment, my son and I to record that telephone conversation without me having to commit a crime in Pennsylvania to record that conversation without the consent of the other person.

So while the previous speaker and the maker of the amendment talk about seniors and the fraud that is happening to seniors by way of telemarketing, it is all ages. It is all ages of people that can be called in their home to be solicited by somebody claiming to be from the energy company, claiming to be from your communications company, claiming to be the FBI, and you have no recourse whatsoever to record that telephone call and provide evidence to law enforcement.

This amendment will cure that under the Wiretap Act, and I encourage its passage. Thank you very much.

The SPEAKER. The Chair thanks the gentleman.

Ms. DELOZIER. Thank you, Madam Speaker.

This amendment to this bill for SB 838 clarifies that the probation office, not the officer, shall identify conditions of probation and lead to an early conference; reinstates language requiring PCCD (Pennsylvania Commission on Crime and Delinquency) to establish the standards for these conditions; reinstates some language that allows victims to receive copies of a defendant's probation status report; and makes a few technical changes.

I ask for a "yes" vote to this amendment to SB 838.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentlelady.

On that question, the Chair recognizes the gentleman from Montgomery County, Representative Briggs.

Mr. BRIGGS. Thank you, Madam Speaker.

And I do want to thank the gentlelady, the previous speaker, the maker of the amendment, regarding this. This was a good conversation. There were some concerns that were raised during the committee meeting on SB 838, and a number of us — bipartisan, bicameral — a number of the stakeholders got together to address some of the concerns, and that is the product of this amendment.

So I think it makes 838 better, and I support the amendment and hope to encourage – so it is an agreed-to amendment, and thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the gentlelady from Allegheny County, Representative Kinkead.

Ms. KINKEAD. Thank you, Madam Speaker.

I rise also in support of this amendment. This amendment allows for victims to have input, but not the ability to object to probation proceedings. It puts some guardrails in on things that were a little bit of an overreach, and it is the product of painstaking negotiation on both sides, and so I would ask my colleagues for a "yes" vote. Thank you.
