REMARKS BY SPEAKER

The SPEAKER. I must say, I am personally completely proud, humbled, and privileged to offer congratulations, now that it is official, to Representative Lindsay Powell.

It is always a very special moment when someone talks to folks in their communities – their neighbors, their family, their circle of supporters – and decides to put themselves, launching out into the public, and seek whether or not they have the support of their local community. Everyone in this hall recognizes it is no small task, and it certainly is not a small personal ask, but we are completely grateful and excited, not just because you are new and you joined this body, but I must say, for those who do not know, Pennsylvania's history continues to get written every day and becomes more and more incredibly inclusive. Representative Powell is the first person of color to serve her neighbors in the 21st Legislative District.

Certainly, as you have heard, in this chamber we are tackling some of our biggest challenges. They are not challenges unique to where I live in the 191st Legislative District, my neighbors in the Commonwealth – excuse me – in both Cobbs Creek and the lower southeastern part of Delaware County, but they are challenges that neighbors around Pennsylvania are finding themselves dealing with right now, and we are privileged to have the responsibility of coming together – my favorite one – listening. I will say it again: listening. We come together, we listen to the needs, and most importantly, we collaborate, because it is in this chamber that we are able to put together policies that we hope will advance all of Pennsylvania and certainly put us forward.

I can say I am very grateful, not just from this summer, but for a few years now I have been able to personally know Representative Powell, the work that she did while working in the city when I was a new member of the leadership team, and I would say, very pesty. She was able to give me a tour in her prior job, working at the time for the city and the prior administration, and show me some of the needs that were going on in the city of Pittsburgh as it relates to affordable housing, and how pressing these needs are not just where I live, but all the way hundreds of miles into southwestern Pennsylvania.

We know that you are a champion. I cannot say will be, because you already have been a champion of so many issues that many of our colleagues here support. And I am very excited that you can take this moment, look around. And welcome to your brand-new job, the beautiful Pennsylvania House of Representatives. Congratulations.

There are some very distinguished guests Representative Powell has, and I would like to take this time, before going to the leaders for remarks, to acknowledge them.

We are so glad that we have in our midst her lovely mother, Ms. Roxanne Duncan. Welcome. We cannot imagine how proud you must be always, but especially in this moment in time. We are thrilled to have Alex Magill, Lindsay's partner, and Duncan Powell, Lindsay's sibling. Welcome to the floor of the House.

We have some distinguished members from the Pennsylvania State Senate that got a hall pass – literally – for this morning. We are thrilled to have, also from Allegheny County, Senator Lindsey Williams, and from my hometown of Philadelphia County, Senator Sharif Street. Welcome.

Also in well of the House, we have the former mayor of Wilkesburg, Her Honor, the Honorable Marita Garrett. Welcome.

We also have Jason Bolton, Lindsay Borden, Kinsey Casey, Leah Danville, Dan Gilman, Derek Hauessler, James Hill, Pernell Hughes, Yanet Lewis, Jeffrey Morris, Carver Murphy, Alexis Nieves, Erika Nieves, Molly Onufer, Glorisel Regalis, Grant Regan, Cassandra Romanowski, Kayla Sieminski, Benjamin Sieminski, Dallim Sieminski, Blake Sieminski, Gabrielle Walker, Fredrick White, Carol White, and Pamela White.

We are so glad to have all of you right here on the floor of this historic chamber.

And with that, I know our floor leaders have some wise words, so back to listening.

REMARKS BY MAJORITY LEADER

The SPEAKER. I am going to first call on the gentleman from Montgomery County, the majority leader, Representative Bradford, for remarks.

Mr. BRADFORD. Good afternoon, and it is a good afternoon indeed.

I want to welcome our newest member to the House chamber and the newest member to the Democratic Caucus, Lindsay Powell.

Lindsay has an extensive background working in her community, in the city of Pittsburgh, and in the Federal government. An accomplished public servant, she will bring fresh ideas to our caucus, and she will serve her constituents well.

Lindsay served for 5 years with the city of Pittsburgh as an assistant chief of staff. During her time, she drafted legislation and policy – and evidently had the opportunity to work with our Speaker. She also oversaw the creation of the first citywide digital equity initiative, the expansion of the summer free meal program during the pandemic, and the implementation of Avenues of Hope to help small businesses succeed.

Lindsay also served as director of workforce strategies at Innovate Pittsburgh, which is working to accelerate Pittsburgh's status as a global innovation city. Lindsay also worked in Congress with U.S. Senator Chuck Schumer and U.S. House Democratic Leader Hakeem Jeffries. Lindsay received a Bachelor of Arts from Wheaton College in sociology, and a master of science in public policy management from Carnegie Mellon University's Heinz College, where she won the Otto A. Davis Award that recognizes graduates' commitment to racial and social justice. She is a tireless advocate, and she will be a tremendous Representative for the residents of the 21st District.

Now, I must tell you something. We have had a few special elections over the last few months, and the last one was probably the first time that I had the honor of speaking as the Democratic leader. And listening to the good minority leader give some sage advice, I thought to myself, well, you know, that man thought about it ahead of time, and I did not think I had. So I want you to know, I did take your lead, Mr. Cutler. And I thought to myself, what advice would I give to a new member? And I was like, what sage wisdom would I have after being here for almost a dozen years to a new member? And it is an honor, and it is a tremendous honor, and everyone is going to mention that, and it is an amazing opportunity to serve your constituents and your friends and to do right on policies that have already been your life's work.

But it is also a job, and with that job, there are headaches and frustrations. There are good days and bad days. There are child-care challenges. There are HR (human resources) challenges. There is every challenge you would have in a typical job. But that balance between what is an honor is so outweighed, because it is so important the work you do. That is the work of your life, and you have an opportunity to take it to the next level.

So I want you to know how, from this person who thought about it for all of 5 minutes because you inspired me to, that is my first point. My other point is this: the people. Not just the people in your district – because you already know them and you have had the honor to represent them – but the people in this building, your future colleagues, your current colleagues now, the staff, partisan staff on both sides, the support staff, who do an amazing job. I thought about my own time here. The people I have become friends with sometimes are now going to be lifetime friends. Long after I leave this building, they will be here. You will have the opportunity to make those friends, and I would encourage you, despite the disfunction that sometimes overtakes us, despite the partisanship that is often overheated, the people, the friendships, the connections you will have with those people you will serve with will mean more than anything, the honor to serve and the people you serve with.

That is all I can leave you with. So with that, I say, welcome to the House. We look forward to working with you.

REMARKS BY REPUBLICAN LEADER

To run in and get milk and bread could take an hour or more, and that is okay because we all recognize that as being our job. We serve the people where they meet us, whether it is in person, whether it is through letters, e-mails, or phone calls.

First and foremost, this is a job of service. I think it is something that we all need to be reminded of from time to time. But the truth is, in that spirit of service, Representative Powell, welcome to the House. I look forward to working with you and wish you the best of luck. And I think that you will find that this – as the leader pointed out – can be absolutely one of the most rewarding jobs that you will ever serve in.

So thank you for being willing to serve, and I look forward to doing so alongside of you.

On the question,

Representative Rowe offers amendment A01445. Will the House agree to the amendment? It is the Chair's understanding that amendment is withdrawn. The Chair thanks the gentleman.

Representative Lawrence offers amendment A01446. It is the Chair's understanding the amendment is withdrawn. The Chair thanks the gentleman.

All right. It is the Chair's understanding that amendment A01450, also offered by Representative Lawrence, is withdrawn.

On the question recurring,

Will the House agree to the bill on second consideration?

Mr. **FREEMAN** offered the following amendment No. **A01487**:

Amend Bill, page 2, lines 8 through 18, by striking out all of said lines and inserting

(a) No later than seven days after the first official submission of a subdivision or land development application, and as a criterion of approval, the subdivider or developer shall post signage of a minimum of nine square feet in surface area.

(b) The developer shall ensure that:

(1) The signage is conspicuously posted visibly along the external road frontage on each subdivision or land development.

(2) The signage includes a description of the posted project and the entity where the application was filed.

(3) The signage type is of a sufficient size and font to read from a minimum viewing distance of 50 feet. A summary title of the proposed development must have a minimum of four-inch lettering.

(4) The signage is installed outside of the limits of public right-of-way and in accordance with all applicable Federal and State requirements.

(5) The signage remains posted until after approval, disapproval or withdrawal of the application.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the maker of the amendment, Representative Freeman.

Mr. FREEMAN. Thank you, Madam Speaker.

Madam Speaker, this amendment is of a technical nature and was drafted to address some concerns and issues that were raised in the committee meeting, where we considered this legislation and reported it to the House.

Among the provisions of this amendment is that it stipulates that as a criterion of approval, the required signage must be posted "No later than seven days after the first official submission of a subdivision or land development application,..."

It further requires the signage to be visibly posted "...along the external road frontage on each subdivision or land development," and that signage must be "...a minimum of nine square feet in surface area," which was a suggestion of Chairman James – and a good one because it clarified language that had been misdrafted.

Also in this amendment, signage type must be "...sufficient size and font to read from a minimum viewing distance of 50 feet." And "A summary title of the proposed development must have a minimum of four-inch lettering." That was the suggestion of Representative Brett Miller, and a good suggestion to clarify that it was legible.

And finally, this amendment would have "The signage" must be "installed outside of the limits of public right-of-way and in accordance with all applicable Federal and State requirements."

The amendment was drafted in consultation with PennDOT, the planners association, and in research reference to various Federal manuals pertaining to highways.

I would urge a "yes" vote.

AMENDMENTS RULED OUT OF ORDER

The SPEAKER. The Chair rules the following amendments out of order for violating House rule 20: amendment A01376, amendment A02069.

RULING OF CHAIR APPEALED

The SPEAKER. For what purpose does the gentleman from Union County, Representative Rowe, rise?

Mr. ROWE. To make a motion, Madam Speaker.

The SPEAKER. The gentleman is in order, and he may proceed.

Mr. ROWE. Thank you, Madam Speaker.

Madam Speaker, I rise to appeal the ruling of the Chair that amendment A02069, which amends HB 251, is out of order.

The SPEAKER. The Chair thanks the gentleman.

For the colleagues' awareness, Representative Rowe appeals the ruling of the Chair that amendment A02069 violates House rule 20. House rule 20 provides that no bill shall be passed containing more than one subject. The subject of HB 251 is providing for the sale of used police vehicles to local or regional police departments. Amendment A02069 adds a second subject to the bill by providing that veteran-owned businesses shall be considered as small diverse business for the purposes of Title 51, chapter 96.

On the question,

Shall the decision of the Chair stand as the judgment of the House?

The SPEAKER. On that question, for argument, the Chair recognizes the maker of the motion, Representative Rowe.

Mr. ROWE. Thank you, Madam Speaker.

Madam Speaker, I believe amendment 02069 is in order because the underlying bill deals with the benefits provided by the Department of General Services to certain groups under the Commonwealth's procurement process, and that is exactly what my amendment does.

The underlying bill provides specific benefits to municipal police departments through the procurement process, and my amendment states that a veteran-owned small business shall automatically be considered a small diverse business for the purpose of the Commonwealth's procurement process.

You see, Madam Speaker, due to a recent policy change by the Department of General Services, veteran-owned small businesses are no longer eligible for the same State contracts they built their business on. This change was wrong, it was made without legislative input, and it hung our veteran-owned small businesses out to dry. I believe this amendment is in order because it gives us the opportunity to right this wrong and to restore to our veterans the benefits they have earned.

I would ask that all of the members would vote "yes" so that we can consider my amendment and restore those benefits to those who have worked and suffered and sacrificed so much for our freedom.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the floor leader, the gentleman from Lancaster County, Representative Cutler, on the motion.

Mr. CUTLER. Thank you, Madam Speaker.

To build slightly off the prior speaker's comments, his amendment deals specifically with the process related to the procurement use of assets and the fact that a veteran-owned business would be considered a small and diverse business during the procurement process.

Just last week the Pennsylvania Supreme Court, in *Weeks v. Department of Human Services*, that the 2019 Human Services Code bill contained a single subject of "benefits pertaining to the basic necessities of life to low-income individuals." So the court just recently upheld a similar topic as being unifying, and this one is no less such.

I believe that the amendment should be included as a matter of law, but more importantly, Madam Speaker, it should also be included because it is good policy. Thank you.

The SPEAKER. The Chair thanks the gentleman.

We have many situations. One example I can think of is, HB 1060 dealt with 1 section of the law and it was amended to add 28 other sections of the same law. There are many examples like that, Madam Speaker. When the same topic is in the same general area, it should be considered in order. So I think the legislation dealing with how we dispose of taxpayer-funded State police vehicles and how we get rid of legislators getting taxpayer-funded State cars, it is all the same topic dealing with cars that taxpayers pay for.

So I would ask for support in appealing the ruling of the Chair. Thank you.

I rise today to offer amendment A01644 to HB 1479. Madam Speaker, the bill provides IT accessibility standards for State and local government Web sites through the Office of Information Technology. I believe it is a good first step in making government Web sites more accessible for all users. I think it is a very good bill.

Madam Speaker, my amendment states that if a public entity makes a good-faith effort to comply with the standards on technology and implementation of the plan, the public entity is presumed to be in compliance in any civil action brought against them. Madam Speaker, I believe that a public entity acting in good faith to comply with the accessibility standards in the bill should not be punished by a civil action brought against them.

Madam Speaker, if a public entity is acting in good faith and complying with the accessibility standards, which could involve significant cost, the public entity should not be subjected to burdensome litigation costs. This amendment would ensure that a public entity spends more money towards implementing accessibility measures than spending money on litigation costs.

Again, Madam Speaker, I think the underlying bill is pretty good. I think my amendment makes it a stronger and better bill, and I urge a "yes" vote. Thank you.

It adds language to the Borough Code providing that an elected or appointed official of the borough who makes a decision which results in a financial loss cannot be surcharged as long as he was – he or she was acting in good faith on the advice of the solicitor. It also authorizes the borough to appoint not only just a human being, but also a partnership, a limited partnership association or professional corporation, as the borough's needs require. Finally, it removes the requirement that the preliminary budget be prepared beginning at least 30 days prior to the adoption of the budget. It does not change the requirement that the public has a minimum of 10 days on which to view the proposed budget.
