Members and guests, if I can have your attention. We have another very special guest joining us today. Sergeant at Arms, please close the doors of the House and clear the aisles as we prepare for the guest to address us this morning.

DIRECTOR-GENERAL JAMES K.J. LEE PRESENTED

The SPEAKER. Located to the left of the Speaker's rostrum, we are so very honored to welcome James K.J. Lee, the Director General of the Taipei Economic and Cultural Office in New York, representing Taipei and Pennsylvania and the tristate area. Director General Lee is also the head of Taipei's United Nations Affairs Task Force. Director General Lee assumed his role in July of 2020 and has had a very distinguished career in foreign service.

Prior to his appointment by President Tsai Ing-wen, Director General Lee served as the Secretary General of the Ministry of Foreign Affairs, overseeing the ministry's core operations for 3 years. During his 35-year career, he has served as Deputy Representative of the Taipei Economic and Cultural Representative Office in the United States, Representative of the Taipei Representative Office in the Netherlands, and as Director General of the Department of European Affairs in Taipei. Throughout his career, Director General Lee has dedicated himself to strengthening bonds and friendship between Taipei and all of its allies. In his current position, he has been instrumental in deepening economic and cultural ties between Taipei and the northeastern part of these United States.

Director General Lee is joined today by director Fuyuan Liu and senior officer Ivana Yun-Hsuan Tsai.

Director General Lee, we would be honored if you would join us on the rostrum to address the floor of the House.

Members, please welcome him.

Mr. LEE. Thank you, Madam Speaker, for your kind introduction.

I am still a little bit nervous, although I have been in such an occasion many times, but this is unique today.

So, Honorable Madam Speaker and distinguished Representatives of the Keystone State, thank you very much for inviting me to witness this memorable moment. It is a great honor and pleasure for me to be here today to speak with you and all Pennsylvanians.

On behalf of the people and government of Taiwan, I would like to express my profound gratitude for the bipartisan support in the General Assembly on the two recently introduced pro-Taiwan resolutions. The first one passed on October 4 and recognized October 10 as the "National Day of the Republic of China (Taiwan)," and thanks to Representative Shusterman for initiating this resolution. The second resolution the Assembly is going to vote later recognizes our long-standing friendship between Taiwan and Pennsylvania. We are thankful to Representatives Rowe and O'Mara for cosponsoring it.

Although Taiwan and Pennsylvania are thousands of miles apart and different considerably in culture, history, and language, we have long enjoyed dynamic interactions in the fields of economy, education, science, and technology. And our bond has been growing stronger along the way. It is easy to see why. We both share an unwavering commitment to freedom, democracy, and human rights. Just as the Commonwealth of Pennsylvania played a key role in the formation of American democracy, Taiwan is at the forefront of democracy in Asia. Our shared commitment to the values that underpin our democracies rings truer than the Liberty Bell, and it is these shared values and common interests that deserve our time and effort to bridge the distance that separates us.

Our partnership's success would not be possible without the support of our friends in this hall. Pennsylvania decided to reopen its Trade and Investment Office in Taipei last year; has led to an even stronger Pennsylvania-Taiwan partnership. Pennsylvanian farmers and manufacturers now have even greater access to our market, and Taiwanese consumers greatly benefit from your quality products. Thank you so much for your hard work.

There are so many opportunities between our two sides for cooperation and we have made excellent progress lately. We are collaborating with partners in western Pennsylvania on AI (artificial intelligence) robotics, advanced manufacturing, and autopilot vehicles. The Pittsburgh Robotics Network has signed an MOU (memorandum of understanding) with the Taiwan Automation Intelligence and Robotics Association lately.

On the east side, through UPenn Innovation Center and Temple University, we are connecting Pennsylvania's bio-med cluster with Taiwan's life science and cloud tech industries. My office is also working with UPenn's Singh Center for Nanotechnology to facilitate a semiconductor collaboration project. These sectors are rising stars for our future cooperation.

And we are also working on educational cooperation and cultural exchanges. Given the increasing needs for Mandarin language learning in the United States and Taiwan's aspiration to become a bilingual nation by 2030, America and Taiwan have launched an education initiative focused on Mandarin and English training. The University of Pittsburgh, Temple University, and Juniata College have established cooperations with schools in Taiwan. We send Chinese language teachers to those universities and pay for their round-trip air tickets, and those universities just need to pay them a reasonable local wage. So we also offer scholarships for their students to study in Taiwan. So if you have any candidate school in your district and would like to have a similar cooperation, please contact with my office and we will try to facilitate this cooperation with you. And I assure you that Taiwan remains committed to further enhance this partnership. My office will continue to be a facilitator, and in the process, I would appreciate your continued support and guidance.

Taiwan is a democratic success story and a trustworthy partner of the United States. We are grateful that the Biden administration often reaffirms the U.S.'s rock-solid commitment to Taiwan and has taken a series of actions to boost our ties. We are also grateful to the strong bipartisan support on Capitol Hill, where more than 30 pro-Taiwan acts and resolutions have been introduced this year. Across the board, we share a high degree of mutual trust and common strategic goals, including how we can work together to preserve a free, open, and rules-based Indo-Pacific. I am grateful that the spirit of friendship and collaboration is also shared by Pennsylvania legislators through actions such as passing the resolution and establishing a Taiwan Caucus.

Ladies and gentlemen, my service in the Navy has taught me that the most powerful battleship is friendship. And my almost 40 years in the foreign service tells me that there is no friendship that is quite like that between Taiwan and the United States. Our relationship has stood the test of time and it continues to grow stronger.

Standing here today I call back to the famous words of William Penn: "A true friend...advises justly, assists readily, adventures boldly...and continues a friend unchangeably," quote, unquote.

I assure you that Taiwan will continue to be a true friend and trustworthy partner of Pennsylvania. And I believe that, by standing united and holding fast to our shared ideals, we can achieve what we set out to accomplish.

Just like Pennsylvania, Taiwan is full of warm and welcoming freedom-loving people. For millions of Americans who have visited Taiwan, T-A-I-W-A-N refers to "They Are Incredibly Warm And Nice." I sincerely hope that through our relationship, more Pennsylvanians will visit Taiwan and see what my country has to offer. Once you experience our famous convenience stores, you might start feeling differently about Wawa.

It is truly a privilege to be here today and share my thoughts with you during such an exciting time, and I look forward to seeing what the future holds. Thank you very much. Thank you.

I just want to take a second and recognize what I think is the significance of us working together to pass this resolution and share a tiny bit about my own experience visiting Taiwan earlier this year. I had a unique opportunity to visit Taiwan with a delegation of other elected officials that were under the age of 35, and there were three State elected officials – one from Utah, one from Georgia, and then me, from Pennsylvania – and we were on very different sides of the political aisle, but we found something in common: that we believe that the support that the United States provides to Taiwan is critical.

Taiwan in so many ways is the farthest beacon of western democracy. In Asia it is instrumental for people to have equality. When they talk about democracy, they are literally talking about preserving freedom in their nation.

So for a resolution that has the names of both David Rowe and Jennifer O'Mara on it, I think it shows in this chamber that we can put our partisan politics aside when it is really important and work together for an issue like this. So I want to thank Representative Rowe, Representative Shusterman, and Madam Speaker for your hospitality.

And for our guests today, know that we, both Democrats and Republicans, stand united here in Pennsylvania to support the Republic of China, Taiwan.

GERMANENESS QUESTIONED

The SPEAKER. On that question, the Chair recognizes the gentleman from Beaver, Representative Matzie.

The impetus of this bill is death, plain and simple. This amendment runs far afield of the legislative intent and is poorly constructed. "High-crime area" is not defined – jaywalking? loitering? Double-parking? "Well-founded fear" is not defined – fear of heights? fear of snakes? fear of spiders? "Prevalence of crime" is not defined. Uses the word "permanent." What does that mean? How is it quantified? What if the person moves back? Plus, not all providers in this act are geographically encased. Why does moving require canceling a cell phone contract?

Madam Speaker, I would like to make a motion.

The SPEAKER. The gentleman is in order, and he may proceed.

Mr. MATZIE. I make a motion that amendment A02478 is not germane.

The SPEAKER. The gentleman, Representative Matzie, has raised the question of whether the amendment, A02478, is germane to the bill. Under House rule 27, questions involving whether an amendment is germane to the subject of the bill shall be decided by the House.

On the question,

So I believe this is germane to the underlying bill, and I ask for a positive, or whatever the Speaker decides as to be a positive on the fact that it is germaneness.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentlelady.

On that question, the Chair recognizes the gentleman from Lancaster, the floor leader, Representative Cutler.

Mr. CUTLER. Thank you, Madam Speaker.

Madam Speaker, here in Harrisburg, sometimes we like to confuse issues with big words like "germane." The truth is, let us look at the plain English. We are talking about early termination fees — one is for death; one is for high crime. I think that is an issue that everybody outside of this dome could understand. It is germane. It should in fact be included in the bill, and I would urge support of the gentlelady's amendment.

GERMANENESS QUESTIONED

Mr. MATZIE. Thank you, Madam Speaker.

Amendment A02480 prohibits the imposition of an early termination fee for moving out of low-achieving school districts to a non-low-achieving school district. This provision is nullified if the Lifeline Scholarship Program or similar program is passed. A02480 has potential nondelegation issues, however, as they empower the Chief Clerks of the House and Senate to determine when unspecified legislation dealing with a certain subject was passed, which has the legal effect of determining when the act becomes effective. I do not think this subjective judgment is something we can delegate.

Therefore, Madam Speaker, I would like to make a motion.

The SPEAKER. The gentleman is in order, and he may proceed.

Mr. MATZIE. Thank you, Madam Speaker.

I make a motion that amendment A02480 is not germane.

I had the opportunity to talk with him – he was going to Mansfield University – and he was telling me that he moved out of Harrisburg for one reason and one reason alone, and that was to get out of the failing school districts that are here in Harrisburg for decades upon decades. He moved to a much better district—

The SPEAKER. The gentleman will suspend.

The question is the germaneness of the amendment. The gentleman will keep his argument focused on whether or not the offered amendment is germane to the underlying bill, not on any substantive policy arguments at this moment.

The gentleman may proceed.

Mr. OWLETT. Thank you, Madam Speaker.

I believe this is germane because there are reasons that people are moving out of failing school districts to other areas of the State, and these are big decisions that are made that have to do with contracts that they might be in, and we need to look for ways

that we can help them. That is exactly what this amendment would do, and I believe it is germane to the bill because this has to do with contracts.

We have looked for obvious reasons over the decades to avoid votes just like this. We can make this vote today, and I think it is important to do. Please vote that this is germane to the bill.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentleman.

Those who believe the amendment is germane will be voting "aye"; those who believe the amendment is not germane will be voting "no." Members—

The Chair apologizes. The button is hit. The Chair was on a roll.

The Chair recognizes the gentleman from Lancaster, Representative Cutler.

Mr. CUTLER. Thank you, Madam Speaker.

Completely understand of being in a groove and keeping things rolling, but I would like to discuss the amendment and the motion that is here before us.

Here we go again. Rather than vote the underlying issue, we will spend more time debating whether or not it belongs in the bill. And for those outside who are watching, it is fairly simple. We are talking about reasons to terminate a contract. The good gentleman is defending it as, death is the only reason. We happen to believe that there are some other reasons, such as failing schools, as a reason to move. It should also be included. It absolutely is germane because both deal with failing areas of the law, which is as follows: You have to terminate a contract because the law does not protect you.

Mr. ECKER. Thank you, Madam Speaker.

Madam Speaker, this bill currently contains a dual enforcement mechanism, a private right of action that is unnecessary and detrimental to the true intent of the bill – or issue, I should say. My amendment would give the Attorney General the exclusive jurisdiction with an operator, venue, rights holder, or primary ticket platform that suffers an injury as a result of another person's violations of the speculative ticketing acts or practices prohibitions. By allowing the enforcement through litigation, you are also allowing for inconsistent outcomes, an added burden to the legal system, and greater potential for frivolous lawsuits.

AMENDMENT WITHDRAWN

Mr. ECKER. I believe that the Attorney General would be best suited to promote consistent outcomes to actually attack this issue; however, in an effort to keep this bill moving forward, I will withdraw my amendment at this time.

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1278**, **PN 2037**, entitled:

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in wiretapping and electronic surveillance, further providing for definitions and for exceptions to prohibition of interception and disclosure of communications, providing for public access and for Department of Corrections retention policy and further providing for expiration of chapter.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the maker of the bill, the gentleman from Chester County, Representative Pielli.

Mr. PIELLI. Thank you, Madam Chair.

Today I ask your support for HB 1278, which not only renews our soon-expiring Wiretap Act, but improves upon it by removing certain communications made in the presence of our State parole agents, commissioned police officers of the Department of Corrections, and calls from telemarketers, and it removes them from the definition of "oral communication" under the Wiretap Act. HB 1278 will extend the Wiretap Act to 2029.

This act has proven to be an extraordinary tool for our law enforcement in the prosecution of many crimes since its inception. And now we have the opportunity to pass this bill as amended by my esteemed colleague, Representative Bonner, to further protect our citizens from the nefarious acts of manipulative telemarketers. We also help to protect both our State parole officers and State parolees by including the legal use of body cameras to ensure accountability and fairness, and the same can be said for our commissioned police officers employed by the Department of Corrections.

As such, I ask for your vote to support this bill and to ensure the extension of this much-needed tool in the arsenal of our law enforcement. Thank you.

Thank you, Madam Chair.

The SPEAKER. The Chair thanks the gentleman.

BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1378**, **PN 1538**, entitled:

An Act amending the act of December 17, 1968 (P.L.1224, No.387), known as the Unfair Trade Practices and Consumer Protection Law, providing for online access control measures.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the maker of the bill, the gentleman from Montgomery County, Representative Malagari.

Mr. MALAGARI. Thank you, Madam Speaker.

Madam Speaker, I rise in support of HB 1378. For those in the audience, it is PN 1538.

Last year thousands of Pennsylvanians filed complaints with the Attorney General's Office regarding issues in the ticketing presale for Taylor Swift's Eras Tour that resulted in Ticketmaster canceling the public sale of concert tickets. So some people were thinking that the system was breaking down, that there had been a glitch. But it was not a brief interruption or a slight malfunction. Really, bots were able to keep the presale tickets and scalpers were attempting to sell them for up \$28,000. Long story short, it was a bad time for fans. So Ticketmaster cited a "staggering number of bot attacks" during this incident and worked with then Attorney General Shapiro's office to reopen ticket sales to legitimate customers.

Scalpers should not have been left to their own devices. Tickets come with prices, but not vices. Entertainers, retailers, and venues want this legislation. Grinch bots create an artificial scarcity of popular and desirable products and services, and therefore, manipulate the market for consumer goods. Grinch

bots never miss a beat, they are lightning on their feet, and that is what we do not see. Consumers literally cannot compete or buy tickets as quickly as the bots can.

Ticket price gouging, scalping, and bots are not new. Thirteen years ago Governor Rendell signed an act into law prohibiting the use of ticket-purchasing software. But nothing seems to work the first few times, am I right?

So now in 2023, there are new tactics. There is new technology, and so we need new legislation. So we need to go so ahead of the curve so that the curve becomes a sphere. We need to tighten the law on this, update the language on electronic queues and waiting periods, and to cover new scam tactics.

So we can improve the online marketplace for entertainment, and we should. In our history, across our great divide, there is a glorious sunrise dappled with the flickers of light. The Federal Reserve has estimated that Swift's Eras Tour boosted the economy, and estimates suggest that boost could be up to \$5 billion. So this is not just champagne problems. With those numbers at stake for the economy, we can see how important it is to ensure a fair marketplace for tickets.

I get it. Look, players are going to play, play, play, play, and haters are going to hate, hate, hate, hate, but here is what I am going to ask you to do, is vote "yes" on HB 1378.

Thank you, Madam Speaker.

The SPEAKER. The Chair tells the gentleman to shake it off. On that question, the Chair recognizes the gentlelady from Delaware County, Representative O'Mara, on final passage of HB 1378.

Ms. O'MARA. Thank you, Madam Speaker.

I bow to you. That was good.

I will be brief. We remember all too well the pain beating on us like a drum last year when Eras Tour tickets were as hard to find as twin flame bruises. I recall late November, when fans who were ready for it fought in the great war and found the tickets sold out due to bots. While some may say no body, no crime, it should be criminal for these bots to buy up all the tickets and sell them for up to three times their original price. I am so sick of running as fast as I can to beat these bots. But despite being painted blue, we can drop everything now to prevent future catastrophes on Ticketmaster.

I know this topic is delicate for some of you, but this bill is the one, and I urge all of my colleagues to just say "yes." Thank you.

An Act establishing the Wildlife Rehabilitation Grant Program and the Wildlife Rehabilitation Grant Fund; and imposing duties on the Pennsylvania Game Commission.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the maker of the bill, the gentlelady from Monroe County, Representative Probst.

Mrs. PROBST. Thank you, Madam Speaker.

The wildlife rehabilitators are essential in treating and temporarily caring for our injured, diseased, and displaced wildlife. They also provide essential education in order to mitigate human-wildlife conflicts, which is a health and safety factor, and they promote the stewardship of wildlife.

A lot of people may think, and I have heard in the chamber, that I am anti-hunter and anti-wildlife. I am here for the record, my son's name is Hunter, and my family all hunts. So I am definitely looking forward to this legislation because it would establish that there is a wildlife grant to provide grants to them to care for the injured, diseased, and displaced wildlife. And while the program would be administered by the Pennsylvania Game Commission, no money would be allocated from the game fund, and I want to repeat that. They are willing to administer the grant and no money would come from the game fund.

Under this legislation, the General Assembly may appropriate money to carry out the provisions of the act. Furthermore, grants would be awarded on a first-come, first-served basis, with each organization's office location only being eligible for one grant award per calendar year. Lastly, grant awards would be determined based on the wildlife intake numbers of a wildlife rehabilitator from the previous fiscal year.

There are 35 wildlife rehabilitators in Pennsylvania. Pocono Wildlife represents 12 counties. We need to fund them. So I am asking for a "yes" vote to HB 1522. Thank you.

Officer Mendez and his partner, Officer Raul Ortiz, had just arrived for their shift at the airport, where they were both assigned as officers of the department's airport unit, when they came across a group of individuals attempting to break into a car in one of the airport's parking garages. As the officers approached the group, the individuals attempting to break into the car opened fire on the officers, fatally wounding Officer Mendez and injuring Officer Ortiz.

I am grateful to say that Officer Ortiz is now home recovering from his injuries, but I am very, very sad that Officer Mendez, although taken to Penn Presbyterian Medical Center, one of the best trauma centers in the nation, ultimately, he succumbed to his wounds and passed away.

Officer Mendez leaves behind a lovely family, a wife and a daughter, as well as a very decorated career of service and leadership within the Philadelphia Police Department. Officer Mendez has been described by his family as someone who worked very hard to serve the community, and he loved spending time with his family and he always wore a smile.

We are very grateful for his dedicated public service, and we send our condolences, love, and support to the family he left behind and to all of the mourning women and men in uniform.

I would ask all the members of this august body to please rise in a moment of silence in honor of fallen Philadelphia Police Officer Richard Mendez.
