#### **PRAYER**

HON. MARYLOUISE ISAACSON, member of the House of Representatives, offered the following prayer:

Thank you.

As many of you know, I serve in the seat that Benjamin Franklin himself once held, and I never forget that, as many have served before us in each of our elected seats and many will serve after us. Our seats in the House are the people's and we are mere Representatives of their voices, voices that must be heard and that we should seek to elevate so that they ring through this chamber.

I bring up Ben Franklin in opening prayer today not only because October 6 of this year, just last week, marked the 300th anniversary of Ben Franklin's arrival in Philadelphia, but because he is one of our Founding Fathers, the Father of the Constitution, one of the public servants that helped birth this country, values, and freedoms we love so dearly; the "first American," as many people refer to him.

And it was he who said, "Without Freedom of Thought, there can be no such Thing as Wisdom; and no such Thing as publick Liberty without Freedom of Speech." These are words to reflect on as we see many efforts across our State and our great country to limit and prevent freedom of speech, to censor that which may not align with our own personal thoughts or beliefs, to deprive future generations of their rights to receive information and ideas.

It is also Ben Franklin who said, "Freedom of speech is a principal pillar of a free government; when this support is taken away, the constitution of a free society is dissolved, and tyranny is erected on its ruins." Words for further reflection when we think about what our responsibilities as Representatives of a free government are — and what they absolutely are not.

Censorship of freedom of speech violates the First Amendment right when it is the governing body who takes part in it, and I think we can all come together in the protection of our rights as citizens of this Commonwealth and country, no matter what that looks like in your heart or in your district.

I leave you once again with the words of Benjamin Franklin as we bow our heads and get to work for the people of Pennsylvania: "God grant that not only the love of liberty but a thorough knowledge of the rights of man may pervade all the

nations of the earth, so that a philosopher may set his foot anywhere on its surface and say: This is my country."

This amendment would lower the threshold of workers on a public work project that are required to be skilled craft labor from 70 percent to 50 percent. Much like my other amendment, this is simply aimed at lightening the restrictions we are placing on the contractor in the marketplace. Trimming the 70-percent threshold to 50 percent in terms of the skilled craft labor ratio helps to ensure that not just big construction conglomerates can win bids and do projects. It would allow for more competition in the marketplace and allow for more options for buyers.

Mr. D'ORSIE. Madam Speaker, I withdraw this amendment. The SPEAKER. The Chair thanks the gentleman.

in an audit of the contractor or subcontractor within the prior five-year period.

(B) for a contractor or subcontractor that is self-insured for workers' compensation purposes, an affidavit stating that the contractor or subcontractor has not received a citation for a violation under 29 U.S.C. Ch. 15 (relating to occupational safety and health) within the last three years.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the gentlelady from Cumberland County, the maker of the amendment.

Mrs. GLEIM. Thank you, Madam Speaker.

This amendment would add a requirement that the contractor or subcontractor demonstrate effective workplace safety by either certification of workplace safety by the Department of Labor and Industry or for a contractor or subcontractor that is insured for workers' compensation purposes. Madam Speaker, verifiable safety certifications or verifiable safe work histories are the most appropriate metric to make sure that contractors are not cutting corners on worker safety. Having a mod rate of one or lower is a very good indication of whether a contractor or subcontractor is safe, and I urge my colleagues for an affirmative vote.

### RESOLUTION

Mr. FRANKEL called up HR 245, PN 2160, entitled:

A Resolution urging the Congress of the United States to provide the State of Israel with the support necessary to ensure its safety and security and condemning the terrorist attack in Israel by Hamas.

On the question,

Will the House adopt the resolution?

The SPEAKER. The Chair recognizes the gentleman from Lancaster County, Representative Cutler.

Mr. CUTLER. Thank you, Madam Speaker.

Madam Speaker, I rise in support of this resolution and standing in support of the people and the State of Israel and against Hamas and Hezbollah terrorists. We talk a lot in this building about supporting democracy, but I do not believe that you can support democracy without also supporting Israel.

Israel is a Jewish State that is the historical and cultural Jewish homeland, and it is the only functioning pluralistic democracy in the Middle East, and Israel is one of America's strongest allies in that area. I think that is why they are so hated by the people who wish to cause them harm. It is these things that make them a constant target.

Today we stand with one voice in support of Israel while it exercises inherent right to self-defense and self-preservation, as outlined in the resolution. I stand with Israel and its people while civilians are suffering and hostages are separated from their families, and we must stand against those who want nothing more than destruction and war and the eradication of the Jewish people. I encourage a positive vote.

Thank you, Madam Speaker

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the gentleman from Luzerne County, Representative Kaufer.

The Chair recognizes the gentlelady from Warren, Representative Rapp.

Ms. RAPP. Thank you, Madam Speaker.

Madam Speaker, I rise today in support of my colleagues on the resolution. I rise in support because of what happened on Saturday, October 7, which was the very definition of terrorism. It was an unprovoked attack on innocent people mourning the 50th anniversary of the Yom Kippur War. This attack was meant to instill fear into the hearts of the people of Israel. Hamas invaded sovereign borders. They killed hundreds of civilians and took even more hostages, including American citizens.

No matter what you may be hearing from some organizations, this attack cannot be justified. This was not the first attack on Israel; it will not be the last. I know their nation will move past this vicious attack, like they have countless times over thousands of years, but we cannot be silent on this issue.

My prayers are with the Israeli people and those here in the Commonwealth with family who call Israel home. No matter what your political leanings may be, I urge you to condemn the terrorism by Hamas.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentlelady.

On that question, the Chair recognizes the gentleman from Lawrence, Representative Bernstine.

Mr. BERNSTINE. Thank you, Madam Speaker.

Madam Speaker, on October 7 of 2023, the radical Islamic terrorist group known as Hamas, operating from the Gaza Strip – which is the property of Israel – conducted a terrorist operation that was the most catastrophic operation against the Jewish people since the Holocaust. During this operation, they parachuted terrorists into civilian areas, slaughtered women and children who were visiting marketplaces, participating in music festivals, and living their lives in their homes. This included murdering infants in their cribs and decapitating these babies in front of their families. These radical Islamic terrorists not only barbarically slaughtered civilians, but also currently hold 199 hostages, including children and infants.

This is not and should not be a condolence or sympathy resolution, but rather is a resolution that condemns the actions of Hamas. Just as Israel had no authority to determine our response to 9/11, the United States has no authority to determine the actions of Israel in their rightful quest to defend their nation against Hamas and other Islamic terrorist organizations. The charter of these groups openly calls for the extermination of Jews and the State of Israel itself. October 7 was not shocking or surprising. October 7 was exactly what Hamas and other radical Islamic terrorist organizations have called for for the last 100 years. Madam Speaker, these radical organizations and these terrorists will continue to attack freedom until they achieve their goal of the destruction of Israel or these groups themselves are completely destroyed.

The next days, weeks, and months will include civilian casualties, but this is not the fault of Israel. This is due to the actions of Hamas, who have previously and continue to use civilians as human shields. Israel has taken every reasonable action to reduce these casualties. The United States of America and this Commonwealth must not only condemn the actions of Hamas, but also must stand shoulder to shoulder with Israel as they defend themselves against Hamas and other nations and terrorist groups who have called for their extermination.

I call to support this resolution. Thank you, Madam Speaker. The SPEAKER. The Chair recognizes the gentleman from Luzerne County, Representative Kaufer.

Mr. KAUFER. Thank you, Madam Speaker.

The attacks on October 7 were no doubt an act of terrorism, an act by a group whose ideological goal and view is to destroy the Jewish people, to exterminate every last Jew. Over the course of history, Jews have faced this threat time and time again. We have a holiday named Purim. There was an ancient — what I would consider an ancient Hitler, named Haman, that we actually have noisemakers to drown out his name as we tell the story of being pled by Queen Esther to save the Jewish people. Again we had the threat during the Holocaust of Hitler and the attempts to exterminate the Jewish people once again, and the acts that happened just several days ago by Hamas as, once again, the same thing: an attempt to destroy and exterminate, eliminating the Jewish people from this earth.

The terrorism that happened happened to people who got up — many going to temple, just going to pray, celebrating at a music festival — who had no idea that that would be their last day. But not only was it done to kill innocent people, but the mutilation that happened — the imagery that many of us have seen will forever be emblazoned upon our minds.

It was nearly 50 years ago, just over 50 years ago that many in temple services during the Yom Kippur War, as the gentlelady from Warren mentioned; there was something that my temple had done – which they call it, "May this be the last war," and it was 50 years since the last war – playing a song that is to commemorate what we hope will be lasting peace. Nearly 50 years to the day. Obviously, it was not.

For many of you, this is something you watch passively, but I know that there are many of us here who have friends and family that were overseas who were killed, people that did not know that would be their last day. And the many times that I had the opportunity to go to Israel, some with some of the members here of this chamber, we were actually there in these areas where people were decimated and killed. The minority leader and I, we have spent some time along the border of one of those very kibbutz that was annihilated. On different family trips we have

spent time in the town of Sderot, which has been covered quite extensively on the news recently, that is rocketed daily – even before today or today's times – rocketed daily, every single day. This was not an accident; this was a systemic goal to exterminate the Jewish people once again.

It means a lot to me to be here in front of you, my colleagues, as a Jewish American, here, asking for your support. Some of us who woke up in those days after and the days leading up and as we saw calls for there to be attacks here across the United States on Jews, trying to carry over that attack here to the United States, I think some of you probably saw, and those of you that called me, and you know, I was certainly shaken over the attacks, my family was shaken. Never did I feel so afraid to live in this country.

I want to thank you, my colleagues, because I know many of you – and I hope this will pass unanimously – but I know many of you are going to vote for this and are going to support this. And I thank you for your vote, because as a Jewish man standing here today, I am glad that I am still standing here and that all these attacks on my religion and on the people before me and generations before and after, the Jewish term "L'dor vador," from generation to generation. We will defeat terrorism. We will defeat these threats as we have in the past, because I look forward to passing this off to my daughter's generation and the generation after that, because the Jewish people will not be exterminated, and we will defeat this threat.

Thank you. I please ask for an affirmative vote. Thank you. The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the maker of the resolution, Representative Frankel, the gentleman from Allegheny County.

Mr. FRANKEL. Thank you, Madam Speaker.

First, let me thank my colleague, Representative Kaufer, for cosponsoring, co-priming this resolution. And I want to thank all of my colleagues for working together, particularly my caucus, to craft this resolution, and to all my colleagues across the aisle for your cosponsorship. It means an enormous amount to me personally, and certainly to my community in Pittsburgh and Jews throughout the Commonwealth of Pennsylvania.

It has been more than a week since a diverse crowd of young people at an all-night dance party in Israel were trapped by terrorists and gunned down en masse; more than 260 young people murdered in that field. More were murdered in bomb shelters as they were trying to protect themselves and their families. They were hunted down; their final moments pure horror. They could have been my children or yours. A family of five, including 6-year-old twin girls and their 4-year-old brother, messaged their loved ones that they were in a safe place in their home. Hamas terrorists found them and killed them all. People were shot in their cars, killed on the street. At one bus stop, seven Israeli civilians lay dead. Military forensic teams examining the bodies found signs of torture and rape.

These are images that, you know, burn through our minds, and as we have seen – nobody should ever see – but they remind me of other images as I hearken back in the history of the Jewish people, which my colleague referenced, and the many, many times that the Jewish people faced existential eradication. But I have memories that go back, you know, to stories I have heard from my parents and my grandparents. And the images that we saw the other day recall the images that we can see in documentaries about what took place in the Holocaust, the intimate brutality and heartlessness of destroying individuals.

I mean, I have in my mind the image of my mother and her family, who escaped western Europe in the early 1930s in the face of anti-Semitism, were able to relocate in South America because they could not get a visa to the United States, but leaving behind aunts and uncles and cousins, none of whom survived the Holocaust. I recall my wife's family, who were merchants in the town of Dortmund, Germany. My late father-in-law was bar mitzvahed the day before Kristallnacht and watched as his grandfather was brutally murdered in the streets that Night of Broken Glass. He escaped and ended up in the United States, joined the Army and the OAS (Organization of American States), was a paratrooper and liberated – was part of the liberation of Mauthausen Concentration Camp. You can see his photograph today at the Holocaust Memorial Museum in Washington.

I think of my late mother-in-law, whom I never met. She, at 15 years old, was shipped to Auschwitz. She survived. We can only imagine what happened to her during the 3 years that she was there. She was a survivor for a while, but so traumatized that when my wife was 10 years old, committed suicide. These are images that I hold as I see what is taking place today.

And as we also turn to the time in 10 days from today, when we will be commemorating the fifth anniversary of the anti-Semitic attack and murder of 11 of my neighbors at the Tree of Life synagogue, it also recalls to me why it is important for us to stand together and call out this horrific terroristic attack that mirrors so much of what history has shown us and what we need to reject and counter.

Hamas's stated goal is to eradicate Jews, and they will cause unlimited suffering to achieve it. They care not for civilians or human life. They are a danger to Israelis, and they are a danger to Palestinians, and if we do not speak out, they are also a danger to our own humanity. I want to thank you again and say to you, never again is now. Thank you.

# **BILL ON THIRD CONSIDERATION**

The House proceeded to third consideration of **HB 1527**, **PN 2139**, entitled:

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, further providing for personal needs allowance deduction for medical assistance-eligible persons in nursing facilities.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Montgomery County, the maker of the bill, Representative Sanchez.

Mr. SANCHEZ. Thank you, Madam Speaker.

HB 1527 amends the Human Services Code by increasing the personal needs allowance for medical assistance-eligible residents of nursing home facilities. Specifically, it increases their monthly allowance from \$45 to \$60 per month.

Madam Speaker, I would first like to thank the gentlelady from Bradford and Wyoming Counties for all of her assistance on this legislation. I also want to thank the Representatives from Pike and Monroe Counties and Dauphin and Cumberland Counties as well for their help.

This bill is a perfect example of bipartisan work, which resulted in it being unanimously reported out of the Aging and Older Adult Services Committee. The personal needs allowance provides residents of nursing home facilities the opportunity to purchase clothing and meet personal expenses that are not covered by medical assistance. However, the amount allowable has remained unchanged since 2007, with no adjustments reflecting the inflation of personal care items or incidentals.

The bill has the support of the administration, the State Long-Term Care Ombudsman, the PA Association of Area Agencies on Aging, AARP, the PA Adult Day Services Association, and the PA Health Care Association, just to name a few.

And the administration believes this bill could go into effect on January 1, 2024. There is no known opposition. And, Madam Speaker, an increased PNA would go a long way to help residents who rely on Medicaid increase the quality of their lives and maintain their dignity. And for these reasons, Madam Speaker, I ask my colleagues for their full support of HB 1527. Thank you.

The SPEAKER. The Chair thanks the gentleman.

# BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1658**, **PN 2087**, entitled:

An Act amending the act of December 17, 1968 (P.L.1224, No.387), known as the Unfair Trade Practices and Consumer Protection Law, prohibiting speculative ticketing acts or practices.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Beaver, the Chair, Representative Matzie.

Mr. MATZIE. Thank you, Madam Speaker.

If you do not have it, you cannot sell it. You see, that is really what speculative ticketing is all about. It allows unofficial sellers to list tickets for sale even though they do not actually possess – and may never have – those tickets. Also, many times these sellers mimic or mirror official Web sites to confuse consumers. This is not only deceitful, but it is inherently unfair to consumers. It hurts fans; it hurts venues; it hurts artists.

HB 1658 ends the practice of speculative ticketing in Pennsylvania and stops the use of duplicitous platforms for purchasing tickets. Simply put, if you do not have it, you cannot sell it, and you cannot fool someone into thinking they are buying that ticket from somewhere else.

To be clear, I am not trying to restrict or stop secondary sellers from plying their trade. I am merely calling for honesty and transparency in that process. The Federal government is looking at measures but has not acted. Yet again, they seem to look and not act, so it is really up to States to step in. And some States have: Arkansas, Nevada, New Jersey, New York, just to name a few. Many more are still looking at this issue.

Today we have an opportunity to protect Pennsylvanians. I hope you will join me, because if you do not have it, you cannot sell it. I ask for a "yes" vote on HB 1658.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Montgomery County, Representative Ciresi.

Mr. CIRESI. Thank you, Madam Speaker.

Madam Speaker, this bill is simple. If you die, you cannot be charged for early termination fees. Imagine that, charging, for somebody who died, early termination fees. This bill is narrowed and focused and targeted. It requires notice and submission of a death certificate to prevent the misapplication of the law.

To be clear, the legislation in no way excuses someone from debts or payments in arrears; it simply stops the imposition of early termination. This law is in place in New York, and I can speak from experience. When my mother passed away over 10 years ago, she had a car lease, and the car company tried to charge us for the remainder of the lease, but under the laws of the State of New York, we did not have to pay for the remainder of the lease. It was not her fault she died early. She passed away. Why should the family have to pay that?

I would ask everyone today to vote in the affirmative for this bill.
