An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school health services, further providing for dental examinations and dental hygiene services.

On the question, Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the maker of the bill, the gentlelady from Philadelphia County, Representative Cephas. Miss CEPHAS. Thank you, Madam Speaker.

So first and foremost, I want to thank both chairs and members of the Education Committee for prioritizing the health and wellness of our families across the Commonwealth, particularly as it relates to our school-age children. I also want to thank my

colleague from Lancaster County for her leadership on this issue, and particularly working across the aisle to address challenges that transcend urban, suburban, and rural areas alike.

If you are parents to school-age children, you know there is a mandate for dental screenings for school-age children entering grades K to first grade, third, and seventh, and these screenings are only being able to be provided currently by dentists or certified school dental hygienists, but given the scarcity of dentists across Pennsylvania, and with today's financial constraints in our schools, administrators face challenges in maintaining even a school nurse, let alone a certified school dental hygienist. Increasingly, school districts are grappling with difficulties in hiring dentists to meet these requirements due to the demands on their private practices and associated costs.

Our proposed legislation, HB 1478, seeks to address these challenges by broadening the range of dental professionals available to serve our students. This bill aims to amend the Public School Code, providing school districts with an additional option for complying with the dental screening and dental hygiene requirements of section 1403. This additional option will enable districts to utilize public health dental hygiene practitioners to conduct screenings and provide the necessary documentation for our school-age children.

We all know, when our young people have dental challenges, they are three times more likely than their counterparts to miss school as a result of dental pain, which further creates an urgency to fill the gaps in our overall dental system. As we strive to ensure that our students receive all the support they require, both within and outside the school environment, this bill will help ensure that they have access to the essential care needed for their dental health and overall well-being. It also removes barriers for school administrators in fulfilling their responsibilities by creating this opportunity to expand dental practitioners to support our young people.

So again I ask my colleagues for a "yes" vote, and again I want to thank my colleague from Lancaster County for her work and her support.

Thank you, Madam Speaker.

And I also would like to thank the gentlewoman from Philadelphia for helping get this legislation to the floor for a vote. I am so happy to be able to partner with her. Several years ago, a constituent of mine, who is a public health dental hygiene practitioner, came to me asking for help. Public health hygienists are allowed to work in public health settings without dental supervision, but not allowed to conduct screenings in school without a dentist present.

Since the General Assembly passed legislation to create the P.H.D.H.P. in 2007, over 900 dental hygienists have applied for this credential. The role they play is critical to help with oral health care. My constituent has been approached by a local school district who was having difficulty finding dentists to do the mandated dental screening for schoolchildren, and they asked her if she could help. While her education and her training had prepared her to conduct screenings, currently statutes and regulations in Pennsylvania prevented her from being able to help. This legislation is needed to change that.

HB 1478 is a start to trying to improve this situation. It will help thousands of PA schoolchildren who are currently not getting dental screenings to find a dental home, and it will help school districts who cannot find a dentist to do the mandated screenings. I urge my colleagues on both sides of the aisle to vote "yes" on HB 1478. Thank you.

The House proceeded to third consideration of **HB 1556**, **PN 1817**, entitled:

An Act amending the act of February 14, 2008 (P.L.6, No.3), known as the Right-to-Know Law, in State-related institutions, further providing for reporting, for contents of report and for copies and posting and providing for contracts.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the maker of the bill, the gentlelady from York, Representative Klunk.

Ms. KLUNK. Thank you, Madam Speaker.

Madam Speaker, Pennsylvania's Right-to-Know Law is a key method that we have here in Pennsylvania to ensure that our agencies are open and transparent in their work for this Commonwealth. Our four State-related institutions are part of those agencies that fall under this important law, and, Madam Speaker, they should be because they educate our children. And even beyond the K through 12 education, it is critically important for the competitiveness and vitality of this great Commonwealth that we hold them accountable.

These institutions receive hundreds of millions of dollars each and every year to educate our children, and as parents and taxpayers, we should know more about what these institutions are doing with these dollars. Right now the current chapter of our Right-to-Know Law concerning our State-related institutions is about 32 lines – 32 lines in total. Madam Speaker, that is about one page of text to hold them accountable to the parents and taxpayers, and I believe it needs more.

Madam Speaker, there have been many iterations of this bill over the years and in both chambers, but together with my good friend from Fayette County, our bill greatly expands on the reporting requirements for these four institutions – their graduate schools, their law schools, their medical schools, their branch campuses. The bill clarifies existing requirements and adds some additional reporting requirements, including the salaries of all officers and directors and the highest 25 salaries paid to employees, plus the next 175 highest salaries if they are greater than \$150,000.

It also includes reporting requirements for budgets on any project, program, or auxiliary enterprise which is the subject of a specific line-item appropriation from the General Fund, and information regarding student enrollment, faculty count, and credit requirements. And even more importantly, Madam Speaker, to provide even greater accessibility and accountability, each State-related institution would be required to provide full, complete, and accurate information as may be required by the Department of Education or the chair or minority chair of the Appropriations Committee of either the House or the Senate.

And finally, Madam Speaker, to add an additional and paramount piece to the reporting is that these institutions must provide a list of all of their contracts in excess of \$5,000, and each list of those contracts must be filed with the Governor's Office, the Secretary of the Senate, the Chief Clerk of the House of Representatives, and the State library, and also shall be published on the institution's Web site.

Madam Speaker, this is the more that we need. This is the more that our Right-to-Know Law needs here in Pennsylvania to ensure complete openness and accountability when it comes to these State-related institutions. I have had the opportunity to speak with representatives of many of these State-related institutions, and they all agree that we need this bill to improve openness, to ensure accountability and transparency for our taxpayers and our parents.

So, Madam Speaker, I rise today to support this bill and encourage a "yes" vote. Thank you.

The SPEAKER. The Chair thanks the gentlelady.

On that question, the Chair recognizes the gentleman from Centre County, Representative Benninghoff.

Mr. BENNINGHOFF. Thank you very much, Madam Chair.

I will be relatively brief on this. I just stand in support of HB 1556. While this bill may not be perfect and it may not be written like any one of you may have written it, it is a bill whose – a phrase I will steal from a former Representative – Representative Bishop said, it is a bill whose time has come.

Many of you have requested greater oversight, greater transparency of some of the funding that we give the taxpayers to many of our institutions of higher education. This is an opportunity to do it. Again, is it written exactly like you would do? Not necessarily. But no bill, for the most part, finishes as it started. They are a collection of a lot of people's input, a lot of different meetings, a lot of different hearings, and this is one that has been discussed over and over and for several years, many years; both sides of this chamber, people have requested greater transparency and better insight to where this money is going. To not let this bill pass will fail on those attempts and will give you no insight.

I rise, Madam Speaker, to ask the members to support HB 1556 as a very good start to where we need to be on this and a good opportunity to get the insight and transparency many people wish. Thank you.

# BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 735**, **PN 2210**, entitled:

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in Commonwealth budget procedures, providing for scope and for definitions; providing for Flood Insurance Premium Assistance Task Force; in powers and duties of Department of Human Services and its departmental administrative and advisory boards and commissions, providing for child support enforcement fees; and, in judicial administration, providing for surcharge and fee.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. The Chair recognizes the gentleman from Bucks County, Representative Warren, for a brief description of Senate amendments.

Mr. WARREN. Thank you, Madam Speaker.

HB 735 is back in the House on concurrence. This bill will establish the Flood Insurance Premium Assistance Task Force, which will analyze the administration and seek cost reductions in flood insurance. The Senate amended the bill to change the composition of the task force. I am agreeable to the amendments.

In addition, the Senate amended the bill to include some Administrative Code provisions, including the reestablishment of child support fees and judicial surcharges that expired in July of this year, and the suspension of a transfer from the Judicial Computer System Augmentation Account to the School Safety and Security Fund. I am also supportive of those changes.

The bill passed unanimously in the Senate, and I would respectfully request a like result here in the House.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the gentlelady from York, Representative Keefer.

Mrs. KEEFER. Thank you, Madam Speaker.

A couple issues I have with this is, first of all, the flood insurance task force. We understand that the flood insurance premiums are being driven at the Federal level, and so our municipalities have to adopt these ever-expanding flood insurance maps, because if they do not, none of them will be available or their citizens will not be able to get the insurance that they need. Whether their area has flooded before, whether it is projected to flood, it does not matter; now in the new map, they have to pay. And there is little we can do. We can study it all day long; until we address it at the Federal level, I do not know what a task force is going to do.

The other part of this bill, as far as the fee goes for child support, it says it is for the "child support enforcement," and yet we are going to allow the Department of Human Services to keep that fee. It is the counties who have to go after these funds over and over again, the counties who are often underresourced in this area, and then the families who ultimately – and children – pay the price.

So for those reasons I cannot support this. Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentlelady.

On that question, the Chair recognizes the gentleman, the chair of Appropriations, from York, Representative Grove.

Mr. GROVE. Thank you, Madam Speaker.

You know, it is with great frustration that I have to come up here and support HB 735 for the simple fact that we have a long-standing law on Rainy Day Fund transfers that is very clear: it is 10 percent of the surplus. Unfortunately, we have a Budget Secretary who twice now has miscertified amounts, one for property tax relief, which this body stood unanimously to correct to provide over a billion dollars of property tax relief to homeowners. Now we have a fix; that does not need done. But the simple fact that the Budget Secretary submitted an egregiously lower amount than the statute requires, we are here today to make sure that does not happen again.

Hopefully, moving forward, the Budget Secretary will have conversations with people on how to properly calculate certifications on numerous fronts. But with that, I stand in support of HB 735 to make sure almost \$900 million of the General Fund money gets put into our Rainy Day Fund, because I have a feeling it is going to be raining a hell of a lot soon.

Thank you, Madam Speaker.
