TUESDAY, December 16, 1975.

The Senate met at 11:00 a.m., Eastern Standard Time.

The PRESIDENT pro tempore (Martin L. Murray) in the Chair.

MOORE AMENDMENT

Senator MOORE, by unanimous consent, offered the following amendment:

Amend Sec. 21 (Sec. 724), page 15, lines 19 and 20, by striking out "three cents (3ϕ) " and inserting: two cents (2ϕ)

Senator MOORE. Mr. President, considering the depressed economic condition now existing in Pennsylvania, the provisions of Section 724 of the bill under consideration would cause an additional hardship to manufacturers of construction equipment who must obtain special permits for the movement of overweight and oversized loads on Pennsylvania highways.

My first amendment would change the mileage charge on line 19 of page 15 from three cents to two cents. This would be a great help to those manufacturers, especially in my District, who must compete with manufacturers of similar equipment in bordering states.

I would ask the support of my colleagues on this amendment, and I ask for a roll call vote.

And the question recurring, Will the Senate agree to the amendment?

On the question, Shall the bill pass finally?

Senator TILGHMAN. Mr. President, I would like to state for the record that I am not going to vote for this bill, but I think I owe it to my constituents to give some logical reasons why I do not think this money should be given to PennDOT through the Motor License Fund at the present time.

I have a great deal of information here, and I think as I am standing at the microphone that I will not go through all of this information. I think all of my colleagues in the Senate are well aware of some of the accusations that are made about the operation of Penn-DOT at the various county sheds. I have here employment records of individuals who have recently been hired, within the last month, by PennDOT; people who, as far as

I am concerned, have no right whatsoever to work for this Department. The lowest salary figure I have for this employment is \$12,096 per year.

I think the Department is badly run. The Motor License Fund, according to a document which most of us have seen from the Attorney General's office, has some \$14.9 million in it which should be lapsed. I would point out to the Department that I would like to go on record by stating that on page 23 of the bill, lines 23 and 24, wherein it is written that the Department shall report to the General Assembly how these additional funds were being expended. I want the Department to know as of now that the Republicans on the Committee on Appropriations of the Senate will request this information from the Department and see that we get it on time.

Mr. President, I am not particularly enthralled with the use that is going to be made of this money when it goes through the Motor License Fund to the Department of Transportation. Incidentally, I am sure most of my colleagues are aware that we do have to pass an appropriations bill for these funds. This is not the last we will hear of these funds, because when we return in January we must appropriate this money from the Motor License Fund to the Department of Transportation.

The other day, while driving to Philadelphia, I was listening to KYW radio. I heard the nominee for the Secretary of PennDOT—I believe his name is Pulakos, and I do not know if I am pronouncing that correctly—stating where the money we are voting on this afternoon would be used. Yesterday I asked him if he would send me the breakdown of these funds. Maybe all of you have seen it, but if you have not I am going to go through it very quickly.

For winter traffic services there is \$23.2 million; for bridge painting, \$3.3 million; for traffic line painting and signs, \$3.3 million; and for highway resurfacing, \$57.9 million. I think the public has been led to believe that all this money is going to go into resurfacing the highways and fixing potholes. If my figures are correct, on a yearly basis, approximately a third of the money will go for highway resurfacing and the balance of the money will go for items which I do not believe should be entailed in this legislation at the present time.

Senator BELL. Mr. President, when we were asked to provide votes on this side of the aisle for the gas tax increase recently, I was one of those who voted "yes." When Secretary Kassab appeared before the Republican caucus which, incidentally, was an open caucus, the public and news media were invited but they were not there, I called to Secretary Kassab's attention the status of the Pennsylvania Department of Transportation and how people had been indicted, how people had been convicted and how there was general inefficiency.

Secretary Kassab said, "Well, things were rotten under Bartlett and they are rotten today."

I am bringing that up because just last week I also called on the person being designated as the new Secretary of Transportation and suggested that it was time to clean the stables of the Pennsylvania Department of Transportation of politics, to take politics out of those who seek jobs; that they forbid, absolutely forbid, the purchasing of \$100 tickets by the contractors who do the road work, and just generally clean house.

DOT at the various county sheds. I have here employment records of individuals who have recently been hired, within the last month, by PennDOT; people who, as far as

Cumberland County, right near the entrance to the Naval Base, in New Cumberland, eight men standing around doing nothing. This is what the public has seen and, Mr. President, I am voting "no" today in protest over the failure of the present administration to clean politics out of PennDOT and to try to get some efficiency into PennDOT.

Mr. President, I am not new at this game of criticizing people because I criticized Governor Shafer and Bartlett during the times the Republicans held office and on behalf of the people who will be paying these taxes I am going to vote "no" today.

And the question recurring, Shall the bill pass finally?

(During the calling of the roll, the following occurred:) Senator WOOD. Mr. President, having voted under a misapprehension, I would like to change my vote from "no" to "aye."

Senator TILGHMAN. Mr. President, I wonder if anybody on the other side of the aisle would care to give us some information on this bill. I do not understand what the bill does. I have read the bill. I have read the resumes and one of the resumes that I read, I would like to read to you what it says because it is kind of interesting. It says, "Engine and truck companies housed together are to be considered one company unless they have the same number in which case they would be considered one company and the other company housed in the same facility shall be another company. Squad companies and elevated platforms will be separate companies."

Mr. President, I am totally unable to understand this legislation and would ask the gentleman from Allegheny, Senator Scanlon, to explain it to us.

Senator SCANLON. Mr. President, I certainly have difficulty understanding that language but, as I understand it, this bill is a part of a negotiated labor contract between the mayor and the president of the fireman's union in Pittsburgh. It has something to do with transferring firemen from one station to another. They were designated originally as truck companies and engine companies. A lot of the stations in Pittsburgh were closed and, for administrative purposes, they are all to be categorized as one now and just called an engine company; but, they did have like, one part of the north side would be a truck company and four blocks away there would be an engine company and the truck company would only house one of those large hook and ladder units. Over in the engine company it would house a pumper. When they were negotiating this labor contract there was some confusion because of the laws previously passed in Harrisburg as to the proper designation when they consolidated these companies.

Mr. President, I have been assured by Mayor Flaherty and the president of the union that this bill has been agreed to. I do not know whether that answers your question or not.

Senator TILGHMAN. Mr. President, I thank the gentleman. I understand that he did not write the legislation. I appreciate the remarks he made. I just wonder if we are putting into statute a labor understanding between the firemen and the administration in Pittsburgh.

Mr. President, first of all, I have some reticence about putting it into the statutes of the State, but if we are and if we have to, I wonder if it would be possible for

this bill to go over so we might get a little bit more information on it. We would have our staff telephone the people in Pittsburgh to try to get exactly what it does.

Mr. President, I would request that the bill go over in order unless there are great objections to it.

Senator SCANLON. Mr. President, the problem with that is that as of January 1, 1976, Pittsburgh becomes Home Rule. I think it is necessary, as I understand the situation, that this bill be passed before we adjourn.

Senator TILGHMAN. Mr. President, I would vote in the negative because I think under Home Rule they could probably do this themselves.

WHEREAS, Coal, petroleum, limestone, sand and gravel and other materials serving the economy of Allegheny County must be transported over substantial distances on

the Mississippi/Tributary inland waterway system; and WHEREAS, H. R. 8590, The Waterway User Tax Act of 1975, (1) would impose a ton-mile additional tax upon the transportation of all freight over the inland waterway system and (2) would also impose a lump-sum charge for each lockage through a government lock by a recre-

ational boat; and
WHEREAS, The proposed ton-mile tax would necessarily cause higher costs and increased prices for products of the Allegheny County region, would depress the region's economy and would contribute to unemployment

where and inflation; and Where and inflation; and Where and inflation; and Where and Allegheny County region at unfair economic disadvantage in relation to areas located closer to the center of the Mississippi/Tributary waterway system and in relation to those areas not dependent upon the inland waterways; and

WHEREAS, The proposed lockage charge for recreation boats would be prohibitive, amounting to a dollar per mile on the Allegheny and Monongahela Rivers, and would therefore destroy much of the inland market for boat equipment manufacturing and marina services; therefore be it

RESOLVED (the House of Representatives concurring), That the General Assembly of the Commonwealth of Pennsylvania memorialize the members of the United States House of Representatives and the United States Senate of the Congress of the United States to vote against the enactment of H. R. 8590, The Waterway User Tax Act of 1975, and any other measure imposing burden-

some levies upon inland waterways transport, for the reasons recited above; and be it further
RESOLVED, That copies of this resolution be transmitted to each Senator and Representative from Pennsylvania in the Congress of the United States, and to the presiding officers of the Senate and House of Representatives of the Congress of the United States.
