L. 1368, No. 542), entitled 'An act amending, revising and consolidating the laws relating to delinquent county, city, except of the first and second class and second class A, borough, town, township, school district, except of the first class and school districts within cities of the second class A, and institution district taxes, providing when, how and upon what property, and to what extent liens shall be allowed for such taxes, the return and entering of claims therefor; the collection and adjudication of such claims, sales of real property, including seated and unseated lands, subject to the lien of such tax claims; the disposition of the proceeds thereof, including State taxes and municipal claims recovered and the

redemption of property; providing for the discharge and divestiture by certain tax sales of all estates in property and of mortgages and liens on such property, and the proceedings therefor; creating a Tax Claim Bureau in each county, except a county of the first class, to act as agent for taxing districts; defining its powers and duties, including sales of property, the management of property taken in sequestration, and the management, sale and disposition of property heretofore sold to the county commissioners, taxing districts and trustees at tax sales; providing a method for the service of process and notices; imposing duties on taxing districts and their officers and on tax collectors, and certain expenses on counties and for their reimbursement by taxing districts; and repealing existing laws," be recommitted to the Committee on Conference for further consideration.

Ordered, That the clerk present the same to the House of Representatives for concurrence.

CONSIDERATION OF EXECUTIVE NOMINATIONS

Senator FUMO asked and obtained unanimous consent for immediate consideration of the nominations made by His Excellency, the Governor, and reported from committee at today's Session.

NOMINATIONS TAKEN FROM THE TABLE

Senator FUMO. Mr. President, I call from the table for consideration the nomination reported from committee today and previously read by the Clerk for Bruce W. Kauffman, Esquire, as Justice of the Supreme Court of Pennsylvania.

On the question,

Will the Senate advise and consent to the nomination?

Senator KELLEY. Mr. President, I believe we are faced with a dilemma here today on the confirmation of Bruce W. Kauffman for the Supreme Court of the Commonwealth. I first and foremost want to establish that last year when this nominee was before us for the same position, I wholeheartedly supported his confirmation on the basis of his qualifications.

Indeed, he testified before the Senate Committee on Judiciary at the time, "Courts must interpret the law and order enforcement of all constitutional statutes. Courts must not attempt to be super-legislative bodies, seeking to enact law or to thwart politics adopted by the Legislature. The Legislature makes the law and the Courts interpret the law and the Executive enforces the law."

Mr. President, I believe we should all take a great deal of satisfaction in knowing there is a good fundamentalist who aspires now and is before us for confirmation to the Court.

The dilemma, Mr. President, I believe, is the fact that last year when the gentleman was before us, he went before the voters and did not receive the endorsement of either political party to which he sought the nomination. Now it is a dilemma in this sense. The public policy of the Commonwealth is to elect judges and justices and yet, neither political party embraced his candidacy. Now there is another opening and he is before us again.

Mr. President, I guess what I am suggesting is if we vote in the affirmative, that we are not, in fact, embracing what his nomination last year represented, and that is "the merit selection process," because I happen to believe he is eminently qualified regardless of the fact that he may or may not have come before us on this nomination on merit selection.

Indeed, last year the merit selection process was dealt a severe blow and I believe we should take great heart and confidence in that.

Today, however, I wholeheartedly support the confirmation of Bruce W. Kauffman but not because of merit selection but because I know from examination that he is eminently qualified. I commend the Governor for making this nomination to

Mr. President, maybe there is no dilemma for us. The point being, Mr. President, that we must be mindful of what happened last year and because this same nominee is before us for the same position this year. Our confirmation of this nominee is not an embracement, at least, in my judgment, of the merit

selection process. In that regard, there is a dilemma of sorts. We must make a choice.

Mr. President, I urge my colleagues to vote in the affirmative.

NONPREFERRED APPROPRIATION BILL ON THIRD CONSIDERATION, DEFEATED ON FINAL PASSAGE

SB 1201 (Pr. No. 1479) — Considered the third time and agreed to,

On the question,

Shall the bill pass finally?

Senator LINCOLN. Mr. President, Senate Bill No. 1201 would appropriate \$200,000 to the Fayette County Commissioners for the operation of the Great Meadows Amphitheater. I would like to give a little bit of background on the amphitheater and some of the activities that are going to be taking place in this particular area which is high in historical value.

First, let me give you the geographic background. The amphitheater is located in Morton Township in Fayette County, which is very close to the Federal park where the beginning of the French and Indian War started. It is very close to Ohiopyle State Park. It is an area that has very recently been developed for tourism. The State Park at Ohiopyle itself in 1978, the last year where figures were available, had over 1.1 million people, and over 110,000 people took advantage of the commercial rafting that takes place at the Youghiogheny River.

You say, why should the Commonwealth of Pennsylvania appropriate \$200,000 of its taxpayers' dollars for something in Fayette County?

There is a uniqueness to this amphitheater. It is the only one in the State. It is going to put us in a position where we are going to be able to compete with Ohio and West Virginia, two neighboring States, who already have amphitheaters which are actively participating in dramas. West Virginia, a State not

operation of theirs. The State of Ohio appropriates \$200,000 for its particular operation, which is in southern Ohio.

We are projecting there will be 40,000 people who visit this particular amphitheater this summer running from June 20. 1979 to August 30, 1979, during a production called "The Young Washington."

One of the reasons why the county needs this money, the first year and the first year only, is there is an awful lot of cost in promoting this and there is no sense in having it unless you are going to promote it and actively pursue people to come into the area.

With the projection of 40,000 people taking advantage of this, information received from the United States Travel Data Center estimates that each person will spend \$57 per day while visiting the area. This \$57 a day, multiplied by the 40,000 people, comes out to approximately \$2,280,000, and I think that is a pretty good return on a \$200,000 investment.

There will be professional people hired, Mr. President, to perform so it is going to be on a level of competency that you will enjoy watching. It is something that is going to tie in well with the other historical values in the area.

Mr. President, I would just like to give you some of the costs to the county. For labor cost for the production alone it is over \$107,000. For the props and everything that are needed, it is \$56,000. Administrative salaries and expenses for the project at the amphitheater are projected at \$175,000 annually, Of course, there is postage, shipping charges, the whole bit, and everything else that goes into it.

Mr. President, we are hopeful we are going to receive approximately \$239,000 in revenue from ticket sales. In subsequent years, the sale of tickets is going to, hopefully, even out with the cost of the operation. It is one year, it is a project the State has built, GSA money was used, it was turned over to Fayette County which is a small county. I think the \$200,000 is well spent and would very much appreciate support for the passage of this bill.

Senator HAGER. Mr. President, I guess it will come as no surprise to the Members of this Chamber that I will oppose this special appropriation, this non-preferred appropriation for a brand new category of gifts from the General Assembly of the people's money to other people. I have been opposing on previous occasions special appropriations for County Associations for the Blind or for some other charitable matter and I shall continue to do that.

I think that we kid ourselves when we think we are being charitable by giving away somebody else's money.

Mr. President, I understand the allure of this for the gentleman from Fayette, Senator Lincoln. He and I have discussed it; he knows the reasons for my objection to it. One of the reasons, very frankly, is when one person does this, immediately other Members of the General Assembly figure "Well, if the General Assembly is giving money to the gentleman from Fayette, Senator Lincoln for the gentleman's special project, then they ought to give it to me for mine. If I do not do it, my people will be mad at me for not doing my job."

Mr. President, I, frankly, do not think that is our job. We are

known for its wealth, appropriates \$100,000 annually to the | not grantsmen of the peoples' money to whatever we can get it for in our districts.

> Mr. President, I will oppose Senate Bill No. 1201 on those grounds and on those grounds alone, and I will ask others to join with me in voting "no" on this appropriation.

> Senator BELL. Mr. President, in Delaware County there is Rose Tree Amphitheater. It is run by the County Council. It also has performances not only on weekends but practically every night during the summer. It is in an historical location, immediately adjacent to U.S. 1, and readily accessible to all parts of historical southeastern Pennsylvania. If this bill were to pass I think I would want my little piece of the sugar. Therefore, I am going to vote "no." I would rather send the gentleman from Fayette, Senator Lincoln, this \$200,000 in the form of medical prescriptions for senior citizens.

> Senator SNYDER. Mr. President, to quote the words of the eminent gentleman from Westmoreland, Senator Kelley, "This is a dilemma."

> Mr. President, I think I must vote "no" on this and yet it is without any prejudice to amphitheaters or to the dramatic productions they plan there and certainly no prejudice against Fayette County or the able Senator from that county. I think the danger in this is that we enter into a completely new field in these special appropriations. We have been doing some in the fields of education and health, as we all know. Even those would deserve to be organized and to put under a policy that I think the Legislature as a whole ought to adopt.

> As the gentleman from Lycoming, Senator Hager, said, this is the type of legislation that puts every Member at the mercy of every other Member in a way. I, too, have an amphitheater in my county and a very fine one. I think the moment we pass something like this, we are all somewhat under the gun to do the same thing for our areas.

> Mr. President, I think that should this bill pass—I think some of us should vote against it—it does set a completely new precedent in recent times.

> Senator KELLEY, Mr. President, I, too, have had the general practice predating the activities of the Minority Leader in voting against most non-preferreds. My understanding of the facts and circumstances leading up to Senate Bill No. 1201 is very unique and there is a valid distinction between it and what the gentleman from Delaware, Senator Bell, and what the gentleman from Lancaster, Senator Snyder, say about their amphitheaters. That is, that the Commonwealth is the one that constructed this amphitheater. It is right next to a Federal park, that is for necessity.

> Mr. President, I believe it is incumbent on a one-shot proposition where the Commonwealth failed to complete its job on this amphitheater to do so. I think in terms of what was done by this Commonwealth and we are still in a dilemma, attempting to get rid of a museum that the Commonwealth built and does not know what to do with in the City of Philadelphia.

> Mr. President, we have a dilemma with the gentleman's property in the County of Lancaster where we had a possible loss in the railroad museum equipment into millions of dollars through tax credit that we legislated to preserve and protect.

Mr. President, I do believe there are times and circumstances

peculiar circumstances that require us to deviate from the norm. In this particular case I think there are circumstances that justify an affirmative vote for this, even though many of us are opposed, generally, to non-preferreds in specific instances like this. The facts are different, Mr. President, and justify an affirmative vote and I urge it.

Senator LINCOLN. Mr. President, I appreciate the concern for going into new areas for non-preferred appropriations.

I served in the Body on the other side of this building for six years and I have heard all the arguments for and against nonpreferreds that could possibly exist.

Mr. President, I think the bottom line, in this issue as any other issue that deals with appropriating State funds, is not whether or not you are opposed or for non-preferreds appropriations, but what are the benefits going to be from the dollars that you are appropriating.

Mr. President, I think without question that the benefits from this \$200,000 appropriation can be argued that they will be as well spent or better spent as any of the non-preferred monies that we have appropriated in this year's budget and the past years' budgets.

Mr. President, I want to say I am not going to stand here like others and say that I cried about the non-preferreds—I have looked at them and I have been dismayed at times—but I understand in each district, in each part of this Commonwealth, there are different needs and different wants. I have, for the seven budgets that I have been a party to in this capacity that I serve in, have voted for all non-preferred appropriations. There have been times when I could have been a hero and could have stood at the microphone and criticized and brought out all the reasons why we should not be doing that. In the past I have chosen not to do that and I probably will choose not to do that in the future. I think we have somewhat of an obligation to all portions of the State.

This is one time that I am standing before you asking for the support for my immediate area and also for support of something that is going to have a definite effect on all of the Commonwealth. We do have a tremendous number of visitors coming into the area because of some other scenic and historic parks that are located in the area. We have access to Maryland, West Virginia and Ohio, and we are going to be bringing those people in. They are going to be spending dollars on gasoline, they are going to get the gasoline tax and the sales tax. It is not something that I feel the State will not be repaid for, possibly within the first year. I am not saying to you that I am looking for this appropriation on an annual basis. The start-up cost of this particular operation is too much for a county the size of Fayette to absorb.

Mr. President, I can tell you that we have a Board of County Commissioners that has distinguished itself over a period of twelve or fourteen years that they have been working together in being conservative in their spending, in being conservative in their approach to the taxes and it is Fayette County, I would think, right now could stand head and shoulders with any county in the Commonwealth for the way they are operated. But this is just a little bit too much to ask them to take on in the first year, Mr. President. I have a list of other non-preferred

bills that we have passed this year, they go back No. 16A, 23A, 35A, 37A, 40A, 46A, 62A, 63A, 72A, 73A. There is a Senate Bill No. 1163 right now in the House Appropriations Committee that appropriates anywhere from \$5,000 to as high as \$667,000 for different and various projects that are shared by the Members of the Minority caucus.

Mr. President, I only bring that out because that seems to be where most of the opposition to Senate Bill No. 1201 is coming from. I would ask them to examine their own districts, their votes on money that is spent in their districts. I would like to say to the gentleman from Delaware, Senator Bell, that if he is willing to give up the hundred or so thousand dollars that is spent in Delaware County in non-preferreds for medical assistance, that next year we will be very happy to accommodate him.

Senator ZEMPRELLI. Mr. President, I would withdraw my

The PRESIDENT. Without objection, Senate Bill No. 1201 will go over in its order on final passage temporarily.

PARLIAMENTARY INQUIRY

Senator LINCOLN. Mr. President, I rise to a question of parliamentary inquiry.

The PRESIDENT. The gentleman from Fayette, Senator Lincoln, will state it.

Senator LINCOLN. Mr. President, there is some question in my mind and in the minds of several of my colleagues as to whether a two-thirds vote is required. There is some question as to whether this should have been categorized as a non-preferred appropriation.

Mr. President, it is an appropriation to a municipal government and it is not within the charitable or educational appropriations which generally are categorized as non-preferred.

Mr. President, I think if you check Section 30 of the Constitution—

The PRESIDENT. Is the gentleman citing a section of the Constitution?

Senator ZEMPRELLI. Mr. President, would the Chair be gracious enough to advise me as to the status of the proceedings at this moment?

The PRESIDENT. Senate Bill No. 1201 is over in its order temporarily. There is a question of parliamentary inquiry by Senator Lincoln before the chair.

Senator ZEMPRELLI. Mr. President, would you recognize the gentleman for the purpose of withdrawing his inquiry?

Senator LINCOLN. Mr. President, I would like to withdraw my question of parliamentary inquiry.

Senator ZEMPRELLI. Mr. President, I understand that the gentleman is willing to withdraw his question of parliamentary inquiry based on the fact that if Senate Bill No. 1201 goes over in its order, that he may raise that question at the next Session of this Senate, without prejudice.

The PRESIDENT. That is correct.

Senator ZEMPRELLI. Mr. President, based on that consideration and understanding, I would request that the bill go over in its order.

The PRESIDENT. Without objection, Senate Bill No. 1201 will go over in its order on final passage.

Mr. President, I wish I could be supportive of the program, but the mail I am receiving from my area and the research that I have done on the program, indicates that I should be voting "no" and trying to get these monies to be available for transportation.

Senator FUMO. Mr. President, what this amendment basically does is straighten out some language and allow for some input into the office space situation in the South Office Building. The way House Bill No. 1847, Printer's No. 2273 is presently drafted, it indicates that the space in the South Office Building shall be granted to the General Assembly.

Then it goes on in the next paragraph to say that the Speaker, the Majority and Minority Leader of the House of Representatives shall allocate the space in that office building.

It is my position, and I would hope the position of some of my colleagues, that we should add to that language after the word "Representatives" and the President pro tempore, Majority and Minority Leaders of the Senate. If the space is being granted to the General Assembly, certainly the Senate is a part of the General Assembly, or at least it was the last time I heard. I do not think anyone intends to hamper or impede the space problems in the House, but I think that this Chamber should have some input, be it even if it is just to exercise in an advisory capacity, because we are talking about a building with 90,000 square feet. Mr. President, today when the Senate passed Senate Bill No. 681, that is the prescriptions paid for the older citizens financed from the General Fund, I think we made a great step forward. I was the prime sponsor of Senate Bill No. 437. As I recall, this was co-sponsored by the gentleman from Philadelphia, Senator McKinney, the gentleman from Philadelphia, Senator Lynch, and the gentleman from Delaware, Senator Loeper.

The bill I put in did not have any prepayment, but the \$4.00 fee with this prescription, I think, is far workable. I have not agreed that this is impossible for the State to finance because the gentleman from Philadelphia, Senator Smith, told me last night he understood it would cost around \$30 million a year. There is money to finance it.

Mr. President, now it goes to the House of Representatives. I certainly hope the House of Representatives is as receptive to the older citizens of Pennsylvania as this Senate of Pennsylvania was today.

Once again, Mr. President, we are using General Fund money for our older citizens. But, why shouldn't we? These people as I have said before have paid taxes all their lives, they have worked all their lives. Now when they need help, the Commonwealth should help them. I certainly hope the House of Representatives quickly moves this bill and puts it on the Governor's desk because I think once the Governor realizes the tremendous plight of the older citizen, especially with these prescriptions, I think the Governor might find the money and I think we could have a bright new day coming for the older people of Pennsylvania.
