## SENATE

TUESDAY, January 6, 1981, 12:00 m.

This being the day and hour fixed by the Constitution of Pennsylvania for the convening of the 165th Regular Session of the General Assembly, the Members of the Senate, together with the Senators-elect, chosen at the last General Election, held on November 4, 1980, assembled in the Senate Chamber.

The PRESIDENT (Lieutenant Governor William W. Scranton III) called the Senate to order at 12:00 m., Eastern Standard Time.

It is a distinct honor and a privilege to have with us today two very distinguished judges, Judge Richard B. Wickersham and Judge John P. Hester, both of the Superior Court. ### NEWLY ELECTED SENATORS WELCOMED TO THE SENATE

The PRESIDENT. The next order of business calls for welcoming remarks by the Lieutenant Governor. They will be brief, but I do want to welcome all the new faces, the new Senators here today for the first time. It was two years ago that I was a new face in the Senate. I want to report to you that I have weathered two years of this institution remarkably unscarred and I have enjoyed the opportunity to do so. I welcome you here as new Members of the Senate and look forward with the rest of the Senators to working with you in this coming Session.

I also want to welcome back all the old familiar faces with whom it has been my pleasure to work for the past two years, and I am looking forward again to another two years of a distinguished record of this remarkable institution.

But, more importantly I want to welcome the friends, the families and the supporters of those newly elected Senators who have been sworn in today who are here. You make this occasion a very special occasion. Your presence brings an aura of warmth and support, and a family to the Senate of Pennsylvania, which is indeed welcome. I have rarely seen so much decorum in ceremony of the Senate of Pennsylvania and every once in a while that is particularly important.

Your presence here today is extremely welcome. We are glad to have you and we hope you will come back soon and come back often. All of us in the Senate extend to you our very best wishes to enjoy your day here in Harrisburg, a very special day for those for whom you have come to support and for you who have supported them for so long.

Finally I would like to make a very special introduction. I have for the past two years stood up here while listening to various Members make introductions of their guests and I would like to make an introduction of not only my guests but the guests of the entire Senate. I would like to, at this point, please ask you to rise and I introduce to you the distinguished Governor of Pennsylvania, Dick Thornburgh and his wife, Ginny Thornburgh.

(Applause.)

### ANNOUNCEMENT BY THE PRESIDENT

The PRESIDENT. Before taking up the order of business of electing the President pro tempore and several other officers of the Senate, the Chair would like to continue the practice started a few Sessions ago, that is, if there is only one candidate for each of the several offices or for any of the offices, the Chair will dispense with the calling of the roll and ask for a voice vote on the nomination.

The Chair hears no objection to that procedure.

### ELECTION OF PRESIDENT PRO TEMPORE

The PRESIDENT. The next order of business then before the Senate will be the election of a President pro tempore of the Senate for the 1981 Session. This is in accordance with Article II, Section 9, of the Constitution of Pennsylvania.

The Chair at this time recognizes the gentleman from Blair, Senator Jubelirer.

Senator JUBELIRER. Mr. President, Senate colleagues, families of my Senate colleagues and visitors in the gallery. It is fitting that the first decision we are called upon to make in the new Session—election of a President pro tempore—is one of our most important decisions. In addition to being third in line of succession according to the Constitution, the President pro tempore contributes heavily to the personality and image of this Body and influences greatly the direction it takes.

The gentleman from Lycoming, Senator Hager, is well suited both in talent and temperament for this critical position. In only two terms as Senator, including the last four years as Republican Floor Leader, he has established a

reputation as an outspoken and aggressive advocate who gets things done.

Mr. President, we have witnessed time and again his determination to move forward to a conclusion; his ability to force an issue and forge a consensus; his willingness to work with all and demonstrate fairness and equity; his dedication to stay at the job until the desired end is realized; and finally, Mr. President, his ability to begin with a dream or a vision and to strive to make those dreams and visions come true, all requisite qualities of the top position of the Senate.

His qualifications rest not on duration of service, but on the record of leadership and achievement he has built, a record crowned by the perseverance that led to the adoption of many pieces of landmark reform legislation that many felt could never make it.

Mr. President, if we are to find solutions to pressing problems in the coming months, we will need as President pro tempore an individual who can work with the Members and Leaders of both caucuses, one who can subordinate partisan considerations on behalf of the general good, one who would choose conciliation over confrontation at those critical times. In Henry Hager, we have such a person. We appreciate and respect the tireless devotion he brings to this Body.

Mr. President, I would be remiss if I did not also acknowledge the tremendous sacrifices made by his wife, Sally, and his daughters, Hanna and Eleanor, as Merc plays such a large part in the operation of the Senate.

Mr. President, it is an honor and a privilege to offer in nomination the name of an outstanding human being, an understanding leader, one who surely will continue this Body's tradition of great leadership, Senator Henry G. Hager of Lycoming County for the office of President pro tempore of the Senate of Pennsylvania.

Senator STAUFFER. Mr. President, in addition to all of the things that the gentleman from Blair, Senator Jubelirer, said about the gentleman from Lycoming, Senator Hager, I would like to add that the gentleman is one who has proven his dedication to the Senate of Pennsylvania, a most important attribute. I know that every one of us, every one of our fifty Members, can count on him to be an impartial administrator and to represent this Body with both honor and dignity. Mr. President, the gentleman has genuinely earned the position to which we nominate him today.

Mr. President, I am pleased to second the nomination of the gentleman from Lycoming, Senator Henry Hager, as President pro tempore of the Senate of Pennsylvania.

Senator HOWARD. Mr. President, I suppose only a person who has had to endure the phenomena that is known as a legislative caucus really understands the unusual term implied by the title of legislative leadership. The fact that in the gentleman's four years since he has been the Republican leader in the Senate, that Senator Hager has been able to bring some order out of that frequent chaos, has been able to give both focus and direction to the contributions that the Republicans have made to this Body, I

think speak more eloquently to his qualifications to hold the office he seeks than any possible words that we can add to that.

Mr. President, the fact that the gentleman seeks the office causes many of his friends to be a little concerned for his sanity, but the fact that he does seek it means that we can think of no better person to fill it and I certainly second his nomination with enthusiasm.

The PRESIDENT. Are there any other nominations or seconds?

Senator ZEMPRELLI. Mr. President, Governor and Mrs. Thornburgh, my distinguished colleagues of the Senate, friends of Senators, and friends of the Senate, it is a great privilege to rise today and place in nomination a colleague for the position of President pro tempore of the Pennsylvania Senate. This is a position of great honor and great distinction, a position that we should fill with a man who combines the qualities of experience, wisdom, tolerance and gently manners.

Mr. President, I am sure that if each of us were to search our souls, we would know there is one man among us who meets all of these qualifications, and who has demonstrated all of these qualities over the past decade.

Mr. President, he has served the General Assembly of Pennsylvania and the citizens of this Commonwealth with a distinguished career that has transcended five decades beginning in 1945. The gentleman has served this Chamber as President pro tempore for the last decade, longer than any other man in the history of the Senate. During that decade he has presided over a Chamber which has gone through the most significant period in its entire history.

Mr. President, some of us who served with him in this past decade, each could give adequate testimony to the many improvements in the Pennsylvania Senate that he has fostered. It is inevitable—and I know the change will continue—and I realize that in making this nomination that the decisions made in November by the voters of Pennsylvania will bring great changes to this institution.

Mr. President, I feel constrained to make this nomination not out of partisan politics or considerations, nor in any way to mar these proceedings for those who were victorious in November.

Mr. President, I hope that I am successful in making this nomination in the same gentlemanly manner that has so distinguished the career of the gentleman I am nominating. In a sense my reasons were expressed by one of the youngest Members in November, a man who is not here today, but who dearly loved this institution for the four years that he served as a Senator. The gentleman ended his farewell speech to his colleagues knowing that he would not be here today by saying, "Marty, you will always be President pro tempore to me."

Mr. President, we recognize the inevitable without rancor but we are saddened. I feel it is important that we reaffirm our appreciation of the particular dedication to the Senate of Martin L. Murray. Therefore, Mr. President, I nominate the Honorable Martin L. Murray of Luzerne County for

the position of President pro tempore of the Senate of Pennsylvania.

Senator SCANLON. Mr. President, if you can see me behind the floral display of the gentleman from Allegheny, Senator Romanelli—doesn't he look peaceful? It takes an awful lot of flowers to cover me.

Mr. President, it is my honor and privilege to second the nomination of the gentleman from Luzerne, Senator Murray. As usual the gentleman from Allegheny, Senator Zemprelli, has taken ninety per cent of my speech and what I was going to say.

Mr. President, I would like to reiterate that the gentleman from Luzerne, Senator Murray, did come to the General Assembly in 1945 and has served a veritable lifetime to the improvement of this General Assembly, the State of Pennsylvania, and has dedicated a lifetime to the people of this State.

As was stated, he has been the pro tempore here for ten years. As was stated, and in my opinion, he will always be the pro tempore.

Mr. President, one thing Marty always stated was that he wanted to take care of his Senators. He referred to all of us, Republicans and Democrats alike, as his Senators. His door was always open to everybody on both sides and he provided a dignified leadership.

Mr. President, there is no question that the working conditions for all of us including staff and research and the ultimate product that we have produced has improved during the ten years that the gentleman from Luzerne, Senator Murray, was pro tempore. Without demeaning anybody and without being partisan, as has been stated, I consider it a privilege and an honor to second the nomination of Senator Martin L. Murray of Luzerne County for the office of President pro tempore.

#### NOMINATIONS CLOSED

The PRESIDENT. Are there any other nominations or seconds? The Chair sees none and the Chair will now declare the nominations for President pro tempore closed.

On the election of the President pro tempore the Clerk will call the roll and the Secretary and the Chief Clerk will act as tellers. The candidates for the office of President pro tempore are the Honorable Henry G. Hager of Lycoming County and the Honorable Martin L. Murray of Luzerne County.

As your name is called, please state the name of the candidate for whom your vote is to be cast. The Clerk will call the roll.

The PRESIDENT. The Honorable Henry G. Hager having received twenty-six votes, the Honorable Martin L. Murray having received twenty-two votes, the Chair declares The Honorable Henry G. Hager duly elected President pro tempore of the Senate of Pennsylvania.

#### SENATOR HENRY G. HAGER UNANIMOUSLY ELECTED PRESIDENT PRO TEMPORE

Senator ZEMPRELLI. Mr. President, the election not having been a surprise and one of the few things that has not been a surprise in the last two Sessions, I would move at this time, Mr. President, that the vote by which Henry G. Hager was made President pro tempore of the Senate be made unanimous.

The PRESIDENT. It has been moved by Senator Zemprelli that the vote by which Senator Henry Hager was made President pro tempore of the Senate be made unanimous.

Senator MURRAY. Mr. President, I second the motion.

The motion was agreed to.

The PRESIDENT. Senator Hager is unanimously elected President pro tempore of the Senate of Pennsylvania. (Applause.)

#### COMMITTEE APPOINTED TO ESCORT PRESIDENT PRO TEMPORE-ELECT TO THE ROSTRUM

The PRESIDENT. The Chair now takes pleasure in appointing the following committee to escort the President pro tempore to the rostrum for the administration of the oath of office:

The gentleman from Blair, Senator Jubelirer; the gentleman from Chester, Senator Stauffer; and the gentleman from Allegheny, Senator Zemprelli.

The committee will proceed to the performance of their duty.

(Whereupon, the President pro tempore-elect was escorted to the rostrum of the Senate.)

#### ADMINISTRATION OF OATH OF OFFICE TO PRESIDENT PRO TEMPORE-ELECT

The PRESIDENT. The oath of office will be administered to Senator Hager by Judge Wickersham, Judge of the Superior Court.

(The oath of office was administered accordingly.)

The PRESIDENT. Please be seated. It is now an honor and a privilege for me to present to you the President pro tempore of the Senate of Pennsylvania, Henry G. Hager.

(Applause.)

#### REMARKS BY THE PRESIDENT PRO TEMPORE

The PRESIDENT pro tempore. Mr. Stevenson, thank you very, very much for coming today. Bishop Stevenson is the Bishop of my church, but as he sees me almost as regularly in the Senate as he does in church, I think it is wonderful for him to come. This, incidentally, is the first time we have seen each other in the Senate Chamber.

Governor and Mrs. Thornburgh, I am particularly pleased that you would join us. I noticed, Dick, that there was a terrific round of applause when Ginny was introduced and I think it must be wonderful to be married to such an admired lady. I assume that at least fifty per cent of it was for you. I want to tell you that for my colleagues here in the Senate, and I am speaking as a representative not only of them but of virtually everyone who has been felled by the flu this last week or two, that we are deeply honored that you would come. We look forward to the next two years as a real true partnership, not to exclude the third branch of government, but between our two co-equal branches, and I know that we will continue without any difficulties such as we had the last two years.

Seriously, we are all very, very proud of you as Governor. You have been fantastic in that job and we look forward to you continuing in what I consider to be the loneliest job in the State. Something the gentleman from Lebanon, Senator Manbeck, told me four years ago, that there was no lonelier job, and I think the gentleman is right. For any one of us, there are forty-nine friends and colleagues with whom to work and with whom to deliberate. We know how lonely it is to have a co-equal branch in your control alone and we think you have handled it with real distinction.

Judge Hester and Judge Wickersham, thank you both very, very much for coming. We are honored to have the Superior Court here. It is, of course, a distinct pleasure for me to have "Wick" here because I had the pleasure of campaigning for his election, although Judges, of course, are not in politics, we all know that. Nonetheless, it was a pleasure to campaign with you and particularly Joanne, who is one of the loveliest ladies I know.

To the Members of the Senate, there is a change coming, hopefully, it will be a change over me. You have heard the words of Bob, "not confrontation but conciliation." May I suggest to you that it will be my new watchword and working from a different posture now, I think you will find that my approach will be much, much different.

Members of families and friends of the Senate, I cannot really add to Bill Scranton's very eloquent welcome to you. I must comment, Bill, that it was not kind to say that you have rarely seen such decorum in the Senate. Usually there are only fifty of us here, and you know that we are always as well mannered as we are at this very moment.

Last, but not least, Bill, I address these comments to you as well. I know of no one who in two years has so endeared himself to the people over whom he presides as you. You came to us very young. You grew very quickly old. I think

that I speak for all fifty Members of the Senate of this last two years when I say that you are, frankly, beloved by the Senate of Pennsylvania.

Now, we have two other people whom I would like to introduce to you before I ask Marty Murray to join me here at the desk. I would like to introduce the Treasurer of our Commonwealth, if I can find Bob Casey—oh, here he is. Robert Casey, would you please stand?

(Applause.)

The PRESIDENT pro tempore. You have heard that Senator Martin L. Murray has been the President pro tempore of the Senate of Pennsylvania for the last ten years. His immediate predecessor, Senator Robert D. Fleming is here. Bob, where are you? Will you please stand?

(Applause.)

The PRESIDENT pro tempore. I believe everyone in attendance here today can understand that this is a day of particular significance to my party, representing as it does, the point at which we have come to Majority status after ten years in the Minority. It is a responsibility we have sought. We accept it with a sense of determination to act constructively and only in the best interests of Pennsylvania and her people.

In a few minutes we shall be electing a new Secretary of the Senate, a new Chief Clerk of the Senate, and resolving to defer the election of a Librarian of the Senate. We do these things with the expressed purpose of making management studies of the operations of all three of these service offices and of introducing legislation to abolish the office of Librarian.

There will be other changes which we shall recommend, I am sure. None of them, however, should necessarily be viewed as criticisms of past management under the Democratic caucus. On the contrary, we shall be consulting with Democratic Leadership and past committee chairmen, actively soliciting their experienced views about changes which will help the Senate be of more service to all of those whom we have been elected to serve.

We expect the Minority party to be a full participant in helping to resolve all of the problems which lie ahead. The competition of ideas between the two parties has been one of the key elements in making our form of government unique. It is this competition which provides a resistance to excess. It is this competition which spawns new ideas and innovative approaches. There can be little question that our quest for innovation as a Minority has contributed to our now being in the Majority. We expect, and we will welcome, innovative proposals from the new Minority because the people of this State will be the ultimate beneficiaries of that kind of competition. It is my hope that we can hold partisanship for its own sake to a minimum. In the first speech that I ever made in the Senate on February 13, 1973 I suggested that we take a party position only when it is also a philosophical position. That is still a sound idea and I hope we shall all try to live by it.

Although we shall welcome Minority proposals, that does not mean that our new Majority intends to rest on its laurels. On the contrary we shall continue to build upon our record of the recent past. Our caucus is made up of many talented and dedicated Senators. It has been very much a team effort. They have demonstrated ability as creative thinkers. We have developed a talented staff of equally dedicated people who provide excellent support service to all of us. We intend to continue the process of developing new solutions to old problems. We shall be no more docile in the Majority than we ever were in the Minority. The electorate has given us the responsibility to lead and we intend to exercise it.

Pennsylvania has many problems which have accumulated over a long period of time. Because many of them are complex, there will be no "quick fixes." Solid progress, however, can and must be made.

We are a mature State compared to those in the Sun Belt with which we must compete. Some of our problems are a product of that maturity. Some of them are caused by actions of government taken years ago which may have suited the environment then but have become problems themselves in the environment of today. The Federal Government has tilted its efforts to the Sun Belt and part of President-elect Reagan's transition staff recommendations accept the resultant economic shift as a natural development. It is not natural. It was artificially created and the northeast which is still the population, manufacturing, service and financial center of the world, must reassert itself in the halls of Congress.

Our responsibility in Pennsylvania State Government must be not only to accept an active role in the Washington effort for the northeast, but also to do whatever must be done to insure that the benefits which inure to the northeast because of those efforts also inure to Pennsylvania.

In my view, rejuvenating the economy of our State must be our number one priority. We cannot afford to ignore the losses of job opportunity which have taken place over the last decade. The opportunity for productive and dignified employment is one which must be provided our people. It is essential to accomplishing the goal of making Pennsylvania a better place to live. It is paramount in encouraging our young people to spend their productive lives in their native State. It is basic to the creation of a strong and vibrant society.

Government has a preeminent role in achieving that goal. Incentives must be found to attract more investment in Pennsylvania by the private sector. That creates jobs. Disincentives must be identified and eliminated to the degree possible without abandoning legitimate concerns for social problems which a sensitive society must recognize.

We are a people who want to provide help and services to those among us less fortunate than we. We want to help with food, housing, health care, education and in many other ways. To be able to do so, however, we need a healthy economy in Pennsylvania. None of what we hope to continue to be able to do can be done without a strong

base, an expanding base of people earning a living at productive, dignified jobs.

Much of what must be done will not be easy. Everything contained in our existing law got there because interest groups persuaded a majority of some past Legislature to put it there. Change is certain to be resisted by some who may not have the broadest interest of Pennsylvania at heart. Nevertheless, change will have to be attempted. The alternative of accepting the status quo may be the easier and more comfortable path, but that cannot be considered to be a discharge of the responsibility which has been given us.

I do not intend today to discuss specifics about the program which we will advocate. This is a ceremonial day which should not be used for that purpose. Very soon, however, we shall be outlining an initial program in some detail. There will be opportunities enough for genuine progress, if we seize them.

I want to close with several personal comments. Your election of me to this very important office of President pro tempore is now, and will always be, one of the high points of my life. It is an office which is rich in tradition and in history. It is a constitutional office. It has been occupied by some of the most talented and dedicated men who have served in this Chamber. In that regard, I want to extend special recognition to my immediate predecessor, Senator Martin L. Murray of Luzerne County.

Senator Murray has established a pattern of fairness during his tenure in this high office which will be difficult to match. Although it may come as a surprise to some of my friends on the Democratic side, I intend to try. I am fully conscious of Senator Murray's example of service to the entire Senate. I intend to be as evenhanded as I can be in providing assistance to every Senator. Senator Murray managed to do this without ever abandoning his partisan principles. When this Session ends two years from now, I hope all of you will feel that Marty Murray's example was not lost on me.

I want to express my appreciation publicly to Senator Murray for his cooperation during the transition time. His gentlemanly style has helped to make the period, difficult for all of us, very much easier.

I look forward to a very exciting and productive Session. I pledge to each of you my energy and my dedication toward making the next two years memorable ones in the long history of the Senate which we serve: two years in which we contribute something of lasting value to the Commonwealth of Pennsylvania.

I have grown to love and respect this institution and the people with whom I serve. These past eight have been the most meaningful of my forty-six years. It is my hope and my intention that, during these next two years, we become even closer as friends and as members of a winning team engaged in a crucial struggle for the future of our Commonwealth.

With dedication, with purpose and with optimism about the future and our ability to improve it, let each of us



determine here today, at this moment of beginning, that we will build a record in which we can take justifiable pride, a record which will prove to be a period of progress for the people who have given us their trust.

I hope this new year will be one of personal gratification for all of us as we begin the important work which is ours to do.

(Applause.)

### PRESENTATION TO SENATOR MARTIN L. MURRAY

Senator HAGER. Will Senator Murray please come to the desk? Everything which has been said about Senator Murray in his nominating speech by Senator Zemprelli and in the comments of the seconding speech by Senator Scanlon, are joined in by my colleagues. It has been an exceptional ten years. Senator Murray, all of the Members of this last Session of the Senate have gone together and have asked me to present to you a silver tray which says "In recognition of a decade of public service by Martin L. Murray as President pro tempore of the Senate of Pennsylvania from January 1971 to January 1981 presented by his colleagues January 6, 1981," and it is then engraved with the names of all of the Members of the Senate for the Session 1979-1980.

Now, I know I am not supposed to say this, Marty, but what Mike Schaefer said and what Ed Zemprelli has quoted Mike Schaefer as saying and what Gene Scanlon has said for himself, darn it, I find true for me as well. I know we have a new President pro tempore, and I shall try in every way to be one, but I am afraid for me too you will always be President pro tempore.

(Applause.)

Senator MURRAY. Senator Hager, I want to congratulate you and tell you that you will have the cooperation of our side of the aisle.

I am honored to welcome Governor Thornburgh and Mrs. Thornburgh here today, along with the distinguished Judges, Bishop Stevenson and all our guests. It is a great privilege to be President pro tempore.

(Applause)

The PRESIDENT. Ladies and gentlemen, at this time the Senate will be at ease for a few minutes for the purpose of taking some pictures. If you want to take the opportunity to stretch your legs for a minute, that is fine with us.

(The Senate was at ease.)

He also doubles as our parliamentarian and sometimes chaplain. The extent and quality of his work is a matter of wonder to all of us. Though he works long hours at top efficiency, his good humor never fails him. His squibs on our calendars have become famous. But important as his work has been to the Senate, it is his wise counsel and friendship that has meant more to Senators. It is difficult to believe that the Senate can continue to operate and the Senators function without him. It is with deep regret that we accept the fact of his retirement though we must respect his desire to complete his long tour of duty; now therefore be it

RESOLVED, That the Senate of the Commonwealth of Pennsylvania express our gratitude for his many years of truly outstanding service to the people of Pennsylvania, wish him many years of pleasant leisure, and say to him "Mark, you will be sorely missed;" and be it further

RESOLVED, That a copy of this resolution, sponsored by Senator Martin L. Murray, on behalf of all Senators, be transmitted to Mark Gruell, Jr.

### ELECTION OF SECRETARY OF THE SENATE

The PRESIDENT. The next order of business will be the election of the Secretary of the Senate.

Senator STAUFFER. Mr. President, I think the resolution that we just adopted is indicative of the unusual circumstance that we face here today because for so many years the position of Secretary of the Senate of Pennsylvania has been taken for granted.

I doubt that any Member or anyone else present today can remember anyone other than Mark Gruell in the position of Secretary of the Senate which he held for such a long time.

Mark Gruell literally grew up in this Senate and he truly dedicated his life to it. His expertise was so great that it became a challenge to find a replacement. In thinking about our needs and preparing a job description, if you will, I found that there was a need for four special qualifications beyond the normal ones for a very, very responsible position in the private sector.

First, the person must be evenhanded in dealing with fifty individual Senate Members and have a familiarity with our needs.

Second, as our parliamentarian, he must be educationally qualified and be eminently fair because we certainly must have a parliamentarian who is completely and totally fair in every respect.

Third, Mr. President, he must have a full acquaintance with the interior workings of the Senate and we, as Members, certainly know that our workings are unusual and totally unlike those that would be normally encountered.

Fourth, and of extreme importance, he must have an abiding interest in the institution of the Senate. This is critical because we as Members of the Senate come and go but those who serve in the key staff positions must be dedicated to this institution and to its preservation and elevation as the years move forward.

Mr. President, with a job description like that, I think, many would be prone to say that there is no one who exists who can meet that kind of a job description. I must say, Mr. President, we wrestled with the question for many days. As is so often the case where you cannot see the forest for the trees, we found the person very close to us who could meet that job description and who could fill those needs. He had to be convinced to consider the position. As you all know our former colleague, Senator Thomas Andrews did not seek reelection. In our last Session in November he bid us a very emotional goodbye and left for other challenges. When I first spoke to him about the consideration of the Secretary's position, he was not only surprised but he was also in a state of near shock and, in fact, a couple of the remarks he made I dare not repeat. When you apply that job description standard to Tom Andrews, he comes through with flying colors. He is all of the things needed in this position and is available to us to fill a large pair of shoes that are being vacated.

Mr. President, I know from my years of service with him here in the Senate, as well as my personal association with him, Tom will distinguish himself as our Secretary. Therefore, Mr. President, it is my honor and a personal privilege to nominate The Honorable W. Thomas Andrews of Lawrence County as Secretary of the Senate of the Commonwealth of Pennsylvania.

Senator SHAFFER. Mr. President, members of the Clergy, the Judiciary, fellow Members of the Senate, ladies and gentlemen, I can think of no greater honor and no greater pleasure for me, as the Senator from Butler and Lawrence Counties, the Twenty-first District, to approach this microphone for the first time in my career for the purpose of seconding the nomination of Senator W. Thomas Andrews for Secretary of the Senate.

As many of my colleagues know, he is my immediate predecessor as representative from Butler and Lawrence Counties and as the gentleman from Chester, Senator Stauffer, has said, voluntarily chose not to seek re-election.

Mr. President, I need not tell those of you who have served with Senator Andrews about his devotion to duty, his diligence to affairs concerning the public weal, nor do I need to reiterate to you because you know full well how fair and honest he has been and how fair and honest he will continue to be as Secretary of this Body.

Mr. President, I can only bring to your attention quickly and simply but yet with all heartfelt emotion, that the same love and respect which many of you in this august Body have for Senator Andrews is felt by those of us who live in Butler and Lawrence Counties, the area that he so ably and so dedicatedly served for eight years.

Mr. President, it is with all pleasure and respect that I second this nomination.

The Chair will now declare the nominations for Secretary of the Senate closed. The candidate for the office of Secre-

tary of the Senate is former Senator W. Thomas Andrews of Lawrence County.

The PRESIDENT. The Chair declares Tom Andrews unanimously elected Secretary of the Senate.

#### ELECTION OF CHIEF CLERK OF THE SENATE

The PRESIDENT. The next order of business before the Senate is the election of the Chief Clerk of the Senate.

Senator JUBELIRER. Mr. President, I am privileged to nominate Stanley I. Rapp of Dauphin County to the office of Chief Clerk of the Senate. Stan Rapp is a graduate of my alma mater, The Pennsylvania State University. He has served for more than two years as a Republican staff administrator. In this position he has been well schooled in the complex procedures and systems which play an often unnoticed but undeniably integral role in the smooth operation of the Senate. His knowledge of the inner workings of the system, his incomparable administrative expertise, and his immense dedication to the past recommend Stan as an individual who can capably fill the office of Chief Clerk in this difficult period of transition.

Mr. President, I take great pleasure in nominating Stan Rapp to be Chief Clerk of the Senate of Pennsylvania.

Senator GEKAS. Mr. President, I can only endorse the comments and recommendations of the gentleman for Blair, Senator Jubelirer, but that would not suffice in this particular nomination.

Mr. President, I wish to add to the specifics of the qualifications of Stan Rapp that in the brief time that he has been involved in government he has developed what in all of us, I am sure, is a part of us and that is a great esteem, a feeling of respect for the institution which he has served and which he will serve in his new capacity.

Mr. President, that esteem, that respect, I am sure, will ever grow as he devoted his energies and his capabilities and his youth to the task at hand.

Mr. President, I second the nomination of Stan Rapp.

## ADMINISTRATIVE RULES REPORT

TO THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA:

I am pleased to submit to the General Assembly these storm water management guidelines and model ordinances as directed by Section 14(b), Act of October 4, 1978 (P.L. 864, No. 167), known as the "Storm Water Management Act", and under the procedures provided in the Act of April 7, 1955 (P.L. 23, No. 8), known as the "Reorganization Act of 1955".

The Storm Water Management Act is a major step toward stabilizing Pennsylvania's flooding problems. Flood control projects designed in years past are losing their effectiveness as new developments increase the rate and quantity of storm water entering our streams. In Pennsylvania intensity of land use has caused a sharp rise in the number of flooding events. Since 1936 Pennsylvania has suffered 18 major floods accounting for total damages in excess of 5.8 billion dollars. Although there is a tendency to look upon the great floods, such as 1936 and 1972, as remote and unprecedented events, the fact is that serious and moderate floods frequently cause extensive, localized damage to communities throughout the Commonwealth.

Storm water management is concerned with the planning, design and management of the flow and storage of surface waters resulting from large and small storms, including consideration of water quality and interaction with ground water.

The storm water management plans will stabilize the quantity and velocity of storm water which enters our streams. The plans will help to prevent downstream flooding, stream channel erosion and resulting siltation, provide a balance for existing biological habitat in streams, maintain or increase the flow to ground water and reduce the amount of non point source pollution.

Approval of these guidelines will give assistance to counties and local governments facing the increasing problems of accelerated storm water runoff. By passing the Storm Water Management Act, the General Assembly determined that proper storm water management is fundamental to the public health, safety and welfare and the protection of the people of the Commonwealth, their resources and the environment.
