The Senate met at 1:00 p.m., Eastern Daylight Saving Time.

THE PRESIDENT (Lieutenant Governor William W. Scranton III) in the Chair.

PREFERRED APPROPRIATION BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 929 (Pr. No. 1045) — Considered the third time and agreed to,

On the question, Shall the bill pass finally?

Senator LEWIS. Mr. President, I rise to support Senate Bill No. 929 and do it with the anticipation the vote today may be significantly different than that of a few weeks ago when I offered an amendment to add \$3 million to the community college appropriation, at which time all twenty-six Members on the other side of the aisle chose to vote in opposition to that amendment. It appears as if the need as described at that time is or will now be recognized by all of the Members of the Senate and for that I will be thankful.

Unfortunately, Mr. President, the four-month delay in providing this necessary funding has caused a great deal of difficulty and consternation not only for the administrators of our State colleges throughout Pennsylvania, but also for the students whom they serve, our constituents. Unfortunately because of the inability to plan with any certainty, it has been suggested to me that there have been tuition increases that have been necessitated at a number of the colleges, some of which may have been postponed, or at least reduced in terms of their impact, had we taken what I think would have been the responsible steps of putting this money and providing this money in the General Appropriation budget in June as we should have done.

Notwithstanding that, however, Mr. President, as I said, I think we anticipate a major reversal in terms of the previous position of many Members of this Senate and certainly albeit late in time the community college students of Pennsylvania deserve and need this funding.

I also make the observation that the action which I anticipate this Senate will take in just a few minutes will appear to fly directly in the face of the recommendation made by the Governor two weeks ago for an across-the-board cut of one per cent in all General Fund appropriations. As I believe we know, Mr. President, and my colleagues here, I have very strongly criticized that approach for handling our budget matters in Pennsylvania in particular because there are special needs such as this community college need and I think our obligation as it is being shown here is to structure priorities and to deal individually with the needs as they may require,

rather than just trying to brush across all items and treat them identically.

Senator HOWARD. Mr. President, I would like to point out only this is not a State college, this is the community college system we are talking about. These are not discretionary funds, discretionary in terms of their ability to be regulated by the Administration or anyone else, but this \$3 million is hard money that is owed under a formula that has been imposed by law and is not the product of the discretionary judgment of the Administration. Senate Bill No. 929 simply fulfills that legal obligation.

#### BILL OVER IN ORDER

SB 618 (Pr. No. 1182) — Senator SCANLON. Mr. President, at this time I would request the Chair reconsider its action on Senate Bill No. 618, in which it granted the request of the gentleman from Blair, Senator Jubelirer, to go over the bill in order.

Mr. President, we would like to assert an objection to having that bill go over in its order.

The PRESIDENT pro tempore. The Chair reverses its ruling that Senate Bill No. 618 go over in its order without objection and treats the remarks of Senator Scanlon as an objection. Senator Jubelirer, if it is still your wish that Senate Bill No. 618 go over in its order, you will now have to make that in the form of a motion.

Senator JUBELIRER. Mr. President, the issue before us now on Senate Bill No. 618, is whether or not it goes over again. Then, Mr. President, at this time I move that Senate Bill No. 618, Printer's No. 1182, go over in its order.

On the question,

Will the Senate agree to the motion?

Senator SCANLON. Mr. President, may we have a roll call vote on the motion to have Senate Bill No. 618 go over in its order? I urge the Members of the Democratic caucus to vote "no."

Senator JUBELIRER. Mr. President, we ask all Members of the Senate to vote to put this bill over. The reason is very basic. There is some question as to the correctness of the figures in this bill. We are waiting to verify that in writing and we feel it would be most responsible at this time to put the bill over. I do hope all Members will vote to put Senate Bill No. 618 over.

Senator LEWIS. Mr. President, I am interested to hear the comments of the Majority Leader about a question on the figures and would hope the gentleman would be kind enough to share the dilemmas that seem to be confronting us with me so we might also then have the opportunity to look into whatever these problems might be. I am not aware of any difficulty with the figures. In fact, for the information of the Members, this happens to be the very same bill and the very same Federal augmentations that were before us before we broke for summer recess. The development of these numbers is not something that has just happened. It is something that was done for many months and, in fact, the bill specifically and exclusively deals with supplemental Federal augmentations for the 1980-1981 fiscal year. Mr. President, if there are, in fact, problems with the numbers, I think we better get them resolved very, very quickly.

The concern and the reason for passing Senate Bill No. 618 now in a timely fashion, Mr. President, really comes about because of two concerns I have. One is the fact there have been many months that have now elapsed since the time when we rightfully should have funded these programs. Expenditures have been made, the reimbursements are long overdue and it should have been the responsibility of this General Assembly to have attended to this business before we broke for the summer. There have been difficulties that have arisen because of that, none of them serious fortunately, but there is no reason for us to continue to delay unless, as the fears and suspicions have been raised on the part of some, it is the intention to use this bill through the vehicle of forcing it into a Committee of Conference as the method for implementing other Federal augmentation changes which will need to be made by this Administration.

Mr. President, I certainly hope that is not the plan that is afoot here because these supplementary appropriations should be dealt with on their own, as the new appropriations likewise should be given a full and complete airing by the General Assembly and not simply be rammed into a —

### POINT OF ORDER

Senator JUBELIRER. Mr. President, I rise to a point of order.

The PRESIDENT pro tempore. The gentleman from Blair, Senator Jubelirer, will state it.

Senator JUBELIRER. Mr. President, is the gentleman from Bucks, Senator Lewis, not out of order? I think we are debating whether the bill goes over, not something that the gentleman speculates might be forthcoming in the future. I think the only thing before us is whether Senate Bill No. 618 should go over in its order.

The PRESIDENT pro tempore. The gentleman will please confine his remarks to the propriety of the bill either going over or being run.

Senator LEWIS. Mr. President, fortunately the propriety of actions can frequently be determined by all of our past experiences in the way the Legislative process really works and it was to that experience I was addressing my comments.

I think the point is well made, Mr. President. There is no reason for us to delay any further. If there are questions which the Majority Leader believes are legitimate ones that would require the gentleman to insist upon a negative vote today, I would know of no reason why those questions cannot be cleared by our first return, whether it be tomorrow or Tuesday of next week, and would certainly hope that even if my request to have Senate Bill No. 618 not go over today is not concurred in by my colleagues that we would then all make the commitment to move this bill immediately as a propriety upon our return on our next legislative day.

I have been led to understand that it is the position of the Chairman of the Committee on Labor and Industry that he will consider that issue in a separate bill and he is optimistic that his committee will report out such a bill with his support that would restore the benefit with regard to pension offset but a, would be funded, and b, would not be funded with a tax. I just wanted to make sure we had that

commitment from the Chairman so that I can forestall debate and withdraw the idea of introducing amendments.

Senator KUSSE. Mr. President, I, of course, can only speak for myself when it comes to talking about pieces of legislation that will be reported from committee. I previously assured the gentleman from Philadelphia, Senator Fumo, and I now reassure him that I will indeed call up for consideration a bill that will consider the pension offset, and I will vote affirmatively on it and I will urge all of my colleagues to vote in the affirmative. As I told the gentleman from Philadelphia, Senator Fumo, it will of course have to be predicated on no increase in taxes.

Senator FUMO. Mr. President, knowing the power of the gentleman from Warren, Senator Kusse, I am very optimistic that the gentleman's position will greatly help our cause in that area. I have no further questions of the gentleman from Warren, Senator Kusse.

Senator MELLOW. Mr. President, may we be at ease for just a moment?

The PRESIDENT pro tempore. The Senate will be at ease. (The Senate was at ease.)
