The Senate met at 2:00 p.m., Eastern Standard Time.

PENNSYLVANIA FROM THE NATIONAL
INTERCITY TRUCK ROUTE NETWORK AND
PENNSYLVANIA DEPARTMENT OF
TRANSPORTATION TO TAKE ACTION TO
RESTRICT THE USE OF TWIN-TRAILER
COMBINATIONS ON PENNSYLVANIA HIGHWAYS

Senators KUSSE and LYNCH offered the following resolution (Senate Concurrent Resolution No. 43), which was read and referred to the Committee on Transportation:

In the Senate, April 15, 1983.

A CONCURRENT RESOLUTION

Memorializing the United States Secretary of Transportation to remove certain highways in Pennsylvania from the National Intercity Truck Route Network and Pennsylvania Department of Transportation to take action to restrict the use of twintrailer combinations on Pennsylvania highways.

WHEREAS, The Surface Transportation Assistance Act of 1982 and the Department of Transportation Appropriations Act of 1982 prohibited states from banning twin-trailer combinations on the Federal Highway System and certain other qualifying Federal-aid highways; and

WHEREAS, Under this Federal legislation individual states, being most familiar with their highway systems, including the structural capacity of bridges and pavements, traffic volumes and climatic conditions were given responsibility for recommending those highways within their borders that should be included in the National Intercity Truck Route Network; and

WHEREAS, The Pennsylvania Department of Transportation submitted to the United States Department of Transportation a plan recommending that certain Pennsylvania highways in addition to the Interstate Systems be included in the network; and

WHEREAS, The United States Department of Transportation included approximately 1,800 miles of Pennsylvania roads and highways in addition to those recommended by the Pennsylvania Department of Transportation in the National Intercity Truck Route Network, and thus permitting twin-trailer combinations to operate on them; and

WHEREAS, These additional roads and highways include segments that feature undivided roadways, hazardous grades, narrow lanes, three or fewer lanes, areas of high population density and traffic density and other highways that are not as described or contemplated in the Federal legislation; and

WHEREAS, The presence of twin-trailer combinations on the additional roads and highways is a serious hazard to the safety of Pennsylvania citizens; therefore be it

RESOLVED (the House of Representatives concurring), That the General Assembly of the Commonwealth of Pennsylvania memorialize the United States Secretary of Transportation to revise the National Intercity Truck Network to conform to the original plan proposed by the Pennsylvania Department of Transportation; and be it further

RESOLVED, That the General Assembly direct the Pennsylvania Department of Transportation to take all reasonable action

to restrict the use of twin-trailer combinations on Pennsylvania highways; and be it further

RESOLVED, That a copy of this resolution be transmitted to the United States Secretary of Transportation, the Pennsylvania Secretary of Transportation and to each member of Congress from Pennsylvania.

Senators STAPLETON, ZEMPRELLI, SCANLON, SINGEL, KELLEY, REIBMAN and MELLOW offered the following resolution (Senate Concurrent Resolution No. 44), which was read and referred to the Committee on Transportation:

In the Senate, April 18, 1983.

A CONCURRENT RESOLUTION

Memorializing the United States Secretary of Transportation to rescind the section of the Federal Highway Administration truck size and weight policy statement of April 5, 1983 requiring Pennsylvania to add additional mileage to permissible routes for twin-trailer trucks.

WHEREAS, The Federal Highway Administration (FHWA) on April 5, 1983 arbitrarily and without regard to highway safety added 1,723 miles of road to the 2,148 miles already designated by the Pennsylvania Department of Transportation as highways where it will be permissible under the Federal Surface Transportation Act of 1982 for twin-trailer combinations to operate; and

WHEREAS, The 2,148 miles are all that the Pennsylvania Department of Transportation feels is safe to allow these tractor-trailer combinations to operate on; and

WHEREAS, The Pennsylvania General Assembly believes that the Federal Highway Administration (FHWA) is in error in seeking to add mileage to the proposed twin-trailer network as already proposed by Penndot; therefore be it

RESOLVED (the House of Representatives concurring), That the General Assembly of the Commonwealth of Pennsylvania hereby calls on the Federal Highway Administration (FHWA) of the United States Department of Transportation to rescind the portion of the truck size and weight policy statement as proposed in the Federal Register Vol. 48 No.66, of Tuesday, April 5, 1983, Rules and Regulations, insofar as it adds any mileage to the proposed mileage that Penndot itself recommended in its submission to the (FHWA) of March 15, 1983; and be it further

RESOLVED, That copies of this resolution be transmitted to the presiding officer of each House of Congress, each member of Congress from Pennsylvania, the Administrator of the Federal Highway Administration (FHWA), Pennsylvania Transportation Secretary Thomas Larson and Governor Dick Thornburgh.

Such appointee shall be subject to confirmation by the majority of the members elected to the Senate.

Section 3, page 2, line 29, by striking out "3" and inserting: 4

On the question,

Will the Senate agree to the amendment?

Senator KELLEY. Mr. President, this amendment and the six amendments to follow are basically a philosophical change in the method of filling vacancies when they occur in county government. This amendment would provide that the county commissioner vacancy would be filled by the Governor's nomination with the consent process by the majority of the Senate. The same rules would follow where the nominee would have to be of the same political party as the person whose vacancy is being filled.

Senator JUBELIRER. Mr. President, as the Members are coming up and taking their seats, I believe they ought to be aware this is the amendment, as I understand it, that removes from the Board of Judges the ability to make appointments where county commissioner vacancies exist and replaces it with an appointment by the Governor of Pennsylvania. I think the law should remain intact in which whomever was the appointer would have to appoint from the party from which the vacancy occurred.

Mr. President, I believe there is no need for such an amendment. I am going to vote against it because I frankly think this system has worked rather well. I see no need to make such a change at this time. For that reason I would urge a negative vote on the amendment.

Senator KELLEY. Mr. President, I would only like to say that whether or not there is a need with the system having been currently working well or not is not the test. The test is that we know the courts have been deluged with tremendous amounts of work on the judicial system and the courts have been sought and the purpose of Article V being amended, as it was at the convention, was to take the courts out of politics. There is no reason in the world, therefore, for the judiciary to be naming people to public offices that are political. If we know and follow the study, the counties are creatures of the Commonwealth. The county commissioners, therefore, being the head of the executive and legislative bodies of the county government, it is only appropriate that the counties, being the creatures of the State, the Executive Branch of the Commonwealth, therefore, should be the proper one to make the appointments for the vacancies. The philosophical purpose of this amendment is to take the courts out of the process of making appointments to political office. Mr. President, I would urge an affirmative vote and I would ask for a roll call.

And the question recurring,

Will the Senate agree to the amendment?

Senator KELLEY. Mr. President, this amendment deals with the filling of vacancies in the office of district attorney in their respective counties.

Currently when a vacancy occurs, it is the judges of the court of common pleas who fill that vacancy and this amendment would provide that the county commissioners do it. This would not only take away from the judges the higher appointment for a political office, but also remove any taint of conflict of interest because the district attorneys must necessarily appear before those courts that would appoint them. I think this amendment would help give and reconstitute the confidence in government that the people need and I ask for an affirmative vote.

Senator JUBELIRER. Mr. President, again I would speak against the amendment. I think there has been no demonstrated need for a change and I would reject the argument that there is a conflict of interest between district attorneys and judges. I think, if anything, there is far more chance of politicizing this kind of situation where the county commissioners would have this opportunity to appoint a temporary district attorney. I see no reason for the amendment and, I think, potentially, it could disturb some of the checks and balances that currently exist in the courthouse. I just do not think it is a good amendment, Mr. President, and would urge a "no" vote.

Senator KELLEY. Mr. President, I thank the gentleman from Blair, Senator Jubelirer, for his comments but I would suggest that the criteria for this Body or any legislative Body to act only because of a demonstrated need is not the standard by which we should operate. One of the difficulties of our form of government, I suppose, here in Pennsylvania and all of our sister States and the Federal government, is they tend to react when a problem becomes extensive or too broad. I am suggesting, if we really believe in the concept of taking the courts out of the political process, in anticipation of that we should embrace this amendment. I am not saying per se what the courts have done in their appointments in the past has been bad, I am only saying the courts are a Judicial Branch and it is not the proper function for the courts to fill the vacancy in executive administrative branches. At the Commonwealth level, if there is a vacancy in the office of the attorney general, it is not the courts of this Commonwealth that select the nominee, it is the executive. This amendment would give that consistency for the counties to do the same thing. I would, therefore, urge an affirmative vote.

Senator ROCKS. Mr. President, I desire to interrogate the gentleman from Mercer, Senator Wilt.

The PRESIDENT. Will the gentleman from Mercer, Senator Wilt, permit himself to be interrogated?

Senator WILT. I will, Mr. President.

Senator ROCKS. Mr. President, for at least some Democratic Senators, there seems to be some concern as to Senate Bill No. 429 before us for final passage, which amends the minimum wage law of this Commonwealth and has been reported out of the Committee on Public Health and Welfare of the Senate. I wonder, for those of us who did not enjoy the opportunity of the fullest discussion of what would be a change in the Minimum Wage Act, if the gentleman from Mercer, Senator Wilt, would give us, as prime sponsor, his own description as to what this legislation, in fact, does?

Senator WILT. Mr. President, it would exempt those institutions that hired houseparents for juveniles who were in custodial care. It would exempt them from the Minimum Wage Act

Senator ROCKS. Mr. President, would the gentleman please tell me about how many so described houseparents we might be considering in the Commonwealth of Pennsylvania?

Senator WILT. Mr. President, I do not know the exact numbers. I would suspect they were relatively small since the statute already does exempt several kinds of houseparents, those that are defined as educational institutions, elementary, secondary and other kinds, but the ones for which I have particular reference in this bill who are not covered are those which had been placed in institutions which are private commitments or adjudicated juveniles and, therefore, there are relatively few in number, but I do not know exactly what that is.

Senator ROCKS. Mr. President, I am looking at just the analysis of the bill. I am having a hard time describing to those Members who have asked me on this side just what a houseparent is as you have referred to it. Could the gentleman please explain that?

Senator WILT. Mr. President, I cannot give the gentleman a textbook definition but let me tell the gentleman for whom the bill was introduced and who will be served by the bill. I have in my district an institution called George Junior Republic. It is a private, nonprofit institution which houses adjudicated young adults. With the new commitment processes and with all of the regulations that have been promulgated, both by the Federal government and by the State government, rather than mandating the large type facilities, the dormitory type style housing, the new directive is, and a new style of incarceration is, for the smaller individual house units.

The institutions have complied with those requests. We now have what are similar to residential units, even though they might still be at an institution, I use that word in want of a better word. I prefer it to be a school, but in reality it is not a school. So they are basically houseparents with small residential units, mostly as domestic units, as most of the Members

would recognize a domestic dwelling, and these are the parents who live on the campus, oftentimes acting as role models, oftentimes preparing and serving the meals. They are the ones who are in charge of these individuals for a sustained period of time. These people are live-ins so they can simulate a regular nucleus of a family as the Members would know it.

Senator ROCKS. Mr. President, I thank the gentleman. I would like to make just a few brief remarks on Senate Bill No. 429. Mr. President, I personally would like very much to support the gentleman from Mercer, Senator Wilt, in what he is addressing as concern in his district that he brings before the Senate today in a piece of legislation for final passage. However, I will not be able to cast that vote and I would explain for, I believe, some other Members the concern on this side of the aisle. While the bill may be intended in a singular situation in the district of the gentleman from Mercer, Senator Wilt, to rectify what is that singular concern, there are concerns across this Commonwealth today regarding the entire question of our Minimum Wage Act; legislation that could impact on it in any way has had a tendency to see certain red flags raised up the pole and, I think, in fairness to especially those labor concerns in our Commonwealth whereby an amendment to the Minimum Wage Law might get its fair hearing, I would be in opposition to this bill today. However, I certainly understand the gentleman's concern and hope it would be supported and rectified, but I am hesitant to say the Members should do it by passage of this bill on this day. I would much prefer the standing committee of this Senate that has to deal with the act that, in fact, is being amended to have an opportunity to help the gentleman from Mercer, Senator Wilt, address his concerns, so I would ask for a negative vote.

Senator EARLY. Mr. President, I rise to indicate I will be voting in the affirmative on this particular piece of legislation.

I have before me a copy of the Fair Labor Standards Act by the Federal government. They indicate in there that anyone who works for a nonprofit educational institution serving as parents of children is exempt from the Minimum Wage Act. They specifically state orphans.

It has come to my attention, Mr. President, there is no need for me to continue.

Senator JUBELIRER. Mr. President, at the request of the prime sponsor of Senate Bill No. 429, the gentleman from Mercer, Senator Wilt, and others who have indicated they would like a little more time to go over and review the content of the bill, I would ask that the bill go over in its order at this time.

The PRESIDENT. Without objection, Senate Bill No. 429 will go over in its order on final passage.

PETITIONS AND REMONSTRANCES

Senator LEWIS. Mr. President, I would like to have my remarks inserted in the record.

The PRESIDING OFFICER. The Chair hears no objection.

(The following statement was made a part of the record at the request of the gentleman from Bucks, Senator LEWIS:)

Mr. President, about this time a year ago, I presented to the Senate the first in what was intended to be a series of annual reports on the public relations costs of the Executive Branch of State Government. Today, I submit the second report in that series for the edification of the Members and the constituents we represent.

The Governor's budget document informs us that the cost of public relations/public information is budgeted at \$5.2 million for fiscal 1983-84, a substantial undertaking, indeed. A review of how that \$5.2 million is to be expended personnelwise is both educational and enlightening. For example, a year ago we found 135 filled PR/PI positions and eight vacancies within the agencies contained in this survey. This year the levels dropped slightly to 127 filled positions and ten vacancies. Yet, we learned that the salaries of those 137 positions had jumped by more than \$205,000 in the past year—from \$2,978,440 to \$3,184,565. The payroll cost goes even higher when fringe benefits are factored into the equation, rising by almost \$255,000 from \$4,154,994 to \$4,410,623. In fairness, most of the departmental increases were in normal incremental levels of 8 to 9 percent.

There were some notable exceptions, however. One particular exception occurred in the Governor's Press Office. There

salaries generally were raised by 10 percent to 13 percent while the complement was increased by one position from thirteen to fourteen. So the "more-with-less" theme of this Administration hardly applied in this case. Moreover, we found once again that the Governor's Office places a much higher priority on publicizing its policies than it does in formulating them. The Governor's legislative relations section employs five policy people at a combined salary level of \$207,425 to develop and implement the programs of this Administration. The Governor's Press Office, on the other hand, employs eight PR people and pays them \$302,000 to thump those programs for the Administration. That tells me something about what is important and what is not. In addition to the Governor's Office, a review of the PR costs of the Departments of Education, Community Affairs and Labor and Industry proved most revealing. The Education Department complement jumped from thirteen people at a combined payroll of \$296,500 last year, to fifteen people and two authorized vacancies this year at a combined salary level of almost \$398,000. Most of the growth occurred in the department's TV studio operations. The continued expansion and utilization of this facility will bear close watching. Last year we challenged the justification of a 20 percent growth in the PR budget of the Department of Community Affairs. The growth trend continues. Despite the elimination of one \$14,000 Clerk/Stenographer position in the department, its payroll costs jumped by 12 percent. Such growth is most difficult to justify in our view and we will address it in our budget deliberations.

We were encouraged, however, in our findings regarding the State Labor and Industry Department. Last year, we might recall, we challenged the validity of a 33 percent increase in the PR budget of the department. Apparently, someone took heed. This year, we find the department's complement dropped by one position, from four to three, and its payroll costs went down 15 percent. I would like to thank Secretary of Budget Robert Bittenbender for his cooperation in the timely assembly and delivery of the information necessary for this survey to be conducted. This survey is important in a number of respects, not the least of which is the exercise of the legislature's oversight of the expenditures of tax dollars. Last year, when this survey was inaugurated, budgeted PR expenditures jumped 11 percent. This year, expenditures virtually stood still. People tend to be careful about how much they spend and in what way they spend it when they know other people are watching. We intend to be watching each year.

This exercise is also important in another sense. It demonstrates conclusively the ease and dispatch with which information of this nature can be collected and supplied for budgetary review. Inexplicably, the Governor's Office seems to distinguish between the expenditure of \$5 million on public relations activities and the expenditure of over \$30 million on legal activities. The first, in the view of the Secretary of Budget, is entirely appropriate for budgetary review. The second, in the view of the General Counsel, is not. I find the distinction impossible to fathom.
