## SENATE

TUESDAY, September 25, 1984.

The Senate met at 10:15 a.m., Eastern Daylight Saving Time.

The PRESIDING OFFICER (Richard A. Snyder) in the Chair.

## PRAYER

The Chaplain, the Reverend Father WILLIAM J. ONUSHCO, Pastor of St. Margaret's Roman Catholic Church, Reading, offered the following prayer:
