### SENATE

WEDNESDAY, June 19, 1985.

The Senate met at 10:00 a.m., Eastern Daylight Saving Time.

The PRESIDENT pro tempore (Robert C. Jubelirer) in the Chair.

(ii) [Total] The total numbers of undergraduate student credit hours, divided into lower division and upper division course levels, and of graduate student credit hours divided into three course levels—master's, first professional and doctoral.

(iii) [Number] The number of different courses scheduled by level of instruction and the number of sections of individual instruction [at each] scheduled by level of instruction, each further subdivided by two digit Classification of Instructional Program (CIP) categories of instructional programs of higher education as defined by the National Center for Education Statistics, United States Department of Education.

(iv) [Number] The number of terms scheduled and the dates thereof.

(2) For the summer term and the following academic year in total and for each two digit [HEGIS category of instructional programs in higher education as defined by the National Center for Education Statistics, United States Department of Education]

CIP program category, a classification of faculty members or other professional employes by title, including: professor, associate professor, assistant professor, instructor, lecturer, research associate, librarian and academic administrator; faculty members or other professional employes under each title to be subdivided by type of assignment: teaching and nonteaching, and each such set of faculty members or other professional employes to be further subdivided by type of employment: full time or part time; and the following aggregates for each subdivided classification:

(i) The number of faculty and other professional employes and their full-time equivalence in instructional and noninstructional functions.

(ii) The sum of credits assigned to undergraduate classroom courses and the sum of credits assigned to graduate classroom courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iii) The sum of credits assigned to undergraduate individual instruction courses and the sum of credits assigned to graduate individual instruction courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iv) The sum of undergraduate classroom student credit hours and the sum of graduate classroom student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(v) The sum of undergraduate individual instruction student credit hours and the sum of graduate individual instruction student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(vi) [Total] The total salary paid for instructional functions and for noninstructional functions and the amount of this salary paid for each of these functions from [college or] university funds, Federal funds and other funds.

(3) For each term of the period covered for each faculty member employed full time identified by two digit [HEGIS] CIP program category and title, the report shall contain an analysis of the average hours per week spent in [institution-related] university-related activities, stating specifically hours spent in undergraduate classroom contact and graduate classroom contact, hours spent in preparation, hours spent in research and hours spent in public service.

(b) In addition to the requirements of subsection (a), each report covering the 12-month period shall include for all programs of the institution:

(1) Minimum number of credits required for a baccalaureate degree and for a master's degree.

(2) Number of bachelor's degrees, master's degrees, first professional degrees and doctoral degrees awarded in the three previous years and those estimated for that year.

Mr. President, what this amendment does is it amends a section which we amended in committee which would have the Game Commission supply a written and oral report to the Committees on Game and Fisheries of the Senate and the House. This amendment reestablishes that an audit of the Game Commission would be completed by the Legislative Budget and Finance Committee and, in turn, a copy of these results would be presented to the Committee on Game and Fisheries. It is not a binding amendment. It is not a budget review amendment. It is more an informational amendment so that the functions of the Game Commission would be presented to the General Assembly.

Senator EARLY. Mr. President, would the gentleman from Schuylkill, Senator Rhoades, consent to a brief interrogation?

The PRESIDENT pro tempore. Will the gentleman from Schuylkill, Senator Rhoades, permit himself to be interrogated?

Senator RHOADES. I will, Mr. President.

Senator EARLY. Mr. President, can the gentleman tell me if the Game and the Fish Commission are in favor or not in favor of this particular amendment?

Senator RHOADES. Mr. President, I think the best way to put it is they are not necessarily in favor of it, but they are not against it. I think it is something they say they admit they can live with. They are doing approximately three audits right now, so this would be a fourth. It is more, I would say, a compromise position.

Senator EARLY. Mr. President, would they prefer that the amendment was not included?

Senator RHOADES. Mr. President, I would imagine that probably would be the case.

Senator ANDREZESKI. Mr. President, I would like to comment on the amendment being offered to House Bill No. 585. The original purpose of the bill itself was to give the Game Commission a larger working budget by increasing the fees paid for hunting licenses. We are considering House Bill No. 585 on its legislative merit today, but I feel some equally important considerations have been raised since the bill was introduced, and that issue is how to work with the Legislature in expressing support for a bill or amendments.

The license increase bill was amended in the House to give a line by line audit or approval of the General Assembly of the Game Commission bill. We as Legislators, myself, and I am sure, many others, were besieged with constituents who were thoroughly informed or convinced by other parties that the General Assembly was going to control hunting in Pennsylvania. Judging from some of this misguided madness which has taken place across Pennsylvania, one would have thought the Legislature was limiting hunting of animals only to those killed by automobiles. For some apparent reason, those who forgot they had successfully worked with us in the past started doing some really strange things out there. The bill came into the Committee on Game and Fisheries. The amendments that most people opposed were taken out. Currently, in House Bill No. 585, which was to increase the budget of the Game Commission, is an amendment that replaced the amendments taken out that says the House and Senate Committees on Game and Fisheries will review their budgets every year. I think the attempt of the gentleman from Schuylkill, Senator Rhoades, to say, get the General Assembly out of it altogether and just say the Legislative Budget and Finance Committee way of doing this is a very, very good way of keeping the General Assembly, in particular, on specific items, out of the workings of the Game Commission. I would ask the colleagues on my side of the aisle to support this amendment.

In the Senate, June 19, 1985.

**A RESOLUTION**

Directing the Joint State Government Commission to research and compile the Pennsylvania statutory law relating to blindness.

WHEREAS, There are numerous Pennsylvania statutes relating to the handicapped and especially to the blind; and

WHEREAS, These statutes are scattered throughout the body of Pennsylvania law; and

WHEREAS, There is a need to bring these statutes together in one document for easy reference; therefore be it

RESOLVED, That the Senate direct the Joint State Government Commission to research and compile the Pennsylvania statutory law relating to blindness and publish a report containing said compilation.
