Amend Bill, page 1, lines 5 through 17; page 2, lines 1 through 22, by striking out all of said lines on said pages and inserting:

CHAPTER 1

ITEMIZATION OF DEBT FUNDED CAPITAL PROJECT SUBCHAPTER A GENERAL PROVISIONS

Section 101. Total authorizations.

The total authorization for the additional capital project in the category of public improvement projects itemized in section 111 and to be acquired or constructed by the Department of General Services, its successors or assigns, and to be financed by the incurring of debt, shall be \$2,160,000.

SUBCHAPTER B

ITEMIZATION OF PUBLIC IMPROVEMENT PROJECT Section 111. Itemization of public improvement project.

BOAT AND FISH FUND PROJECTS Section 301. Total authorizations.

The total authorization for the capital projects in the category of public improvement projects itemized in section 302 to be constructed by the Pennsylvania Fish Commission, and to be financed from current revenues of the Boat Fund and the Fish Fund pursuant to executive authorizations, shall be \$550,000. Section 302. Itemization of Fish Commission capital projects.

Section 501. Total authorizations.

The total authorization for the capital projects in the category of public improvement projects to be acquired by the Pennsylvania Game Commission, and to be financed from current revenues of the Game Fund pursuant to executive authorizations, shall be \$1,398,000.

Section 502. Itemization of Game Commission capital projects.

The individual capital projects in the category of public improvement projects to be acquired by the Pennsylvania Game Commission, and to be financed from current revenues of the Game Fund pursuant to executive authorizations, are hereby itemized, together with their respective estimated costs, as follows:

CHAPTER 7

DEBT AUTHORIZATION AND APPROPRIATION Section 701. Debt authorization.

The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$2,160,000 as may be found necessary to carry out the acquisition and construction of the public improvement projects specifically itemized in a capital budget.

Section 702. Issue of bonds.

The indebtedness authorized in this act shall be incurred, from time to time, and shall be evidenced by one or more series of general obligation bonds of the Commonwealth in such aggregate principal amount for each series as the Governor, Auditor General and State Treasurer shall determine, but the latest stated maturity date shall not exceed the estimated useful life of the projects being financed as stated in section 703.

Section 703. Estimated useful life and term of debt.

(a) Estimated useful life.-The General Assembly states that the estimated useful life of the public improvement projects itemized in this act is 30 years.

(b) Term of debt.—The maximum term of the debt authorized to be incurred under this act is 30 years.

Section 704. Appropriations.

The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$2,160,000 to be used by it exclusively to defray the financial cost of the public improvement projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

Section 705. Federal funds.

In addition to those funds appropriated in section 704, all moneys received from the Federal Government for the projects specifically itemized in this act are also hereby appropriated for those projects.

> **CHAPTER 9** EFFECTIVE DATE

Section 901. Effective date.

This act shall take effect immediately.

BILL ON THIRD CONSIDERATION AMENDED

HB 1014 (Pr. No. 1251) — The Senate proceeded to consideration of the bill, entitled:

An Act providing for the adoption of capital projects to be financed from current revenues of the Boat and Fish Funds.

On the question,

Will the Senate agree to the bill on third consideration? Senator TILGHMAN, by unanimous consent, offered the following amendment:

Amend Title, page 1, lines 1 and 2, by striking out all of said lines and inserting:

Providing for the capital budget for the fiscal year 1985-1986.

Amend Bill, page 1, lines 5 through 17; page 2, lines 1 through 16, by striking out all of said lines on said pages and inserting:

Section 1. Short title and construction.

(a) Short title.—This act shall be known and may be cited as the Capital Budget Act of 1985-1986.

(b) Supplements.—A reference to this act shall be deemed to include a reference to the supplements to this act.

(c) Fiscal Code.—The provisions and definitions of Article XVI-B of the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, shall apply to this act to the extent they are not inconsistent with this act.

Section 2. Overall limitations on debt to be incurred for capital projects.

The maximum principal amount of additional debt to be incurred during the 1985-1986 fiscal year, and thereafter until the enactment of the 1986-1987 capital budget specifying the maximum debt for the 1986-1987 fiscal year, for capital projects specifically itemized in a capital budget pursuant to section 7(a)(4) of Article VIII of the Constitution of Pennsylvania, and the fund to be charged with the repayment of such debt, shall, with respect to each category of capital projects, be as follows:

This act shall take effect immediately.

On the question,

Will the Senate agree to the amendment?

Senator FUMO. Mr. President, this amendment is very similar to a bill that is currently sitting in the Committee on Appropriations, with the exception of the fact that the money for the Philadelphia Convention Center is somehow lacking from that bill. I know that was not a typographical error or one that was made in the Legislative Reference Bureau.

Mr. President, not being one who wants to delay these other projects that are so important to the Commonwealth, I would like to ask the Majority Leader, the gentleman from Chester, Senator Stauffer, if he would stand for interrogation.

The PRESIDING OFFICER. Will the gentleman from Chester, Senator Stauffer, permit himself to be interrogated?

Senator STAUFFER. I will, Mr. President.

Senator FUMO. Mr. President, I would like to ask the Majority Leader whether or not he will give me and my colleagues a firm commitment that the Philadelphia Convention Center issues will be dealt with next week, as I understand he has already committed to privately?

Senator STAUFFER. Mr. President, we are very actively working on the Philadelphia Convention Center project. There have been a great many meetings, and I would say the meetings have been very positive in nature. I personally feel very optimistic about the situation. We had a very long discussion in the Republican caucus today with regard to the project. We are moving forward on the project. I believe I am safe in indicating to the gentleman that it is our intention to move forward. The only caveat in being very accurate in answering the gentleman's question, Mr. President, would be when he stipulates the next week. I would hope things will fall into place. I fully expect they will, but when you tie it down to a time period as early as next week, I would not want to commit to that and then feel a few days from now that I had not been truthful.

Senator FUMO. Mr. President, what I meant by next week was that we would complete it before we left here next week. If I was unclear, I apologize, but maybe I can rephrase the question. Maybe the Majority Leader can give me a deadline that he is willing to commit to. If it is not by next Wednesday, the following Wednesday, as long as there is a deadline, Mr. President. One of the problems the gentleman should be aware of with regard to this issue is that it has dragged on and on and on for many, many months now and costs are escalating quite rapidly, and there appears to be a lot of consternation and speculation and things of that nature with regard to this. We from Philadelphia are receiving an awful lot of pressure, as I am sure my colleagues from around the state are, on the issue from both representatives of the city, from members of the business community in the Delaware Valley area, from members of the labor unions in the Delaware Valley area, and I would like to have from the Majority Leader some realistic deadline that he can give to me, if not next week, then when?

Senator STAUFFER. Mr. President, I fully recognize the gentleman's words with regard to the great deal of interest and the great deal of pressure that is involved in this project. I would point out to him, as he well knows, that I have spent an inordinate amount of my personal time on this matter over the past number of weeks. The only commitment I can make as far as a time frame is concerned is that we are very seriously working on this and have every intention of moving this to a conclusion just as quickly as possible. I can assure the gentleman that the concern he has expressed is being heard by the Members of our caucus and will certainly be taken into full consideration as we move forward with this process.

Mr. President, I am not dancing on the head of a pin or dodging the gentleman in giving that kind of a response. I am being very accurate in pointing out to him we have a complex piece of legislation to deal with, I believe we are making great progress with it, and I believe we are going to bring this to a successful conclusion, but I am not in a position to stand here today and say that on a given date we will have reached that conclusion. I am hopeful we will reach that conclusion in a time frame that would be more than pleasing to the gentleman.

Senator FUMO. Mr. President, that, obviously, is an answer that does not please me. Perhaps we can go about this in a different way. Will the gentleman assure me that we will have this matter completed before we break for recess before the Primary Election? Perhaps we can narrow it down that way.

Senator STAUFFER. Mr. President, I can assure the gentleman, as far as my timetable is concerned, I certainly want this issue dealt with and out of the way before we reach that point. I must point out that we have other items on our agenda that are extremely important and, in my judgment, this is something that should be dealt with and settled one way or the other before we go to that time period.

Senator FUMO. Mr. President, now we are getting somewhere. Will the gentleman then assure me, possibly, that we will resolve this before we break for our recess for budget hearings?

Senator STAUFFER. Mr. President, I will not assure him of that, but I would point out that is a possibility.

Senator FUMO. Mr. President, so then the best I can get is a commitment that we will resolve it before we break for the Primary Election, not necessarily that we will get a commitment that we will do it before we break for the budget hearings. I thank the Majority Leader for that.

Mr. President, I am, of course, not happy with those responses, because this issue has been languishing around for about a year now, I believe, if not longer, and I really think we have delayed far too long. It was, Mr. President, my inten-

tion at this point in time to offer an amendment to the amendment putting back in the money for the Philadelphia Convention Center so as to get the ball moving, and it is still my natural, political and legal inclination to do that. However, at the request of the city administration, I am specifically refraining from doing so and will not do so. I do not think it is the best judgment, but I will yield to the leadership in Philadelphia who have requested me to do that. In that sense, Mr. President, I assume the rest of this amendment is agreed to by our side.

Senator SALVATORE. Mr. President, I would just like to say a few things. I was listening to that exchange between the Majority Leader and the gentleman from Philadelphia, Senator Fumo, and I would like to add my two cents to it. We have been working very feverishly to try to put this convention center together. As I have explained to the Senator, my good colleague from Philadelphia, there are a lot of questions that are unanswered. We have been working hard on this, and I think we have accomplished a lot today. I think if the Senator from Philadelphia would be patient, I think we will have a convention center. We might have to change the name to the Wenger Convention Center, but the gentleman from Lancaster, Senator Wenger, says that he would like to expand it out to Lancaster County.

Seriously, I just feel that in a complex construction involvement of this magnitude that involves all this money, it is wise for us to proceed cautiously and make sure we do not make mistakes that have been made in other projects. I think we can save a lot of money by doing that, and we can give the taxpayers of Pennsylvania a good convention center.

Senator WILLIAMS. Mr. President, I would like to add my voice and comment to the desire that we accomplish a result on the convention center in the Philadelphia area. Needless to say, we have for months been wrestling with that proposition, sufficient in my judgment that we by this point can have some guidepost, timewise, as to when this matter can be accomplished and resolved. To add one other brief note, it seems to me that those issues have been sharpened and reduced. I am hopeful all of the weighty and substantive considerations will be quickly and correctly resolved for the benefit of all the parties concerned. Just adding that note of both urgency, perceptiveness and insight, I am hopeful the answers that the Majority Leader gave were not-and I know they were not-intended to be evasive or carried out longer but, rather, to be as accurate as possible, and I just wanted to add that note.

Senator PECORA. Mr. President, I want to bring to this Senate's attention the fact that not everybody here is in favor of \$185 million for a convention center in Philadelphia. I also want to bring to their attention that I introduced the resolution two months ago that if you are really interested in your city you would get private enterprise to invest into a convention center.

POINT OF ORDER

Senator ROCKS. Mr. President, I rise to a point of order.

The PRESIDING OFFICER. The gentleman from Philadelphia, Senator Rocks, will state it.

Senator ROCKS. Mr. President, what is before the Senate at this moment?

The PRESIDING OFFICER. We are on the amendment offered by Senator Tilghman to House Bill No. 1014, Senator.

Senator ROCKS. Mr. President, then as a matter of personal privilege I would ask that the Chair would enforce that the remarks and the exchanges on this floor be limited to that matter which is in a bona fide way in front of this Chamber right now.

The PRESIDING OFFICER. It is the feeling of the Chair that the gentleman has stated a point of order instead of a point of personal privilege and that you are correct that the debate should be limited to the amendment and not to the merits of the bill. I would caution the gentleman from Allegheny, Senator Pecora, to confine his remarks to the substance of the amendment.

Senator KELLEY. Mr. President, may we be at ease for a moment?

The PRESIDING OFFICER. The Senate will be at ease. (The Senate was at ease.)

Senator PECORA. Mr. President, as you probably realize, I am not as intelligent as the gentleman from Philadelphia, Senator Rocks, because I assumed that when the previous Senators were speaking about a convention center, that I had the same privilege. But, being that it is a point of order and with your decision, I must ask that the previous Senator's remarks be taken from the record. They were out of order also.

The PRESIDING OFFICER. Senator Pecora, the Chair does not have the authority to strike remarks from the Senate record.

Senator PECORA. Mr. President, why do they have a priority to speak?

The PRESIDING OFFICER. The Senate will be at ease.

(The Senate was at ease.)

Senator ROCKS. Mr. President, I would like to withdraw the point of order.

Senator PECORA. Mr. President, as I was previously stating, that I used my county as an example, we have the City of Pittsburgh Convention Center which has been a flop. We had to raise the hotel-motel tax to help them a few years ago. We have a private enterprise in the Borough of Monroeville which is doing a fantastic job. They have no state subsidies, no hotel-motel tax, and they are on a profitable basis. They are making money, and they are paying taxes to the municipality. They are paying taxes to the county, and they are paying taxes to the Commonwealth.

In my resolution I recommended that we give the hotelmotel tax to private enterprise to invest in convention centers in this Commonwealth. I feel by taking that action we will not then be using the taxpayers' dollars of Pennsylvania. We could initiate convention centers in any part of this Commonwealth with private enterprise money. I feel we have a responsibility to the people who elect us to protect their tax dollars, to provide jobs, to entice private enterprise, and to have a subsidy of taxes into this Commonwealth to benefit all.

Senator FUMO. I have two brief remarks, Mr. President. First of all, I recognize the words of the gentleman from Allegheny, Senator Pecora, and that is easy to say after he has already gotten his convention center for Allegheny County.

Next, Mr. President, in response to the gentleman from Philadelphia, Senator Salvatore, we will gladly call this convention center the Salvatore, Bell, Pecora, or whatever, if he gives me three votes and we will gladly enshrine their names in bronze, gold, silver, platinum, whatever they would like. If they want to talk about it, I will be here in the Chamber.

Senator BELL. Mr. President, I was going to keep quiet on this, but this has developed into a cat fight. I think there are more than three votes over here on this side, but you do not get those votes by pulling the cat's tail. Let me suggest that a number of us in here who are for the convention center want to see a proper bill with safeguards for the state's financial share. Some of you can snicker and laugh all you want but, from what I read in the newspaper, nobody even knows who speaks for the City of Philadelphia, whether it is the gentleman from Philadelphia, Senator Fumo, the mayor or the president of council. Get your act in order.

Senator WILLIAMS. Mr. President, I do not want to carry on the debate with the cat, so to speak, but I do want to indicate it is clear that we from Philadelphia at least speak for Philadelphia legislatively on this issue, and I have the dubious distinction of being the leader of that delegation so I do speak officially for that. Any clarification the gentleman may like, I would be glad to provide him with that. I do not want it to be understood that the media necessarily speaks for Philadelphia. They join in our effort, however. We are like Republicans, they argue; like Democrats, they argue. That is nothing new. I speak for the Philadelphia delegation, and the Philadelphia delegation in the Senate speaks for Philadelphia.

Senator JONES. Mr. President, in light of the question that my good colleague over there wanted to know who speaks for Philadelphia, I have to stand because, simply, I feel a little insulted. I am here to speak for, certainly, a part of Philadelphia and, certainly, to vote here. My vote would help the whole Commonwealth. I am saying I do not know what is going on here, but I am very dead serious about the convention center. We need the convention center in Philadelphia. I speak for a lot of my people who do a lot of hotel work, and right now what is happening in Philadelphia is a lot of our hotels are in trouble. If we do not get the convention center, there is going to be chaos in Philadelphia. I do not know who is playing political jokes or what is going on here, but I stand, truly, to speak for the people of Philadelphia who need that convention center. I am not over here snickering. As a matter of fact, I am shocked that it is even remotely funny. It is a very serious situation. I would hope my colleagues, both on this side and the other side, would take this situation very seriously and let us get down to business as soon as possible so we can have a vote on it.

And the question recurring, Will the Senate agree to the amendment?

SENATE RESOLUTION

HONORING DR. MARTIN LUTHER KING, JR., ON THE ANNIVERSARY OF HIS BIRTH

Senator BELL, on behalf of himself and Senators JONES, STAUFFER, SHUMAKER, HANKINS, WILLIAMS and BODACK offered the following resolution (Senate Resolution No. 116), which was read as follows:

In the Senate, January 21, 1986.

A RESOLUTION

Honoring Dr. Martin Luther King, Jr., on the anniversary of his birth.

WHEREAS, Martin Luther King, Jr., born, on January 15, 1929, in Atlanta, Georgia, followed in his father's and grand-father's footsteps by becoming a Baptist minister after graduation from Morehouse College in 1948 and Crozer Theological Seminary in 1951; and

WHEREAS, He received his doctorate from Boston University in 1955; and

WHEREAS, In 1954, as pastor of the Dexter Avenue Baptist Church in Montgomery, Alabama, Dr. King organized a citywide boycott of the city's segregated busing system which led to a United States Supreme Court decision forcing desegregation of the buses; and

WHEREAS, Throughout this and later civil rights protests, Dr. King espoused the philosophy of nonviolent passive resistance and civil disobedience; and

WHEREAS, In 1957, Dr. King moved back to Atlanta to join his father as associate pastor of the Ebenezer Baptist Church and organized the Southern Christian Leadership Conference to fight segregation and discrimination throughout the south; and

WHEREAS, During the following years, his protest activities resulted in being frequently arrested, beaten, jailed and threatened with violence; and

WHEREAS, Dr. King led a massive voter registration drive in Selma, Alabama, resulting in the famous freedom march to Montgomery, the State Capital; and

WHEREAS, His famous march on Washington, D.C., in 1963 culminated in a great rally at the Lincoln Memorial at which he gave his immortal "I have a dream" speech; and

WHEREAS, Dr. King's efforts resulted in enactment of the Federal Civil Rights Act in 1964; and

WHEREAS, His personal sacrifices and determined leadership of the civil rights movement in the United States were formally recognized in 1964 when he received the Nobel Peace Prize; and

WHEREAS, Dr. King was assassinated in 1968 while in Memphis, Tennessee, to organize a "poor people's campaign"; and WHEREAS, The third Monday of January has been designated as a national holiday in order to give all Americans an opportunity to reflect upon the profound impact Dr. King has had on life in the United States; therefore be it

RESOLVED, That the Senate honor Dr. Martin Luther King, Jr., on the anniversary of his birth and urge all Pennsylvanians to commemorate his life and what it stands for by participating in activities and ceremonies honoring Dr. King.

Senator BELL asked and obtained unanimous consent for the immediate consideration of this resolution.

He had preached down in Georgia, but when he was an associate pastor he preached in Chester at Calvary Baptist under Reverend Pious Barbour, now deceased, and at Bethany Baptist in Chester under Reverend Daniel Scott who is still the pastor. There are many people in Chester, including a person who is actually almost a member of our family, who has worked for us for a number of years, who were there in the church during his first sermon. It is because of this, the close affiliation between Pennsylvania, Chester and the Borough of Upland with Dr. King, that it is only fitting that we adopt this resolution. If we look back, it was this Body that adopted a resolution commemorating the birthday of Dr. King before the nation saw fit to do so, and I know there are Senators in this room right now who cosponsored and worked on that resolution in those days.
