STATEMENT BY THE PRESIDENT

The PRESIDENT. For the record, the Chair has been informed by the Secretary of the Commonwealth that all of the Senators-elect have filed in his office the accounts and affidavits as required by the Act of June 3, 1937, Public Law 1333, Section 1632.

Before proceeding with the oaths of office, the Chair would like to request the indulgence and cooperation of all photographers, whether you be news photographers or amateur photographers, and others who would like to take pictures, so that during the actual administering of the oath there will be no picture taking. In lieu of that, we would ask the individuals who are sworn in to remain at the bar for a few minutes after the actual administering of the oath so that anybody who wishes can come forward and take pictures at that time. During that brief time, the rest of us will remain in recess for a few minutes.

ADMINISTRATION OF OATH OF OFFICE

The PRESIDENT. The next order of business will be the administration of the oath of office to the newly elected Senators. It is a distinct honor and a privilege to have with us two distinguished judges: Justice Juanita Kidd Stout of the Pennsylvania Supreme Court and Judge D. Brooks Smith of the United States District Court for the Western District of Pennsylvania.

These jurists have kindly consented to come here today to administer the oath of office to our Senators-elect and Senate officers in accordance with Article VI, Section 3 of the Constitution of Pennsylvania.

We will now proceed with the administration of the oath of office to the Republican Senators-elect by Judge Smith.

Will the Republican Senators-elect please present themselves in front of the rostrum at this time. Please bring with you your Bibles that have been placed upon your desks. Will all please rise.

I have the honor of presenting Judge Smith who will now administer the oath of office to the Republican Senators-elect.

Judge SMITH. Will you all please place your left hand on your Bible, raise your right hand and repeat after me:

I, (your name), do solemnly swear, that I will support, obey and defend the Constitution of the United States and the Constitution of this Commonwealth, and that I shall discharge the duties of my office with fidelity, so help me God.

Congratulations, gentlemen.

(Applause.)

The PRESIDENT. Will the Republican Senators remain at the bar, and the rest of you please be seated for a few minutes while we entertain photographers, family and friends who wish to record the moment.

The Senate will be at ease.

(The Senate was at ease.)

The PRESIDENT. Would the Senators please return to their seats. The Chair thanks all of the participants for their orderly handling of the situation, and the Chair would now ask, again, if the photographers would refrain and join us after the administration of the oath of office to the Democratic Senators-elect.

The next order of business is the administration of the oath of office to the newly elected Democratic Senators. The oath will be administered to the Democratic Senators-elect by Justice Juanita Kidd Stout.

Will all of the Democratic Senators-elect present themselves in front of the rostrum. Please bring with you your Bibles that have been placed on your desks.

Will all please rise.

It is now my honor to present Justice Stout who will administer the oath of office to the Democratic Senators-elect.

Justice STOUT. Please place your left hand on the Bible, raise your right hand and repeat after me:

I, (your name), do solemnly swear, that I shall support, obey and defend the Constitution of the United States and the Constitution of this Commonwealth, and that I shall discharge the duties of my office with fidelity, so help me God.

You have been sworn, and congratulations.

(Applause.)

The PRESIDENT. Once more, would all of the guests and friends please be seated. The Senate will go at ease while we allow photographers to come forth at this time to record this auspicious moment.

The Senate will be at ease.

(The Senate was at ease.)

Chamber to attend the swearing-in of his son over in the House of Representatives. Although he is not physically present in this Body, he is with us today in Session and in the Capitol.

(Applause.)

The PRESIDENT. The Chair thanks the gentleman for those remarks and they will be spread upon the record.

NEWLY ELECTED SENATORS AND FAMILIES WELCOMED TO THE SENATE

The PRESIDENT. The Chair at this time would like to take the opportunity to welcome all the newly elected Senators to the Senate of Pennsylvania and to say that we are particularly pleased to greet those Senators joining us for the first time in this august Chamber. We are also pleased to welcome all the spouses, children, family and friends of all of the newly elected Senators. While this Chamber has seen its share of partisan and ideological battles, my own feeling is that the best way to proceed, particularly at the beginning of every Session, is as Abraham Lincoln suggested, and that is with charity toward all and with malice toward none.

DISTINGUISHED GUESTS PRESENTED TO SENATE

The PRESIDENT. In that spirit, we are delighted to have with us a number of very distinguished guests. The Chair would simply recognize and welcome to the Chamber the distinguished gentle lady from Allegheny County, the Auditor General-elect Barbara Hafer, who is with us. Wave or something, Barbara.

(Applause.)

The PRESIDENT. We also have with us the distinguished District Attorney from Philadelphia, Ron Castille.

(Applause.)

The PRESIDENT. We are pleased also to have with us an individual who was honored on this Senate floor not too long ago, a distinguished gentleman with a lifetime of service to the Republican Party and to the people of Pennsylvania in general. Mr. George Bloom is with us as well.

(Applause.)

The PRESIDENT. And an individual who continues to be very active in politics in Pennsylvania and government and has just served as the Chairman of the Pennsylvania Electoral College, Ms. Elsie Hillman, is with us as well. Welcome.

(Applause.)

The PRESIDENT. It is always a pleasure to welcome back former Senators to the Chamber. We would extend a cordial welcome and introduce all of the guests. Senator Joe Gurzenda is here. Joe.

(Applause.)

The PRESIDENT. Senator Herb Arlene is with us.

(Applause.)

The PRESIDENT. Senator Elmer Hawbaker is with us as well. Senator.

(Applause.)

The PRESIDENT. And Senator Charles Dougherty is also with us. Charlie.

(Applause.)

The PRESIDENT. Welcome to all of you and thank you for helping us make this festive occasion even more special.

IN MEMORIAM SENATOR FREEMAN M. HANKINS

The PRESIDENT. At this time, the Chair would take a moment to note the passing away of a longtime Member of the Body, the Honorable Freeman Hankins. Freeman Hankins was a gentleman and a leader in every sense of the word. Senator Hankins ended his notable Senate career just this past Session, and the Chair would deeply appreciate it if the Senate and all of the guests would please rise and join me in a moment of silence for the deceased Senator Freeman Hankins.

(Whereupon, the Senate en banc stood in a moment of silence in solemn respect to the memory of Freeman M. Hankins.)

STATEMENT BY THE PRESIDENT

The PRESIDENT. Before taking up the next order of business dealing with the election of the President pro tempore and several officers of the Senate, the Chair would like to continue the practice started a few Sessions ago, that if there is only one candidate for each office, the Chair will dispense with the calling of the roll and ask for a voice vote on the nomination. Is there any objection to that procedure? There being none, we will proceed.

ELECTION OF PRESIDENT PRO TEMPORE

The PRESIDENT. The next order of business before the Senate will be the election of a President pro tempore of the Senate for the 1989 Session. This is in accordance with Article II, Section 9, of the Constitution of Pennsylvania.

Senator LOEPER. Mr. President, the position of President pro tempore of the Senate is one that is provided for in the State Constitution. The pro tempore is the chief administrative officer of the Senate, and is second in line of succession to the governorship of this Commonwealth. He presides over the Body in the absence of the Lieutenant Governor and exercises executive control over the Senate Chamber and the institution of the Senate itself. When the Members of the Senate elect a President pro tempore, we look for qualities of leadership, dedication and impartiality. In four years, our President pro tempore, Robert C. Jubelirer, has carried out his responsibilities with confidence, fairness and excellence. He has served with dignity and integrity, demonstrating the patience and tact that is required in that special position. While public focus is given to the duties of presiding over the Senate, Bob Jubelirer has also been an effective spokesman for the institution of the Senate itself, well representing to Pennsylvanians

our goals and our efforts, putting forth our views and accomplishments and contributing to the progress of the Senate of Pennsylvania. He has been a leader in our effort to professionalize and modernize the institution in order for us to better meet the demands of all of our constituents. With the ever increasing responsibilities of the office, it is essential that we choose a strong leader and a capable administrator.

Mr. President, it is my privilege to place in nomination for the office of President pro tempore of the Senate of Pennsylvania for the 173rd Session of the General Assembly, the gentleman from Blair County, the Honorable Robert C. Jubelirer.

Senator BRIGHTBILL. Mr. President, it is both an honor and a privilege to second the nomination of Robert Jubelirer as President pro tempore. As the Senator from Delaware County noted, as President pro tempore of the Senate, his job is that of being an administrator. It is a difficult task to put partisan politics aside and take on the responsibilities of a position where the key objective is fairness in the administration of the Senate. This takes a unique individual. Fortunately, we have such a unique individual in Robert Jubelirer, and I have no doubt that this fairness will continue in the coming Session. He is a graduate of Penn State University and Dickinson Law School. He has been a great pro tempore. He is an outstanding advocate. I, along with his colleagues, respect his unquestionable integrity, his sincerity, and the tremendous ability which he has brought to this high office. Mr. President, this position requires a person who is fair, a person who has personal integrity and someone who is competent. Bob Jubelirer has those qualities. He is an outstanding choice for President pro tempore, and it is a great pleasure for me to second the nomination of Robert Jubelirer for the office of President pro tempore of the Pennsylvania Senate.

Senator MELLOW. Mr. President, I think the gentleman from Delaware, Senator Loeper, and the gentleman from Lebanon, Senator Brightbill, have basically said all that we could possibly say about the nomination or seconding speech for Senator Bob Jubelirer. Had I known before we came on the floor of the Senate this afternoon, Mr. President, that I would have had on this side of the aisle twenty-five Democrats as opposed to twenty-three, having Senator Arlene and Senator Gurzenda sitting with us, I probably would have been making a nominating speech as opposed to a seconding speech today, but not being in that position, I will have to go along with the program and make a seconding speech. Mr. President, Senator Jubelirer, I believe, has been able to distinguish himself in a tremendous fashion here in the State Senate. I have had the chance of serving with Senator Murray, Senator Hager, and now Senator Jubelirer for the past four years as President pro tempore. That is a very difficult position because it is a position where, in fact, you must represent all fifty Members of this particular Body, and you must try to meet and deal with each one of the problems they have. But also, Mr. President, you have to deal with the political philosophy of the party which you represent. And that is a very fine line, Mr. President, that I think Bob Jubelirer has followed in an outstanding fashion. I take a great deal of pleasure this afternoon in making a seconding speech and seconding remarks for our President pro tempore of the Senate, Senator Bob Jubelirer.

NOMINATIONS CLOSED

The PRESIDENT. Are there any other nominations or seconds? If not, the Chair will declare the nominations for the President pro tempore closed. The candidate for the office of President pro tempore is the Honorable Robert C. Jubelirer of Blair County.

(A voice vote having been taken, the question was determined in the affirmative.)

The PRESIDENT. The Chair declares Senator Jubelirer unanimously elected President pro tempore.

(Applause.)

COMMITTEE APPOINTED TO ESCORT PRESIDENT PRO TEMPORE-ELECT TO THE ROSTRUM

The PRESIDENT. The Chair takes pleasure in appointing the following committee to escort the President pro tempore to the rostrum for the administration of the oath of office: the gentleman from Delaware, Senator Loeper; the gentleman from Lebanon, Senator Brightbill; the gentleman from Lackawanna, Senator Mellow. The committee will proceed to the performance of their duty.

(Whereupon, the President pro tempore-elect was escorted to the rostrum of the Senate.)

ADMINISTRATION OF OATH OF OFFICE TO PRESIDENT PRO TEMPORE-ELECT

The PRESIDENT. The oath of office will now be administered to Senator Jubelirer by Judge Smith.

Please rise.

Judge SMITH. Senator, during the years you were my law partner, I never had a chance to tell you what to do. This may be the closest I ever get.

Please place your left hand on your Bible, raise your right hand and repeat after me:

I, Robert C. Jubelirer, do solemnly swear, that I will support, obey and defend the Constitution of the United States and the Constitution of this Commonwealth, and that I will discharge the duties of my office with fidelity, so help me God.

Congratulations, Senator.

(Applause.)

The PRESIDENT. Please be seated.

REMARKS BY THE PRESIDENT PRO TEMPORE

The PRESIDENT. It is my honor to present to you your President pro tempore, the Honorable Robert C. Jubelirer of Blair County.

The PRESIDENT pro tempore. Rabbi Zionts, Lieutenant Governor Singel, honorable judges, distinguished guests, families and friends of the Senate: Thank you so much for joining us on this very, very special day. Judge D. Brooks Smith, United States District Court for the Western District of Pennsylvania and Justice Juanita Kidd Stout of the Supreme Court of Pennsylvania, two very distinguished jurists who are here with us today, we in the Senate extend our gratitude to you for taking time out of your busy schedule and for being here to honor us with your presence. It is particularly gratifying to me to be sworn in, not only by a former law partner who has distinguished himself as one of the youngest district court judges in these United States, but a longtime boyhood friend who has been a very, very special part of my life and the life of my greater family. It is also well to note Brooks Smith was once an intern in the Senate of Pennsylvania and, obviously, that is what catapulted him to the distinguished position which he now holds.

Judge Stout, you have been a source of inspiration to many. We appreciate you being here, taking time from your busy schedule, away from your family and from the Supreme Court, and we are deeply honored that you would be here today.

Of course, the greatest honor for me always comes in having the opportunity to introduce any member of my family. Two years ago most of my family was here with the exception of Laurie, who could not be here at that time. Today, Laurie and her husband Chuck are here, and I would want to introduce two very special people: an assistant district attorney from Philadelphia who is here with her boss—they are both away and I am very concerned about the City of Philadelphia right now. Laurie and her husband Chuck were married on October 22nd and Chuck is Dr. Charles Langman who is a podiatrist in Philadelphia, and if any of you have sore feet from campaigning, we have the guy for you. Laurie and Chuck, will you please stand up.

(Applause.)

It is difficult to express fully my appreciation for your vote of confidence. Senator Loeper, Senator Brightbill and Senator Mellow, thank you for your gracious words of nomination. They are more than that. They go to the heart, as you know, and I very much appreciate the manner in which the nominations were made. The confidence you have displayed in me is something that I have always felt was the highest honor that any Member could ever have, and to have the confidence of the Members, the colleagues who elect you, well, it is both an honor and a trust, and I will continue to serve the Members and the institution to the very best of my ability, with respect and with fairness. Your counsel and your friendship have meant a great deal over these past four years, and I will continue to rely on your support and guidance in this Session, and certainly your prayers, which are deeply appreciated.

The Senate and the Commonwealth lose something when veteran lawmakers and leaders step down. In some respects, November 30th, 1988 marked the passing of an era, for it was the last day of service for a number of illustrious and distinguished colleagues with long records of service and extraordinary contribution to our deliberations and accomplishments.

But we also gain something through the distinctive talents and enthusiasm and ideas of their successors, who we welcome here today: Senator Terry Punt, who served ten years in the House of Representatives; Senator Mike Dawida, who also served ten years in the House of Representatives; Senator Chaka Fattah, who served six years in the House of Representatives; Senator Earl Baker, who served as a Chester County Commissioner; Senator Bud Belan, who served as a District Justice in Allegheny County; Senator Gene Porterfield, who is a successful businessman.

Today is a day of ceremony. We do not offer a glimpse of the ebb and flow of debate or a Calendar loaded with a laundry list of bills, or the hectic pace that Session, committee meetings and constituent work brings. Swearing-in day is probably the only day of the two-year Session where we can proceed at such a leisurely pace.

The oath of office administered to those who were elected in November is a reminder of the trust we hold, the cause we serve and the responsibility each and every one of us bears. It is a privilege to serve with the men and women who have been elected to the Senate, who are hardworking, creative, and accepting of the demands and the sacrifices, and you, the families who are here today, we salute you because, clearly, your support gives us the inspiration and the opportunity to serve. We know that sacrifices that come with elective office and public service are many. The passions of philosophy, of ideas, of issues so often expressed in this Chamber are a reflection of our desire to meet the needs of our citizens and to make a lasting contribution to our state. The choices we face are difficult and consequential. The decisions we make must reflect the wisdom of deliberation as well as the urgency of the needs we seek to address.

Although the bill numbers and the details of legislation change from Session to Session, our broader goals remain the same—to afford economic opportunity to our communities, to ensure access to quality education, to protect our environment, to direct a broad range of human services to those with special needs, to invest in highways and public facilities, to moderate taxation and to spend state funds wisely. There is nothing new or unique about these endeavors. They represent the enduring expectations our citizens hold toward state government. Meeting these expectations fairly and compassionately will continue to be our charge and our challenge.

The passage of legislation is often a beginning, rather than an ending. We find ourselves revisiting issues, trying to find a better way to protect our children, to preserve jobs, to allow our senior citizens to live with dignity, to fight the scourge of that evil—drugs, to save farmlands on which rests the state's leading industry.

We can note with pride the achievements of the last Session. We have a right to stand tall and be proud of what was done in this Body in the last Session—the series of successes in protecting the environment, the expansion of our effort to promote and fund quality education, and the flurry of legislation approved in the post-election Session. However, there remain many issues before us, issues affecting the vitality of

the Commonwealth, issues of importance to the people of this state, issues of complexity and controversy in their resolution.

Harry Truman noted that, "It is amazing what you can accomplish if you do not care who gets the credit." The Senate does not always get the credit for its extensive legislative contributions. Many times we witness a Member devoting months or even years to an issue, only to see a Governor, whether he be Republican or Democrat, given the credit for signing the measure, or perhaps our effort is dismissed because the commentators wanted action earlier. I salute each and every one of you, because I believe you are the most dedicated men and women I have ever come into contact with, and I believe you have done a magnificent job. No question about it, when we are able to work together—and I have seen it many times—it may not make the headlines, but when I see it. it is incredible what we can accomplish, you and I, working together. Members on both sides of the aisle have demonstrated a willingness to engage in give and take, to devote the attention to detail, to ultimately participate in the compromise that builds consensus, that yields solid legislation and sound policy.

There are abundant critics of our traditions, our manner of deliberation, our occasional partisan fireworks, yet they cannot erase the ultimate productivity that has marked our efforts, nor can they properly fault the evident sincerity and fidelity with which the Senate has sought to improve the quality of life for every person who resides within the borders of this state. You and I working together, working with probably the finest staffs I have ever seen anywhere, professional people, dedicated people, people who care about the men, women and children who live in this Commonwealth, working together. As I said, it does not always make a headline, but we know that that dedication, that quality of life that is so special to us in Pennsylvania, it is because we have worked so hard to achieve it.

During the fourteen years I have been privileged to serve in this Chamber, I have seen changes in issues, changes in philosophy and, yes, changes in Membership, but there has been no change in the strong sense of public service, the commitment to ideas aimed at improving this Commonwealth, the faithfulness with which the opinions of our constituents are represented and their needs responded to. These are strongly and consistently in evidence.

So, my friends, it is a new year, a new Session, with new opportunities for all. We will do our very, very best to make it a productive year for Pennsylvania. I want to thank each and every one of you for sharing this very special day with us. Being here in this great Body to feel the history, to know that the men and women here are the most committed and dedicated men and women that you will find. I know it is going to be a great year, and I am privileged to be able to be a part of it. I thank you from the bottom of my heart, all of you, for the confidence that you have once again placed in me. God bless you all, and I wish you all the healthiest and happiest of new years. Thank you.

(Applause.)

The PRESIDENT. The Senate will be at ease for a moment while we record the moment in pictures.

(The Senate was at ease.)

ELECTION OF SECRETARY OF THE SENATE

The PRESIDENT. The next order of business before the Senate is the election of the Secretary of the Senate.

Senator WENGER. Mr. President, for the past seven and one-half years we have been fortunate to have a highly professional and respected person as Secretary of the Senate of Pennsylvania. We all know this is not an easy job. As Parliamentarian to the presiding officer, he has demonstrated an impartial attitude at times of partisan contention. Because of the sensitivity of many of the issues raised on the Senate floor, there are times when feeling and emotion run strong. It is at such times that the cool head and the even hand of the Secretary of the Senate is so important to the orderly disposition of the matter before us. Mr. President, it is my honor and pleasure to place in nomination the name of the person who has served us so well since June of 1981. Mr. President, I nominate the Honorable Mark R. Corrigan for the position of Secretary of the Senate of Pennsylvania.

Senator FUMO. Mr. President, it gives me great pleasure to second the nomination of the Honorable Mark Corrigan for the position of Secretary of the Senate. I have known Mark since his first days in the Senate when he served as legal counsel for the Committee on Local Government. I have always found him to be very competent and conscientious and a great public servant. He has served with distinction as Secretary of this Body, and I think people should know that his job is not an easy one, either. He must deal with two parties that are often in conflict, and he has consistently acted in a bipartisan and professional manner when called upon to do so. Mark should be proud of his service to this state and to this Senate, and I am proud to second his nomination as Secretary of the Senate and urge my colleagues on both sides of the aisle to give Mark their unanimous support.

NOMINATIONS CLOSED

The PRESIDENT. Are there any other nominations or seconds?

If not, the Chair will now declare the nominations for Secretary of the Senate closed. The candidate for the office of Secretary of the Senate is Mark R. Corrigan of Dauphin County.

(A voice vote having been taken, the question was determined in the affirmative.)

The PRESIDENT. The Chair, therefore, declares Mark R. Corrigan unanimously elected Secretary of the Senate. (Applause.)

ELECTION OF CHIEF CLERK OF THE SENATE

The PRESIDENT. The next order of business before the Senate is the election of the Chief Clerk of the Senate.

Senator WILT, Mr. President, for the last two and one-half years, Gary Crowell has ably met the monumental challenge of managing a multi-million dollar payroll, a myriad of accounts and ensuring the fiscal integrity of the Senate. Much to his credit, he has kept his cool and proceeded with fairness and patience when the Members of this Body have clamored for his attention on one crucial issue or another. Gary is respected for his professionalism, his forthright method of management, his balance and fair judgment. His success as chief fiscal officer reflects positively on this Body, and it is crucial to the responsibility of the operations of the state government. He carries out his duties with expertise and a thorough understanding of the Rules of the Senate and the law of the Commonwealth. His work is guided by his commitment to maintaining the integrity of the Chief Clerk's Office. Gary's attention to detail and his well-reasoned decisions merit the position, and I am proud to nominate Gary E. Crowell to be the Chief Clerk of the Senate.

Senator LINCOLN. Mr. President, before I start my nominating speech, to all the young people, the little ones here, even though we are only on number twelve, the rest of the show really moves a lot quicker, so you can fidget a little bit. It will be over pretty soon.

Whenever I volunteered to second the nomination of Gary Crowell, I did that with a great deal of pride. I have had the privilege of knowing Gary and working with him now for some time, and I think going over in my own mind what I was going to say, the first word and the only word that kept coming forward in how to describe the job he has done and what we would expect he will do in the future is that Gary Crowell is a "professional." That is something that was not always apparent or in place in the Chief Clerk's Office here in the Senate over the years. I have had the opportunity to work with Gary on a number of occasions and, more particularly, on the COMO committee. I am a little bit tough sometimes and I can be probably as partisan as you can get, but I have to say that Bill Lincoln has a lot of respect and a lot of trust in Gary Crowell. It is with a great deal of pride that I second that nomination, and I look forward to working with Gary for the coming two years.

The PRESIDENT. Are there any other nominations or seconds? If not, the Chair will now declare the nominations for Chief Clerk of the Senate closed.

The candidate for the office of Chief Clerk of the Senate is Gary E. Crowell of Cumberland County.

(A voice vote having been taken, the question was determined in the affirmative.)

The PRESIDENT. Gary E. Crowell is unanimously elected Chief Clerk of the Senate of Pennsylvania.

(Applause.)

I, (your name), do solemnly swear that I will support, obey and defend the Constitution of the United States and the Constitution of this Commonwealth and that I shall discharge the duties of my office with fidelity.

Congratulations, gentlemen.

(Applause.)

The PRESIDENT. Will the officers please stand by. There is a request for pictures.

The Senate will be at ease.

(The Senate was at ease.)
