# **COMMUNICATION FROM THE GOVERNOR**

# SURPLUS PROPERTY DISPOSITION PLAN NO. 1 OF 1989

The PRESIDENT laid before the Senate the following communication in writing from His Excellency, the Governor of the Commonwealth, which was read as follows:

#### COMMONWEALTH OF PENNSYLVANIA GOVERNOR'S OFFICE Harrisburg

# TO THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA

By the authority vested in me by Article XXIV-A of the act of April 9, 1929, (P.L. 177, No. 175), known as "The Administrative Code of 1929," added by Section 5 of the Act of July 1, 1981 (P.L. 143, No. 48) and entitled "Disposition of Commonwealth Surplus Land," I transmit herewith the 1989 Surplus Property Disposition Plan.

The annual Surplus Property Disposition Plan, required by Article XXIV-A, provides for the systematic management of Commonwealth-owned real estate assets and the efficient disposition of surplus holdings. The Plan also ensures that all conveyances are made for fair consideration predicated upon fair market value.

Contained in the Plan for 1989 are three (3) properties whose usefulness to State Government has ceased. However, they are useful and valuable for other purposes. Any special considerations, such as zoning restrictions, retention of mineral rights, and easements or leases presently in effect, have been identified.

Pursuant to Article XXIV-A, the Plan was transmitted to the Chairman and the Minority Chairman of the House and the Senate State Government Committees. The House and Senate Committees conducted a joint public hearing on September 26, 1989, as part of their review of the Plan and advised the Department of General Services of their findings.

The Department of General Services also invited public comment on the Plan through publication in the Pennsylvania Bulletin, Vol. 19, No. 34, August 26, 1989. In addition, pursuant to Article XXIV-A, the Department requested and received approval of the Plan by the Attorney General as to form and legality.

Legislative consideration of the sale of the property contained in the Plan will result in substantial benefits to the Commonwealth, including the return of idle real estate to the local tax rolls, the reduction of State exposure to liability and other insurance risks, and the elimination of excessive security and maintenance costs.

I, therefore, transmit to you and urge your approval of the 1989 Surplus Property Disposition Plan.

## HOUSE MESSAGE

# HOUSE INSISTS UPON ITS NONCONCURRENCE IN AMENDMENTS TO HB 331, AND APPOINTS COMMITTEE OF CONFERENCE

Senator FISHER. Mr. President, it is my privilege to introduce three ladies from Allegheny County, one of whom is from my district, who are here with the Allegheny Intermediate Unit. They are Jean Harrington from Bethel Park, Pauline Johnstone from Wexford and Maureen Dougherty from Pittsburgh. Maureen is President of the AIU Education Association.

# SPECIAL ORDER OF BUSINESS

# DR. GRZEGORZ BOGUTA WELCOMED TO SENATE

The PRESIDENT. It is with a great deal of pleasure that I introduce to the Senate Mr. Grzegorz Boguta. Mr. Boguta is the consultant to the Minister of Culture and Arts in Warsaw, Poland. He holds a Ph.D. in bio-physics from Warsaw University. He is also the publisher and director of NOWA. which is Poland's most recognized authority on Solidarity and governmental matters. Of interest is that Mr. Boguta also spent a year in prison, imprisoned by martial law under the previous regime, where he completed his doctoral thesis. Since that time he has been an active, key member of the Solidarity movement. He has been a foremost authority in the publishing movement in Poland. He was appointed by Lech Walesa as publisher for the special commission on Solidarity and has been a very close advisor to Lech Walesa. It is appropriate that as we are noticing major changes in Eastern Europe, and furthermore at the same exact time that Lech Walesa is addressing a Joint Session of Congress, that we have with us one of the key advisors to the Solidarity movement and one of the key personal friends of Lech Walesa to address us today in the Pennsylvania Senate. With Mr. Boguta are Ed Hoffman and Claire Hoffman. Would you stand, please. Louis and Louise Bocian and Grzegorz Boguta's wife, Magda.

It is with a great deal of pride and gratitude that we welcome Mr. Grzegorz Boguta to the Senate of Pennsylvania and would ask if you would share a few comments with us at this time. Dr. Boguta.

(Applause.)

Dr. BOGUTA. Thank you, President Singel. Thank you, Senator Jubelirer. Thank you, Members of the Senate, for this opportunity to address you. Since most of my life is devoted to analyzing history and to publishing truth to my readers, I feel compelled to share with you some of these historical facts about Poland during the past forty-five years.

In 1945, the Allies divided Europe into East and West and gave the East to Stalin and the Communist government. The Poles have never accepted the Communist system. Poland never received any Marshall Plan money because of political reasons. The Soviets took all of the war reparation money intended for Poland and retained it for themselves.

In the 1970s, the Western governments gave economic aid to the Communist government of Poland ostensibly to support the weakened totalitarian system in Eastern Europe. This aid amounted to approximately \$20 billion. The people of Poland, rightfully, could not understand this massive support from the Western governments to the Communists. Even today it continues to be questioned by Poles as to the logic behind this action.

Poland today is in need of a major infusion of financial support. We know that the U.S. government is intending to provide substantial assistance to the Polish government. Along with that governmental aid, the new, non-communist Polish government has opened the door for Western invest-

ment and for help in creating a normal free economy in Poland.

I am requesting today that those of you who are present in this Senate consider ways that Pennsylvania can make a major contribution to assist in the new Polish government to create the free market economy so vital to our success. Lech Walesa is now in the United States as the guest of your government and being hosted by the AFL/CIO, reiterating his invitation to your government and to your private sector to invest in Poland. Mr. Walesa urges you to meet with Polish partners and with our business people to create trade agreements for establishment of business in Poland. Mr. Walesa has said very often, I do not want to ask for your help with my hand out. I offer you new possibilities of making business in Poland. I am in the United States to contact many individuals and businesses who are preparing to establish trade relationships in Poland. I am asking your Senate Body to consider ways that you can assist me in attracting economic support through your legislative Body and through the influence you exert on the private sector. I have been attending meetings with an independent entrepreneur and various reputable companies in this area of Central Pennsylvania. By making these contacts, I am in the process of forming a joint venture with this independent entrepreneur, Louis Bocian of Hershey, to legalize the Pennsylvania-Poland Partnership. Our purpose is to encourage Pennsylvania companies to accompany Mr. Bocian on a trade mission to Poland to communicate with Polish government officials and to meet with Polish businessmen who wish to form trade relations with Pennsylvania companies. It is obvious to me that an investment in Poland by Pennsylvania based companies would have economic benefits for Poland and for Pennsylvania mutually. Your investment in my country will provide necessary commodities for my people and result in profits generated back to Pennsylvania. One of my major responsibilities as a consultant with the Polish government is to develop legislation on a broad range of matters regarding the economic, political and social changes taking place in Poland today. I am urging you, the Pennsylvania Senate, to advise me of your thinking on matters that could constructively affect the new democratic government taking shape in Poland today. I would request certain considerations from you as follows: That your Senate would issue a proclamation to make December 1989 Solidarity with Poland month; and you would issue a public endorsement of support for the development of private sector investments in Poland and urge your constituents to participate. I would urge your support to assist in the forming of the Pennsylvania-Poland Partnership of which I can be the Polish partner. I would urge that the Senate provide financial aid to support the development of the Pennsylvania-Poland Partnership in their efforts to organize a trade mission to Poland in early 1990. I would urge Lt. Governor Singel and one or two of your Senate Body to accompany the Pennsylvania-Poland Partnership on its initial trade mission to Poland. I would urge one or two of your Members to meet with Mr. Bocian to identify his needs and to assure financial support to the Pennsylvania-Poland Partnership.

In closing, let me thank you for this invitation to speak to you on behalf of the new democratic government of Poland. We will succeed in our quest. Nothing can stop us now, but how fast we succeed and how successful our lives will be will be somewhat dictated by people like you and how you respond to our invitation to join us in this great experiment. I am not asking for a handout, I am asking you to give us support to help Poland to help itself. Support the private initiatives that are being formed. Please give consideration to entrepreneurs such as the Pennsylvania-Poland Partnership to help them in their efforts. Thank you, President Singel; thank you, Senator Jubelirer. Thank you very much.

(Applause.)

The PRESIDENT. Thank you very much, Dr. Boguta. You have given us an ambitious agenda, and I note that several of the Senators are already signing up for the first trade mission to Poland.

On the question,

Shall the bill pass finally?

Senator BELL. Mr. President, I just briefly read the bill and I think we have had this in front of us before. As I read it, it appears that a judge is 70 on the last day of the year of his birthday, rather than on his birthday. I just do not understand this.

Mr. President, I desire to interrogate the gentleman from Montgomery, Senator Greenleaf.

The PRESIDENT. Will the gentleman from Montgomery, Senator Greenleaf, permit himself to be interrogated?

Senator GREENLEAF. I will, Mr. President.

Senator BELL, Mr. President, I am not opposing it, but I want to know why.

What I want is for the sponsor to explain the rationale behind the fact that when somebody is 70 years old, you should take the year of his being 70, rather than the day he was 70.

Senator GREENLEAF. Mr. President, the bill takes the position that it is a reasonable interpretation to say those individuals, yes, they have reached an age of 70 at their birthdate, but they continue to be 70 for the following calendar year. This would allow a judge to retire during his 70th birthday year in conformance to the mandatory retirement age, but allow him to retire at the end of that year. It would be a much more efficient administrative way of handling retirements rather than having a judge, for example, retire in February and then have a vacancy until the end of the year or until an election is held. So I think it is a much more orderly way of handling the situation and meets the constitutional and statutory requirements.

Senator BELL. Mr. President, I thank the gentleman.

Now to just say something on the bill. In other words, the Chairman of the Committee on Judiciary, it is my understanding, has looked into this and assures us that this is constitutional, and when we pass this bill, as I am sure we will, it will then be legislative intent that is expressed in a statute that a person is 70 the whole year he is 70.

Senator O'PAKE. Mr. President, as in prior Sessions when we passed this bill, I would, respectfully beg to differ. I do not think we can change the Constitution by passing a statute. The Constitution is very clear and despite the best intentions of those who would like to see judges serve longer, i.e., until the last day of the year in which they turn 70, that is not what the Constitution says. I think if we want to change that, we

have to change the Constitution and not pass a statute. Therefore, once again, I will have to oppose this.

Senator BELL. Mr. President, I desire to interrogate the gentleman from Berks, Senator O'Pake.

The PRESIDENT. Will the gentleman from Berks, Senator O'Pake, permit himself to be interrogated?

Senator O'PAKE. I will, Mr. President.

Senator BELL. Mr. President, does the gentleman have a copy of the Constitution at hand?

Senator O'PAKE. Mr. President, no, I do not.

Senator BELL. Mr. President, does the gentleman know what section it is?

Senator O'PAKE. Mr. President, no, I do not. I am just doing this from memory. We did the same thing in the last Session and tried to change the Constitution by passing this type of statute. It died in the House, fortunately, and the same reasoning that applied, and I think you agreed with me then, I think has to apply once again.

Senator BELL. Mr. President, after last night, I find I cannot agree with anybody on anything.

Senator O'PAKE. Mr. President, I now have a copy of the Constitution. It is Article V, Section 16, subsection (b), which says, "Justices, judges and justices of the peace shall be retired upon attaining the age of seventy years."

Senator BELL. Mr. President, but it does not say on attaining the birthday of the 70th year?

Senator O'PAKE. Mr. President, it says upon attaining the age of 70 and you attain the age of 70 on your 70th birthday.

Senator BELL. Mr. President, therefore, Senator Greenleaf's and your interpretation differ as to what this means?

Senator O'PAKE. Mr. President, I think the plain meaning is that when you attain the age of 70, you attain it on your 70th birthday and not at the end of that year.

Senator BELL. Mr. President, I think last night I learned that the plain meaning has fifty different interpretations.
