SENATE TUESDAY, March 30, 1993

The Senate met at 1 p.m., Eastern Standard Time.

The PRESIDENT (Lieutenant Governor Mark S. Singel) in the Chair.

SB 315 (Pr. No. 882) (Amended)

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for certification of mechanics and for penalties for exceeding maximum weights.

SB 323 (Pr. No. 883) (Amended)

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for certification of mechanics and for penalties for exceeding maximum weights.

SB 385 (Pr. No. 408)

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further defining "terminal"; defining "maxi-cube vehicle" and "stinger-steered automobile" or "boat transporter"; and further providing for the length, width, maximum number and operation of certain vehicles.

SB 428 (Pr. No. 456)

An Act amending the act of May 21, 1931 (P. L. 149, No. 105), entitled, as amended, "The Liquid Fuels Tax Act," providing for additional uses of fuel tax funds.

SB 432 (Pr. No. 460)

An Act designating an interchange under construction on Interstate 79 in Cecil Township, Washington County, as Southpointe Interchange; and designating a portion of State Route 1032 in Cecil Township, Washington County, as Southpointe Boulevard.

SB 502 (Pr. No. 539)

An Act amending the act of May 11, 1889 (P. L. 188, No. 210), entitled "A further supplement to an act, entitled 'An act to establish a board of wardens for the Port of Philadelphia, and for the regulation of pilots and pilotage, and for other purposes, approved March twenty-ninth, one thousand eight hundred and three, and for regulating the rates of pilotage and number of pilots," further providing for rates of pilotage.

SB 503 (Pr. No. 540)

An Act amending the act of March 29, 1803 (P. L. 542, No. 156), entitled "An act to establish a Board of Wardens for the port of Philadelphia, and for the regulation of pilots and pilotages, and for other purposes therein mentioned," further providing for power of commissioners to license pilots, for rules of disputes, for review of proceedings, for neglect of duties and for disabled vessels; providing for inactive status, for refresher training, for grounds for discipline, for disciplinary sanctions, for additional pilotage, for compulsory pilotage and for penalties; and making repeals.

SB 559 (Pr. No. 596)

An Act amending Title 75 (Vehicles) of the Pennsylvania Statutes, further providing for leaving Consolidated an unattended child in a motor vehicle.

BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 474 (Pr. No. 746) - The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of April 9, 1929 (P. L. 177, No. 175), entitled "The Administrative Code of 1929," establishing the Governor's Office of Citizen Service (PennServe) within the Department of Labor and Industry; creating the Community Service Advisory Board; and providing for coordination of Commonwealth community service programs.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Schuylkill, Senator Rhoades, for his remarks on the legislation before us.

Senator RHOADES. Mr. President, would the Majority Leader stand for brief interrogation?

Senator LINCOLN. I will, Mr. President.

The PRESIDENT. He indicates that he will. The gentleman may proceed.

Senator RHOADES. Mr. President, on page 2 of the bill, under line 26, section (6), it says, "Educational activities, through a Pennsylvania education system"--which means our school system—"or a community or governmental entity, that instill an ethic of civic responsibility and citizenship in all Pennsylvanians and in particular young Pennsylvanians." Could someone explain to me, is that a value or an ethic or a moral?

The PRESIDENT. Senator Lincoln, I suppose that is directed to you.

Senator LINCOLN. Mr. President, if the gentleman has no objection, I would defer to the prime sponsor, Senator O'Pake.

The PRESIDENT. He does not seem to object. Senator O'Pake, can you field that question?

The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Mr. President, this is an attempt to allow PHEAA to, in the future, develop some type of incentive for those who are getting PHEAA scholarship assistance to provide some kind of community service in return for the State grant. It is purposely vague because we do not really know yet what the Federal government is going to come down with, and we want to make sure that Pennsylvania is able to capture those Federal dollars if and when they become available.

Senator RHOADES. Mr. President, I guess what I am interested in more so was just that "instill an ethic of civic responsibility and citizenship...." I think this refers back to the debate we had about 2 or 3 weeks ago relative to ethics and morals and standards, and so on and so forth.

I would also refer, just from the standpoint, too, on line 18, page 3, "(C) PennSERVE shall work to renew the ethic of civic responsibility in Pennsylvania...." I guess I am going to have to question, whose ethic?

And on page 4, under line 23, it says, "The plan shall include creation of a data base that will enable local governments to share information with educational institutions,...." I hope that is not going to meet with any objections of people's names and all being stored in some kind of data base, how terrible that could possibly be. I say that tongue in cheek.

The other thing is on page 6, under line 14, "(I) Educational programs that are aimed at increasing awareness in communities and educational institutions about community health programs," and

"(II) Engagement with community health clinics and professional medical personnel to ensure that all Pennsylvania children are immunized." I would bring up that when the State Board was asked to rescind that section, especially lines 14 to 16, it was done and taken out. There may be some difficulty in that particular portion.

I would add, I think that the PennSERVE concept is definitely needed and is a step in the right direction. I am just concerned from the great debate we had in this Chamber a few weeks back that this bill could get hung up because of those misinterpretations or interpretations.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Mr. President, I was glad to hear my distinguished colleague admit that he was speaking tongue in cheek. The ethic we are talking about is the work ethic. I think it is very obvious from the hearings that we had that our young people do want to give something back to their communities, and we have structured this bill in an attempt to make that possible so that the law, rather than impeding getting off the welfare rolls, would actually encourage people to get off the welfare rolls and work and give something back to their community.

Mr. President, are we on the merits of the bill now?

The PRESIDENT. We are on the question of final passage of Senate Bill No. 474.

Senator O'PAKE. Mr. President, I urge passage of this bill. Mr. President, we have the historic opportunity in Pennsylvania to provide sufficient avenues for our young people to give something of themselves back to their communities. Senate Bill No. 474 will permanently establish in State law PennSERVE, while expanding Pennsylvania's youth volunteerism initiatives. This legislation statutorily establishes the Governor's Office of Citizen Service within the State Department of Labor and Industry. It creates the Community Service Advisory Board to assist in the development of citizen service policy, and encourages a wide range of innovative community service initiatives. Among its provisions, the bill will link obligations to opportunities and rights to responsibilities for our young people by enabling college students to obtain tuition reimbursement and/or academic course credits for their community service. It also encourages community service as a key component of sentencing for nonviolent youth offenders.

Several weeks ago, the gentleman from Allegheny, Senator Belan, and I convened a joint hearing of the Committee on Labor and Industry and the Committee on Intergovernmental Affairs, and we listened to the inspiring words of many young people who summarized their triumphs over the cycle of welfare dependence. These young men and women testified about moving themselves from the welfare rolls to continued educational pursuits or active employment, as well as testifying about a renewed hope and involvement in themselves, in their community, and in a government that believed in their potential and their worth. Their testimony validates that this legislation will assist in the movement of individuals who had been caught in the web of welfare dependency, moving to independent and productive lives.

As the hearing progressed, it was apparent that all across this Commonwealth young people are meeting the needs of their communities as they offer food and friendship to the homeless, they aid older Pennsylvanians in maintaining their quality of life, they provide education and mentoring to their peers about drug and alcohol abuse and AIDS, they implement literacy training, as well as advocate for social change. We should affirm the existence of these programs by strengthening this call to service.

These youth service leaders, as well as each one of us in this Chamber, have answered a call to public service. We should guarantee that all young people in Pennsylvania have the opportunity to do the same.

The passage of Senate Bill No. 474 is consistent with the national movement to make public service a common expectation of all young people, and thus, Mr. President, I urge unanimous support for Senate Bill No. 474.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Mr. President, are we on final passage or third consideration?

The PRESIDENT. At the moment, we are on final passage.

RECONSIDERATION OF BILL

Senator BRIGHTBILL. Mr. President, I move that we reconsider the vote by which Senate Bill No. 474 was agreed to on third consideration.

The PRESIDENT. Senator Brightbill moves that the vote by which Senate Bill No. 474 was agreed to on third consideration be reconsidered.

On the question, Will the Senate agree to the motion? The motion was agreed to.

And the question recurring,

Will the Senate agree to the bill on third consideration?

AMENDMENT OFFERED

Senator BRIGHTBILL, by unanimous consent, offered the following amendment No. A0710:

Amend Title, page 1, line 23, by striking out and

Amend Title, page 1, line 24, by removing the period after "programs" and inserting: ; and further providing for aboveground refrigerated low-pressure storage and handling of propane.

Amend Bill, page 9, by inserting between lines 10 and 11:

Section 2. Section 2217 of the act, added December 18, 1992 (P.L., No.180), is amended to read:

Section 2217. Above-Ground Refrigerated Low-Pressure Storage and Handling of Propane.-The Department of Labor and Industry shall make, promulgate and enforce regulations setting forth minimum general standards for the design, installation and construction of above-ground refrigerated low-pressure storage facilities for propane. Said regulations issued under the authority of this act and the act of December 27, 1951 (P.L.1793, No.475), referred to as the Liquefied Petroleum Gas Act, shall be such as are reasonably necessary for the protection of the health, welfare and safety of the public and persons using such materials, and shall be in substantial conformity with the generally accepted standards of safety concerning the same subject matter. No above-ground refrigerated low-pressure storage facilities for propane can be operated within this Commonwealth after December 31, 1994, unless regulations have been issued by the Department of Labor and Industry under this section.

Amend Sec. 2, page 9, line 11, by striking out "2" and inserting: 3

On the question, Will the Senate agree to the amendment?

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Mr. President, last Session we dealt with this issue that the amendment deals with, which is aboveground refrigerated low-pressure storage facilities for propane. Last Session we passed a section of the Administrative Code which required the Department of Labor and Industry to adopt regulations for these kinds of facilities, and at that time I proposed as part of that package a provision that said that no such refrigerated propane storage facilities shall be operated until regulations are passed. That was defeated here in the Senate. Now I have received a letter from the Secretary of the Department of Labor and Industry, and what Secretary Foley's representative is telling me is that they do not intend to adopt regulations, that they now intend to proceed statutorily. That is fine, except that if they do not adopt statutes and they do not adopt regulations, we are going to go another couple of years and these tanks are going to exist because of the Commonwealth doing absolutely nothing.

So, the amendment that I have proposed here is an amendment to Section 2217, which provides that no aboveground refrigerated low-pressure storage facility can be operated within this Commonwealth after December 31, 1994, unless regulations have been issued by the department. In other words, the department has until the end of this legislative Session to either adopt regulations or this legislature has until the end of this Session to pass a law regulating these things, and I think that is being fair. I think that is plenty of time, and I would ask for a unanimous vote on amendment A0710.

As we in this great country of ours, and a free country, remember those who gave their lives in World War II and before in the worst atrocity, the worst genocide ever known to mankind, I think it is appropriate to never forget.

As we look at the action of neo-Nazism that appears to be on the horizon, I think it is important that each and every one of us remember as we vote for this resolution that it can, indeed, happen again unless all of us are vigilant and fight and protect the freedoms that we are so blessed with here.

So, Mr. President, I urge each and every one of my colleagues to vote not only for Senate Resolution No. 25 but to remember the reason behind it. It is not just some vote, some innocuous resolution. It is a meaningful resolution and one that I believe is as important to a free society as anything we could be voting on.

Thank you, Mr. President.

The PRESIDENT. On the resolution, the Chair recognizes the gentleman from Fayette, Senator Lincoln.

Senator LINCOLN. Mr. President, I would like to join with the gentleman from Blair, Senator Jubelirer, and the gentleman from Philadelphia, Senator Salvatore, in talking about something I think that many of us were fortunate enough not to have to experience, and I know in my lifetime, in my earlier and younger days, I did quite a bit of reading about the Holocaust and it is amazing how easily we can forget something like this if we do not force ourselves to remember it.

There were millions and millions of people who died in the middle 1930s and the early 1940s in Europe and in Asia. The thing that I think is important about this particular resolution is that we in this country who were not affected by this in any way, shape, or form as the people in Europe were have built two museums just recently. One of them opened in Los Angeles just a short time ago. It is called the Tolerance Museum. Fifty million dollars was spent. The tragedy of what happened then is portrayed so real in this particular museum that it is hard to believe. They take a young boy or a young girl and give you a card that shows their name on it and you go through the tour of this museum and at the conclusion of your tour they give you another card that shows you what happened to that young person, the number of young children who died in the prison camps during the Holocaust.

Very shortly, in the next 2 to 3 weeks, in Washington, D.C., there is another museum that is going to be opened as a remembrance of the Holocaust, and I think this is a very serious effort that we are making here today, that this resolution, I think, will always be something to remind us how easily this happened and how easily it could happen again and how difficult we should make it to happen just by thinking about it. So, I am very pleased to say that Senator Salvatore has offered this, and I am supportive and I would hope that the whole Senate supports this resolution.

DESIGNATING THE MONTH OF APRIL, 1993, AS "SEXUAL ASSAULT AWARENESS MONTH"

Senators SCHWARTZ, JONES, BORTNER, FATTAH, DAWIDA, STEWART, ANDREZESKI, LEWIS, REIBMAN, LaVALLE, STAPLETON, PETERSON, CORMAN, SHUMAKER, GREENLEAF, BAKER, RHOADES, FISHER, HART, LEMMOND, HELFRICK, JUBELIRER and LINCOLN offered the following resolution (Senate Resolution No. 38), which was read, considered and adopted:

In the Senate, March 30, 1993

A RESOLUTION

Designating the month of April, 1993, as "Sexual Assault Awareness Month."

WHEREAS, Sexual assault affects every person in this Commonwealth either as a victim/survivor of sexual assault or as a family member, friend, neighbor or coworker; and

WHEREAS, Incidents of sexual assault continue to increase and impact all racial, ethnic, economic, geographic and social groups, regardless of age or gender; and

WHEREAS, National, State and local statistics indicate an ever increasing demand for sexual assault services, education and community support; and

WHEREAS, Pennsylvania's sexual assault programs served 33,800 persons last year and over 8,000 of those were sexually abused children; and

WHEREAS, Statistics fail to completely represent the numbers of people sexually assaulted since fear of skepticism, ridicule and stigma continues to deter victims from reporting the violation to authorities and seeking help; and

WHEREAS, Pennsylvania's sexual assault programs' staffs and volunteers are working towards a society free of sexual violence by promoting prevention and providing numerous educational programs to schools, community organizations and other professionals; and WHEREAS, Sexual assault programs require commitment of community leaders and concerned citizens to continue providing quality services which aid unfortunate victims and survivors of sexual assault; therefore be it

RESOLVED, That the Senate designate the month of April, 1993, as "Sexual Assault Awareness Month" and encourage its members to participate in the awareness activities that will take place in their communities; and be it further

RESOLVED, That the Senate recognize the need to promote awareness, education and prevention of sexual violence in this Commonwealth and to support the diligent efforts of sexual assault centers to eliminate this violent crime.
