#### SENATE

TUESDAY, June 6, 1995

The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Mark S. Schweiker) in the Chair.

#### **PRAYER**

#### **REPORTS FROM COMMITTEES**

Senator HART, from the Committee on Finance, reported the following bills:

#### SB 633 (Pr. No. 657)

An Act amending the act of May 29, 1956 (1955 P. L. 1804, No. 600), entitled "Municipal Police Pension Law," providing for the establishment of police pension funds or pension annuities by regional police departments; further providing for employment of an actuary and for payments by the State Treasurer, and making editorial changes.

#### SB 651 (Pr. No. 683)

An Act amending the act of June 27, 1947 (P. L. 1046, No. 447), entitled "State Tax Equalization Board Law," further providing for the determination of market value of taxable real property.

#### SB 996 (Pr. No. 1193) (Amended)

An Act amending the act of June 21, 1939 (P. L. 626, No. 294), entitled "Second Class County Assessment Law," providing for reduction of tax rates in certain cases.

#### SB 1037 (Pr. No. 1140)

An Act providing for limits on real property assessments on counties of the first class.

#### HB 1488 (Pr. No. 1737)

An Act amending the act of June 17, 1913 (P.L.507, No.335), referred to as the Intangible Personal Property Tax Law, further providing for a variable rate of taxation on the value of personal property.

Senator PETERSON, from the Committee on Public Health and Welfare, reported the following bill:

#### HB 2 (Pr. No. 1519)

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Public Welfare Code, providing for a job training program and establishing a timetable for implementation; providing for pension funds of recipients; providing tax credits to employers of public assistance recipients; further providing for uniformity in administration of assistance, for a workfare program, for applications for assistance, for eligibility and for aid to families with dependent children; providing for an electronic benefit distribution system; imposing a penalty for failure to appear at a criminal court proceeding; and providing for powers and duties of the Department of Public Welfare, for retesting and for protective custody of AFDC children for a publicly financed voucher program to provide access to privately delivered health insurance coverage.

# BILL REREPORTED FROM COMMITTEE AS AMENDED ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 858 (Pr. No. 1135) -- The Senate proceeded to consideration of the bill, entitled:

An Act providing for adoption of capital projects to be financed from current revenues of the Keystone Recreation, Park and Conservation Fund.

On the question,

Will the Senate agree to the bill on third consideration?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Mr. President, we discussed this bill in the meeting of the Committee on Appropriations. For the benefit of the Members, this is the SWAM bill, S-W-A-M bill.

Mr. President, we have a Governor who is, to put it kindly, a hypocrite who says to the General Assembly that WAMs are evil, that you cannot have WAMs, you should not be putting this money into your districts, and hates the process because it is discretionary, and yet we have before us a bill which gives the administration the ability to do all those, quote, "evil things," end of quote, that the Governor says the legislature should not do.

Mr. President, I refer the Members to the notes of testimony of the Committee on Appropriations hearing before the gentleman from Montgomery, Senator Tilghman, and myself on April 4, 1995, when Secretary Seif and Mr. Solano, the Deputy Secretary of DER, appeared before us, and I would like to read into the record some of the interrogation on behalf of the gentleman from Montgomery, Senator Holl, and myself. On page 43 it begins:

SENATOR HOLL: Are these items listed in the budget anywhere as a line item?

MR. SOLANO: Those items are not listed in the budget

SENATOR HOLL: In other words, they're purely a departmental decision --

MR. SOLANO: That's correct.

SENATOR HOLL: -- by people here in Harrisburg? How do they compare to WAMs? It sounds like Solano WAMs, Governor's WAMs.

MR. SOLANO: Senator, when I evaluate these, they're WAMs of a sort.

SENATOR HOLL. Thank you, Mr. Chairman.

Then we go on, and on page 61 of the notes I began my interrogation:

SENATOR FUMO: One last area of questions, if I may. We were talking before with the Solano's WAMs, Key 93 grants. When you provide that list to Senator Tilghman are you going to provide him the whole list, Pat?

MR. SOLANO: Yes.

SENATOR FUMO: We have no problem with you having WAMs, we have no problem with that.

MR. SEIF: They're called SWAMs.

SENATOR FUMO: That was our problem, we didn't mean to name these things WAMs, if they were something else they'd be all right, but I just want to explore this area a little bit because the government [sic] seems to be so adamant against the WAM process, although it's ill-defined in his mind.

Also in your document on page 5 it talks about grants provided through the federal land and water conservation fund program. Are they handled in a similar fashion? Pat, maybe you can tell us how it is divvied up.

MR. SOLANO: Our land and water fund, Senator, is down to where I think we're only getting 400,000.

SENATOR FUMO: Some senators would consider that a nice size WAM.

MR. SOLANO: WAMs, most of the projects we do with those relate to those that we have. We have projects in a preferential order of need, a lot of them in the sewage treatment.

SENATOR FUMO: Who determines the preferential order of need?

MR. SOLANO: We go over the program, it comes from the program people, and I have to approve it.

SENATOR FUMO: So you approve -

MR. SOLANO: That's before the secretary gets it.

SENATOR FUMO: So it's similar to a Senator determining his priority needs in his district, you do it statewide.

MR. SOLANO: Now and then I get a request from a Senator that I look at more heavily.

SENATOR FUMO: Okay, I just want to get this straight, if you could provide us with all those types of internal decisions that are made and the criteria, for example, the trails money, where you just said you got, I think you said 1.2 million in requests for 800,000 dollars.

MR. SOLANO: That's correct.

SENATOR FUMO: That means that somebody is going to have to make a decision about who gets the 800,000 and there's going to be some disappointed 400,000 worth of disappointed projects. How is that done in your shop?

MR. SOLANO: What we did in this, we're working with the local communities on this to where we have a guideline that we use in establishing the priority nature of it based on the beneficial use of where it connects from one place to another or where it connects with an enterprise or where it connects with another state park.

Mr. President, it goes on and on, and basically the bottom line is that these are Governor's WAMs. Mr. President, I have no objection to the legislative initiative process. I do have an objection to the hypocrisy of Governor Ridge, on the one hand saying he does not like discretionary spending, but on the other hand stating that it is a wonderful program if he is the one who gets to do the discretionary spending.

Mr. President, more troubling to me is the fact that at this very moment Deputy Secretary Solano has been instructed by the front office to begin lobbying legislators and Senators for the Governor's choice program. Now, when we have an individual who is in charge of this much money in a discretionary fashion calling Members about educational choice, which is the Governor's pet project, and therefore, through innuendo, using

a blackmail and extortion process, this is what the Governor calls good government?

#### POINT OF ORDER

Senator LOEPER. Mr. President, point of order.

The PRESIDENT. The gentleman from Delaware, Senator Loeper, will state his point.

Senator LOEPER. Mr. President, I believe that the debate has gone far afield, and to refer to actions of the Governor or any of his employees as blackmail I think is totally out of bounds, and I would ask the Chair to rule it out of order.

Senator FUMO. Mr. President.

The PRESIDENT. I would remind Senator Fumo that he will confine his remarks to the topic at hand.

Senator FUMO. Mr. President, by authorizing and voting for this bill today, we put into the hands of the Governor a vast amount of money at his discretion. And the person who is making those discretionary decisions has been instructed by that front office to call the General Assembly on a legislative issue that is important to the Governor that will shortly be before this General Assembly. Maybe blackmail is a word that offends the other side, so I will not use it, but I will give you the scenario that is going on. This Governor has the audacity to say to Members of this General Assembly that what we did in previous years with legislative initiative grants was immoral, it was wrong, it should not be repeated again, and yet he takes the process and refines it to a new height. That, Mr. President, is appalling.

I know that this Governor came here and said he was for change, but I think the people of Pennsylvania thought that change was to be a positive one and not a negative one. He has taken the art of politics far beyond Tammany Hall and given it new definition. He is a politician's politician, a hack's hack, and this is just another vehicle for him to--

#### POINT OF ORDER

Senator LOEPER. Mr. President, point of order.

The PRESIDENT. Senator Fumo, please confine your remarks to the topic at hand.

Senator FUMO. Then if we are going to give him this vehicle to do this with, we should understand clearly what we are doing. We are only giving him more ammunition to come back and use it against us when we attempt to exercise our honest discretion in voting on various issues, particularly the issue of school choice.

Mr. President, I recognize there are many Members who need the projects in here, and I will not ask for a negative vote on this bill because of that fact. It is just a shame that we have to witness this type of, and I do not know what else to call it besides blackmail, so I will just say this type of "blank" and you fill in the word, in State government. Mr. President, I think it is another sad day in Pennsylvania, and regrettably, with this Governor, those sad days are coming on a very disturbing, regular basis.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Loeper.

Senator LOEPER. Mr. President, I think the Members are well aware that the bill before them deals with the appropriation or authorization of capital money for 12 different State Parks throughout the Commonwealth of Pennsylvania. It is money that is appropriated from the Keystone Park and Recreation Fund, or Key 93, that would be matched by Federal dollars to give much needed improvements to many of these State Parks that have long needed some additional funding in order to complete their capital projects.

As I stated earlier, I think the previous speaker was totally out of line as far as his remarks about the motivations of the Governor and this administration. Mr. President, this is no different than many capital funding bills that we have for authorization before this Senate, and I would ask for an affirmative vote.

And the question recurring,

Will the Senate agree to the bill on third consideration? It was agreed to.

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

### BILLS ON THIRD CONSIDERATION AMENDED

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, providing for improper use of criminal investigative material.

On the question,

Senator BRIGHTBILL, on behalf of himself and Senator MELLOW, offered the following amendment No. A3041:

Amend Sec. 1 (Sec. 4501), page 1, line 18, by striking out "sentence is imposed." and inserting: any of the following occur:

- (1) Sentence is imposed.
- (2) The defendant is acquitted.
- (3) The trial is otherwise finally resolved. This paragraph includes dismissal of charges, acceptance of a plea bargain or the declaration of a mistrial in a situation which would give rise to double jeopardy.

On the question,

Will the Senate agree to the amendment?

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Mr. President, Senate Bill No. 468 deals with statements made and information provided for compensation by prosecuting officers during the course of an investigation. The facts that come out of this deal with the Susan Reinert homicide case and an individual named Dr. Jay C. Smith who was charged with that. Since then he has filed a civil rights action against an author by the name of Wambaugh.

I would like to just read into the record, for the Members' appreciation, a portion of a memorandum opinion that was handed down on May 15 by the Federal court having to do with this matter. Smith alleged in his complaint that Troopers Holtz and Van Nort were the primary investigators assigned to investigate the Reinert murder, which occurred in July 1979. Smith alleges that in correspondence or a letter dated January 29, 1981, Wambaugh promised to pay Van Nort an additional \$45,000, saying, "This [case] is current and hot which is why I'm offering you this kind of money."

The opinion recites that the correspondence also provides that Wambaugh wrote, "During this period of time you would reveal to me everything you know about the case and supply me with any documents which might help me.'" And then the opinion alleges that on June 19, 1981, Van Nort told Wambaugh by correspondence, "Things are going well, here, but slow. I will keep in touch with you."

I would call to the Members' attention that this kind of money, \$45,000, which is a lot of money, was offered in 1981. It is now 1995, and I think that this practice of having authors and TV writers and those kinds of people pay for information is one that really has the great potential of affecting our criminal justice system.

I thank the Members for their support in the past, and I would hope that we can pass this bill in the near future.

And the question recurring,

Senator CORMAN. Mr. President, in 1966 the General Assembly passed into law the Recreational Use of Land and Water Act to encourage owners of land to make land and water areas available to the public for recreational purposes by limiting their liability. The act was to protect the landowner, either private or public, from liability and negligence for injuries arising out of the free recreational use of land and water. Landowners are still liable for willful or malicious failure to guard or warrant against dangerous conditions. This protection was a major factor in leading many landowners to permit free public hunting, hiking, fishing, boating, or other recreational pursuits on their property.

Subsequent to the act's passage in 1966, several Supreme Court cases have narrowed the scope of the act, allowing that improvements to these recreational lands were not protected under the act. This uncertain state of law has discouraged landowners and clubs and other organizations from undertaking projects for better access for persons with disabilities. Such projects may include special hunting areas, parking facilities near boating, fishing, or hunting areas, trails, wheelchair ramps, other special fishing piers and boat docks, just to name a few.

The language in the bill we are about to consider, Senate Bill No. 654, clearly provides protection for these most important land improvements that will allow all Pennsylvanians to enjoy the bountiful recreational opportunities that our State provides now and, under the protection of this bill, will continue to develop in the future.

WHEREAS, Community banks have reinvested, on average, 95% of their loan portfolio in their own communities through residential mortgages and commercial, agricultural and student loans; and

WHEREAS, Community banks play a significant role in local economic development efforts, stimulating the economy to produce jobs and new opportunities and, as a group, they contribute an important and strong part of this Commonwealth's economic fabric; and

WHEREAS, Community banks also enjoy the trust of their customers; and

WHEREAS, Indeed, neighbors are helping neighbors build their homes, save for higher education, plan for retirement and fulfill other dreams: and

WHEREAS, Community banks have long helped in the development of our communities and this Commonwealth as a whole; therefore be it

RESOLVED, That the Senate of Pennsylvania designate June 12 through 16, 1995, as "Community Banking Week" in Pennsylvania with heartfelt appreciation for the contributions of these helpful institutions.
