The PRESIDENT (Lieutenant Governor Mark S. Schweiker) in the Chair.

The PRESIDENT. The Chair recognizes the gentleman from Favette, Senator Kasunic.

Senator KASUNIC. Mr. President, I rise today to ask my colleagues to support Senate Bill No. 109. It will provide the necessary State funding to convert Somerset State Hospital into a medium security prison. Although I and the community would have preferred to keep it open as a State hospital, we

found after numerous meetings with the administration that a closing was inevitable. It was not, and I want to stress this, it was not a question about the care or the quality of care at the facility. It was simply a numbers crunch. The evidence for that is over the years the hospital has been commended many, many times over, as well as its employees, for the quality of care that it gave to its patients.

In essence, what we are saying is that if we simply just allow the hospital to close, it would have a very devastating effect on the economy of Somerset County, a county that already has a very high unemployment rate. I am simply saying that it would add to the county's troubled economic problems, and it is vital that we today approve funding to convert the hospital to a correctional facility and save the much needed jobs in Somerset County. I ask for your support.

Thank you very much, Mr. President.
