SENATE

TUESDAY, January 28, 1997

The Senate met at 1 p.m., Eastern Standard Time.

The PRESIDENT pro tempore (Robert C. Jubelirer) in the Chair.

URGING THE PENNSYLVANIA TURNPIKE COMMISSION AND THE PENNSYLVANIA DEPARTMENT OF TRANSPORTATION TO CONSIDER PROVIDING PARKING AREAS AT INTERCHANGES OF THE TURNPIKE AND NORTHEAST EXTENSION AND AT INTERCHANGES OF OTHER MAJOR HIGHWAYS IN THIS COMMONWEALTH

Senator HOLL offered the following resolution (Senate Resolution No. 10), which was read and referred to the Committee on Transportation:

In the Senate, January 27, 1997

A RESOLUTION

Urging the Pennsylvania Turnpike Commission and the Pennsylvania Department of Transportation to consider providing parking areas at interchanges of the turnpike and Northeast Extension and at interchanges of other major highways in this Commonwealth.

WHEREAS, It is the public policy of this Commonwealth to encourage conservation of our natural resources; and

WHEREAS, The use of car pools by the motoring public of this Commonwealth is a worthwhile conservation endeavor to conserve natural resources such as oil and natural gas; and

WHEREAS, There is currently very little short-term or long-term parking space available to the general public at the interchanges of the Pennsylvania Turnpike and the Northeast Extension and at interchanges of other major highways in this Commonwealth; and

WHEREAS, Additional short-term and long-term parking for the general public at the interchanges of the Pennsylvania Turnpike and the Northeast Extension and at interchanges of other major highways in this Commonwealth would facilitate and encourage carpooling by the citizens of this Commonwealth; therefore be it

RESOLVED, That the Senate of Pennsylvania urge the Pennsylvania Turnpike Commission and the Department of Transportation to consider providing parking areas for use by the general public at the toll interchanges of the Pennsylvania Turnpike and the Northeast Extension and at interchanges of other major highways in this Commonwealth.

RESOLUTION FROM THE STATE OF OHIO

The PRESIDENT pro tempore laid before the Senate the following Concurrent Resolution No. 21 from the Ohio General Assembly, which was read by the Clerk as follows:

(121st General Assembly) (Senate Concurrent Resolution Number 21)

CONCURRENT RESOLUTION

To urge the United States Congress, governors of other states, and other state legislatures to support H.R. 1842 and other legislative initiatives to mitigate the economic warfare among the states that has resulted from the adoption of targeted business incentive programs.

Be it resolved by the Senate of the State of Ohio (the

House of Representatives concurring):

Whereas, Targeted business incentive programs have proliferated into a counterproductive economic war between the states and now form the cornerstone of state-sponsored "economic development" policies: and

Whereas, These programs fail to promote healthy and equitable statewide economic growth and, in reality, result in states engaging in economic warfare moving businesses from one location to another both within and between states, with no significant economic benefit in the aggregate; and

Whereas, America's future in the global economy lies within its educational, industrial, technological, and research capabilities throughout the entire fifty states; and

Whereas, Disarmament of wasteful programs can be achieved through a combination of new state and federal policies; and

Whereas, States would be better off providing a less burdensome tax climate for all businesses and a quality educational system geared to providing an adequately trained and ready work force, support for research and development, and a quality transportation system, along with other high-quality traditional government services; and

Whereas, Efforts are currently under way in the United States Congress to identify and eliminate federally funded programs that are used by the states to escalate this economic warfare; now therefore be it

RESOLVED, That the General Assembly of the State of Ohio strongly urges the Ohio Congressional delegation to embrace and support efforts in the United States Congress such as H.R. 1842 and other legislative initiatives that will begin to mitigate this economic warfare; and be it further

RESOLVED, That the General Assembly strongly urges the governors and other legislatures in the respective states to promulgate this message; and be it further

RESOLVED, That the Clerk of the Senate transmit duly authenticated copies of this Resolution to the members of the Ohio Congressional delegation, to the Speaker and Clerk of the United State House of Representatives, to the President Pro Tempore and Secretary of the United States Senate, and to the governors and the appropriate officers of the legislatures of all the other states.

BILL REREPORTED FROM COMMITTEE AS AMENDED, AMENDED

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Delaware, Senator Loeper.

Senator LOEPER. Mr. President, the amendment adds one additional judge in Northumberland County.

And the question recurring,

Will the Senate agree to the amendment?

It was agreed to.

On the question,

Will the Senate agree to the bill on second consideration, as amended?

Senator BODACK offered the following amendment No. A0011:

Amend Sec. 1 (Sec. 911), page 2, line 2, by inserting brackets before and after "41" and inserting immediately thereafter: 43

On the question,

Will the Senate agree to the amendment?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Bodack.

Senator BODACK. Mr. President, this amendment would call for adding two judges to the Court of Common Pleas of Allegheny County. This coming June it will be 3 years since the Senate first considered adding more common pleas court judgeships throughout Pennsylvania, and we are here again today to do the same thing.

Since that time there has been, of course, an ever-increasing caseload in Allegheny County, and I have become convinced that there is an absolute need for these additional judges in my home county. I still believe that the State needs to do more to properly fund the courts throughout the Commonwealth, but by the same token I do not believe that the issue should cause us to sidetrack this legislation at this time.

In June 1994 the legislation called for five additional judges in Allegheny County. That bill failed enactment, as did a similar proposal in early 1995. At that time, Mr. President, Senator Fisher, who was the Majority Whip of the Senate, argued in the debate we had here at the time that he thought the Senate should have agreed that the existing system for reimbursing the counties for judgeships should stay for these new judgeships that we were doing that day. In essence, he said the reality is that the Allegheny County commissioners' opposition, not the creation of judgeships, should not be considered. He went on to further state that he believed that Allegheny County would in fact need five new judgeships over the course of the next 3 years. Well, it has been 3 years, and if you look at the caseload Senator Fisher referred to at that time, the court handles very much the same type of caseload that the city of Philadelphia does, which has almost double the number of judges that we have in Allegheny County.

Now today, Mr. President, my amendment draws on the same talk that we had with Senator Fisher a few years ago. This amendment provides for two additional judges for Allegheny County. It is not the five that were asked for the last time when I felt it was not necessary. Since that time I have seen the caseload increase. I have discussed personally with the president judge the need for these additional judges in Allegheny County, and I am at this point convinced of the absolute need for two additional judges, not the five that I argued against 3 years ago.

Today there are cases that involve gang wars, drive-by shootings, sexual harassment, dysfunctional families, product liability, and issues such as asbestos exposure. Mr. President, I submit that those cases are bursting the dockets of the civil, criminal, and family courts of Allegheny County. Allegheny County does need these additional judges, and I urge support on both sides of the aisle for this amendment.

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Allegheny, Senator Hart.

Senator HART. Mr. President, I rise in opposition to the amendment. I think, as those of us who are Members of the

Committee on Judiciary discussed, the counties that are to be included in this bill are the ones in which the county commissioners in those counties and the president judges in those counties have agreed that they can, number one, afford to pay for additional judges and, number two, obviously, that they need an additional complement of judges. I did receive a letter from the president judge of Allegheny County just last week asking for additional judges. However, Mr. President, I have conferred with county commissioners in Allegheny County and they are not convinced that we need to add two judges to the bill at this time.

Mr. President, I ask for a negative vote on the amendment for the very reason that I think we need to establish that a county can afford these judges before we send an additional mandate to that county, and consider the request of the president judge in Allegheny County further and possibly include it in a later bill to add the complement to that county, because all the other judges that are in this bill, the additional judges, have been agreed to by the county commissioners and the president judges of those counties included.

So again, I ask for a negative vote on the amendment. Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Bodack.

Senator BODACK. Mr. President, I would like to point out to the gentlewoman from Allegheny, Senator Hart, that there are counties, I understand, where the commissioners have not agreed to the addition of judges in their counties, and I would like to further point out that 3 years ago in the debate with Senator Fisher, he stated that this is not a mandate, rather it is a shared responsibility between the legislature and the counties that are involved. I submit to the Members today that that has not changed and it should still be a shared responsibility as opposed to a mandate for Allegheny County.

Thank you, Mr. President.
