The Bethel Park Varsity Hockey Club won the PIAA Hockey championship this year in West Chester with an overall record of 25 wins, 1 tie, and 0 losses. These titans of terror laid a path of destruction through high school hockey that is still being felt today. Their tenacity and talent were only matched by their speed and sportsmanship.

As an example of the Blackhawks' fortitude, I offer a story of one player, Mike Sill. Last year I personally watched him get knocked down in a game against the mighty Meadville Bulldogs, and he was knocked down again after he got up, after receiving an injury which required 14 stitches. He may have been temporarily down but he was not out of the game, and he burst to his feet and scored immediately. The story is not merely anecdotal but serves as an example to describe a team that is tough, tenacious, and intimidated by no one. The Blackhawks had one goal in mind: the State championship. Mr. President, once this freight train gained momentum, there was nothing to stop these Hercules of hockey.

During the playoffs, many worthy opponents fell victim to their prolific pummeling. However, their opposition was not paltry. In the championship game for the Penguin Cup, the Blackhawks defeated the mighty Meadville Bulldogs 3 to 2. In deference to the gentleman from Mercer, Senator Robbins, the Bulldogs were a worthy opponent, having won five previous consecutive State championships, but the Blackhawks had a date with destiny.

After their victory over the Meadville Bulldogs, their climb to the top concluded in West Chester against the Friars of Malvern Prep. Again, to the gentleman from Chester County, Senator Thompson, I tip my hat. He can be proud of a great team. But with a final score of 4 to 3, Malvern proved to be a formidable force. However, the Bethel Park bird of prey was soaring to greater heights and would rightfully make his nest on the championship title. The Friars were left to look on with admiration to a prize lost to a strategic strike by Bethel Park.

So, Mr. President, in closing, I offer my congratulations to head coach Bob Kennedy and the entire Bethel Park Varsity Hockey Team for a great season and an outstanding achievement.

PETITIONS AND REMONSTRANCES

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise today to talk about an issue that is extremely important to me and it has been for many years. I rise today to speak about the community colleges throughout the Commonwealth of Pennsylvania. The reason that I speak about the community colleges today and why this issue is important to me is that I am a graduate of Allegheny County Community College, and three other members of my family have had the opportunity to attend the community colleges in our county and they were very fortunate to be able to take the college education they received at the community colleges and move on to 4-year institutions and receive their degrees in that regard.

Mr. President, these higher education institutions provide a valuable education to those individuals who may be financially challenged, who are seeking a chance, and in many cases that chance is a second chance at a better and brighter future. Community colleges throughout our Commonwealth continue to provide the best higher education alternative to 4-year institutions, given the occupational and technical programs that they have to offer. Mr. President, these types of programs that are being offered ultimately end up leading to employment in skilled positions, which we so desperately need throughout our Commonwealth.

However, Mr. President, over the years tuition costs have constantly been on the rise. This should not be the case since most of the individuals who choose to go to community colleges and attend these fine institutions have lower tuition reimbursement rates than many other institutions, and we should try to strive to make those tuition rates even lower. Mr. President, today community colleges are in a real crisis, given an inadequate State funding formula, tuition which is capped by State law, and more importantly, difficulty with local governments and school districts and their ability to maintain adequate levels of tuition reimbursement. The current financial system underfunds by more than \$2,000 per student, compared to other States across our nation. Unfortunately, today community colleges are limping along year after year with primitive computers and other teaching resources, not to mention postponing maintenance projects because of the lack of sufficient funding.

Mr. President, community colleges not only perform a great service to the students attending, but they also perform a very valuable service to business, to government, to civic and non-profit organizations. They do this by formal and informal arrangements that have been devised over the years by these businesses and organizations to allow them to send employees and potential employees to community colleges for very specific training.

Mr. President, I find it hard to understand why it is that we are making it harder and harder for students to attend community colleges and we are making it easier for businesses in our Commonwealth to come here and provide work for our graduates. We need to do both, Mr. President. If not, these companies that come to Pennsylvania will be forced to go outside of Pennsylvania for their employees instead of looking at the individuals they already have in our Commonwealth who are ready, willing, and able to do the jobs that they need. We need to ensure that Pennsylvanians are competitive in the workforce, and to do this we need to provide a lower cost of education at the community colleges across this Commonwealth.

Mr. President, as I mentioned earlier, I am a graduate of the Community College of Allegheny County. I could not be more pleased with the fine education that I received there. It prepared me for my future endeavors of schooling at Indiana University of Pennsylvania, and ultimately at Duquesne University School of Law. Mr. President, over the past several years I have had the opportunity to serve as an adjunct professor at the community college, and it is my way of giving back to this great higher education institution, not only for the edu-

cation I received there but for the experiences I received while in attendance.

So, Mr. President, I stand today to ask my colleagues at a time when we are stressing the importance of education to the future of the Pennsylvania economy, from charter schools to school vouchers to higher education, I ask all of the Members to stop and think of the benefits that the community colleges across our Commonwealth have given to the nearly 310,000 students actively attending the community colleges throughout our Commonwealth.

Mr. President, this brings about another concern. The State Board of Education believes that there should be 28 community colleges across the State, but today we only have 15. That is a little more than 50 percent of the number which is desired and would be appropriate throughout our Commonwealth. In fact, in Beaver County and in nearby Allegheny County there is a concern that the Community College of Beaver County will be forced out of business within the next 18 months. Mr. President, I think we can all agree that we need to do something to prevent tuition costs from rising while our enrollment is declining. I pledge my support and ask for action from my colleagues as we address this budget issue in the State Senate and House today and tomorrow to devise a plan to help decrease the tuition costs of community colleges.

Mr. President, I thank you and the Members of the Senate for allowing me the opportunity to speak about this very important issue.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Delaware, Senator Loeper.

Senator LOEPER. Mr. President, I could not help but hear the gentleman's interest in the community colleges throughout Pennsylvania and the vital role that they play in our education community. I think that tomorrow, Mr. President, on the Senate floor when we have an opportunity to consider a general appropriations bill, the gentleman will be very pleased with what was able to be done for our community colleges in Pennsylvania as part of the new 1997-98 General Fund budget, the areas of concern that were addressed, areas that were brought to the budget table not only by Senator Fumo, representing his Caucus, but also by many Members in our Caucus as well as the House of Representatives. I think that there was a sincere recognition of the role that the community colleges play, and we wanted to try to address that in order to help them out in the coming year, and I think the gentleman will be pleased with the results of it.
