#### HOUSE CONCURRENT RESOLUTION NO. 6

Jan. 30, 1997

MEMORIALIZING THE U.S. CONGRESS TO PROPOSE AND SUB-MIT TO THE SEVERAL STATES AN AMENDMENT TO THE CONSTITUTION OF THE UNITED STATES PROVIDING THAT NO COURT SHALL HAVE THE POWER TO LEVY OR INCREASE TAXES.

WHEREAS, separation of powers is fundamental to the United States Constitution and the power of the federal government is strictly limited: and

WHEREAS, under the United States Constitution, the states are to determine public policy; and

WHEREAS, it is the duty of the judiciary to interpret the law, not to create law, and

WHEREAS, our present federal government has strayed from the intent of our founding fathers and the United States Constitution through inappropriate federal mandates; and

WHEREAS, these mandates by way of statute, rule or judicial decision have forced state governments to serve as the mere administrative arm of the federal government; and

WHEREAS, federal district courts with the acquiescence of the United States Supreme Court, continue to order states to levy or increase taxes to comply with federal mandates, and

WHEREAS, these court actions violate the United States Consti-

tution and the legislative process; and

WHEREAS, the time has come for the people of this great nation and their duly elected representatives in state government, to reaffirm, in no certain terms that the authority to tax under the Constitution of the United States is retained by the people who, by their consent alone, do delegate such power to tax explicitly to those duly elected representatives in the legislative branch of government who they choose, such representatives being directly responsible and accountable to those who have elected them; and

WHEREAS, several states have petitioned the United States Congress to propose an amendment to the Constitution of the United States of America; and

WHEREAS, the amendment was previously introduced in Congress; and

WHEREAS, the amendment seeks to prevent federal courts from levying or increasing taxes without representation of the people and against the people's wishes; and

NOW, THEREFORE:

BE IT RESOLVED by the House of Representatives of the 139th General Assembly, the Senate concurring therein that the Congress of the United States prepare and submit to the several states an amendment to the Constitution of the United States to add a new article providing as follows:

"Neither the Supreme Court nor any inferior court of the United States shall have the power to instruct or order a state or a political subdivision thereof, or an official of such a state or political subdivision, to levy or increase taxes."

BE IT FURTHER RESOLVED that the Legislature of the State of Delaware also proposes that the legislatures of each of the several states comprising the United States that have not yet made similar requests apply to the United States Congress requesting enactment of an appropriate amendment to the United States Constitution, and apply to the United States Congress to propose such an amendment to the United States Constitution.

BE IT FURTHER RESOLVED that the Secretary of State of the State of Delaware transmit copies of this Resolution to the President

and Vice President of the United States, the presiding officer in each house of legislature in each of the states of the Union, the Speaker of the United States House of Representatives, the Majority Leader of the United States Senate and to each member of the State of Delaware Congressional Delegation.

## **SYNOPSIS**

In 1990, a U.S. Supreme Court decision (Missouri v. Jenkins) upheld an appeals court ruling which affirmed a District Court's order allowing the local school board to raise property taxes as part of a school desegregation plan in Kansas City. This Resolution calls for an amendment to the U.S. Constitution which would end the self-proclaimed authority and power to tax which the federal courts have given themselves. The language of the proposed amendment does not change the Constitution. Rather, it reasserts a basic premise of representative government-there shall be no taxation without representation.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, also with the spirit of recognition, they are no longer here, they had to leave about 4 hours or so ago, but we were blessed in the gallery with the presence of the Overbrook High School Mock Trial Team, which earlier this year won the Pennsylvania Bar Association's Statewide High School Mock Trial Competition and then went on to the national competition in Nashville, Tennessee, and finished in the top half of the 42 teams that were competing.

For purposes of the record, Mr. President, I would like to call off the eight members of the team. Their names are Bridgett Richardson, April Wood, Yenneeka Long, Myishing Cox, Desiree Travers, Tanika Lott, Tyray Miller, Tiyana Miller, Stefanie Threet, Timothy Carr, and Chanae Smith. Bruce Eisenberg, Mr. President, is their teacher sponsor; Erick Chizmar, from the Timby law firm, was their attorney coach; and

Phil Beauchemin, from Overbrook High School, was their guidance advisor.

In their absence, Mr. President, I would appreciate if the Members of the Senate would give them a warm round of applause and recognition for the great accomplishment that this mock trial competition team from Overbrook High School performed.

The PRESIDENT. The Chair thanks Senator Hughes for bringing that to our attention and their presence earlier in the afternoon.

(Applause.)

The PRESIDENT. The record will reflect their presence and their accomplishments and the fact that this body took a moment to recognize the same.

Whereas, He worked closely with the Department of Health to establish the Pennsylvania Egg Quality Assurance Program, which works to protect consumers against egg-related food poisoning that has been problematic in other states; and

Whereas, Charles C. Brosius strives to model his character on that of Thomas Jefferson, and he exemplifies Jefferson's ideals of honesty, loyalty, hard work and public service; and

Whereas, He is a family man who shares the credit for all of his considerable successes with Jane Brosius, his wife and partner in work and life; and

Whereas, Charles C. Brosius is a successful farmer and businessman in his own right and a man of unquestioned integrity and commitment to the highest ideals, both personally and professionally; therefore be it

Resolved, That the Senate honor and express its gratitude to Charles C. Brosius for his lifetime of achievements and public service.

On the question,

Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Bradford, Senator Madigan.

Senator MADIGAN. Mr. President, I would like to thank my colleagues who signed on as part of this resolution.

There is an old saying about bureaucrats who regulate agriculture. Farming looks mighty easy when your plow is a pencil and you are a thousand miles from the cornfield. It is a pretty accurate statement that just about sums up how most farmers feel about the folks in Harrisburg. That is why the resignation of Charles Brosius was such a blow to our farm community. Although he was an excellent government official, Charlie was always a farmer first and he never forgot what it was like to make a living growing crops and livestock. He is a public servant in the true sense of the word, one who really looks out for his constituency, the men and women who operate farming operations, large and small.

He has been hailed by leaders in agriculture for his successful efforts to make the Agriculture Department more farmer-friendly and reducing bureaucratic red tape. And Charlie has been applauded for his work on new initiatives like the development of the Diagnostic Veterinary Laboratory and the passage of the Domestic Animal Health Act. Charlie knows how important it is for farmers to find new markets for their products, and during his tenure he pioneered efforts to improve the promotion and export of our Pennsylvania products.

More importantly, Charlie Brosius is a man of conviction and principle. Whether serving in State government or heading up his own successful business, Charlie is first and foremost a good man who strives to do the right thing and who succeeds in doing the right thing. Those of us serving in the legislature and his former employees will miss him, and so will the men and women who operate farms throughout our great Commonwealth. They have lost an advocate and a friend, which is something they very much need in Harrisburg. His shoes will be tough to fill, and his departure is a sad thing for the farm community and our Commonwealth.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Delp.

Senator DELP. Mr. President, today we have an important occasion here in the Senate of Pennsylvania. Through the resolution that we have before us, we are taking the opportunity to honor a man whose lifetime of achievement and public service truly make him a unique Pennsylvanian, that person being Secretary of Agriculture, Charlie C. Brosius. During his tenure with the department, Secretary Brosius has been a tireless advocate for the Commonwealth's number one industry, an industry that will continue to benefit from his legacy for many years to come. His efforts on behalf of the farming community and his advocacy for agribusiness here in Pennsylvania are unparalleled.

His successes are too numerous to mention, but we would be remiss if we did not acknowledge some of his most noteworthy achievements, including making the Department of Agriculture more farmer-friendly, reducing bureaucracy red tape, overseeing the development of the new Diagnostic Veterinary Laboratory, and assisting in the passage of the Domestic Animal Health Act, which are today providing critical services to Pennsylvania farmers as we deal with the current avian flu epidemic.

Secretary Brosius also spearheaded Pennsylvania's efforts to improve the promotion and export of our food and forest products and helped to strengthen our presence in the global market-place. He was responsible for the creation of the first International Day activities during the annual Farm Show.

But additionally, I want to take an opportunity today to thank his wife, Jane, who graciously shared Charlie with the Commonwealth for the last 3 years. And I can tell you from my own personal experience, not too many weeks ago I had a town meeting down in my district in Loganville, in the heart of the farm country down in York County, and Secretary Brosius was gracious enough to give up one of his free nights to come down and speak to the farmers, and accompanying him that evening was his wife, Jane. That is quality time when you are a public servant. I know I do not need to tell my colleagues all about that. They live that life as well. But certainly Jane has made a sacrifice over the last 3 years as well, and I appreciate it.

Mr. President, as chairman of the Senate Committee on Agriculture, I can tell you that our State government is going to miss Charlie Brosius. After all, this successful farmer, businessman, and family man is the embodiment of integrity and a commitment to high ideals. But I am certain as we move forward in his absence, we will build on his successes and his vision, and we will embrace the future and move into the next century, thanks in a large part to his accomplishments.

I ask for a unanimous vote on the resolution we have before us today honoring Secretary Brosius.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Bell.

Senator BELL. Mr. President, I have been here a good many years. I have seen Secretaries of Agriculture come and go. Charlie Brosius is the finest Secretary of Agriculture I have known, and he is also one of the best Secretaries that this State has ever had. He is a neighbor to my southern Chester County neighbors, whom I represent. Not only has he done what was said here before, fighting avian flu, but he is also involved in that threat to the mushroom industry, the mold, which could destroy a multimillion dollar industry, and I understand that they finally are breaking through with a solution.

Charlie Brosius is loved and respected by his neighbors in Chester County, and I just want to quote him on one statement he made to me one day. We were talking about the future of agriculture, and he said, "There is a three-legged stool - Penn State, New Bolton, and the Secretary of Agriculture - and that three-legged stool is the backbone of the biggest industry of this State," and, Charlie, your neighbors will miss you being Secretary, but come back to Chester County.

The PRESIDENT. The Chair recognizes the gentleman from Indiana, Senator Stapleton.

Senator STAPLETON. Mr. President, just a word for our Members on this side of the aisle. I certainly found Charlie Brosius to be a gentleman and a man of his word. No matter what side of the aisle, it made no difference to this Secretary. His cooperation with our Members of the Committee on Agri-

culture and Rural Affairs was always there. I recall his visit to Indiana County to the farmers there who had the highest regard and still have the highest regard for this man. We will miss him, and we are looking forward to working with the new Secretary of Agriculture.

Thank you very much.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Thompson.

Senator THOMPSON. Mr. President, I am proud to have Charlie Brosius as my constituent in the 19th district. You have heard a lot this afternoon about Charlie's service to the farmers of Pennsylvania as the Secretary of Agriculture. His service goes back far before that. I can remember working with him nearly 30 years ago as a township supervisor. I also had the privilege of appointing Charlie as a charter member of the Chester County Agricultural Development Council, and that group set an agriculture preservation program in place in Chester County which has been a hallmark for Pennsylvania and for the nation as far as agricultural preservation is concerned. I have also had the privilege of serving with him on the Penn State Great Valley Advisory Board.

The Secretary may be stepping down as Secretary, but hopefully he will not be stepping out of public service. In fact, there are a lot of other nice projects we would like to get him involved with in Chester County. So we thank him for what he is doing and we also thank him for what he is considering doing to continue his work in public service.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Gerlach.

Senator GERLACH. Mr. President, I also rise to urge the unanimous adoption of this resolution by Senator Madigan. I first had the opportunity to meet Charlie Brosius back in the late 1980s when I joined the Chester County Agricultural Development Council, and if there are three words that any one of us could ascribe to Charlie they are honesty, integrity, and decency. Charlie exhibited those qualities when I first met him back in the late 1980s, he exhibited those qualities in everything I have seen him participate in since then in his personal and professional life, and I think it is a wonderful opportunity for us today, for those of us who knew Charlie in some other capacity before today or in some capacity as a legislator in working with the Department of Agriculture, that we give this resolution our unanimous support and demonstrate to him our caring and our respect for all that he has done for Pennsylvania's agricultural community and Pennsylvanians generally. So I would urge the unanimous adoption of this resolution.

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Wenger.

Senator WENGER. Mr. President, Charlie Brosius has served as Pennsylvania's Secretary of Agriculture for the last 2 1/2 years, and he has served with distinction. Previous speakers have pointed out his various and numerous accomplishments during those 2 1/2 years as our Secretary of Agriculture, and I will not repeat all of them. But I would like to add that for a 10-year period from 1982 to 1992, before the most recent reapportionment, Charlie Brosius and his fine family were my constituents in Chester County and I got to know them person-

ally. I got to realize that Charlie Brosius was the kind of person you could confide in and you could go to and seek advice when it came to those areas in which he had expertise. He is the kind of person who looks you in the eye and tells you the truth and you can be proud to know him.

He distinguished himself in his local community. His public service at the local level and at the State level are well known. He is a man for all seasons. I have seen him communicate effectively with the farm community, the financial community, the agribusiness community, the academic community. He is the kind of person who can be an asset in just about anyplace he may be found.

I would like to say that in addition to speaking on behalf of his integrity and his character, it has been a pleasure for my wife, Barbara, and I to know Charlie and Jane and to call them our personal friends.

Senator BRIGHTBILL. Mr. President, I offer this amendment, and believe it has been agreed to.

Senator KUKOVICH. Mr. President, I do not believe I have agreed to this amendment yet, and I would like a brief explanation of what it does to the county share for nursing homes.

The PRESIDENT. Senator Kukovich, to whom do you place the question?

Senator KUKOVICH. Mr. President, to the maker of the amendment. I ask if he would stand for brief interrogation.

The PRESIDENT. Senator Brightbill, do you wish to stand for interrogation?

Senator BRIGHTBILL. Yes, Mr. President.

The PRESIDENT. Senator Kukovich, carry on.

Senator KUKOVICH. Mr. President, the gentleman said the amendment was agreed to, but it is my understanding that this bill was agreed to in an agreement made between this administration, Governor Ridge and Secretary Bittenbender, and the County Commissioners Association, especially in light of the \$2 billion that has been brought into the Commonwealth in terms of Federal dollars since 1992. I am wondering how this amendment affects the forensic section of that agreement and the county nursing home share of that agreement?

Senator BRIGHTBILL. Mr. President, the forensic section of that agreement is not impacted. The county nursing home section of that agreement is impacted. My understanding is that the County Commissioners Association has agreed to this amendment, which has the effect of not repealing Section 472 of the Public Welfare Code, and the reason for my belief is that they believe that this amendment is necessary to get the rest of the bill through the House of Representatives in a timely fashion. And I think it is half a loaf versus a full loaf.

Senator KUKOVICH. Mr. President, I have no further questions. I thank the gentleman. I think that is an accurate explanation

I guess where I have a problem is that I thought this issue was dealt with fairly back in 1995, and I would simply like to read into the record a letter from Secretary Bittenbender dated September 25, 1995, directed to the executive director of the County Commissioners Association. It says: (Reading)

It is my understanding that on September 22, 1995, representatives of the County Commissioners Association of Pennsylvania and the Department of Public Welfare executed an Agreement which, if and when approved in accordance with Commonwealth procurement requirements, will provide for an intergovernmental transfer of funds from various signatory counties to the Commonwealth. In light of this Agreement, consistent with the intent of the parties, and assuming that the intergovernmental Transfer Agreement is fully executed and implemented, I am writing to advise you that:

Number 1, and I will not read this part because this part is still contained within the bill, but paragraph 2 of this letter is now being repealed by this amendment. (Reading:)

The Commonwealth agrees that it will not oppose legislation eliminating the provision at 62 P.S. §472 which requires counties to pay ten percent of the certified non-federal share of the cost for public nursing home care, and if such legislation is enacted by the General Assembly, and is constitutional in the opinion of the Governor's General Counsel and does not otherwise contain any provision objectionable to the Governor, the Governor shall sign such legislation.

That is signed by Robert Bittenbender.

Apparently what this language would do could eventually hurt the counties to the tune of about \$25 million or \$26 million. In light of the fact that when this agreement was struck an extra \$35 million came to the Commonwealth to pay through this fiscal year, I think the counties operated in good faith at that point in time, and I am not sure of the rationale for going back on that commitment and I am also not sure what this will mean to the nursing home in my county if this legislation does not pass intact.

I understand Senator Brightbill's interest in trying to move a bill through. I will oppose this amendment and ask my colleagues to do so, and then they can vote in favor of the bill on final passage.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Northampton, Senator Uliana.

Senator ULIANA. Mr. President, just briefly, I would rise in strong support of the Brightbill amendment.

A couple of weeks ago I rose on this Senate floor to offer an amendment which would have merely allowed for a 2-year window for this exemption from the 10 percent nonfederal share payment by the counties for their nursing home costs. At that time there was a lot of discussion. I am glad to see that now the County Commissioners Association agrees with my position that we should still keep control over payment and costs at the local hand, because many times when we get into the position of writing an open check, that is paying from Harrisburg, allowing local governments to administer the pro-

grams, those programs strangely grow well beyond belief and we end up having a great fiscal problem.

The intergovernmental transfer that the previous speaker talked about is something which is a great benefit to the Commonwealth of Pennsylvania and is something that the counties, along with the State, have been working on for a number of years. But we have no concrete assurances from Washington that that will continue for the indefinite future, and we need to protect ourselves so that the State does not get into a position of tremendous liability of paying for something where we have no control over the management of those costs.

So I thank Senator Brightbill for offering this amendment, and I would urge all the Members of this Senate to support it here today because it is important that the State keeps proper fiscal controls over a program in which we have had to restructure the payment system to keep it controlled, because during the early 1980s it was growing tremendously and was almost out of control.

Thank you very much, Mr. President.
