Senator LOEPER. Mr. President, I move that the Senate do concur in the amendments made by the House to Senate Bill No. 755.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Mr. President, we support the legislation. It does increase the cap, but at the risk of being characterized as big spenders, we sincerely believe that the cap is still too low. I believe Senator Jubelirer at one point in time was quoted as having asked for a \$300 million increase and I think he was right. And we are disappointed that the cap has not been

increased by \$300 million. There are many, many projects throughout the Commonwealth that absolutely have to be funded, and with the kinds of surpluses that we are talking about in today's government, we could easily afford to do this. This is capital money. It is money that we can take care of very easily, and it is truly unfortunate that the Governor did not agree to increase this cap by \$300 million.

We are probably today going to pass a capital budget bill that I think is somewhere in the neighborhood of \$6 billion or more, and one of the problems we have with these capital bills is that everybody goes home and says what a great thing they did for their constituents by getting something into the capital bill. The only problem is that a year or two later people are waiting to see the project, and these capital budgets are not negotiated, so they really are authorizations. We are saying that we want \$6.7 billion, I think it is, yet we are only going to be able to spend \$150 million of that. So all those projects in there are simply not going to be funded.

I think that we should really increase this cap to \$300 million. I truly regret that the Governor did not agree to that, and I regret that my colleagues here on the Republican side of the aisle and in the House did not stand up to the Governor and demand that. So we will support this, but we do think that it should have been much larger.

The PRESIDENT. The Chair recognizes the gentleman from Westmoreland, Senator Kukovich.

Senator KUKOVICH. Mr. President, I am a cosponsor of this bill and I am in favor of it. It is time that we increase some of the compensation for the judges of elections and the other clerks and machine operators, inspectors, et cetera. My one concern, which I want to put in the record, is that this probably more appropriately and in the past has been to an Election Code bill. This is a County Code bill and, again, I have no particular problem with that, and I will support it.

What I want to place on the record, however, is that I would hope that at some point in this Session we will have an Election Code bill, especially for the purpose of dealing with the issue of campaign finance reform, at least in somewhat of a limited way in this Chamber. And I just want to put the Members on notice that anything they can do to begin to address the issue of campaign finance reform would not only be important to this Chamber, but it is probably one of the most imperative issues that we need to address in this legislative Session, and I hope that we have that opportunity.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Mr. President, I just want to add one thing to this, the fact that it is becoming increasingly more difficult to get people to participate in the election process, not only as voters but also as workers at the polls for these various jobs. This bill, even though it increases the amounts, still does not even meet the Federal Minimum Wage Law for these workers, and I would urge us at some point in time in the future to

seriously take a look at what we are going to do with our election process in Pennsylvania.

We cannot always just blame the voters for their lack of participation. We do have a responsibility, and the very crux of democracy is based on an election system that is functional. In many areas we have outdated voting machines that do not work properly and in some areas of Pennsylvania we are still using paper ballots. Perhaps it is time for us to maybe even set up a task force to look into the electronic voting machines that they have in Montgomery County. And I think it is time for the Commonwealth to get involved to ensure that the elections are run properly, fairly, and efficiently. We have kind of let the counties worry about this over the years, and we have seen problems.

Recently in Philadelphia, because of flash returns, it appeared as if one traffic court judge won. When the final returns were done and the actual tally was certified, another person won by only 12 votes, and that caused a large degree of consternation. It is about time we start to address these issues so that we do not have these problems. If not, they are only going to continue to grow.

But it is important for the people of Pennsylvania to know that even with these increases we are still not even paying these people what they would get for flipping hamburgers at McDonald's, which is the Federal minimum wage.

Thank you, Mr. President.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Schwartz.

Senator SCHWARTZ. Mr. President, since we have a few moments here, I did just want to comment about two items to-day that I think are significant to the Commonwealth. One is that I appreciate the opportunity to offer the resolution which was just unanimously passed recognizing the "Work to End Domestic Violence Day," domestic violence prevention day in Philadelphia. There are a number of activities going on, particularly in corporations and in neighborhoods. There is a real effort to increase awareness of both the problem and the resources available to women and families in the area of domestic violence. So I appreciate the Senate of Pennsylvania recognizing the effort that is going on in Philadelphia, and I hope that it leads to the end of domestic violence not just in Philadelphia but of course across the Commonwealth.

Secondly, if I may, Mr. President, I just wanted to briefly recognize something I hope my colleagues noticed in the papers. They may have received some press releases yesterday. About 10 days ago I spoke on the floor of the Senate about the Children's Health Insurance Program that we have in Pennsylvania and the fact that there are going to be significant dollars, about \$120 million, available to the Commonwealth as of today. I was very pleased to see that the Governor did respond to a number of my concerns, and many of us I think voiced our concerns about this, that we should begin today to expand availability of health insurance to the children of working parents who do not qualify for Medical Assistance because they are earning just a little bit too much by expanding the CHIP program as of today, and the Governor did announce yesterday that he would do that, he would deal with the waiting list and begin to open it up in anticipation of the Federal dollars.

Secondly, he said he would be moving ahead aggressively to apply for those dollars from the Federal government, and he said that he would be sure to draw down all of the Federal dollars available to Pennsylvania. Mr. President, that was very significant, and I hope and I would suspect that a number of

my colleagues, both Democrat and Republican, did really push the Governor to do this, and I thank them on behalf of not just myself, obviously, and Senator Kukovich, who worked on this bill as well, but on behalf of the children of Pennsylvania. That is very significant. It may mean that we will have to add some State dollars, potentially \$20 million of State dollars next year in order to draw down all of the Federal dollars available to us. How significant it will be, Mr. President, when we will potentially be able to insure about half of Pennsylvania's uninsured children

Mr. President, I would go further as well and call on all of us to take this opportunity to do even more for Pennsylvania's working families, and that is to work with the private sector, to work with market reforms, to push our insurers who have already been extending health insurance on an at-cost basis and providing some of their own subsidies, to push them even further to assure that all of our families have access to health insurance for their children by providing health insurance for children at cost. I will be introducing legislation to that effect shortly.

So I say this is actually a good day for Pennsylvania, that we have actually encouraged the Governor and he has stepped forward to embrace the idea of children's health insurance for uninsured children in Pennsylvania. I hope that we can work together over the next weeks and months to expand the Children's Health Insurance Program, to expand potentially some of the benefits that are available to those children and to help reach out to the almost 300,000 children who do not have health insurance in Pennsylvania who could.

So we will have significant dollars available from the Federal government. I am glad that we will be drawing them down. I look forward to working with the Republican leadership in making sure that we add State dollars so that we can draw it all down and then going even further, because the goal of reaching every child and giving them access to health insurance is achievable in Pennsylvania and I hope we get it done.

SENATE CONCURS IN HOUSE AMENDMENTS

SB 188 (Pr. No. 1351) -- The Senate proceeded to consideration of the bill, entitled:

A Supplement to the act of July 11, 1996 (P.L.595, No.101), entitled Capital Budget Project Itemization Act for 1996-1997, itemizing public improvement projects, furniture and equipment projects, transportation assistance projects, redevelopment assistance and redevelopment assistance capital projects, flood control projects, Keystone Recreation, Park and Conservation projects and forestry bridge projects to be constructed or acquired or assisted by the Department of General Services, the Department of Conservation and Natural Resources, the Department of Environmental Protection, the Department of Community and Economic Development, the Department of Transportation, the Pennsylvania Fish and Boat Commission or the Pennsylvania Game Commission, together with their estimated financial costs; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects to be constructed or acquired or assisted by the Department of General Services, the Department of Conservation and Natural Resources, the Department of Environmental Protection, the Department of Community and Economic Development or the Department of Transportation; stating the estimated useful life of the projects; authorizing certain waivers; making appropriations; and making repeals.

On the question,

Will the Senate concur in the amendments made by the House to Senate Bill No. 188?

Senator LOEPER. Mr. President, I move that the Senate do concur in the amendments made by the House to Senate Bill No. 188.

On the question,

Will the Senate agree to the motion?

The PRESIDENT. The Chair recognizes the gentleman from Westmoreland, Senator Kukovich.

Senator KUKOVICH. Mr. President, I am strongly in favor of this legislation. I think it is good for the Commonwealth. There are some projects in Westmoreland County that are embodied in this bill that are very timely and it is very important. I do have one concern, and it has to do with the Philadelphia Naval Shipyard, especially the press that I have been reading the last day or two.

My concerns, I suppose, are twofold. One is the process, the so-called fast-track process that is being used. My concern is that too often when we have rushed legislation through, mistakes are made. I have a concern about that. Secondly, I think that the total amount embodied in this bill is around a \$6 billion figure. Obviously, those are not projects that will be signed off on in the near future, or ever. Probably the most money that would be spent out of this, and I am just offering some conjecture, is maybe in the \$300 million, \$330 million, \$350 million range when we look at total capital spending typically and redevelopment assistance spending.

From newspaper accounts, the Kvaerner deal--if I pronounced that correctly--is about \$182 million, so I begin to worry as to how many projects that we are going to vote on today will actually be funded in reality. What I am saying is, although we all want to create jobs, as I look at some of the newspaper accounts about the amount of money spent for jobs, when I take a look at the original Meyer Werft deal, where they talked about roughly \$108,500 per job, the Sony deal, which is working well in Westmoreland County, where we spent only \$15,700 per job, and there are several other examples. This one I am seeing up to as high as \$340,000 per job.

I think it would behoove us to try to do an economic cost benefit analysis on the Philadelphia Naval Shipyard project, and I am mentioning that because what I would like to do is move to suspend the rules for the purpose of a specific amendment on the Philadelphia Naval Shipyard to remove that from the bill to deal with that separately.

Senator LOEPER. Mr. President, may we be at ease for a moment.

The PRESIDENT. At the request of Senator Loeper, the Senate will be at ease.

(The Senate was at ease.)

MOTION WITHDRAWN

The PRESIDENT. The Chair recognizes the gentleman from Westmoreland, Senator Kukovich.

Senator KUKOVICH. Mr. President, this is a very serious issue, and seeing maybe a lack of individuals here for an affirmative vote, my intention is not to drag this out. What I would do is withdraw the motion with the caveat that Secretary Bittenbender and the Governor's Office try to provide us with a cost benefit analysis of this as quickly as possible so at least we are aware of this action we are taking before this project is actually signed off on and State money is released. I would just ask that as a courtesy, and I hope that my colleagues on both sides of the aisle would be supportive of that.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Mr. President, just in the same vein, although I do not want to belabor this either, but I think that had we been able to be part of this process in greater depth than what we are today, we would not have seen this problem. This has been run through here, we have the religious holiday tonight, and some Members are not here so we probably could not have a debate, but I would hope in the future that when we deal with things of this magnitude, that we would not do it in the rapid fashion in which the Majority is doing it here today. I think every Member here, regardless of whether he supports endeavors in this capital budget or not, should have the opportunity to make his feelings known. The House just went through an extensive debate on this bill. Unfortunately, we will not have the opportunity to do that, and it would always be my belief, being a Member of this body, that this institution would preserve the ability for us to debate and air out our issues rather than get into a situation in which we frustrate debate.

I have been advised by the Majority Leader of certain commitments made to him by the Minority Leader, so we will, of course, honor those commitments. But in the future I would hope we would not even have to get into this kind of problem, we would have the kind of debate, offer amendments to bills. We really have to stop the process of trying to run things through here. We have seen it happen on too many occasions by using the Committee on Rules and Executive Nominations and thereby frustrating other Members. So we have some deep institutional concerns about this process.

On the bill itself, Mr. President, as I said earlier in discussing the cap, this is a \$6 billion wish list. It has been Christmas-treed with every program that I think any Member in the General Assembly could possibly imagine. There have been no constraints placed on it, and I hope that the people who think that they have projects in this do not get their hopes up that those projects are going to be funded. Nowhere near one-hundredth of the projects are going to get funded, if we are lucky, and that is part of the problem with the capital budget. I say this year in and year out, and the only reason why I say it again this year is because I note that the more I say it the more support I start to get even on the other side of the aisle.

The capital budget should not be just a blanket authorization. We as an institution, along with the House of Representatives, should begin to negotiate the capital budget. Right now it is just a vehicle for Members to go home and say they did something when in fact they have not done a damn thing, and all we do is we give the Governor a \$6 billion potential WAM. It is about time that on both sides of the aisle we sit down and air out our differences with the House, the same way that we do the operating budget, and decide and make the tough choices that have to be made on what we think should be funded in our districts and what priority those projects should get. Otherwise, sooner or later somebody is going to actually expose this for the foolish effort that it really is. We should really start negotiating capital budgets, and I do not care what the percentages are, but they should be negotiated back and forth so that we have something meaningful rather than be able to go home

and say, I put a piece of paper out there somewhere but you will never see the bricks and mortar.

So with that, Mr. President, I ask for an affirmative vote, and I do not think there will be any negatives, so you may proceed. Thank you.
