Senator ROBBINS. Mr. President, I would like to take this opportunity to urge my colleagues to support Senate Bill No. 425, also known as the athletic agent registration bill. Mr. President. Pennsylvania is home to one of the largest segments of athletes, both professional and recreational, in the United States. Only California, Texas, and possibly Florida surpass the Commonwealth in the number of young athletes who participate in professional sports. Currently, 16 States have passed laws that now regulate athletic agents and how they do business in those States. Considering the fact that Pennsylvania is home to one of the largest number of athletes in the nation, we have become a haven for a number of unscrupulous athletic agents.

Each year the Pennsylvania Athletic Commission receives approximately 200 calls from young athletes, parents, and coaches to either lodge complaints about the activities of athletic agents or to inquire about an agent's qualifications. With the passage of this legislation, Mr. President, the Pennsylvania Athletic Commission, for the first time, will be given the authority to register athletic agents, which will include background checks and require them to be bonded. In addition, the State Athletic Commission will be authorized, after a hearing, to suspend an agent from doing business, impose fines, and to recover bond proceeds from agents who make an offer or enter into any agreement with student athletes before the athletes' eligibility for college athletics expires.

Although this legislation would require the registration of athletic agents, it is important to recognize that this bill is designed to protect the people who have the greatest potential for exploitation, our young athletes. Therefore, Mr. President, I urge all of my colleagues to support Senate Bill No. 425 to give protection to our young athletes from the enticements and abuses of unscrupulous athletic agents.

Thank you, Mr. President.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, I would like to be recognized just briefly to make an observation. I rise just as a point of information under Petitions and Remonstrances because I did not want to do it at the time when the Governor's veto message was being received in the Senate. Mr. President, by our reading of the Pennsylvania Constitution, Article IV, The Executive, Section 15, which deals with approval of bills and vetoes, it is very clear that when the Governor decides to sign and/or veto a bill, the Governor has so many days in which he must take action. With regard to Senate Bill No. 188, the capital budget bill, the Senate of Pennsylvania passed the bill in its final form on October 1. The Governor then delivered a veto to part of the bill on October 10, which was totally appropriate.

Mr. President, the inappropriate thing about the way the bill was handled was that once the Governor decided to veto parts of the capital budget bill, that bill also had a 10-day period of time in which the Governor had to sign it for it to become law, and that same time period in which any part of the veto of the capital budget then must be received by the office of the Secretary of the Senate, or in this particular case the chamber in which the bill originated. This was a Senate bill. The veto message would have to go back to the Senate. If it were a House bill, the veto message would have to go back to the House, and the Governor would have 10 days to sign the bill or 10 days to veto the bill.

Well, what happened in this particular case, Mr. President, and as I said earlier, we were not going to make an issue out of it as the veto message was received and read across the desk by the Chair earlier today, because we thought it was important that we discuss it here tonight in Petitions and Remonstrances, the Governor did appropriately sign a part of the bill and veto a part of the bill on October 10, 1997, which was 9 days from when the Governor originally had the bill after the Senate had passed it, and that was all fine.

What then took place, Mr. President, is that bill had until the next day, which would have been October 11, which would have been 10 days from the day we passed the bill for it to have been submitted to the Senate, since it was a Senate bill, and it would have had to have been received in the office of the Secretary. Now October 11, Mr. President, was a Saturday, and the individual who had received the bill from the Governor, I believe the Governor signed it in the Mansion late on a Friday afternoon, basically should have taken the bill right back to the Senate immediately so that it would have been received by the Secretary of the Senate, or certainly no later than midnight of the following evening, which would have

been Saturday, October 11. The Constitution provides for that, Mr. President, and that part of the Constitution is very clear.

But what took place, Mr. President, is that the individual who had the veto message did not submit it to the Secretary of the Senate until October 14, which was a violation of the Pennsylvania Constitution. And it appears to me that it was around 10:30 in the morning on October 14, which would have been the 13th day after the bill was signed, in violation of the Constitution of whether in fact the veto could have been accepted or not. That individual, for some reason, kept the signed copy of the veto on Friday, Saturday, Sunday, Monday, which was a holiday, and then submitted it to the office of the Secretary of the Senate on Tuesday sometime in the morning.

Now, Mr. President, we had the opportunity of reading what the Governor's veto message was in the newspaper. It appeared in the newspapers throughout the State on Saturday, October 11. However, we in the Senate did not have the opportunity to be able to call the office of the Secretary and ask if the veto message was on hand so that we could find out what projects in our districts the Governor vetoed.

For example, Mr. President, although I was not responsible for placing any of these projects in the capital budget from the senatorial district which I represent, this was all done in the House of Representatives, there were millions and millions of dollars' worth of projects from the 22nd Senatorial District that the Governor vetoed, although we were not able to receive the message. And then I was kind of amazed as I went through the veto message, Mr. President, to find out that in Allegheny County, the Governor took a \$75 million capital budget item for the enhancement of Three Rivers Stadium and vetoed that, along with a number of other projects out west, at the same time that there is some major discussion taking place on a question that will appear on the ballot for a regional sales tax, of which many Members of this particular body are, I assume, very interested because I think some of them have been campaigning, if not publicly, privately to make sure that that in fact takes place.

So, Mr. President, my concern is that the Governor was in the right, he was totally correct in doing what he wanted to do with regard to signing the capital budget bill and vetoing a part of the capital budget bill. The individual who was responsible for then returning this part of the capital budget bill back to the Secretary of the Senate within that same timeframe did in fact not do it in violation of the Constitution. We could have raised that constitutional point of order today, Mr. President, and we did not do that.

And then it is quite intriguing, as far as I am concerned, that dated October 20, in a letter by Governor Ridge, and I thought the Governor was on his way to Europe to negotiate the contract for the port in Philadelphia, that we now receive a letter that was sent to the Secretary of the Senate dated October 20, which is today, where the Governor says, "It is with regret that I must withdraw the veto message for Senate Bill No. 188, P.N. 1351, received by your office." It is kind of incredible that there was a violation of how the veto message should have been received to begin with, since it was at least 3 days late based upon the Constitution, that the Governor is

in Europe today negotiating, or at least on his way to Europe today to negotiate what may or may not take place with regard to the port in Philadelphia, and the capital budget bill that we passed was a main part of the funding mechanism for that port, and then we received a letter today from Governor Ridge saying that he has withdrawn his veto message of Senate Bill No. 188 effective today, which was late initially in coming to the Senate of Pennsylvania.

Mr. President, what concerns me and many of my colleagues about this is the fact that we are really not certain as to what is taking place, and it is obvious that maybe some people within the administration or within the front office are not exactly certain as to what procedure should be followed. If this was a bill, Mr. President, that was not a capital budget item bill where the Governor could sign and/or line-item veto the same bill which would have two different results, and this was a very significant, substantive piece of legislation and the Governor wanted to veto it, then some clerk whose responsibility it was to make sure that message was filed in the Senate within the constitutional framework of 10 days would have failed miserably in his or her job performance. As I said, I do not know who that person is, Mr. President, but it seems to me that at best it was skewed as to who should be handling this, and maybe there were some major concerns as to why the news media received the veto message on a Friday and it was not filed with the Senate until the following Tuesday, and then today when the Governor is traveling to Europe to negotiate the contract with regard to the port which was funded in the capital budget, we do receive the veto message from the Governor, signed by Governor Ridge.

I think, Mr. President, this sheds more and more light on the fact that if we are going to have capital budgets in this Chamber and in the House of Representatives, and indeed that is the way that we should do capital improvement projects in Pennsylvania, you will find no argument with me about how we should do that, then, Mr. President. We should not have signed and turkeyed 6 billion dollars' worth of projects into a capital budget and sent it over to the Governor so that the Governor could then either sign, veto, or do what he would please with capital budgets. It is important that we have some form of a negotiated capital budget so that we do not deceive or mislead people, the constituents we represent. It is unfortunate that people, I believe, have offered projects into the capital budget for the purpose of trying to do with a 30-second sound bite on radio or perhaps during a campaign on television, or maybe even more important, send out direct mail to their constituents as to what they are doing in Harrisburg to be able to benefit the district which he or she may represent, whether it is in the House or the Senate.

And finally, Mr. President, I believe there was some editorial comment in the newspapers, at least in western Pennsylvania, that talked about the capital budget and said it was important that the capital budget be voted on and signed because of the tremendous help that it would bring to western Pennsylvania. Well, some of that help also was going to go to eastern Pennsylvania and to northeastern Pennsylvania. And many of us realize that when a capital budget passes that funds 6 billion dollars' worth of projects and the Governor only has the authorization to fund in that particular year approximately 450 million dollars' worth of projects, less than 8 percent of what was passed in here, then there are people in this body and in the other House of government, the House of Representatives, and indeed in the administration who are being intellectually dishonest, because based just on what appeared in here, I have heard at least one, and I am not going to identify who they are, but I have heard at least one individual running for election and/or reelection in the November 4 election of 1997 taking credit for capital improvement projects in a municipality in Pennsylvania based on what was done in this budget when in fact some of those projects were vetoed. But then today someone in the front office saw the error of what took place and in the absence of the Governor submitted his letter withdrawing the veto message.

So I am really very, very confused as to what the process is, how we are going to proceed with capital budgets in the future and why we even allow a \$6 billion capital budget to pass the General Assembly and be sent on to the Governor for his signature when we know full well that only \$450 million of that money can be funded for this particular year. We are just not being fair with the people we represent, and I do not believe that we should be intellectually dishonest with the 250,000 constituents who have sent us here to Harrisburg to do their business.

Thank you very much, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Loeper.

Senator LOEPER. Mr. President, I would just like to correct what I believe was a misstatement of the Minority Leader, and that was to the best of my knowledge, the Governor's veto message of certain portions of the capital budget bill was not in fact read across the desk today at any time during our formal Session. In fact, Mr. President, I believe that there was an awareness on the part of the administration that there had been an unfortunate delay in the receipt of that here in the Senate, and therefore the Governor, recognizing that, wrote a letter indicating that he was withdrawing that document from the Senate. And I think in fairness, Mr. President, we should read the remainder of the letter. I believe Senator Mellow read the first sentence or so of it, but let me continue, because I think it is important that it be noted in the record.

And it says, "It is with regret that I must withdraw the veto message for Senate Bill 188, P.N. 1351, received by your office. Although a good faith effort was made to deliver the message in the manner set forth in the Constitution, it has come to my attention that delivery may not have been made within the time provided and may, therefore, be defective.

"However," and I think this is very important, Mr. President, to be part of the record, "I intend to use the veto message as a blue print for approval of all capital projects. Projects which are duplicative or which do not meet all appropriate legal criteria will not be funded.

"I regret any inconvenience this misunderstanding has caused your office or the Senate of Pennsylvania. Your cooperation in returning the veto message is greatly appreciated." Mr. President, let me just reinforce that one paragraph, and that is where the Governor indicates that he intends "to use the veto message as a blue print for approval of all capital projects. Projects which are duplicative or which do not meet all appropriate legal criteria will not be funded."

I think, Mr. President, that very clearly outlines the policy of this Governor and this administration. I might also indicate, Mr. President, that it was just 2 weeks ago when Wall Street was the latest to acknowledge Pennsylvania's growing reputation for creating jobs and managing its finances. In fact, citing strong growth in jobs, Moody's Investors Services improved the Commonwealth's general obligation rating from A-1 to AA-3, the first time Pennsylvania has earned a double rating from the agency since 1968. I think it is also interesting to note that Fitch Investors Service has raised the State's G.O. rating from AA- to AA, again pointing to the State's successful operating trend of recent years, including a more conservative budgeting practice and gradual accumulation of reserves. I think this really very ably represents the administration's position.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, I see here the issue is a violation of the Pennsylvania Constitution, and regardless of what the Governor may or may not have done today in rescinding or withdrawing his veto message, he did that because some individual who was charged with the responsibility of returning this document to the Secretary of the Senate 10 days from the day that the General Assembly had passed the bill did not do their job in making sure that it was returned to the Senate.

Now, if for some reason they could not do that on a Friday afternoon because the Senate may have been closed, the security people in the Capitol, I am sure, could have made the proper contacts so that the individual could have filed the veto message. Mr. President, the veto message did not have to actually be received in the Senate until the next day, which was Saturday, and I am sure that that person who was carrying this veto message around either in a portfolio or in a briefcase could have at that particular point in time come to the Capitol to make sure that the document was on file with the Secretary of the Senate. They did not do that, Mr. President. They kept the document not only Saturday but Sunday and Monday. And I had the opportunity of reading in the newspaper what exactly took place with regard to the veto, and I asked my office if they could share with me a copy of what projects had been completely eliminated on the veto message, and they said, we cannot because we cannot get a copy of the veto message.

Mr. President, that is what is at issue here. The issue here is the violation of the Constitution and how some individual had the responsibility of making sure that this document was delivered on time to the Secretary of the Senate, and they in fact did not do that, and that put the Governor in the position of having to say that for that reason, I will withdraw my veto message. I applaud the Governor for saying, in the second paragraph, that he intends to use the veto message, as Senator

Loeper said, as a blueprint for approval of all capital projects. That is the same exact thing that his two immediate predecessors did. Both Governor Casey and Governor Thornburgh used the exact same type of blueprint and veto message in the capital budgets that they received, and both Governors took projects in the district that I represent and thought that they were not appropriate projects at the time and they vetoed those projects in the capital budget.

What has taken place here is that a person who was charged with a responsibility, a very important responsibility, failed to do his or her job properly, and that is what should be brought to the floor of this Senate, because the next time it could take place with a bill that would be very substantive in nature and not necessarily a capital budget, but a bill that the governor may in fact want to veto and because we did not receive it in a timely fashion, that would cause a constitutional problem right here in the Senate. It is very important, Mr. President, at least in my opinion, that we make that argument and that discussion here tonight.
