The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I would like to rise very briefly to discuss House Bill No. 1125. It is an issue that I have worked on for the past year and a half or so. Last year, working with then Senator Fisher and this year with Attorney General Fisher, I introduced legislation which is nearly identical to the legislation that we will be voting on today.

Mr. President, the purpose of this legislation is to provide protection to drug-induced sexual assault and rape victims. In particular, the statute is designed to combat Rohypnol and other substances known as date rape drugs. These are very powerful, odorless, colorless drugs that are thrust upon unsuspecting victims at many activities, for example, parties at college campuses and the like.

Mr. President, for a number of years I served as a law enforcement officer, and for the past 5 years I served as a member of the Center for Victims of Violent Crimes. I can stand here today and tell you that there are several concerns that this particular piece of legislation addresses, one which has recently hit our college campuses and has made its way into our Commonwealth, so I ask that the Members of this General Assembly support this legislation.

I am very happy that Representative Bard has been able to push it through the House unanimously, and I am hoping that my colleagues here in the Pennsylvania Senate will do likewise and send a very, very clear message to the unscrupulous individuals who want to utilize this particular drug, because it makes it very, very difficult to prosecute some of the perpetrators because the victims' thought processes are interfered with with respect to this drug. I ask that all the Members support this bill.

Section 1. (a) Authorization.-Under the requirements of section 20(b) of the act of June

Amend Sec. 1, page 1, line 12, by striking out "section 2" and inserting: subsection (b)

Amend Sec. 2, page 1, line 17, by striking out all of said line and inserting: (b) Land to be released from Project 70 restrictions.-

Amend Sec. 3, page 4, lines 17 and 18, by striking out all of said lines and inserting: (c) Use of sale proceeds.-The net proceeds, selling price less expenses, from the sale

Amend Sec. 3, page 4, line 19, by striking out "section 2" and inserting: subsection (b)

Amend Sec. 4, page 4, lines 26 and 27, by striking out all of said lines and inserting: (d) Deed clause.-The Central Pennsylvania Conservancy deed to the Seven Gables

Amend Bill, page 5, by inserting between lines 2 and 3: Section 2. (a) Authorization.—Pursuant to the requirements of section 20(b) of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as the Project 70 Land Acquisition and Borrowing Act, the General Assembly hereby authorizes the release of the restrictions imposed by section 20 of the Project 70 Land Acquisition and Borrowing Act, from the lands owned by the Township of Hempfield, Westmoreland County, and more particularly described in subsection (c) in exchange for the imposition of the section 20 restrictions on lands to be conveyed to the Township of Hempfield from Robert E. and Ella J. Griffith and more particularly described in subsection (d).

(b) Freedom of restrictions.-The lands described in subsection (c) and owned by the Township of Hempfield, Westmoreland County, shall be free of the restrictions on use and alienation imposed by section 20 of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as the Project 70 Land Acquisition and Borrowing Act, upon the imposition of and recording of the Project 70 deed restrictions set forth in subsection (e) on the parcel of replacement land described in subsection (d) to be conveyed to the Township of Hempfield from Robert E. and Ella J. Griffith contemporaneously with the conveyance of land described in subsection (c).

(c) Land to be free from restrictions.-The parcel of land authorized to be released from restrictions is more particularly described as follows:

All that parcel of land located in Hempfield Township, Westmoreland County, Pennsylvania, described as follows:

Beginning at a point at the southwest corner of the parcel of land of Robert E. and Ella J. Griffith described in subsection (d), which point is at or near the center of S.R. 1032; thence along the approximate center of S.R. 1032 south 19 degrees 00 minutes 19 seconds west 61.00 feet to a point in the approximate center of S.R. 1032; thence, along other land of Hempfield Township, north 74 degrees 17 minutes 40 seconds west 488.232 feet to a point at land now or formerly of William E. and Pamela M. Pershing; thence along the land of William E. and Pamela M. Pershing north 76 degrees 48 minutes east 125.989 feet to an oak tree; thence along other land of Robert E. and Ella J. Griffith south 74 degrees 17 minutes 40 seconds east

381.45 feet to the place of beginning.

Containing 0.6079 acres of land.

(d) Land on which restrictions are to be imposed.—The replacement parcel to be subject to restrictions in exchange for the parcel described in subsection (c) is more particularly described as follows:

All that certain tract or parcel of land situate in the Township of Hempfield, County of Westmoreland, Commonwealth of Pennsylvania, bounded and described as follows:

Beginning at a point at the northeast corner of the parcel of land of Hempfield Township described in subsection (c), which point is at or near the center of S.R. 1032; thence north 14 degrees 15 minutes east 100.00 feet to a telephone line on land of Robert E. and Ella J. Senator LOEPER. Mr. President, this bill contains new enforcement tools that will strengthen the effectiveness of the county courts' Domestic Relations sections' effort to establish paternity, to locate noncustodial parents, establish and enforce child support orders, as well as collecting delinquent child support payments.

Mr. President, Pennsylvania's Domestic Relations sections have established a record of national leadership in cost-effective pursuit of child support, but we need to ensure that they have every means available to collect the money that is still owed to Pennsylvania's children. The bill will also allow the department and the Domestic Relations sections to expedite paternity establishment and enforcement of support orders. I believe, Mr. President, that it is quite clear that the financial support of both parents can make or break the financial self-sufficiency of a family. Finally, Mr. President, this bill would restore the State's share of the support pass-through.

I would like to just take a moment to commend all the efforts put forth to bring this bill to fruition before the Members of the Senate today, particularly Senator Brightbill, Senator Kukovich, Senator Greenleaf, and Senator O'Pake, who worked very diligently together to bring this legislation before us. Mr. President, I ask for an affirmative vote.

The PRESIDENT. The Chair recognizes the gentleman from Westmoreland, Senator Kukovich.

Senator KUKOVICH. Mr. President, I would concur and also thank the aforementioned folks and others on the Committee on Judiciary, in particular Senator Earll, Senator White, Senator Gerlach, and Senator Hart, for being supportive of children. There was a ticklish issue regarding the pass-through to some of the poorest children, and I think a reasonable compromise was made. I am very supportive of the overall impact of this legislation and also support an affirmative vote.

Senator KITCHEN. Mr. President, I, too, would like to thank the Senate Members who were involved with this bill. It is so important that the poor families in the State of Pennsylvania continue receiving the \$50 pass-through. Even though it is not counted in the TANF formula, when the family applies for food stamps it is all counted as income.

So I would like to thank you very much for thinking of the suffering and the struggling of the poor people in this State, and I look forward to working with everybody on other kinds of things that we can do for families in this State.

## PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Wagner.

Senator WAGNER. Mr. President, I rise to talk about comments made by Governor Ridge this past weekend in regard to southwestern Pennsylvania. The Governor wrote an article in the editorial section of the Pittsburgh Post-Gazette on Sunday, November 23. In that article he indicated how to move forward with economic development projects in southwestern Pennsylvania. Many of the projects were part of the Regional Renaissance Initiative that was part of a referendum vote in an 11county area this past November 4, and as we all know, that initiative failed across the board in all 11 counties.

The Governor specifically indicated how we in the southwest can count on him to help with a plan, a new plan, a so-called plan B, that many people are talking about, a plan to build a convention center, a plan to build a stadium or stadiums, cultural attractions, and industrial parks in southwestern Pennsylvania in the 11-county area. The Governor further indicated that the Sports and Exposition Facilities Task Force Report, and I am sure all of us remember that report that started in 1995 and was completed in 1996, should be reviewed and its findings embraced for the southwest to move forward on a multitude of economic development projects, of which, Mr. President, the major recommendation or finding in the report to come up with funding was to sell the State Store system, and it is indicated in the Governor's article that we should relook at that issue and embrace that initiative.

We all know that the whole logic behind the funding or sale of the State Stores was to come up with the State's share of funding that would be utilized with a matching share of funding at the local level to do economic development projects such as a convention center, a stadium, whether it be in Pittsburgh or Philadelphia, or other economic development projects such as industrial parks, of which that is a concern in many outlying areas in southwestern Pennsylvania.

In the article, the Governor further indicates that the State will come up with 35 percent of the funding for those projects. In regard to stadiums, and it is really a new thought, maybe a thought that has been mentioned in the past, but the Governor makes it an emphasis of this article, in regard to stadiums, he suggests that we build a multi-use stadium in the Pittsburgh area rather than two separate stadiums, one for football and one for baseball. And if a multi-use stadium is built, the Governor will consider, and I repeat consider, that the State financing share be on the one-third and possibly make it higher, maybe 50 percent or, who knows, even greater.

Three other recommendations were made in the article in addition to selling the State Stores and a multi-use stadium. One of those three recommendations was to be wary of new Lottery proposals in the Commonwealth for economic development projects, and I agree with the Governor on that point, because it could potentially harm the existing Lottery that funds a multitude of senior citizen programs. The other two points he makes is to debate honestly on plan B, especially as it relates to funding sources, and the final point is to debate together.

Now, Mr. President, I rise to talk about this because, number one, it is an article written by the Governor and not comments made by the Governor in an article, so I know how strongly he feels to take the time to mention all these concerns in regard to southwestern Pennsylvania. Mr. President, also I respect the Governor very much. However, I have some great concerns about the comments made in this article. First and foremost is bringing up the issue of selling the State Stores again, for that to be part of the southwest getting funding on economic development projects. I am not here to talk about the State Store issue. I have talked about it on the floor before. Who knows, I may talk about it again in the future, so I do not want to talk about it today.

But I simply want to state that if we are going to keep bringing up the State Store issue and the privatization of the State Stores, let us just put a bill on the floor in both the Senate and the House and vote on the issue. And let us vote the issue up or let us vote the issue down, because the issue cannot continue to linger, particularly if it is tied in with, as the Governor suggests, economic development projects in southwestern Pennsylvania. I do not want to see that happen as a State Senator from that area of the Commonwealth. I feel as if we are being held hostage, that the State Store issue and the funding related to it, if it were privatized, is necessary in order for key, and I repeat, key economic development projects to move forward, and I do not want to see the southwest being held hostage.

Recently, within the last month, and I support the initiative, the State is coming forth with at least \$180 million to possibly \$200 million-plus for a very important project in the Philadelphia area, the shipyards, and the redoing of an industry that has been lost in southeastern Pennsylvania. I support that initiative, but in order for that area of the State to get that kind of money, there did not have to be the privatization of the State Store system to be a matching source from State government for that to happen.

So when I look at key economic development projects in the southwest, and I begin to read the Governor's comments that we need to privatize the State Store system for a funding source related to those projects, I am very concerned, because there has been a project I have been pushing for a long time that needs State funding and it could move forward if we get an amount of money equal to what the shipyards are getting, and that is a new convention center for southwestern Pennsylvania. A convention center was built and opened in 1993 in the southeast, in Philadelphia, and it is a magnificent facility and has done wonders for the city of Philadelphia and southeastern Pennsylvania. Pittsburgh and southwestern Pennsylvania desperately need the State's assistance on the same kind of project, and I want to see the State make a commitment similar to the kind of commitment that has been made in the southeast for that project.

I rise to talk about that, Mr. President. We have a convention center that is simply uncompetitive. It is a guppy in comparison to what Philadelphia has, in comparison to what 50 other cities in this country have, and it is hurting the economy of southwestern Pennsylvania. So, Mr. President, I rise to differ slightly with the Governor and to send a message, and I will do it in a more formal way, that if we are going to continue to talk about the privatization of the State Store issue, let us not do it in the same language with economic development projects for the southwest, when in fact that is not the discussion when we are talking about economic development projects in the southeast, because southwestern Pennsylvania sends taxpayer dollars to Harrisburg to the same degree as any other part of this State.

And if there is going to be a discussion on the privatization of the State Stores, put the bill on the floor of the Senate for a vote and let us deal with it separately and not with key economic development projects. I want to debate also. I want to debate a plan for the southwest, and I am sure my colleagues in this Chamber want to debate, but I do not want to debate it with another issue that is of great controversy in this Chamber and the other Chamber across the hall. And that is the tone that I read in this article, Mr. President, and quite frankly, I disagree with it.
