#### SENATE RESOLUTION ADOPTED

Senators THOMPSON, MURPHY, BELAN, TOMLINSON, LAVALLE, BODACK, GERLACH, AFFLERBACH, PICCOLA, WHITE, CONTI, KASUNIC, MOWERY, ROBBINS, COSTA, O'PAKE, SALVATORE, ULIANA, BELL, RHOADES, EARLL, TARTAGLIONE, KUKOVICH, BRIGHTBILL, TILGHMAN, LOEPER, WOZNIAK, LEMMOND, HART, SCHWARTZ, MELLOW, WAGNER, MUSTO and STOUT, by unanimous consent, offered Senate Resolution No. 246, entitled:

A Resolution calling on the President of the United States and the Federal Government to take all necessary and appropriate action to respond to the surge of steel imports resulting from the financial crises in Asia, Russia and other regions.

On the question,

Will the Senate adopt the resolution?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Chester, Senator Thompson.

Senator THOMPSON. Mr. President, some of us are old enough to remember growing up in the 1950s when we went to bed at night fearing an attack by Russia. Today we are under a more insidious attack, this time from Russia, Japan, and Brazil, among others, and this attack is real and has already inflicted more damage than the feared missiles of the Cold War. The attack is costing jobs and is threatening the very economic health of Pennsylvania and America.

That attack is in the form of foreign steel imports dumped on American markets at prices, in some instances, at 50 percent below the cost of production. What damages have those imports wrought so far? In the past 5 years, steel imports have grown from 4 percent to 28 percent of the market. In the first 5 months of this year alone, steel imports have risen by 79 percent. Now we can talk about market share and tons of steel shipped, but the bottom line is that unfair and illegally dumped steel imports costs jobs both here in Pennsylvania and throughout America.

The American steel industry is the most important in the world. America's steelworkers are the most productive, efficient, and talented people in the world, and it was America

that taught the world how to make steel. But the American steel industry, the American steelworkers cannot compete in their own country and in their own hometowns with both hands tied behind their backs. Their hands are being tied by the governments of Russia, Japan, and Brazil, who are attempting to solve their economic problems by dumping steel plate products on American markets at prices less than half the cost of production. This practice is not only unethical, but it is patently illegal and it must be stopped.

Steel dumping is not only a problem for the American steel producer and the American steelworker. It affects steel industry suppliers and their employees and their suppliers and employees. Steel dumping affects each and every one of us. Our government has the tools at hand under international law to address this peril, and it is high time to exercise those tools to level the international playing field. The President and his administration are duty bound to address this issue and address it now. It is inconceivable that the American Congress and the administration are appropriating billions of American dollars into the International Monetary Fund to prop up the economies of Japan, Russia, and Brazil, when those very countries are torpedoing the American economy with below-cost steel imports.

America simply cannot be a dumping ground for foreign steel. The "Stand Up For Steel and Stand Up For America" effort organized by American steel producers and the United Steelworkers of America has been established to call public attention to the problem and to muster support to have the President take action. It has the united effort of both labor and management, and it transcends party lines. "Stand Up For Steel and Stand Up For America" now needs the support of the general public. It is now time for our friends and neighbors throughout Pennsylvania to take up the cause. The current administration knows the value of polls, and we must show President Clinton that no matter how the question is asked, 100 percent of Americans do not want their country to be the dumping ground for foreign steel.

I urge my colleagues to take up this fight and to convey that message as clearly and as strongly as possible, to contact the White House and demand that the President exercise his powers and take legal action to stem illegal steel imports that are decimating the jobs of the American steel industry and costing other Americans their jobs.

Mr. President, I urge my colleagues to vote in favor of this resolution.

# The PRESIDING OFFICER (J. Doyle Corman) in the Chair.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Murphy.

Senator MURPHY. Mr. President, I also want to rise in support of this resolution to change the ways that this country is dealing with the dumping of steel. My colleague has mentioned many of the very important points, but there are some others as well. What we do in this nation is we send billions and billions of dollars to other countries to help the International Monetary Fund and also to help their economies get

going. We are certainly pleased to help Russia as it has emerged as its own nation since the demise of the Soviet Union, and we certainly want to also see other nations, such as Brazil, succeed.

What is not right, however, is when they are shipping tons and tons of steel to this country at below the cost it takes them to manufacture it, and in the meantime, people in our Commonwealth and this country are losing jobs, because they do not have the opportunity to work. So we are really paying double for this. We are paying not only for helping those countries emerge by giving them cash assistance, but when our citizens and steelworkers lose jobs, we are paying again, and who will pay for their care, who will pay for their unemployment when they are laid off? Who will take care of their families? Who will take care of their increased health costs and mental health costs when they are not employed, and how will this nation survive if an emergency arises again and we do not have the steel manufacturing capability to take care of that? We certainly want to help people in other nations, but this is one of those times when I certainly hope that Congress and our President will look to the citizens of Pennsylvania first.

I know in my district I have a specialty steel manufacturing plant, Universal Stainless and Alloy, and they have also been struggling along with this and watching the dumping that takes place in this nation. And, quite frankly, it is wrong, and our nation can no longer sit still and say that we are going to take care of other countries around the world on the backs of steelworkers who are already struggling as it is. So I hope other Members of the Senate here will also support this resolution and send a clear message to Congress and the President: It is time we also look to support our citizens.

Thank you very much, Mr. President.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Delaware, Senator Bell.

Senator BELL. Mr. President, this past week the Philadelphia area newspapers stated that hundreds of steelworkers at U.S. Steel and Fairless Works in the Delaware Valley are being laid off because of this situation.

And I want to compliment Senator Thompson for taking the spearhead on this fight. You know, this country can only remain strong with industry, a basic industry such as steel. It will not stay strong with service jobs. I was talking to a steelworkers' group last week, and they told me how depressed our steel industry is in Pennsylvania.

Fellow Senators, this resolution is a fight for jobs. It is a fight for the entire fiscal integrity of this Commonwealth, because without jobs, we are in bad shape.

Mr. President, I strongly urge an affirmative vote.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Mr. President, I rise to support this resolution. As I look around this room, I think most people understand coming from Johnstown, Pennsylvania, we have a very large history of steel, and in the early 1980s we went through a very difficult transition from the huge integrated steel mills to the smaller, more efficient systems we have to-day. At that time we had foreign dumping, we had a change in

our entire corporate structure, and we lost tens of thousands of steelworking jobs in our region alone, not counting what occurred in Pittsburgh and other parts of this nation.

When we look at the Pacific Rim, we look at the economy of Korea and Japan and the difficulties that they are going through, I think internationally everybody understands that, and those investments are being made to the International Monetary Fund, other grants, other loans that the other countries as well as the United States are putting in there because we know that strong, viable economies in those nations help us out. However, the other side of that coin is what those nations are attempting to do to alleviate some of their economic hardships is export their unemployment, and I think that is a tragedy, and it is not right and it is not in the spirit of international competition and cooperation.

Our people have suffered greatly over the past years. We have seen incredible changes. We have seen an arena where individual families were once surviving on the income of a steelworker. Now both the husband and wife have to work, and health care benefits are escalating, et cetera, et cetera, et cetera. And now we face the uneven playing field of foreign governments dumping their steel on our borders simply to keep their people working.

We are doing our job internationally through Congress by investing and trying to shore up those economies to make a stronger opportunity for everybody. It is not right, it is wrong, and although I do not think we should put up walls in fair competition, when unfair dumping is occurring on our shores, it is time for the President, it is time for the United States Senate, it is time for the United States Congress to take action, appropriate action, and protect our jobs here in the United States against unfair foreign competition and their dumping.

Thank you very much. I hope we have a unanimous vote to send that message to Washington. Thank you.

# The PRESIDING OFFICER (David J. Brightbill) in the Chair.

#### ANNOUNCEMENT BY MAJORITY LEADER

The PRESIDING OFFICER. The Chair recognizes the gentleman from Delaware, Senator Loeper.

Senator LOEPER. Mr. President, while we are continuing the important debate on the resolution that is before us, we still have two off-the-floor meetings to hold today. First is the Committee on Game and Fisheries, to be followed by the Committee on State Government, and if we could hold those meetings concurrently with the debate on this resolution, I think it could probably help with our scheduling of the afternoon.

The PRESIDING OFFICER. The Chair announces to the Members that a meeting of the Committee on Game and Fisheries will be held contemporaneously with this debate off the floor in the Rules room. That is to be followed by the meeting of the Committee on State Government.

And the question recurring, Will the Senate adopt the resolution?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I, too, rise to encourage my colleagues to unanimously adopt this resolution dealing with the dumping of steel into our country.

Mr. President, I have a district office in Homestead. Homestead, Pennsylvania, at one time was the steel-making capital of the world, and, Mr. President, I would invite all of my colleagues to visit Homestead and see what devastation has taken place since the decline of the steel industry. A resolution such as this one is very important. I encourage my colleagues to stand up and place an affirmative vote along those lines, to make certain that many of the communities that still exist in our Commonwealth and in our country do not end up financially distressed like Homestead.

And, Mr. President, I am very pleased to hear some of my colleagues from the other side of the aisle talk about making certain that we do not, at the expense of the steelworkers, that the steelworkers across our Commonwealth, or the working men and women of our Commonwealth and our country, are not the ones to suffer in situations such as this.

Today, Mr. President, the issue is the dumping of steel into this country. Tomorrow the issue may be something else, but I am very encouraged by what I see from my colleagues from the other side of the aisle as it relates to the concern for the working men and women of our country and our Commonwealth, and I hope that that trend or that belief in looking out for the working men and women continues in this Commonwealth and in this Chamber.

Thank you, Mr. President.

# The PRESIDING OFFICER (Robert J. Thompson) in the Chair.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Wagner.

Senator WAGNER. Mr. President, I also rise in support of this very important resolution. Mr. President, many resolutions that come in front of this body are procedural kinds of resolutions or complimentary kinds of resolutions. This one is certainly much more important. I compliment you for introducing it, and obviously for my colleagues' support.

Mr. President, on the eve of Veterans Day in 1998, it is appropriate that we deal with this resolution. A lot of people do not know it, but southwestern Pennsylvania outproduced the world in steel production in World War II. It really, truly was one of the reasons why this country played such an important role in winning World War II, because of the steelworkers and the steelworkers' families, not just in southwestern Pennsylvania but throughout Pennsylvania.

There has obviously been a decline in the steel industry since then. But as the previous speaker indicated, we have another attack going on, and that attack is directly at the steel industry in this country, and something drastic needs to be done before additional thousands of American people lose their jobs, not because of competition, because this is not fair competition. This is not an open, fair world economy in regard to this issue. We have countries that are subsidizing their steel

industry to dump that product into the market in this country. And that, Mr. President, is putting thousands of Americans right now out of work, and it is having a rippling effect, a rippling effect on other industries and the communities in which these steel plants presently are located in surrounding areas. Something needs to be done, Mr. President, and done now.

With this resolution, hopefully the President of the United States will wake up and Congress will take the appropriate action that is necessary. Obviously, a unified effort in passing this will send the right message from Pennsylvania.

Thank you, Mr. President.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Washington, Senator Stout.

Senator STOUT. Mr. President, likewise, I join my colleagues this afternoon in support of this resolution to oppose the dumping of foreign steel in this country.

Two weeks ago Saturday, on the steps of the Washington County Courthouse, there was a rally for people to stand up for steel. Hundreds and hundreds of steelworkers and their families and supporters and elected officials from local, county, and Federal government joined together to support this resolution to oppose the foreign dumping of steel in this country. Unfortunately, in the past in the decade of the 1970s and 1980s we lost nearly 100,000 steelworkers' jobs in Pennsylvania. And all you have to do to see what happened to the carbon and steel industry in southwestern Pennsylvania is get in a boat on the Monongahela River and bob down and go past community after community that used to have a vital steel industry. Now the mills are shut down, the land is vacated, and people are out of work.

You look at communities like Monessen, and the only thing left there is the coke works. You go to the town of Donora. That town is shut down from the steel industry. Go on down the Monongahela, as the previous speaker alluded to, and Homestead, McKeesport, and down to the south side of Pittsburgh. That plant and mill has been leveled. You go down to join the Allegheny to form the Ohio River and go down the Ohio River Valley and come to places like Aliquippa in Beaver County, where at one time during World War II close to 20,000 people worked at that facility, and now it is as level as this floor in this Chamber because the steel industry is gone.

So what is left in the steel industry here in southwestern Pennsylvania is primarily the specialty steel industry of the stainless steel and the alloy steel, and unfortunately, these foreign imports are destroying those jobs here, so we must take strong action to convince the Federal government and our Congress and our President to lead a strong battle against the foreign imports and dumping of steel. If we do not do that, we are allowing foreign governments to export their unemployment to this country and put our people out of work. So I strongly support this resolution, and I think we have broad-based support on both sides of the aisle for this resolution.

Thank you, Mr. President.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Bucks, Senator Conti.

Senator CONTI. Mr. President, I would like to add my voice to the clarion call of this resolution for a reform in regard to imported steel. I also rise on behalf of my colleague from Bucks County. We have had a tremendous loss of jobs in Bucks County at the U.S. Fairless plant. Seven hundred jobs out of 1,000 have been lost because of imported steel. So I rise today to support this resolution on behalf of the Senator from Bucks County and myself who represent the Fairless area. It is an important initiative, and I urge all my colleagues to support this resolution.

Senator FUMO. Mr. President, I rise for two reasons. First I want to announce that the Philadelphia delegation has reorganized and that Senator Vincent Hughes has been elected chairman of the Philadelphia delegation. I know we all wish him well in that endeavor.

Secondly, Mr. President, I rise to express my thanks and gratitude to all the people who called me and my family during my recent illness, Members, bipartisan. You know what often happens up here, Mr. President, is we start to read the media and we start to believe our press that everybody hates our guts, and in fact, that is not true. There are a lot of people out there who love a lot of us, and I want to, on behalf of my family and myself, thank everyone who called. And a quick update, I still do not know what it was. I still have it, but not as bad, but coming back in Session has been good for me.

Thank you, Mr. President, and I thank everyone else.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Mr. President, I rise to call attention to a very serious problem in making the welfare-to-work program a success instead of just a slogan in Pennsylvania. The welfare-to-work program is breaking down, and if we are serious about making a paycheck replace a welfare check, the Governor must take some action now. While the State is saving a substantial amount of money as people leave the welfare cash assistance program to go to work, the State has refused to use some of those savings to subsidize child care to keep those people working. The Department of Public Welfare itself is projecting that it will save about \$20 million in the cash assistance program because of welfare recipients going to work. At the same time, those single working parents who are making minimum wage or just above are expected to pay \$100 a week or more for nonsubsidized child care.

On October 8, over a month ago, 11 other Senators joined me in writing to the Governor and the Secretary of Public Welfare asking them to fix this problem by using some of this \$20 million savings from cash assistance to help pay for child care for working mothers who came off the welfare rolls. To date, no response. Is anybody there? Does anybody care? Who is suffering as a result of the administration's failure to act? First of all, the children of these working parents. Secondly, many employers who have trained these welfare recipients for a job and who may lose those welfare recipients back to the welfare rolls. And third, the welfare-to-work program itself.

Mr. President, the math is simple. There just is not enough money for a single parent earning minimum wage to feed and clothe their family, to pay their rent, and have \$100 a week or more available for child care. It just does not add up. It makes little sense to force people off of welfare, perhaps give them job training, help them to find work, and then cause them to quit their jobs and go back on welfare because they cannot afford decent child care. This serves only to restart the cycle of welfare dependency. The money to fix this problem is available now from cash assistance savings. Let us use some of it to make welfare-to-work a true success. Governor, those of us who want welfare-to-work to succeed ask you to take action now.
