WHEREAS, We, your Memorialists, the Members of the One Hundred and Nineteenth Legislature of the State of Maine, now assembled, in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress, as follows:

WHEREAS, the United Nations Convention on the Elimination of All Forms of Discrimination Against Women was adopted by the United Nations General Assembly on December 18, 1979, became an international treaty on September 3, 1981 and as of December 1997 has been ratified or acceded to by 161 nations; and

WHEREAS, Although the United States is considered a world leader in human rights, supports and has a position of leadership in the United Nations, was an active participant in the drafting and is a signatory of the convention, the United States is one of the few nations that have not ratified the treaty; and

WHEREAS, the spirit of the convention is rooted in the goals of the United Nations and the United States, which seek to affirm faith in fundamental human rights, in the dignity and worth of the person and in the equal rights of men and women; and

WHEREAS, the convention provides a comprehensive framework for challenging the various forces that have created and sustained discrimination based on sex against half of the world's population and the 161 nations that have ratified the convention have agreed to follow the convention prescriptions; and

WHEREAS, although women have made major gains in the struggle for equality in social, business, political, legal and educational fields, there is much more to be accomplished; and through its support, leadership and prestige, the United States can help create a world where women are no longer discriminated against and have achieved one of the most fundamental of human rights, equality, now, therefore, be it

RESOLVED: That We, your Memorialists, request the President of the United States and the United States Congress to ratify the United Nations Convention on the Elimination of All Forms of Discrimination Against Women and be it further

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Philadelphia, Senator Schwartz.

Mr. President, I was inclined to offer amendments, but my understanding of the process and the agreement around the process is that it is highly unlikely that any amendments would pass. Therefore I wanted to, in lieu of offering amendments,

make some comments on the budget and to express some of my disagreement with something that is in the budget, and primarily what I want to speak about is education and children.

I do believe very strongly that because this budget includes not the necessary language to implement vouchers but does include almost \$64 million for vouchers for private and parochial schools or some use of \$64 million, there have been a variety of proposals for that, but certainly most likely to be used for private and parochial schools, I wanted to speak to my opposition to that, but more to the point how better we can use \$64 million to enhance the quality of public education in this Commonwealth. And I had an amendment that would have used \$64 million to encourage school districts, enable school districts to reduce class size. Some of our school districts would very much like to do that.

We ought to, Mr. President, use proven research-based techniques if you want or ways in which we could improve the quality of education instead of an unproven use of having a few children leave the public school system. Instead, we should be enabling our public schools, we should be a partner with our public schools to be sure that they provide a world-class education to every child, regardless of where they live in this Commonwealth. Our school districts across this Commonwealth have been saying to us they need our help, they want our involvement, and they could use a few more dollars, and if we are willing to spend \$64 million, and there are actually other areas in the budget where we might be able to draw on the money that we actually should be investing, what a time to make the kind of investment that we ought to to reduce class sizes, for example.

Secondly, I would talk about increasing funding for special education. Many of us have been talked to by our school districts about the need for us to be able to partner with the school districts so that they are not making these difficult choices or spending money they do not have since we have changed the formula. We ought to be doing something about that. I know that we saw an amendment pass on the House side that Representative Jess Stairs put in that passed with broad support on being sure that the State would use some of its dollars, about \$85 million, to help our school districts pay for special education, and the funds again could come from some of those dollars that would be used for vouchers as well as some other money that we have in the budget.

And again, you may know, Mr. President, that I introduced some legislation recently that I called "Invest For Success," which again encourages our school districts to use research-based methods and strategies for improving student achievement. That is what it has to be about, improving the academic success of our children. And our Governor has spoken up about his concern for academically distressed schools, but his answer, Mr. President, has been to change management, to change the bureaucracy rather than to change what really happens in the classroom to really make a difference in student achievement for our children. Mr. President, for maybe \$80 million, use the \$64 million for vouchers and use a few other dollars that might be there from some of the other funds, we could truly make a significant difference on behalf of the 1.7

million children in our public schools across this Commonwealth.

And, Mr. President, I think it is a lost opportunity. The Governor talks about opportunity grants for some children, a few children, knowing full well that if we pass vouchers there are many of us who will try to stop that from happening. Most of us think there are not the votes in the House or the Senate to make that happen, and instead of debating vouchers yet again and defeating vouchers, we should be talking about what we do want to invest in and how we could make a difference to the children of Pennsylvania. Instead, we are having a discussion about what we do not want to do and what we should not do. We should be assuring that all of our children have educational and economic success and economic and educational opportunity, and that is really what opportunity grants should be all about. So I say that we should be working with those school districts, be a partner, and I would say we should be using research-proven methods to do so.

Let me also say that this budget is very much a missed opportunity. I am going to mention two other areas for children that I think are really very important in addition to education, Mr. President, and that is that we should be using some of these resources that we have. And are we not fortunate to have almost a billion dollars in surplus in the State? And while many of us believe in savings, I think the State has to have a reasonable amount of savings, this is the time when I would say we could address at least two other issues for our children, and one of them is the Children's Health Insurance Program.

I have time and time again talked about the Children's Health Insurance Program. Mr. President, the Chair and I stood up recently with the Governor to expand the Children's Health Insurance Program to another 24,000 children in this Commonwealth whose parents cannot afford private health insurance. Well, Mr. President, it is not enough. For just another \$26 million out of almost a billion dollars in surplus that is sitting there not being used, on behalf of our children we could and should stand up and say that we are going to extend health insurance coverage for every child in Pennsylvania, Mr. President. Every child. We will not leave out 50,000 or 60,000 or 70,000 children and say, sorry, the line stops here. You can have health insurance and you cannot. That is unacceptable, Mr. President. And we have the resources to change that. We have the resources, not some huge amount of money that sounds so outrageous that none of us can fathom how we are going to reach this goal, but we have it here and now today.

This Governor, the Chair, Mr. President, and I could stand up at another press conference and say we are committed to extending health insurance coverage for all of our children in Pennsylvania. Now, we will not pay 100 percent necessarily, but we will help working families in this Commonwealth make sure that their children get timely, appropriate health care. We should, we can. We ought to do it as part of this budget. It is a missed opportunity not to.

And another issue, the last one I will mention, Mr. President, is on child care. There has been quite a bit of discussion in the press about some of the child care needs of working families. The fact is that the Governor has made some choices to extend

more child care to our poorest families, reducing the opportunity for those who have been working hard who need some subsidy to keep their children in quality child care.

Mr. President, as I understand it, what we could be doing is using some of the savings because of the reduction in the welfare rolls, some of those Federal dollars that we are not spending on welfare, some of that TANF savings, as it is referred to, Temporary Assistance to Needy Families, and spend it on child care, and instead we are not going to draw down those Federal dollars. We are going to let the Federal government keep Pennsylvania's dollars and not extend child care to many of those families who need it to go to work, to be proud working families in Pennsylvania who need a little bit of help to make sure that their children are in quality child care, Mr. President. We ought to do that. We can do that, Mr. President, with no State dollars, just by drawing down more Federal dollars, and we ought to do that

And we ought to make sure that the child care that we are helping to subsidize is quality child care, and one of the ways we can do that is by extending the Child Care Loan Forgiveness Program into which we now put about \$100,000 every year when we know the need is closer to a million dollars. We should be putting \$740,000 into that program.

So, Mr. President, I may be the lone vote this afternoon, but I am going to vote "no" on this budget because it is inadequate to the task. We have the resources to do far better by our children. We should do better on behalf of public education, we have the dollars to do it. We know some of what works. We know that early reading programs work, we know that smaller class size works. We know that improving the quality of teachers works. And why are we not doing those things instead of saying we are going to shift some kids out of the public schools and send them to private and parochial schools, if they will take them, and if their parents can come up with another \$1,000 or \$2,000 or \$5,000, and instead we are looking aside at what we know can work and helping a few children rather than helping the children of all Pennsylvania families who are in public schools. That is what we ought to do.

I, too, am concerned about student achievement, and we have to be improving the quality of that student achievement. We have to be assured that every one of our children has a healthy start and a strong educational start, and if we want to be strong in Pennsylvania for the future, we should be caring about our children. If we want to be sure that we are going to attract businesses of the future, we should make sure that we have the skilled work force, and that skilled work force are real people, and right now those real people are our children.

And, Mr. President, I say to you this budget is inadequate to the task because it takes too much of Pennsylvania's taxpayer dollars and puts it aside for some day when we may have already missed the boat. It may be already too late to retrieve what we need to retrieve in Pennsylvania, and that is making sure that the children today, the children in first grade and third grade and fifth grade and eighth grade and those who are graduating and hoping to go on to post secondary training have the skills and the knowledge to be successful, because if they are not, we will not be successful in the future.

And I am not looking at lots of money here. I am talking about money that this Governor is setting aside for vouchers that we will probably argue about in the next few weeks. I am talking about some of the money that we could draw down from the Federal government, and the rest of the dollars are small amounts of money that we can draw from other parts of the budget or from money that is going to be reserved in the surplus. Mr. President, we can do better than this and we should, and I call on those who will be sitting in those back rooms negotiating this budget to think about what I said and hopefully include some of my concerns and the concerns of Pennsylvania's families in the budget.

Thank you very much, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Delaware, Senator Loeper.

Senator LOEPER. Mr. President, I would just simply indicate that today we are giving second consideration to House Bill No. 980, essentially a vehicle for the final general appropriations bill, and what we are dealing with today is process. By moving this bill forward, hopefully tomorrow we will be in a position to vote this bill, to send it back to the House of Representatives and to get the bill in a position of a conference committee where a final budget document, a general appropriation bill, can be negotiated that reflects the needs of all Pennsylvanians.

We certainly saw a blueprint presented to us by the Governor with his Budget Message in February. And now it is the legislature's turn to put its imprint on the Governor's blueprint, and I believe, Mr. President, that in moving this process along we are going to be able to reflect in the conference committee many of the needs and wants of the various legislative Members and look forward to move this process forward for all Pennsylvanians.

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, I would just like to echo the words that Senator Loeper just delivered to us, that this is a way of moving the process along. Mr. President, there are a number of changes that I think all Members of the Senate would like to bring about in the general appropriations bill. Once we are able to conclude the action in the Senate and eventually put the bill into a conference committee, Mr. President, I believe that we will be able to reflect those changes in the thinking of the Members of the Senate.

I would just like to say again, and Senator Loeper did say, that this is the way of moving the process on so that we can meet our constitutional deadline and have a budget in place by June 30 of 1999, and it has been a process, Mr. President, that has been handled in the Senate in a very nonpartisan manner, and this is just a continuation of the next step of bringing that about.

Thank you, Mr. President.
