## PREFERRED APPROPRIATION BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

**HB 980 (Pr. No. 1502)** — The Senate proceeded to consideration of the bill, entitled:

An Act to provide from the General Fund for the expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, the public debt and for the public schools for the fiscal year July 1, 1999, to June 30, 2000, for certain institutions and organizations, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1999; to provide appropriations from the State Lottery Fund, the Energy Conservation and Assistance Fund, the Hazardous Material Response Fund, The State Stores Fund, the Milk Marketing Fund, the Home Investment Trust Fund, the Emergency Medical Services Operating Fund, the Ben Franklin/IRC Partnership Fund, the Tuition Payment Fund, the Banking Department Fund and the Firearm Records Check Fund to the Executive Department; and to provide appropriations from the Judicial Computer System Augmentation Account to the Judicial Department for the fiscal year July 1, 1999, to June 30, 2000; and to provide appropriations from the Motor License Fund for the fiscal year July 1, 1999, to June 30, 2000, for the proper operation of the several departments of the Commonwealth and the Pennsylvania State Police authorized to spend Motor License Fund moneys; and to provide for the appropriation of Federal funds to the Executive and Judicial Departments of the Commonwealth and for the establishment of restricted receipt accounts for the fiscal year July 1, 1999, to June 30, 2000, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30,

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President-

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, before Senator Kitchen speaks on this bill, which is the appropriation bill, a very important piece of legislation, may we have some order on the floor of the Senate, please? I think her remarks are important, and we should if we can, please.

The PRESIDENT. Senator Mellow makes an appropriate point. The Senate will come to order.

The Chair recognizes the gentlewoman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President, my colleagues have made it clear that today's vote is more about process than substance. I know how the budget process works. I also know that sometimes people can get lost in the process. I rise today to address the Senate conference committee that will write the final version of this budget.

I urge the Senators who serve on the committee to do so with some compassion. I urge them to place the needs of Pennsylvanians first, and I ask them to share Pennsylvania's wealth with the people who work hard every day and still cannot make ends meet. There is much to like in the process budget we will approve today, but there is also much that can be improved. In a time of prosperity, it is wrong to ask the working poor to pay more for child care. We should be making child care more affordable for Pennsylvanians struggling to move from welfare to work, not less.

This administration wants to raise child care costs for people who can barely afford to put food on their tables. That is wrong, Mr. President. It is cruel, it is short-sighted, and it is bad public policy. This process budget also does too little to improve public schools, especially those in the city of Philadelphia. Education has been and always will be the best way for people to escape the bonds of poverty and build a better life. In a time of prosperity, we have the resources to help our public schools give every child in every school a quality education. I urge my colleagues on the budget conference committee to make improving public education a priority.

Mr. President, too many Pennsylvania children do not have health insurance. Pennsylvania's prosperity, along with Federal funds, will let us give every Pennsylvania child access to quality health care. We have the money. What we have lacked so far is the will. How can we stand by when even one child in this great State does not have access to health care?

Again, Mr. President, I urge my colleagues who serve on the conference committee to let compassion be their guide. I urge them to rework this process budget, and in the process create a spending plan that can lead all Pennsylvanians into the 21st century.

Thank you.

## SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR JAKE CORMAN PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, today I want to recognize some very special guests to the Pennsylvania State Senate. With me today are 11 national champions, actually not all 11 made it down today, but national champions from Penn State University. First I would like to recognize Penn State's 1999 Division I wrestling champion, Glenn Pritzlaff, who is a senior. He captured the 174-pound title and ended his collegiate career with an outstanding record of 79 wins and helped the Nittany Lions capture fourth place in this year's national championship, which incidentally for the first time was held at Penn State in the new --well, not so new anymore--Bryce Jordan Center, and by all accounts it was a very successful event this year in State College.

More importantly, Glenn is an outstanding student athlete. We all know the dedication it takes to become a national champion in wrestling, but Glenn should also be congratulated for his dedication in the classroom. He competed at the top level of Division I wrestling while maintaining a 3.49 GPA in finance.

It is a pleasure for me to recognize him, and also with him today on the floor of the Senate is Penn State's new head wrestling coach, who is from Mifflin County, part of the 34th Senatorial District, Troy Sunderland.

Senator CORMAN. Mr. President, this trophy I am holding in my hand should be no stranger to the Pennsylvania State Senate. It is the fifth consecutive year that the Penn State fencers have won the national title and the seventh time in the 1990s, which is a record since the history of the sport of fencing at the college level. Some of the athletes of this team are joining me on the floor, joining us in the State Senate, and it is my pleasure to introduce them, and while I do that I will pass this off to a former Penn State alum, Senator Thompson, to hang on to, although he did say they did not have fencing when he was there.

With it were left many polluted areas, many, as we refer to, brack holes and shafts that need to be filled.

A survey done by DEP many years ago came up with about a \$15 billion bill. The fact that the Federal government is holding \$1 billion and not releasing those funds to us only continues to spell out that our problems will exist. The fact of the matter is that our coal operators are putting money into a fund and the Federal government is not matching it. I think it is about time that they met their responsibility to enable us to clear up our environment and to make our areas safe and healthy for young people and anyone else who wants to use them.

Thank you, Mr. President.

Senator WHITE. Mr. President, I rise to support Senate Resolution No. 53. Basically, what we are doing is memorializing the President and Congress to support and approve Federal legislation that gives the States authority to place reasonable restrictions upon the importation of trash.

Several years ago Pennsylvania did the right thing: we closed all our landfills that did not comply with the laws. We tightened the laws, we required liners, we adopted stringent recycling policies, and we are basically being responsible in the way we manage our trash.

New York City has recently announced their plans to close the Fresh Kills Landfill in December of 2001. This is going to result in 13,000 tons per day of trash from New York City that is going to be exported, probably to Pennsylvania. Other States that are handling their own trash responsibly have no control, no ability to control the amount of this that will come into their landfills.

This resolution asks that the other States assume some responsibility for the management of the municipal trash that they produce. It is simply asking Congress to give us reasonable tools to enable Pennsylvania and other States that have worked to reduce their amount of trash and to manage it responsibly to preserve some of our landfill capacity for our own future needs.

So, I urge the legislature to support this, and I hope Congress will listen. And while we accept the fact that trash is interstate commerce, we think basic fairness demands that the Federal government provide us with the tools to require our neighbors to also be responsible in the way they manage their trash.

Senator WAGNER. Mr. President, I rise in support of Senator White in Senate Resolution No. 53, and I just want to add one additional significant point that she brought up with regard to New York City, which is basically that New York City does not adhere to the same recycling regulations that Pennsylvania

does, but we are accepting their trash that contains recyclables. And it is really something that is very significant, because we are taking that trash, which does not adhere to the standards of the people of Pennsylvania, and putting it in landfills in Pennsylvania.

Consequently, something needs to be done about this. Hopefully, we can do something ourselves, but if we cannot we need Congress to help us in that effort.

Senator STOUT. Mr. President, I rise today to request support for final passage of House Bill No. 319, which would create an act to require public hearings before the closing of a State mental facility. Western Center School and Hospital, located in Washington County in my portion of the Senate district, is scheduled to close on June 30, 1999, but the families have not had an opportunity to comment on that decision. This act would be applicable to all decisions made after December 31, 1997.

As you are all aware, the Governor vetoed a similar piece of legislation we passed last year. In the meantime, the prime sponsor, Representative Fairchild, has met with the administration and has worked out a compromise that would direct that hearings kick in when there is a 20-percent reduction in patients or staff. The intent of this legislation is that this is a threshold at which point this act would become applicable.

This legislation potentially affects every Member of the Senate, either because a facility is located within your district or you have constituents who have family members in a State mental institution. Therefore, we have enjoyed bipartisan support for this legislation in the past, unanimous support from my side of the aisle, and support from the Republican side of the aisle with the input and involvement of Senator White, Senator Murphy, and Senator Slocum, who have facilities in their districts and have participated in this legislation.

I ask for unanimous support to send a strong message to the administration that we need to have public hearings and give the public an opportunity to comment when an important facility is closed or there is a reduction in staff or patient load, so I ask for unanimous support for the passage of House Bill No. 319.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Mr. President, I, too, rise to support House Bill 319. I think many people have been communicated to by various groups, and you have to realize the people who are in these centers are very physically and mentally disabled and these have been a godsend to the parents and the loved ones, knowing that they have the care and the facilities available to them. I also understand and we have to realize that we live in a

real world, and in many cases there are some of our citizens for whom community-based facilities work just fine.

But in our haste to try to cut costs in the Commonwealth and try to take the more, I am not sure what the entire motive is, to try to put these people in the community, sometimes I think we might be taking a step too far, and I want to caution that many of our people who are in centers could very well live in a community home-based environment and function as fully as possible. But there is still a significant proportion of people who are in these centers who are going to need that 24-hour-a-day care. These people cannot walk, they cannot see, they cannot even manipulate their arms and legs, and I think it is important that we do not throw the baby out with the bath water, and that by having a public hearing on these centers we have an opportunity to hear what the public has to say and make decisions from there.

I think this is a prudent move. We are not tying anybody's hands, but we are taking a step that after all this could be a very emotional issue, and I think taking the caution of passing this legislation is probably appropriate at this time.

Thank you very much.

## PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Dauphin, Senator Piccola.

Senator PICCOLA. Mr. President, it is not often that a Member of the legislature from the central part of the State will come to the floor to say something positive and glowing about the city of Philadelphia, particularly the Philadelphia School District, but I would like to give the Senate some information about the city of Philadelphia's approach to our new Charter School Law and how they have accepted and worked with that particular law, contrary to many of the school districts in the other parts of the Commonwealth.

As the Members of the Senate will recall, slightly less than 2 years ago, the General Assembly adopted a new statute for Pennsylvania creating the Charter School Law. This law would allow each community, each school district to charter public schools within their district, based upon applications presented to them from members of their community, parents, teachers, businessmen, businesswomen, and so forth, people who wanted to become actively involved in the education of the children of that particular district. And the charter school movement across Pennsylvania has come forth with quite a number of applications throughout the Commonwealth.

We are now not quite 2 years into that program, and I would like to indicate why I thought Philadelphia should be recognized for its positive approach to this statute. During the first year of the Charter School Law, in the city of Philadelphia, there were 17 applications for charter schools. The city of Philadelphia approved 11 of those and denied 7, for a 61-percent approval rate. Throughout the rest of Pennsylvania, there were 40 applications for charter schools to various school districts; 18 were approved, 22 were denied, for a 45-percent approval rating.

The second year of the program was dramatically worse. In Philadelphia, there were 25 applications for charter schools, and 12 were approved, 13 denied, for a 48-percent approval rating. But here is the tragedy. In the rest of the Commonwealth during

that second year, there were 56 applications for charter schools. Only two throughout the rest of the Commonwealth were approved. That stacks up against a total of 12 out of 25 in Philadelphia. That is a 4-percent approval rating for the rest of the Commonwealth. The cumulative total for Philadelphia during the almost 2 years of activity of the Charter School Law is a 54-percent approval rating, and the rest of Pennsylvania a 21-percent approval rating. So Philadelphia deserves some credit for taking this statute and working with it the way that I believe the General Assembly intended it to be used.

Back in 1997 when we were debating the charter school statute on this floor, I made the comment, and I will quote, "These first 2 years will be critical, and I sincerely hope that the school districts of the Commonwealth look at this legislation as an opportunity and not as an obstacle to the improvement of education in this Commonwealth." We can now see almost 2 years into the program that the city of Philadelphia looked at this as an opportunity, and the rest of the Commonwealth, for the most part, has looked at it as an obstacle.

One of those districts in the Commonwealth, and there are a number that I could cite, but I will cite a district that has, in my view, consciously attempted to circumvent and contravene the law of charter schools, and that is the Harrisburg School District. They did approve one charter school, to their credit.

But last year, under the leadership of a new superintendent, back in December of last year, the city school district came up with a so-called report on charter schools and their impact on the Harrisburg School District. And the report was trumpeted on the front page of the Harrisburg Patriot-News, and it appeared, and this is a good argument why you should not always believe everything you read in the newspaper, it appeared as if charter schools were of great harm to the city of Harrisburg.

We tried to get a copy of the report, and when we finally were able to get a copy of the report, it turned out it was a 9-page report, although do not let the 9 pages fool you because I can read into the record everything that is on those 9 pages.

Page 1 was simply the title, "Charter Schools: Impact on the Harrisburg School District," and the date, "December 21, 1998."

Page 2 was the methodology and it contained only three bullet points in terms of what they did to come up with this report: "Scanned National and International research on Charters," just scanned them; "Interviewed parents, teachers and principals of exited charter school students." Does not say how many, who, where, when, or how; and number three, "Looked at financial impact of charter schools on the Harrisburg School District."

Page 3 consisted of four bullet points, entitled: "History of Charter Schools." "First Charter School in Minnesota 1991. By 1991, 11 states had charter laws." The third bullet was, "By 1996, 25 states and D.C. had passed laws with 246 schools. In 1998 about 700 charter schools in 30 States with about 170,000...." in enrollment. That was page 3.

Page 4 was titled "Who Starts Charter Schools?" and this is probably the most derogatory part of the report, "Who Starts Charter Schools? Zealots, entrepreneurs, reformers." That is the entire page 4 of the report.

Page 5 consisted of a number of bullet points, "What Have We Found?" Not even whole sentences. "Two-tiered education,

social fragmentation, inequalities, system reform and improved quality, spending, marketing, special needs students, hidden impediments, accountability." Totally incomprehensible bullet points. You are not sure whether they are for them or against them. You have no idea what they are trying to explain.

Page 6 consisted of a quote from an opponent of charter schools: "State charter laws are stronger on theory than practice when it comes to accountability and evaluation."

Pages 7 and 8 merely consisted of an allegation of what charter schools would cost the Harrisburg School District in one year and what the cost would be for the 5-year life of the particular charter. No idea as to how they came up with these dollars and the accounting that backs it up. There are just raw numbers in terms of each year.

And finally page 9, one sentence. Actually, it is one question: "Can Our Community afford this grand experiment?" That was their so-called unbiased report from the superintendent of the Harrisburg School District. It is not surprising that about a month later the Harrisburg School District turned down two very good applications for two additional charter schools in the city of Harrisburg based upon this report. To the credit of the school board, the vote was a 5 to 4 vote, so there are at least four people on that board who are thinking positively about charter schools.

The kind of occurrence that happened in Harrisburg on charter schools is repeated throughout the Commonwealth. Our newspapers, since this law went into effect, have been full of stories about applicants, apparently very qualified applicants, being summarily dismissed and denied by local school districts. These kinds of arguments as put forth in the report from the Harrisburg School District and other school districts are simply intellectually dishonest when it comes to the approach that they take about charter schools.

The Pennsylvania School Boards Association, and I had spoken about this about a year ago here on this floor, have taken up the cause against charter schools by conducting seminars on how to go about the process of denying charter school applications. They have even come up with a white paper most recently that suggests that we eliminate the State Charter School Appeal Board.

What brings me to the floor today, Mr. President, is that I want to draw to the attention of the Members of the Senate that Governor Ridge most recently has sent to us the names of his nominees for the State Charter School Appeal Board. It is incumbent upon the Members of the Senate to confirm those individuals, because on July 1, we will have in effect a State Charter School Appeal Board for charter school applications.

It appears from the record thus far, Mr. President, that this appeals board is vitally needed if the applications for charter schools are to get the due process that they so richly deserve. I urge this Senate to take those names up very seriously, to confirm them as quickly as possible, so that on July 1 we will have an appeals board in place to rectify the wrongs that have been done throughout this Commonwealth, except of course for the fact that I believe the city of Philadelphia has taken a fairly responsible approach.

Mr. President, it is unfortunate that in a State where we like to put as much control in the hands of locally elected school boards as we possibly can that so many of them have taken this negative attitude towards charter schools. I am hopeful that they will change that attitude, but if they do not, we must have, if charter schools are to be successful in the Commonwealth, we must have this appeals board. It is quite possible that because school districts will continue to govern these chartered public schools that are chartered within their districts, that they will have oversight responsibility and control over them that we will continue to run into problems even after an appeals board is created. And if that is the case, Mr. President, we will have to look in the future to the possibility of allowing other institutions, other than school districts, to create charter schools, institutions such as community colleges, institutions such as our State institutions of higher education, our State system, Penn State, Pitt, Temple, our other State-relateds. In addition, perhaps our private institutions as well, giving them the opportunity to form charter schools.

Mr. President, this is for the benefit of our children. We are not in the business of protecting and preserving systems that are not providing the proper educational opportunities for the students of this State. Charter schools are one way to give students and parents the opportunity to get the best possible and most innovative education for their students, and I urge the Senate to bring those nominees for the State Charter School Appeal Board to a vote as soon as possible so that by July 1 we will have that board in place and ready to review the denials that seem to be coming in great numbers from many of the public school districts of this Commonwealth.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise for two purposes this afternoon. The first is to briefly respond to Senator Piccola's remarks and to actually join him in his remarks, and particularly in light of his comments pertaining to the school district of Philadelphia. I would like to add, however, to that list the school district of the city of Pittsburgh, because I believe that the city of Pittsburgh, their school district, has also maintained an open mind and has approved several charters, most recently the Boys' and Girls' Club of Western Pennsylvania. So there have been several approved there. However, I wish I could say the same thing for several other school districts in and around the city of Pittsburgh. That is not the case, as Senator Piccola has indicated, and I would join him in asking that this body take a look very quickly at the number of individuals who have been recommended by the Governor to serve on this board.

Mr. President, the second purpose for which I rise today is to talk about activities that took place today in our Senate Committee on Finance. Mr. President, today we reported out, among various other tax cut bills and the like, four bills pertaining to the Pennsylvania inheritance tax. One of the bills we reported out, Mr. President, was one that I introduced and have long advocated for a number of years which would create a \$100,000 exemption for property owned solely by a particular decedent.

We also reported out legislation which would change the percentage of the inheritance tax rate for siblings down to 6 percent. Currently it is at 15 percent. We would move it down to 6 percent. We also reported out a change from 6 percent to 5 percent to lineal descendants. And finally, we reported out a measure that would essentially establish an exemption for property which would pass from a child to a parent, which happens in many occasions, unfortunately, too many times.

Mr. President, the reason I mention those four individual bills is that I think it is important and it is also reflective of the mood among the residents of our Commonwealth. In two of the bills the prime sponsors are Republican Members of this body, two are measures being supported by Democratic Members of this body, and I think it is reflective of what the people of our Commonwealth feel. This is not an issue among Democrats and Republicans, it is an issue about the working people, the small businesses, and the families of our Commonwealth who are desperately crying out for a change in the Pennsylvania inheritance tax.

Mr. President, I have long advocated that we need to modify the Pennsylvania inheritance tax. One of the reasons is my sincere belief, and I think the belief of many of the people whom I have talked to, that this particular tax actually represents triple taxation. This inheritance tax represents the taxed earnings that you make when you are working, your earned income, it is taxed at that particular time. It is taxed a second time when that income you have, either put into a bank or invested in real estate or your home, and as the value of your property increases, you are also taxed on that increase. And finally, you are taxed again, Mr. President, whenever you want to pass on those earnings or savings to your family members or friends.

Mr. President, we have long advocated in this Commonwealth that we try to get people to make certain that they work hard, that they provide for their families, and that they make sure that they save what they have so they can pass it on to their family members. And after they have done all that, the Commonwealth steps in, and last year stepped in across our State to the tune of \$711 million, and taxes those savings, and I think we need to do something about that.

I think the message that I am receiving is very clear. It is very obvious to my colleagues in the Senate, both Democrats and Republicans, hearing that message as well. And we need to change the fact that Pennsylvania, Mr. President, is one of two States that has one of the highest inheritance tax rates for estates that are valued at approximately \$250,000, and I would submit to you that is approximately 99 percent of the estates that are filed in our Commonwealth.

So, I think it is time to do something about the Pennsylvania inheritance tax. As I have mentioned before, the amount we received last year was \$700 million. I would like to go back to about 6 years ago when Governor Casey initially proposed and this General Assembly passed the spousal exemption. At that particular time it was my understanding that the amount of lost revenue to the Commonwealth was estimated at about \$50 million during that year. At that time the Commonwealth's collections were about \$600 million. With that exemption in place, and today we are collecting \$700 million a year, it tells me and

represents the fact that we are in a situation where we have a tremendous transfer of wealth that is taking place, not only in our Commonwealth but across our country, where more and more people or family members are passing on and transferring the savings that they have accumulated over the years by working very hard, two and three jobs, to save for their families, because they want to pass this on to their family members, and the State is stepping in and taxing them. So, what we are seeing and given the nature of the age of our population in our Commonwealth, what you will continue to see, will be an increase in the amount of revenues collected in Pennsylvania with the inheritance tax, and it will exceed \$700 million next year, and it will continue to climb given the nature of the transfer of wealth that is taking place and the age of our Commonwealth. So, I think we need to do something. Now is the time with the tremendous budget surplus that we have.

I basically wanted to bring to the attention of my colleagues that we are moving forward with this legislation. I ask that they all join us in this regard and make it a very significant part of our budget as we move forward with that process.

Thank you, Mr. President, for the time to address this issue. The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise and thank the Senate for passing Senate Bill No. 383, which for the first time in Pennsylvania adds a criminal charge for someone who sexually exploits a child, defined as someone under the age of 18.

This is a situation which we certainly cannot tolerate in Pennsylvania. There are pedophile cults and other people who engage in this type of activity and induce and force children into prostitution. Not long ago an incident occurred in a State correctional institution in Pennsylvania where a wife brought a child in for her husband and there was alleged sexual activity involved in that incident, and this type of situation would be addressed by the law that we just passed here in the Senate. Such crimes call for serious penalties, and this would be a second-degree felony if an individual was convicted. No one should feel that the risk of harming a child in this devastating way is going to result in just a slap on the wrist, and with the passage of this legislation we have taken the first step in enacting this law.
