SENATE CONCURS IN HOUSE AMENDMENTS

SB 832 (Pr. No. 1185) -- The Senate proceeded to consideration of the bill, entitled:

An Act redesignating a portion of the Lackawanna Valley Industrial Highway, SR 0006, as the Governor Robert P. Casey Highway, designating the Olyphant on and off ramp, Exit 2 of the Lackawanna Valley Industrial Highway as the Representative Joseph G. Wargo Exit, and designating a section of U.S. Route 11 in Columbia County as Columbia Boulevard.

On the question,

Will the Senate concur in the amendments made by the House to Senate Bill No. 832?

Senator LOEPER. Mr. President, I move that the Senate do concur in the amendments made by the House to Senate Bill No. 832.

On the question,

Will the Senate agree to the motion?

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna Senator Mellow.

Senator MELLOW. Mr. President, 6 years ago today each and every one of us who were Members of the Chamber at the time and those in the House of Representatives were notified that Governor Casey was undergoing a double organ transplant in Pittsburgh. A lot has taken place since then, and Governor Casey, thank God, has done well during that 6-year period of time.

Mr. President, for us today to pass Senate Bill No. 832 on the 6th anniversary of the surgery that Governor Casey went through I think is a very dynamic and very strong expression. Senate Bill No. 832 names a brand new highway that has been built throughout my senatorial district the Governor Robert P. Casey Highway. This was a road that first was initiated through resolution by former State Representative Joseph Wargo, and Exit 2 off the road will be named after Representative Joseph Wargo.

It was first introduced in the House of Representatives, Mr. President, back in 1964, and it was 30 years from the date of the introduction that we had the groundbreaking. The road has been under construction now for 6 years and should be completed, Mr. President, later on this year. It also has received very strong support from Governor Tom Ridge during the 5 years now of his administration.

Mr. President, this road opens up an entire new area in northeastern Pennsylvania for industrial development. I am honored to be able to say that Senator Jubelirer was a very strong supporter when I first talked to him about introducing this piece of legislation to have this road named for Governor Casey. I am pleased, Mr. President, that Governor Casey was successful in his double transplant, and that he is a very distinguished constituent in the district that I have been benefitted and honored to represent.

Mr. President, today by us naming what was known before as the Lackawanna Valley Industrial Highway and to be able to name that as the Governor Robert P. Casey Highway on the 6th anniversary of his surgery and the dynamic journey that he led us through with such tremendous courage is just a very wonderful day today for me personally, and I just want to express my thanks on behalf of not only the Casey family but the people of Lackawanna County and indeed the 12 million people of Pennsylvania, because what we are doing today is the right thing to honor a man who has distinguished himself in so many ways, and I am very happy that finally we will be able to come to final passage of this proposal.

Thank you very much, Mr. President.

The PRESIDENT. The Chair recognizes the President pro tempore, Senator Jubelirer.

The PRESIDENT pro tempore. Mr. President, I join with Senator Mellow in expressing my hope that all Members of the Senate will vote in a positive fashion to concur with Senate Bill No. 832. Mr. President, probably the best thing I can say is I am thrilled that 6 years after Bob Casey went through one of the most challenging and difficult medical procedures that any human being has ever undergone, we are here today prepared to pass a bill that sets forth a highway in Lackawanna County, in northeastern Pennsylvania, as the Robert P. Casey Highway.

Thank God, it is not the Robert P. Casey memorial highway. There is no reason, Mr. President, that people who commit themselves, who work hard, who earn their way should have to pass away before a highway or building, or whatever the case may be, is designated in their honor. Bob Casey deserves this. He has earned it. He has shown the world great courage.

When Governor Casey was active, when he was asked who is your adversary on this, who is going to oppose you? I guess it was my name that always came up. But people do not realize that Bob Casey and I had a very strong respect for one another. Whether we were publicly arguing, whether I was carrying the message for the Republican Caucus of the Senate of Pennsylvania, personally I had great admiration and respect for the man who showed me a fighting spirit while he was in office, and when it really counted, that frankly is unparalleled, and when he came back I have a picture sitting in my office of Bill Lincoln and I standing there with tears in my eyes welcoming him back because the courage that he displayed I believe is unparalleled in my lifetime. And I am delighted and pleased that I can be here today joining with Senator Mellow and I believe every Member of the Senate in passing this bill, designating this highway as the Robert P. Casey Highway.

The PRESIDENT pro tempore. Mr. President, I think I can start off my remarks by saying, like I was saying before, when somebody who works so very diligently over so many years makes such an enormous contribution as did Governor Casey in the previous bill as has Speaker Ryan, I think it is appropriate to honor those people. It does not happen every day. It is remarkable that we are poised to do it twice today, but Speaker Matt Ryan has clearly been the moving force and the driving

force to having the legislative office building redone. We call it the Capitol Annex. I think it is far more appropriate to be the Matthew Ryan Building than the Capitol Annex. Matt Ryan has earned this, he has been an icon of State government over many decades. He is as respected a Member of this General Assembly as has ever served here. I think it sets a very good precedent and one that certainly ought to be continued in the future for those people who earn the right for something as outstanding as this to have a building named after them in their lifetime.

Mr. President, I think it is appropriate that this Senate initiate the bill and send it over to the House of Representatives that the Capitol Annex be named the Speaker Matthew J. Ryan Legislative Office Building and providing for its use. As I said, Speaker Ryan has earned it, and I think this is an appropriate reaction to his dedication, hard work, and commitment to many, many issues and particularly to the preservation of the Capitol and to the renovation of what will be the former Capitol Annex Building, and I urge a positive vote, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK, Mr. President, I, too, rise to support this. As a former Member of the House, I have to tell you that Matt Ryan is aboveboard and one of the most respected gentlemen of whom I am aware, and his perseverance for preservation is unbounded. I think many a weaker person would have backed off because of the significant price tag that goes along with reestablishing and refurbishing and taking this entire State Capitol back to its original glory, and I think it is because of his hard work, dedication, and his understanding that this is truly a Pennsylvania treasure that we rightfully so designate a piece of this treasure in his name. There is not a bus trip or group of people that comes into this State Capitol from the four corners of this State that is not mightily impressed with the condition and the beauty and historical ambience of these structures, and I think by naming the annex after Speaker Ryan, I think we are doing him a great service because without his leadership, without his perseverance, without him taking on a lot of criticism. this entire effort probably would not be done in this century.

The PRESIDENT. The Chair recognizes the gentleman from Bucks, Senator Conti.

Senator CONTI. Mr. President, I rise, too, to support Senate Bill No. 1000. As a former Member of the House, as the former speaker, it is an honor and privilege to serve in the Senate of Pennsylvania, but when you serve in the House of Representatives, a piece of that stays with you, and a significant piece of that for me is Matt Ryan and my experience with the Speaker. Senator Jubelirer used the word "remarkable." I think Speaker Ryan is a remarkable individual. He has certainly dignified our institution with his distinguished service, and I do not know anybody who respects the institution and the General Assembly more than Speaker Ryan, so this is an entirely fitting and appropriate gesture on our part, and I am very proud to rise in support of this matter.

The PRESIDENT. The Chair recognizes the gentleman from Dauphin, Senator Piccola.

Senator PICCOLA. Mr. President, I also rise to support Senate Bill No. 1000 and to indicate to the Members of the Senate why this designation is so appropriate and so meaningful. We here in Dauphin County treasure this Capitol building and the Capitol Complex as a jewel and a treasure that is of particular significance to those of us who live here. (viii) Minimum spacing between tandem and tridem axles shall be four feet, one inch.

No permit may be issued for this type of movement upon an interstate highway.

This would allow for a special permit for the hauling of pulpwood and wood chips that are essential and vital to the paper industry in northwestern Pennsylvania, mainly the International Paper plant in Erie, in order to receive raw materials that are to be processed for the paper industry. It has an impact not only on the Erie plant, but since Erie supplies the Lock Haven plant, it would have an impact there. I think it is good business sense to allow Pennsylvania businesses to be competitive with other States in bringing in raw materials, so I support the Earll amendment, Mr. President.

Senator MADIGAN. Mr. President, this would permit the Department of Transportation to issue annual permits for the movement of self-propelled cranes. This has resulted from conferences between the department and a number of Members who have had problems with crane businesses in their district. I ask for unanimous support.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Washington, Senator Stout.

Senator STOUT. Mr. President, I rise to support the amendment offered by Senator Madigan that would allow for annual permits for self-propelled cranes. In my experience as chairman of the Committee on Transportation, this is a major problem encountered by contractors to move a crane from one location to another. This allows for an annual permit to be issued for certain specific routes and bridges that could be used for the movement of these cranes. I think it is important to commerce and business here in the Commonwealth of Pennsylvania so that people can move equipment not only to construction sites but to service buildings that are being erected. So I support this amendment for mobile cranes to have an annual permit, Mr. President.

The PRESIDENT pro tempore. The Chair thanks Senator Stout, who evidently has convinced the entire Senate.

The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, I am not going to take a position against the amendment; however, I think we should look at what we are doing to highway safety in Pennsylvania. This amendment certainly could compromise the safety of the motorist traveling not only on our superhighways but on any particular highway that this kind of crane can travel. This is a very large vehicle. It is very heavy and it could potentially be very dangerous. So although we are not going to express our opposition by voting "no" on the amendment, Mr. President, I think we are going down a very slippery path to compromise the highway safety of the motoring public.

- (D) Maximum weight on the semitrailer tridem (axles four, five and six) shall be 53,000 pounds, with a maximum of 17,670 pounds on any axle in the group.
- (E) Minimum spacing between axle one and axle two shall be 12 feet, six inches.
- (F) The center to center distance between the last drive axle of the truck tractor, axle three, and the first axle of the semitrailer, axle four, must be a minimum of 45 feet, zero inch
- (G) Minimum spacing between tandem and tridem axles shall be four feet, zero inch.

No permit may be issued for this type of movement upon an interstate highway.

On the question, Will the Senate agree to the amendment?

And the question recurring,

It was agreed to.

Will the Senate agree to the bill on third consideration, as amended?

Senator LaVALLE offered the following amendment No. A2033:

§ 4702. Requirement for periodic inspection of vehicles.

* * *

- (g) Exceptions.—The following [are exceptions to subsection (f):] vehicles shall be subject to the requirements provided by this subsection only when an enhanced emissions inspection program is implemented by the department in all areas of this Commonwealth as required for compliance with the Clean Air Act (69 Stat. 322, 42 U.S.C. § 7401 et seq.):
- (1) Emission inspection criteria for registration of subject vehicles with new registration plates.—A subject vehicle never before registered in this Commonwealth or any other jurisdiction having less than 5,000 miles on its odometer and for which an annual or temporary registration plate was originally issued within the past 12 months shall be exempt from emission inspection for one year from the date of original registration. A certificate of exemption shall be affixed to the subject vehicle in a manner prescribed by department regulations.
- (2) Emission inspection criteria for new vehicles with transferred registration plates.—A subject vehicle never before registered in this Commonwealth or any other jurisdiction having less than 5,000 miles on its odometer and bearing a registration plate which has been transferred from another vehicle shall be required to pass an emission inspection prior to the next registration renewal, but not within nine months of the date of purchase of the subject vehicle.
- (3) Emission inspection criteria for used subject vehicles with new or transferred registration plates.—A subject vehicle sold having a title issued in this or any other jurisdiction or sold with a manufacturer's statement of origin and having 5,000 or more miles on its odometer and which displays a currently valid certification of emission inspection shall be required to be emission inspected prior to expiration of the certificate of emission unless the renewal of registration becomes due immediately before the expiration of the certificate of emission inspected, in which case the subject vehicle shall be emission inspected prior to expiration of the new or transferred registration

plate. If there is no evidence of emission inspection, an emission inspection must precede the next registration renewal.

(4) Emission inspection criteria for vehicles operated with miscellaneous motor vehicle business registration plates or dealer registration plate.-A subject vehicle which displays a miscellaneous motor vehicle business registration plate or a dealer registration plate shall be exempt from the requirements for emission inspection until it has accumulated 5,000 miles on its odometer. At that time it shall be subject to the provisions of subsection (f).

§ 4706. Prohibition on expenditures for emission inspection program.

(g) Alternative enhanced emission inspection program.—Notwithstanding the provisions of subsection (f), the department shall comply with all of the following requirements:

(1) The department shall immediately suspend the development and implementation of a centralized, test-only vehicle emission inspec-

tion program until March 31, 1995.

- (1.1) The department shall immediately suspend the operation and maintenance of any existing emissions inspection program or enhanced emissions inspection program implemented pursuant to this section in the counties of Allegheny, Beaver, Bucks, Chester, Delaware, Montgomery, Philadelphia, Washington and Westmoreland.
- (1.2) The department shall immediately suspend the operation, maintenance, implementation, planning or design of any enhanced emissions inspection program pursuant to this section in the counties of Berks, Blair, Cambria, Centre, Cumberland, Dauphin, Erie, Lackawanna, Lancaster, Lehigh, Lebanon, Luzerne, Lycoming, Mercer, Northampton and York.

(2) The department shall immediately notify the Environmental Protection Agency that the Commonwealth is developing an alternative vehicle emission program and intends to seek its approval of the plan in accordance with the requirements of the Federal law.

- (3) The department shall develop and submit to the Environmental Protection Agency an alternative enhanced vehicle emission inspection program for approval which meets the requirements of Federal law and consists of a decentralized test and repair program or a hybrid program which combines both decentralized test and repair and testonly components. The decentralized test program may contain an additional component which will test and repair only those components necessary to achieve compliance with Federal clean air standards. As part of this decentralized test program, the department shall utilize the newest and most efficient technologies, including, but not limited to, remote roadside testing, identification and targeting of gross polluting vehicles and alternative equipment to existing inspection technology. The department may incorporate pilot programs and demonstration projects which achieve and enhance vehicle emissions reductions.
- (4) On the effective date of this subsection, the department shall be immediately prohibited from expending any funds or allowing any other action in furtherance of the development and implementation of a centralized, test-only vehicle emission inspection program until the Environmental Protection Agency approves the decentralized or hybrid system proposed under paragraph (3). Any funds expended by the department after the approval of the program by the Environmental Protection Agency shall be limited to the implementation of the revised vehicle inspection program.

CONSTITUTIONAL POINT OF ORDER

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Mr. President, I rise to raise a constitutional point of order, namely that amendment A2033 violates Article III, Section 7, of the Pennsylvania Constitution in that it is a special bill or local bill by virtue of listing a number of counties, and the Constitution requires that there be at least 30 days' notice prior to the introduction of the bill. There was no notice given on this amendment and this is not something that can be cured through a subsequent notice, and I ask that this be declared out of order.

The PRESIDENT pro tempore. The question before the Senate is the point of order raised by Senator Brightbill that the La Valle amendment is unconstitutional and violates Article III. Section 7. of the Constitution of Pennsylvania.

On the question,

Shall the Senate sustain the constitutional point of order?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Delaware, Senator Bell.

Senator BELL. Mr. President, I agree that Article III, Section 7, is as Senator Brightbill says. But he presumes this is a local or special bill. This bill pertains to one-half of the people of Pennsylvania. I do not think anybody in their right mind would call that a local bill.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Westmoreland, Senator Kukovich.

Senator KUKOVICH, Mr. President, I am not aware of any case law that would interpret that section of the Constitution the way it was just explained. My understanding is that the purpose of this section of the Constitution, and I have never seen this used before on the floor of either the House or Senate to try to prevent legislation from passing, but my understanding is that the purpose is to try to ensure that special legislation for a locality or some small part of the Commonwealth of Pennsylvania would not be run through this body unless those local individuals were informed. That is very different from the amendment being offered.

As Senator Bell said, he is referring to a program that was foisted on this State primarily by the Federal government. There may be some debate. Reasonable people could differ on the validity of that program, and there has been extensive debate in both Chambers for years over this particular program. But never before have we seen this article and section of the Constitution used for legislation that refers to so many counties, or to any county for that matter, as opposed to a local municipality. And it could not by any stretch of the imagination be considered to be special legislation. This is something that affects the entire State no matter how many counties are included.

I think this is clearly constitutional. I think there is no precedent to declare this unconstitutional, and as a matter of policy, this is something that many Members would like to address. I think that we cannot always hide behind parliamentary maneuvers, and I think the maker of this amendment, at the very least, deserves a debate and a vote on this particular language.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Beaver, Senator La Valle.

Senator LaVALLE. Mr. President, I think it is pretty clear to those who are affected by the original legislation that they were named by county, and to argue anything other than that does not make any sense at all. If there is an attempt to avoid voting on the amendment because some folks are not comfortable, I can understand that. You cannot tell that to the people who were named by county when they were put in the program in the first place and now the attempt is to exclude a whole bunch of other counties that were supposed to be in it later on.

Thank you, Mr. President.

The PRESIDENT pro tempore. The question before the Senate is a point of order raised by Senator Brightbill that the LaValle amendment is unconstitutional, violating Article III, Section 7, of the Constitution of Pennsylvania.

Those voting "aye" will vote to sustain the point of order, thereby declaring the amendment unconstitutional. Those voting "no" will vote that the point of order is not well-taken, and thereby declare that this amendment is constitutional.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise to thank the Senate for passing Senate Bill No. 384, which deals with missing children legislation. This legislation deals with the abduction of children and the requirement that law enforcement agencies have an immediate investigation of those abductions, and particularly when they deal with the abduction by a parent of a child. The purpose of it would be to require that the investigation would locate and ascertain the welfare of the missing child, as well as to make sure that that investigation occurs quickly. By the way, the Pennsylvania State Police are very supportive of this legislation and have instituted a program similar to this, and this legislation would give them statutory authority to implement it. It would require an update of a missing persons file within 60 days of the original missing persons entry and also require an investigation and computer file entry of all unidentified children, living or dead.

It would also establish the Pennsylvania State Police Missing Children Information Clearinghouse to serve as a central repository for information on missing children in the Commonwealth, and then finally it would require the obtaining of comprehensive descriptive information on an enrolling parent for a new or transferring student, and by ensuring that law enforcement authorities are notified by the school if an enrolled child is missing, so that we make sure that a child who is abducted and then the abductor attempts to enroll that child in a school that there are steps taken by both the school authorities and the law enforcement officers involved in that situation.

I would also like to make a note of last week when we passed—and I did not have an opportunity to mention it—Senate Bill No. 332, which is Schools for Safe Action. It is my belief that it is important for us to take preventive steps in dealing with school violence and not pass more criminal statutes that we have an abundance of in dealing with this because then it is too late for us to pass legislation that will try to identify the children who are at risk. Many times when we see these reports on TV, they have reports of children who have committed acts for months, sometimes years, or telltale signs of violent, coming violent behavior, and then nothing is done about it, so in Pennsylvania this Senate bill was passed last week and would take a significant step in that direction.

For example, it authorizes all school employees to act in the place of parents in disciplinary matters and would provide good Samaritan immunity for school employees so they can intervene in acts of violence without the fear of litigation and being sued.

It also will provide for conflict resolution training for school employees and conflict resolution instruction for school students so that we deal with these issues before they escalate into acts of violence, maybe not in shootings, but there are still acts of violence every day in our schools that we will hopefully help to prevent by this type of training. Also, school employees would be required to report acts of a criminal nature to supervisors for investigation and referral to the appropriate law enforcement authorities. I had a police chief recently contact me and indicate

that attacks on students and assaults on teachers by students were not reported to him, and I think it is important for them, the law enforcement agencies, to know not necessarily that there will be a prosecution, but they will be involved in it and take the necessary steps that are important to take.

It would also ensure that transferring students will have their prior school conduct records reviewed, and any disciplinary action from a prior school would be continued at the school to which the student transfers. Also, if the student has a police record, the superintendent will review it and determine whether that student should be placed in some type of alternative education, and then also to ensure that the State Board of Education will have a drug and alcohol policy that will be developed and enforced uniformly in schools across the Commonwealth, because drug and alcohol abuse in our schools is one of the major factors in violence and criminal activity.

And finally, when local law enforcement authorities are notified that a student has been a victim of violence, these authorities will notify the victim's family about that act.

I congratulate the Senate on its passage, and I look forward to its enactment in the House.

After he met with President Woodrow Wilson, the President proclaimed that he would have Flag Day on June 14. It was not until Mr. Kerr was in his 80th year that he stood next to Harry Truman as President Truman officially signed the bill designating June 14 as Flag Day.

So on a day like today we not only acknowledge Flag Day, but we also honor the name of W. T. Kerr and the fact that he lived in Pittsburgh, specifically in Collier Township's Rennerdale section, and note how one man's dream and his vision and his patriotism came to make this day what it is today. Senator LOEPER. Mr. President, at this time I move that the Senate do now adjourn until Tuesday, June 15, 1999, at 11:25 a.m., Eastern Daylight Saving Time.

The motion was agreed to.
