The PRESIDENT pro tempore. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, today I rise to urge my colleagues to support Senate Bill No. 130, a measure that would add Pennsylvania to a growing number of States that recognize out-of-State Protection From Abuse orders as valid and enforceable.

Right now, our nation is kind of like a 50-piece jigsaw puzzle, but there are three pieces missing. There are three States where out-of-State PFAs are not recognized. Unfortunately, Mr. President, Pennsylvania is one of those missing pieces, and that is simply not acceptable. We need to put these last three pieces of the puzzle in place so that those protected by PFAs can travel freely throughout the United States, with the reassurance that regardless of where they go they will always have legal safeguards against an abusive partner.

Domestic violence is one of our nation's greatest tragedies. robbing people, women in particular, of dignity, self-worth, and often their lives, and the problem is pervasive, crossing every age group and social and economic strata. In fact, according to the U.S. Department of Justice, anywhere from 960,000 to 4 million women are battered each year by a spouse, former spouse, or partner. Even more disturbing, 40 percent of girls between the ages of 14 and 17 report knowing someone of their own age who has been hit or beaten by a boyfriend, 40 percent.

Mr. President, we owe it to all the victims of domestic violence to join the network of States that are banding together to take a stand against abuse by giving women stronger legal protections. Under Senate Bill No. 130, all Protection From Abuse orders issued out of State will be presumed valid by law enforcement officials and enforced as if they were issued in Pennsylvania. Victims would not be required to present a certified copy of the out-of-State order in order for police to enforce it, and law enforcement officials who acted in good faith to enforce the foreign PFA would be protected from civil liability.

This measure has the full support of the Pennsylvania Coalition Against Domestic Violence, a group that deserves our applause for the excellent work that they do to combat domestic abuse. By supporting Senate Bill No. 130 today, we can do our part to make our nation just a little safer for women who are trying to escape the violence and rebuild their lives. Mr. President, I urge my colleagues to vote "yes" on this measure.

Senator TOMLINSON. Mr. President, Senate Bill No. 65 is the Home and Community-Based Care Act, and the purpose of this bill is to make home and community-based care readily available to senior citizens across the Commonwealth of Pennsylvania.

Right now, we have about 7,500 senior citizens in Pennsylvania eligible for care and help, and in Bucks County alone we have about 120 eligible residents. This bill would help people who need care or nursing home care or who qualify for nursing home care but still would like to stay in their home, it would provide services to them so they could stay in their homes. As we know from many of our parents and people in our community, the longer people stay in their homes, the better the quality of life. Yet, we would still be able to provide nursing care and personal care to them so that they could stay in their neighborhoods, stay in their homes, and stay around their friends and families. To qualify for this, we would use a 300- percent Social Security supplement income, which would be about \$19,000. This bill, as I said, would include about 7,500 people in the State of Pennsylvania, making them eligible for care in their home and providing for a better quality of life. I urge the adoption of this bill.

With the help of HealthLink, access to state-of-the-art x-ray machines, surgical lasers, MRI equipment, and indeed any equipment that would mean the difference between life and death, between comfort and pain, will not hinge on whether somebody lives in a township or borough or city.

Under Senate Bill No. 506, HealthLink grants or loans of up to \$500,000 would be made available. The loans would be

interest-free, and the State commitment must be matched by local commitment. To be eligible, hospitals and health centers would be required to match the grant amount.

Mr. President, this bill is supported by Members on both sides of the aisle and by various areas of the Commonwealth, rural, urban, and suburban. I urge my colleagues to cast their vote for Senate Bill No. 506 and cast their vote for equal access to high quality health care.
