(d) Modification of Federal statute [or regulation], regulation, standard or criteria.—If any Federal statute, regulation [or standard], standard or criteria adopted by the department is amended or modified by the Federal Government, the amendment or modification shall have the effect of so amending or modifying the department's regulations. PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, last week I was joined at Easton Hospital by some doctors and nurses, hospital administrators, and college nursing professors to talk about the serious nursing shortage that exists in Pennsylvania today.

Over the years nursing shortages, and we have heard about them, come and go like some new strain of flu, but the nursing shortage that we are experiencing now is far more severe and it will be far more complex to cure. For every eight nurses leaving the field, three are entering it. Today there are fewer nurses on staff to care for the growing population of older Pennsylvanians who are living longer and need a greater intensity of care. There are fewer men and women seeking a career in the nursing field, and because of increased caseloads, extra shifts, and longer hours, the nurses who are now on the job are burning out sooner and leaving the profession at an alarming rate. There are also more and more nurses who are turning away from the traditional hospital setting. They are taking their training and their skills to a variety of alternative health care settings such as clinics, insurance agencies, managed care groups, and home health care services.

Mr. President, you do not have to have an M.D. behind your name to understand what this means for the patients in hospitals all across Pennsylvania. It means delays in emergency room treatment, backlogs in hospital administration, postponing or even canceling operations, and it means less time that can be spent educating patients who are discharged from the hospital before they are completely healed.

There are always going to be patients who will need medical care, but, Mr. President, who will be there? Are there going to be enough nurses to provide that care? That is the question. Every study that I have seen predicts that the nursing shortage of today will get worse tomorrow and next year and over the next decade.

This is not a short-term issue, so it will require more than a short-term fix. There is no one single magical solution, no miracle drug, or revolutionary gene research breakthrough that can just clone more nurses. That is why I am introducing a resolution today to help Pennsylvania develop a comprehensive, complete set of strategies to address this very serious nursing shortage. I believe we must look beyond staffing standards, because one more regulation is not going to fix this problem. And having nurses spend even more hours out of their day on paperwork is not going to help them set that little 7-year-old's broken arm in the emergency room. We also need to look at scholarships and loan forgiveness. And I want to commend Senator Mowery for introducing Senate Bill No. 640, and I hope that is going to pass soon.

But I also believe we need to look at the bigger picture. We need to look at new fast-track training opportunities, innovative career ladders, and higher wages. We need to look at designing new training modules in our nursing schools and improve the ones that exist. We need to create employee incentives for nurses, because we know that low wages and longer shifts are disincentives. We know that. State government should step in and help hospitals and nursing homes afford to pay bonuses to keep nurses, the best nurses, in the nursing profession and by the patient's bedside. We need to provide incentives for hospitals to forge partnerships with local nursing schools and community colleges, and even mentoring and coaching programs with high school students.

Mr. President, nursing is one of the most physically and emotionally demanding careers you are ever going to find. Nurses are also the name and face of health care today. The current nursing shortage is a problem that cannot be solved solely by the Federal government, by hospitals all alone by themselves, or by any one group alone. I hope that we can take the first step by adopting that kind of approach in Pennsylvania by adopting this resolution. We need more nursing students, we need more nurses, we need to make sure that the nurses in Easton Hospital and every hospital across Pennsylvania are not so overworked and buried in paperwork that they do not have an extra second to spare to help their patients with the real medicine that patients need, which is care, compassion, and love.
