The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Mark S. Schweiker) in the Chair.

Dear Mr. Corrigan:

Section 20-2018-A of the State System of Higher Education's enabling legislation (Act 188 of 1982) states, in part:

Whenever the System deems that it is necessary or desirable to sell, transfer or dispose of real property acquired by and titled to it, it shall request authorization from the General Assembly to sell, transfer, or dispose of said real property; and from time to time, as necessary, the System shall submit to the Chief Clerk of the House of Representatives and the Secretary of the Senate requests to sell, transfer or dispose of real property acquired by and titled to the System for consideration by the General Assembly.

On July 12, 2001, the Board of Governors of the State System approved a request from Bloomsburg University of Pennsylvania, subject to approval by the General Assembly, to sell property at 720 East Second Street, Bloomsburg, Pennsylvania, containing a two-story, 2,500 square foot, brick and stucco single-family dwelling situated on a lot measuring 120 by 128 feet (approximately 0.4 acres). Enclosed is a copy of the Board's approval. The purpose of this letter is to request authorization from the General Assembly to sell the property.

The property was acquired in July 1988 for temporary use by the university to meet critical space deficiencies. Those deficiencies have been satisfied by permanent facilities on campus, so the property is no longer required. The university purchased the property for \$130,000. The property is in good condition, and a current appraisal values it at \$160,000.

As required by Act 188, this office requests that the required resolution to sell the property be drafted and placed on the calendar for consideration by the General Assembly at the next opportunity. Your assistance in this matter will be greatly appreciated.

At this time the Chair is pleased to recognize the gentleman from Mercer, Senator Robbins. I think it is only fitting that the Members of the Senate know that the idea of the Joint Meeting, which Speaker Ryan and I sponsored, came from Senator Robbins, who thought that this was an appropriate way for Members of the Senate and House to be able to hold an appropriate memorial service, and frankly have a good catharsis, and I publicly want to say to Senator Robbins, thank you very much for a great idea.

(Applause.)

Senator ROBBINS. Thank you, Mr. President, and I want to thank you for having that Joint Meeting because I do think it was extremely important, and extremely important for America to see that Pennsylvania is truly standing up remembering and supporting our great country.

A Resolution commemorating and honoring the victims and heroes of the September 11, 2001, terrorist attack on our nation and commending the President and Congress of the United States for taking all steps necessary to care for the victims and their families, implementing measures to prevent future incidents and working to bring the perpetrators to justice.

On the question, Will the Senate adopt the resolution? The PRESIDENT pro tempore. The Chair recognizes the gentleman from Mercer, Senator Robbins.

Senator ROBBINS. Mr. President, the events of September 11, 2001, have been permanently etched into our consciousness. Not since the War of 1812 have we suffered an attack on our nation's capital, and not since the Civil War have more Americans lost their lives on our own soil in a single act of war. As a symbol of American power came under attack, we again are reminded that the price of freedom is not cheap. Our nation has shared in this tragedy that has touched all of her people. We saw evil at its worst. We watched in silent horror the deaths of brave men and women. We have witnessed heroic deeds of all those who rushed into harm's way to save others. For those who say that love of country and patriotism is dead, they are sadly mistaken. America has never been stronger as a people than they are today. These heinous acts have brought our nation together. Today the flags of freedom fly all across this great union, in yards and windows, in front of buildings, and even on cars and the helmets of rescue workers. The Stars and Stripes will fly forever free, standing as a symbol of our great republic.

In the past several days our President has begun the process of deploying units of our Armed Forces, Reserves, and National Guard. As a Vietnam veteran, I understand firsthand what war is. As an infantry company commander and executive officer of A Company, Second of the 101st Airborne Division, I have had to put the bodies of the wounded and the dead on helicopters. Between my tours of duty, I have had the task of telling mothers that their sons had died in war. My second tour of duty, I served with a Vietnamese Infantry Regiment, and as an advisor I had to put their dead and wounded on helicopters. I understand the destruction, the pain that war can cause.

However, with that in mind, we must show our overwhelming support to our men and women who are serving this great country at this most difficult hour in our history. We must keep them constantly in our thoughts and prayers. Mr. President, symbols of the United States were destroyed and many thousands lost their lives on September 11, but we remain undaunted by the task that is now before us. Our President has made it clear that we now are at war with the perpetrators who committed these acts of terrorism. This will be a new kind of war, taking months, possibly years, until final victory is achieved, and victory must be achieved, for without victory we will leave a legacy to our children and our children's children of living in fear. Mr. President, we as a people must now be patient and allow our President and our leaders in Congress the time to plan and implement the strategies that will win this war.

Therefore, Mr. President, I ask that the Senate adopt this resolution to make it perfectly clear to the world that Pennsylvania stands with the President of the United States and the United States Congress in the actions they deem appropriate to win this war that has been suddenly thrust upon our shoulders. Mr. President, today we are no longer Republicans, Democrats, or Independents, we are all Americans. We are all patriots standing together as one people. God bless the victims, God bless those heroes, the firemen, the policemen, the emergency services. God bless Pennsylvania and God bless America.

Thank you, Mr. President.

(Applause.)

THE PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, so much has changed since we last stood here on the Senate floor, and I remember it was a summer day, a very starry night. I remember those stars, but it seems so long ago, and none of us knew, really how could we, that the tragic events of September 11 would change our priorities as a nation and change our lives as well. We have seen, and our nation has seen, a horrible, terrible, frightening sight. So many deaths, so much destruction in New York City and Washington, D.C., that we cannot possibly see the day we have today or the days that lie ahead of us in quite the same way.

Like many of my colleagues and like so many Pennsylvanians who watched as the airplanes crashed and people died, and two of our tallest buildings fell to the ground, it is hard to find the right words or to describe how we feel today, because there are just too many emotions, and some of them do not feel right: anger, fear, bitterness, grief. But all these emotions have brought us together. They have brought us together. And I know that we are united in our prayers and our hearts ache for the victims of this terrible national tragedy. This is a time for us to grieve together, to pray together, to mourn together, in each community, in every family, as State Senators, and as proud Americans.

When I think of the thousands of people who died on September 11, the first casualties of a senseless act of war, I think of men and women hard at work, with pictures of their families on their desks, and I think of fellow travelers all hoping to reach different destinations, all flying toward that same destiny, and I think of the brave heroes calling loved ones on their cell phones to say good-bye, because they looked beyond themselves and they knew what they had to do. And each and every one, each and every man and woman who died was the most important person in someone else's life, and their families and their friends and their loved ones miss them very, very much.

Mr. President, if there is one thing that we can pull from the rubble, something that is so much larger than the numbers of those missing and those who have died, it is how precious each and every person is and how the loss of one single person's hopes and dreams and joy for life matters so much more than all of our own daily struggles and setbacks and disappointments. Today, we are united as one legislative body, as one State Senate, as proud Americans, one and all. My heart goes out, my prayers, my tears, to all the families who have suffered so much. I hope we never forget how their suffering and their loss has become our suffering and our loss. And I hope we never forget that we represent a family, too, and that family is called Pennsylvania.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lehigh, Senator Dent.

Senator DENT. Mr. President, obviously, the events of September 11 have touched us all. I remember being in Harrisburg on a cold winter day in 1993 when a bomb went off in the World Trade Center, and I received calls from family members about my cousin, Steve McIntyre, and we were terribly concerned about his plight. Several hours later we learned he was okay, but it was quite a scare. And then September 11, 2001, occurred and the horrible spectacle that we saw, and again my immediate thought was of Steve. It was just a horrible moment for me and for my family, as it was for thousands and perhaps

tens of thousands and hundreds of thousands of other Americans to watch that.

We were panicked. We knew it had happened again and that he was high up in the World Trade Center. We also knew at the time, we were certain that he had been at work. He was there early every morning. Luckily, we found out shortly afterwards that he was okay, harmed, but okay. I did not get to speak to him until Sunday evening after the attack, and his story was just incredible about how his office, he works in the American Bureau of Shipping as a naval architect, all 11 of his staff on the 91st floor of the first building that was hit, Tower 1, escaped. Although, I will tell you, it was a close call for him. The plane, they believe, struck the 93rd floor, and they are not aware of anyone on the floor above him in that building getting out alive. But for him the worst was not the actual crash into the building, it was what happened when he got down to the bottom of the Trade Center.

When he got down there, he told me that he had been paired up with a woman who had a bad ankle. They had been pairing people on the stairs, the able-bodied with the people who had trouble. And he took her down to the plaza between the two buildings, he said, and I do not quite understand how it looks, but he told me they were very close to the escalator and could see the light of the street, and then he said a horrible explosion occurred, and that explosion he thought was the subway blowing up, when in fact it was the second tower that had collapsed. He said all he remembered was a wind. It picked him up and he flew across the plaza. He then told me that the woman whose hand he was holding, he has no idea what happened to her. Everything went black. He said he thought he was entombed. He said it was so dark he could take his hand and put it against his face but he could not see his hand, but he could breathe. I said, Steve, how did you get out? It was dark. He said people were panicking and yelling and screaming and he said there was a flashlight, somebody with a flashlight. He went over to the flashlight, and it was a firefighter. He grabbed his belt and went out. He walked out bleeding, cut, but he is fine, under the circumstances. Unfortunately, as we know, many other families, many other individuals were not so fortunate as Steve.

Just this morning I got off the phone with a constituent, Barbara Merdinger, whose husband, Alan, worked at Cantor Fitzgerald. His funeral was held last week. I talked to her at some length. She has three children in college and asked what we can do to help her. Our thoughts and our prayers are with her. My daughter's math teacher, Mrs. Sugra, her son, William, from Allentown, is also among the missing and unaccounted for. So what do we do?

Well, we have to support our leaders, our President, our leaders of Congress, and I am proud of them all. This beastly, dastardly, hideous attack on the greatest imperial city and in the Empire State shall not stand. This seething mass of criminality and barbarism they have committed is a mortal crime for which there shall be no forgiveness. For what they have done, these terrorists, is united us. They have lit a fire that is burning in America, it will spread, it will rage, and it will roar until these criminals are burnt off this planet. And we all know that what they have done is united us, and in my community they have united people of all faiths and of all ethnic backgrounds. I

represent a community with a very large Arab-American population, wonderful people, solid Americans, great patriots. They share our anger, our outrage, and our grief. Just on Sunday I spent time in the Islamic Center of Lehigh Valley. They opened up their doors for all of us to see how they worship and how they live and to show us the beauty of their traditions in the faith of Islam. Not long after that we went to the Jewish Community Center in Allentown for an interfaith service with Christians, Muslims, Jews, Hindus, people of all faiths. It was exhilarating, a wonderful moment for all of us in our community. I know this is happening throughout the country.

Again, the terrorists have united us, and I suspect that they now live in terror, and I hope they do. Because he who sows the wind shall reap the whirlwinds, and that is what they are about to reap. Lady Justice has been horribly abused. And as Winston Churchill said after the Allied advances in Europe and while the Americans and the Royal Air Force were bombing many German cities, he made a comment that what we were witnessing was Lady Justice grimly reclaiming her rights. And she will reclaim her rights and justice will be done, and what was perhaps the darkest moment in American history on 11 September 2001, like 7 December 1941, another day that shall live in infamy, we shall overcome this and we will take that dark moment and hopefully out of it we will have developed and will have grown into what is becoming, I think, perhaps our nation's finest hour. I believe, and I have faith in the future and I have faith in this country and faith in the goodness of all people, that under providence, all will be well. God bless America. As a nation, we will be stronger and we will be better in this long, protracted ordeal which I suspect we will be engaged in, one which will show what kind of fiber we are made of as a country, and we are up to the challenge. Again I say to all of you, God bless America. Thank you.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Schuylkill, Senator Rhoades.

Senator RHOADES. Mr. President, I rise to speak in support of this resolution and to pay tribute to the many men and women who should be known as American heroes. So often in the history of our nation, American heroes have been ordinary people who perform extraordinary deeds in the most trying circumstances.

In the aftermath of the terrorists' attacks in New York and Washington and the downing of the terrorist-held plane in Somerset, our nation has seen its citizens perform many extraordinary deeds. We have seen men and women risk their lives to save others, men and women who even today hold out hope for rescues that in another time, in another place, would have long since been abandoned. We have seen men and women give their lives, knowing that their sacrifice would save countless others. We have seen Americans of all races, creeds, come together under the flag of our nation to rally and support their countrymen, the men, women, and children who were victims of these terrorists attacks. These extraordinary deeds have inspired Americans from one shore to the other to respond with a unity of purpose that goes far beyond our nation's quest for justice.

In piercing the shield of America's borders, the terrorists who carried out these evil, despicable, cowardly attacks intended to divide Americans with the slings and arrows of fear, uncertainty, and rage. However, we have seen quite a different result, quite a different resolve. Across this country, across this

Commonwealth, in big cities and small towns, in offices and fields, in halls of government and around kitchen tables, Americans have displayed a resolve that makes us unique among all the world's nations. In the ripples of flags hanging in somber respect and the flicker of candles lit to search for peace and the songs of prayer offered to soothe the pain of war, Americans have spoken with a single, clear voice to say that we shall meet terror with justice, cowardliness with bravery, and despair with hope.

We have seen this resolve as we look to our President and found a true leader to guide us through troubled times. We have seen this resolve in the police and firefighters of New York and the numerous other volunteers who refuse to give up their search for survivors. We have seen this resolve in the men and women of our Armed Forces who are ready to serve their nation at a moment's notice. And now, Mr. President, we see this resolve in our own Governor, who has been called to again serve his nation as the Director of the Office of Homeland Security. I want to take this opportunity to wish Governor Ridge well as he rises to meet this new challenge. He is a great leader who will soon make the nation as proud as he has made all of us here in Pennsylvania.

Mr. President, today I submit that the extraordinary deeds we have seen over the last 2 weeks can inspire us all to become heroes in our own way. Although we may never be called upon to offer the kind of sacrifices we have witnessed since these attacks, the very fact that we are Americans requires us to pay tribute to those heroes by reflecting upon their bravery.

So today, Mr. President, I suggest that we keep our flags flying, keep our candles lit, and keep our prayers loud and strong, and that we continue to discipline ourselves, to constantly remind ourselves, this body, this Commonwealth, this nation, that acts of terrorism, evil, despicable, cowardly acts of inhumanity upon innocent citizens will not stand, will not be tolerated, because this is America, the land of the free and the home of the brave.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Mr. President, as the resolution before us states, September 11, 2001, is another day that will live in infamy. But unlike Pearl Harbor, which was half a world away, this attack happened so close to every one of us. It seemed like we were there, glued to our television sets which brought this unbelievable destruction into every home in America and throughout the world. Like watching a horror movie, we saw the planes strike, the buildings fall, the rubble burying thousands of bodies. We heard the cell phone messages of innocent, terror-stricken men and women at work, on hijacked planes, coming face to face with death, saying their last good-byes to their loved ones. We watched the brave and heroic response of firefighters, police, emergency personnel, clergy, sacrificing their lives to search and save victims of this tragedy.

Mr. President, about one month before that September 11 attack, I was in lower Manhattan cruising on a boat with some other Pennsylvanians, passing between those twin towers and the Statue of Liberty at sunset. It was a special moment for me because 45 years ago as a high school student I wrote a speech which focused on the Statue of Liberty as the symbol of our freedom, our most precious heritage, and as you recall, her inscription says:

Give me your tired, your poor, Your huddled masses yearning to breathe free, The wretched refuse of your teeming shore, Send these, the homeless, tempest-tossed to me: I lift my lamp beside the golden door.

I reflected that August night on what the Statue of Liberty would say about that New York City she was watching, a magnificent, brightly-lit skyline, tall buildings reaching almost into heaven, the hustle, bustle, and roar of the wealthiest, most comfortable nation in the history of the world. I felt warm and thankful that night on that cruise ship, God had truly blessed America. And then one month later we suffered the unthinkable. We were attacked not by nuclear bombs or by missiles launched by a foreign country, but by an evil conspiracy of hate-filled terrorists living the culture of death to the extreme. How could this happen, Americans asked? Why? Why? Thousands of innocent people were entombed in tons of rubble and debris, with clouds of asbestos-laced smoke blanketing their broken bodies. Those horrible pictures with the soundtrack of the anguished cries of people who lost loved ones are indelibly etched in our senses and in our psyche as we struggle to find ways to cope and respond. Remember this: They destroyed the buildings that symbolized our economic prosperity. They almost destroyed the building that symbolizes our military might, but they did not and cannot destroy our soul and our spirit. In an unprecedented way. Americans have responded with a public display of unity and resolve. Our churches have been filled, our blood donor centers have long waiting lines, our monetary donations to the Red Cross and other charities have been generous. We continue to pray for and work to help the victims and their suffering families.

But beyond this outpouring of compassion, what will be America's real long-term response to this terrorist attack? Certainly, the anger and injustice must be dealt with. We pray that our President, the CIA, the FBI, Governor Ridge, and all political leaders throughout the world make the right decisions in the weeks and months ahead. Justice must be done and further attacks must be prevented. As all of us who have suffered the loss of a loved one know, it is our faith and our family that get us through the sorrow and the heartbreak. Now is the time for all faiths and all Americans to stand together as one family under God, to make our neighborhoods better, to make our communities better, and yes, to make ourselves better, more compassionate citizens.

America must do more than wipe out terrorist camps from which hatred spreads like a deadly virus. We must renounce injustice and evil, and overcome hate wherever we see it, replace this virus of hate with a renewed commitment to community, to caring for one another, to justice for all, regardless of race, color, creed, ethnic background, origin, gender, economic status. There is enough violence and injustice among our own people and in our own communities here in Pennsylvania. Life is so fragile, so uncertain, we cannot control tomorrow, we must do our best today. The tears we have shed must give away to action and trust in God. Now is the time for all of us to respond to get our own priorities straight. That can be America's best and most positive long-range response to the terrorists.

Today, we have been hit but not beaten, injured but not deterred. Our arms remain strong, our hearts and our minds

undiminished, and our vision clear. The great tasks of justice and freedom in our own neighborhoods as in the world remain before us. And when the sun rises tomorrow and tomorrow and tomorrow, may our commitment and focus grow stronger and stronger and stronger, and in this perseverance now and always, may God bless our efforts, may God bless America and all its people.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Fayette, Senator Kasunic.

Senator KASUNIC. Mr. President, my words today cannot adequately describe the mix of emotions that I and many Americans have felt since September 11. The outpouring of compassion, the grieving, the donations, the volunteerism, and the overall patriotism shown by our fellow Americans certainly buoys the pain, the fear, the frustration, and the anger that we all feel. For us in Pennsylvania, the fact that one of the four plane crashes happened so close to home, near Shanksville, in Somerset County, makes us all realize the difference between this new war we are facing and ones in the past.

Mr. President, I rise today to offer a resolution condemning the acts of terrorism committed on that fateful day of September 11, 2001, and honoring the heroism of the passengers on United Airlines Flight 93 and the relentless efforts of emergency personnel and the State and local agencies who responded so quickly to the crash and who continue to work with Federal officials in the investigation.

The flight bound from Newark, New Jersey, to San Francisco, California, was overcome by terrorist hijackers who were ultimately defeated by the heroism of the passengers aboard United Airlines Flight 93. Little did they suspect that the Americans would act in the manner that they did. I am sure they were quite surprised of the resolve and the grit that was shown by

the passengers of that plane. And certainly they were shocked when they found out that these patriots, these heroes, were not going to just lay down. These passengers defeated the enemy. The black box recording from the flight confirms the passengers tried to overtake the hijackers to ensure the plane was not used like others, as a weapon of greater destruction. For their heroism and ultimate success in preventing further casualties, we honor them today with this resolution. These brave passengers were average Americans, much like you and I. Many of them traveling home, some of them going on vacations, some going to visit other family members. Maybe they were going on a business trip. However, their behavior, when faced with the knowledge their flight was doomed and another, more vengeful, purpose was happening, the events that took place and as they unfolded was certainly extraordinary.

America's strength, and this was talked about in the Joint Meeting, America's strength is not found in the beauty of this nation, in the beauty of its cities, in its vast mountain ranges, the seashores, or the great plains, America's strength is found in the hearts and the souls of every freedom-loving American, of every Patriot. These individuals join so many other Americans who on that horrific day showed all of us how to behave with grace and valor in the face of death and terror. Now that we live with the threat and future terroristic threats, we must remember those Americans we have lost because of these tragic crashes and the course of events. These individuals will be remembered forever with others. And I repeat that, these individuals will be remembered forever with others in our nation's past who have died fighting for the principles of freedom.

This new war may have new weapons and a new plan for combat, but its mission remains the same: to preserve the right of freedom for our citizens here in America, for the right to pursue the American dream, for the right to pursue life, liberty and the pursuit of happiness. Through this resolution let the Senate resolve, as President Abraham Lincoln said at Gettysburg nearly 138 years ago, "that these dead shall not have died in vain, that this nation, under God, shall have a new birth of freedom, and that government of the people, by the people, for the people, shall not perish from the earth."

May God bless the victims and their families in this time of mourning, and may God bless the greatest nation on the face of the earth, the greatest nation ever to exist. May God bless the USA.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President, on September 11, 2001, just 2 weeks ago, our nation suffered a tremendous tragedy. The ruthless terrorist attack was not just an attack on Americans, but an attack on all humanity. But this cowardly act could not destroy the spirit of Americans. The road to recovery will be long, but we will make it; the threat of a war brings new anxieties, but a new hope for a life without terrorism. We have been warned of the sacrifices needed to fight this war. I am going to ask my fellow Americans to look to our American heroes from wars of the past, but also we can look to the heroes still with us today - our volunteer firefighters, police officers, blood donors, and scores of others who have contributed to the relief effort. Along with a

new war comes a new greatest generation of Americans willing to do what it takes to win the war against terrorism and maintain our democracy. These ordinary citizens performed extraordinary deeds. Many made the ultimate sacrifice with their lives. We must remember the ordinary man who chose to stay with the disabled gentleman bound to a wheelchair in the World Trade Center so he would not die alone. His extraordinary sacrifice is one we should never forget.

I ask you to remember Todd Beamer, a victim of United Flight 93 that crashed in Somerset County. Mr. Beamer was the gentleman who decided with three others to try to take control of the plane from the hijackers. The men knew of the hijackers' plan to take more lives and do more harm to our nation's capital. Let us not forget the firefighters and police officers who were the first to run into a vulnerable building looking for those who needed help. Hundreds of these fallen heroes never waited for someone to ask for help. They simply gave it. So when we find ourselves shaken in these upcoming months, let us not forget those who shone so brightly during the darkest day in America, September 11, 2001. Their example is one we should follow as we move into the next phase of our lives. As we watch the rescue efforts, let us remember that we are all Americans. And, Mr. President, I do want to say that it did personally affect our lives, too. My daughter had a very good friend who lost his life in that tragedy that day. So we can all stay together as Americans.

Mr. President, shock, sadness, and anger are among the emotions I know I have shared with so many Americans during the past 2 weeks as the images of unspeakable pain, anguish, and damage have flooded our television screens and newspapers. I express my deepest condolences to the families and friends of those who perished, as well as to those who were injured in these cowardly acts of madness. I applaud the many thousands who have contributed to the rescue and recovery efforts in New York City, Washington, and Somerset County. I am confident the citizens of Pennsylvania and this great nation will continue to give unselfishly of their time and talents as America recovers from these darkest days and ultimately brings the perpetrators of these heinous crimes to justice. Here within these hallowed walls I pledge to work diligently with all of my colleagues and to do whatever we can do to help in this time of great need and vexing uncertainty.

God, guide our Governor as he faces an unprecedented challenge in our nation's capital, and God bless America.

GUESTS OF SENATOR MIKE WAUGH PRESENTED TO THE SENATE

The PRESIDENT pro tempore. The Chair recognizes the gentleman from York, Senator Waugh.

Senator WAUGH. Mr. President, before discussing this resolution, I would like to just take a moment to introduce two guests who have joined us today in the Senate. Joining us today are my friends and brothers in the fire service, our own State Fire Commissioner from the Commonwealth, Ed Mann, and Chief Charlie Myers, who is the Chief Emeritus of the Vigilant Hose Company in Shippensburg, Cumberland County, but also more importantly today, Chief Myers is president of the Firemen's Association for the State of Pennsylvania. I welcome both of you here today, and I would like to thank both of you, along with Chief Paul Schaefer from the York County Firefighters' Association and John Brenner of the Pennsylvania Fire Services Institute for helping to put together this resolution and the ceremony we are about to have today.

Mr. President, every day police, firefighters, emergency medical service workers across this nation engage in heroic acts: stopping criminals engaged in violent crime, saving homes from the destruction of fire, floods and other natural disasters, and administering immediate medical care to those who need it. We see them patrolling our neighborhoods. We see them in many of our communities here in Pennsylvania running from their homes to the fire station, our volunteers, and we see them responding from fire stations at a moment's notice to strangers, often strangers and neighbors in need. These people, these everyday heroes, are the subject of the resolution that I present today. I do not need to describe the events of September 11. We have all seen the footage, probably seen it way too many times, time and time again on our television sets. We have heard about it on radios, read about it in the newspaper, and talked about it around the water fountain. Quite frankly, the events of that terrible day

have occupied our thoughts and prayers since we first saw or heard of them some 15 days ago now.

The level of devastation is simply beyond our comprehension, and the human casualties are the worst this nation has ever seen in a single day or event, but these everyday heroes answered the call. Countless firefighters, police officers, law enforcement personnel, emergency medical service providers, doctors, and other volunteers from a multitude of jurisdictions answered the call of a nation in distress. Through their efforts, an untold number of lives were saved. We hear the losses and think about the number of lives that have actually been saved in the last couple of weeks by the response of emergency service personnel.

The collapse of the towers of the World Trade Center took the lives of more than 300 of these public servants, all of whom placed the safety and well-being of the people of New York City over their own. They rushed into buildings to ensure that others escaped, and they sacrificed so that others might live.

My first view, and we all have our first recollection of when we heard about this, I happened to be at home that morning, I actually had a meeting at my house, and when I heard about this I immediately turned on the television. The first tower had collapsed and when I turned on MSNBC, the first image that came on to my television set was a street full of fire service and EMS personnel marching in to this scene while people outside of them were running and screaming in the opposite direction. Amazing. And the next image, within about 5 minutes, was the second tower crashing down on all those people marching in. It was dreadful. These were the everyday heroes under extraordinary circumstances. I would like to take just a moment now to recount how Pennsylvanians, our fellow statesmen and women, answered this call.

On the morning of September 11, Pennsylvania's Task Force One, an urban search and rescue unit headquartered right here in Harrisburg, was immediately mobilized to provide search and rescue service at the scene of the World Trade Center collapse. For 8 days and countless hours, 83 fire and EMS personnel and professionals from this Commonwealth stood shoulder to shoulder with emergency responders from other jurisdictions at Ground Zero searching for survivors. As a matter of fact, I had a chance to talk to one of our PEMA information folks last week, and I am actually honored and very proud to say that our Task Force One, our trained urban search and rescue crew from across the State, people from across our State who serve on that crew, were the first federally-certified urban search and rescue team at Ground Zero. They left here Tuesday evening and started work early Wednesday morning at Ground Zero. I am very proud of those folks and they are to be commended for the service that they provided.

In Shanksville, Somerset County, hundreds of State and local police, municipal and volunteer firefighters and emergency medical service personnel provided support at the scene of the crash of United Airlines Flight 93. We have all seen those images and heard the stories. When the Governor made the call for Pennsylvanians to stand ready to assist the disaster relief efforts in Virginia, at the Pentagon, and in New York, an additional 4,821 firefighters and emergency medical service personnel responded to that call by either responding or having their name placed on a list to be a responder, if needed. In just days,

Pennsylvania's everyday heroes helped to raise hundreds of thousands of dollars of financial support for the families of the fallen firefighters and emergency service personnel in New York City. You have seen them in each and every community across this Commonwealth over the weekend standing at the shopping malls with their boots, giving of their time and doing it often with teary eyes to help provide for those who have fallen, our brothers and sisters in emergency services.

On September 10 there seemed to be a shortage of role models for so many of our young people. Yet on the morning of September 11, role models by the thousands emerged to tend to a nation's pain. The police, firefighters, emergency medical service personnel, search and rescue teams and others who responded in this time of crisis are the finest examples of heroism, bravery, and courage. Each of us have looked for ways to comprehend this tragedy, to grieve for those who are lost, and to help heal those who still remain.

To honor fallen firefighters and ease their anguish in the time of their loss, the Cranberry Township Fire Department in Butler County posted a poem entitled, "Men of Flame, I Am Free." In part, the poem reads as follows: (Reading)

Don't grieve for me, for now I'm free; I'm following the path God laid for me. I took His hand when I heard Him call, I turned my back and left it all.

If parting has left a void, then fill it with remembered joy. Perhaps my time seemed all too brief, Don't lengthen it now with undue grief. Lift up your hearts and share with me, God wants me now, He set me free.

There is also in our fire stations a centuries-old fire service tradition to sound a fire bell to memorialize the loss of one of our own. In the past, it was the fire bell that signaled the beginning of the firefighters' shift. Each alarm was sounded by a bell which summoned these heroes of days gone by to fight fires and to place their lives in jeopardy for the good of their neighbors. Once the fire was extinguished and the alarm had come to an end, the bell would be sounded again to signal the completion of the call. When a firefighter makes the supreme sacrifice, it is the somber toll of the bell that announces a comrade's passing. This tradition honors those who have given so much and have served so very well. To symbolize the devotion of these men and women of flame and their duty to the fire service, the fire department of New York City uses a special signal of five rings, four times, commonly referred to as the four-fives alarm. This represents the end of our comrades' duties and the fact that he or she will be returning to quarters for their final time. The number of police, firefighters, EMS personnel who died in the collapse of the World Trade Center, quite frankly, is still unknown, but it is estimated to be better than 300. To all of those who have selfishly given their lives for the good of their fellowman, we honor them here today. Their tasks complete, their duties well done, they are free.

At this time I would like to ask the Members of the Senate and all guests to rise to observe a moment of silence and then the tolling of the four-fives in honor of these brave souls. (Whereupon, a moment of silence was observed, followed by the tolling of the four-fives, in honor of the rescue workers who fell in the line of duty on September 11, 2001.)

Senator BOSCOLA. Mr. President, the men and women who risked their lives to save the lives of so many victims of this terrorist attack on September 11 would be the first ones to say I am no hero, I was only doing my job, I did what I had to do. That is because our policemen and women, our firefighters, our emergency response teams do not do what they do for the glory, or the fame, or any kind of special treatment. They do it because they care. And they care enough to put themselves in danger in order to help others.

A hero does whatever it takes, no matter what the cost, no matter what the risk. Heroes pull together. Heroes make sacrifices that have to be made. And by their example, they show all of us how to live a human lifetime under any circumstances. The circumstances that they faced on September 11 have never been faced by anyone in the course of our nation's history, yet they showed us how to live, and they showed us how to act and overcome the feeling of helplessness in the grips of this tragedy. The men and women we honor in this resolution showed all of us how to conquer fear and the terror and the despair surrounding the sheer enormity of the aftermath of the attack.

I ask for an affirmative vote. Thank you, Mr. President.
