SENATE

MONDAY, January 28, 2002

The Senate met at 2 p.m., Eastern Standard Time.

The PRESIDENT (Lieutenant Governor Robert C. Jubelirer) in the Chair.

PRAYER

The Chaplain, Reverend DAVID LINDROOTH, of Ivyland New Church, Ivyland, offered the following prayer:

As I stand in this room, I see beautiful chandeliers and elegant furniture represented in this crystal, and in the wood and the woven rugs, I see the faces of more than 12 million residents of Pennsylvania. I think of the Russian immigrants who play with their children in the backyard of my church. I think of the elderly Huntingdon Valley man I visited in the hospital last week who, with a twinkle in his eye, described his plan for a complete recovery in time for a spring planting when he would again be on his hands and knees in his garden. I think of the warm summer day my family spent on the shores of Lake Erie last summer and the teenage lifeguard who watched our children splashing in the water. I think of these people because our government provides the chance for them to share their unique qualities of life and love with each other.

My faith teaches that each human being has been placed on this earth for a purpose. In God's eyes, everyone is unique and has individual talents to serve others that cannot exactly be replicated. Each person has the chance to contribute to the perfection of society by choosing to offer each other their gifts. Some people express their talents in limited ways, like an elderly woman I know who only has the strength to offer a quiet smile and a compassionate glance. Others have great talent, and with it will be able to affect the lives of thousands. The point is that each individual was created by God in his image and likeness, and each, in his or her unique way, can reflect the image of the Creator and add to the perfection of society at large. It is God's will that everyone have the opportunity to freely use the talents that they have for the sake of their neighbors. In Pennsylvania, the human tapestry woven by the lives of these 12 million citizens is beautiful indeed.

It is an awesome responsibility to be called to serve on the floor of this sacred hall. I find it humbling to reflect that the decisions taken here will either promote or detract from our citizens' abilities to develop and share their individual God-given talents with others. SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR HAROLD F. MOWERY PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Cumberland, Senator Mowery.

Senator MOWERY. Mr. President, I am pleased to introduce Dr. James Fattu, the new president of the Pennsylvania-Delaware affiliate of the American Heart Association, and Jason Trout, deputy vice president of the Pennsylvania-Delaware affiliate. Let us give them a warm welcome from the Senate.

The PRESIDENT. Would the guests of Senator Mowery kindly stand so we may welcome you to the Senate of Pennsylvania.

GUESTS OF SENATOR MICHAEL A. O'PAKE PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake, for a very special recognition.

Senator O'PAKE. Mr. President, last week, Thursday to be precise, the eyes of the nation were fixed on a school bus from the Oley Valley School District in Berks County. Thirteen young children were being transported from Oley Valley High School to the Berks Christian Academy. They were all ages, from first grade through ninth grade. The bus left the high school with 13 students on it at 7:30 a.m. and was scheduled to arrive at the Berks Christian Academy at 8:10 a.m. By 8:30 a.m., it was

noticed that all 13 students were missing. They were not in attendance. The school reported the missing children to the Oley Valley School District's staff, and subsequently to Chief of Police George Endy. Now, if you remember last Thursday, it was very foggy, heavy rain in the morning, so the chief thought that perhaps the bus lost its way, and he made a very, very thorough search of the usual route. He did not find the bus or the children. The Pennsylvania State Police, and later the FBI, were brought in to assist.

Finally, Mr. President, after 6 hours of worry, anxiety, and prayer, these children were found unharmed in Landover Hills, Maryland. The bus driver, who reportedly had a loaded M-1 rifle in the bus, was taken into custody.

Since September 11, we have all been overwhelmed by the need for security and safety in this country. You can imagine the fear and the terror that struck the hearts of the parents of these students when they had to wait and pray for 6 hours wondering where their kids were after placing them on this school bus early that morning.

There were some real heroes, Mr. President, of that ordeal, and one of them is here today. Before we hear from one of those students who kind of took charge, and when you hear him, you will understand why; he is a very calm, cool, collected, mature, and solid young man, and he is going to talk to us briefly. But also with us here today, and I would like the body to recognize the other people who will not be speaking, of course we have the proud parents of Josh, and I would ask Fred and Debi Pletscher to stand at this time, as well as Nathan, his older brother, who came here for moral support. We also have the superintendent of the Olev Valley School District, Mr. Jeffrey Zackon, who acted very professionally and responsibly. He was there after midnight that night because the State Police escorted a bus with all the parents down to Landover Hills, Maryland, and he waited and received the kids at 12:15 a.m. the next morning. And our fine chief of police who, under a great deal of stress and pressure and tension, did a wonderful job given the resources of the Oley Valley Police Department, Chief George Endy, Jr., is here.

But the real star, the real hero, and the person I am just so impressed with, he spoke to the media when he got back after midnight that night, and actually had many of us smiling and laughing with some of the stories about what went on in the bus. They did get a free meal out of Burger King and had a couple of rest stops along the way, and I am sure he can tell the rest of the story, but it is heartwarming to know that there are young people now who, even under the most trying and difficult circumstances, had the courage and the common sense to calm all the other little kids, because there were first and second and third graders on that bus as well, and therefore one of the heroes of that ordeal, which thankfully ended successfully, peacefully, without anybody being harmed, but I know it is a day he will never forget, I would like the Senate to recognize and have Joshua Pletscher speak to us briefly about his experience during those 6 hours on that bus on the way to Landover Hills, Maryland.

The PRESIDENT. We welcome all of Senator O'Pake's guests and know that this is, I am sure, a very difficult time, but thank goodness all is well that ends well, and, Josh, we invite you to come up and say a few words. Thank you for being here.

(Applause.)

Mr. JOSHUA PLETSCHER. Good afternoon, ladies and gentlemen. It is an honor to speak to you. Thank you, Senator O'Pake, for allowing me to come, and thank you for allowing me to speak here.

It was an interesting day on Thursday. We woke up really tired, not paying attention to anything different that was on the bus, and he called two girls to the front of the bus and we did not know why. We were sitting in the back just messing around and then we just left, and the girls came to the back of the bus and said we were going to Washington, D.C. The bus driver said he was going to show us something. We were really confused. We did not know what was going on, where we were going in Washington, D.C., or what we would be doing there. And so we were going on and we got to Boyertown and turned onto the highway, and a little girl turned around and said, "There's a gun up here," and they just whispered it back and we got a little scared about that, but tried to stay calm. We went up and looked at it. He had a coat over top, so all we saw was the stock. When we saw that, we got a little scared, but we did not want the little kids to get scared, so we just did stuff, we messed around, we waved to cars as they passed, we had trucks honk their horns and we tried to see who could hold their breath the longest going under a tunnel, and we tried not to get scared. The little kids were great during the whole thing. They stayed really calm.

Some people were saying that they called it kidnapping. I do not want to call it kidnapping. One reason, I could not fall asleep during the whole thing, so we were not really napping. But the people, if you watch TV and you see a kidnapping, you always see the kidnapper as a really mean person, you know, looking over his shoulder at everything they are doing, making sure they do not do anything like call anybody or anything. He was not like that. He let us go in to Old Country Buffet to go to the bathroom by ourselves. When we got there, then he was just reading a map, because he kept getting lost. So we went in and after we came back he went back in and put me in charge, for some reason, and he went into the bathroom, and that is when we looked at the gun. We did not see any bullets or magazines or anything. And he came back and we just kept going. We stopped at Burger King, and he treated us. That was pretty nice. And a kid came up to me and said he saw on CNN that a bus was missing. I thought that there was another bus missing, but I guess he thought maybe it was us. But when you grow up in a small town, a little person there, you do not really think that you are on TV and people are looking for you, and that stuff. So, the bus driver said that when we got to Washington, D.C., we were going to call our parents, and that was the thing that worried me the most, calling my mom, because I did not think she knew where we were, calling her and saying, hey, guess where I am? I am in Washington, D.C., and then I would get an earful when I got home.

So, then we got outside of Washington where we were switching over between two maps, one just got us there and the other one was the actual roads in Washington, D.C., and we got lost again. He could not find out where we were and he decided to try to find a police officer to give us directions to where it was. So, we were driving around a little bit and saw a police officer pull into a Family Dollar, so we turned around and went there. He got out of the bus, we all stayed in, and he just went over and

I guess he turned himself in instead. So, out of the whole day, it was really a peaceful ending, which was really cool to see.

When we got to the police station we started to see how big of a deal it really was, because we really did not think it was that big of a deal. We did not know what was going on or anything, being stuck inside of a bus for 6 hours. When we got there, they had the news stations on and the cops were there. They were amazing. We played basketball. I think I gained 20 pounds from them, they kept feeding us and feeding us, and they were really amazing. So, when we found out on the news that it was a big deal, they really helped us to just keep staying calm. That is what I was trying to do for the little kids, because if they got really scared, then that could have made more problems. It was a hard situation to go through, but I know that it was for the good of other people in the future.

Senator O'PAKE. Mr. President, I just wanted to say to Josh that even though you did not make it to the nation's Capitol, we are honored to have you as our guests here in the State Capitol. It is nicer here anyway, and a lot safer.

On the question, Shall the bill pass finally?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Mercer, Senator Robbins.

Senator ROBBINS. Madam President, the agreement between the Pennsylvania Physical Therapy Association and the Pennsylvania Chiropractic Association has resolved the longstanding differences regarding practice issues surrounding manual therapy techniques known as mobilization and manipulation. The agreement, however, is not about ownership of these terms, but rather it is about defining each profession's practices in connection with the definitions.

Regarding Senate Bill No. 1011, defining manual therapy/mobilization, all physical therapy programs in universities and colleges in Pennsylvania for accreditation purposes must teach and educate physical therapist students in manual therapy, which includes mobilization grades one through five. Mobilization, as a practice technique, occurs in five grades. The fifth grade is recognized medically as a form of manipulation. Existing law already permits licensed physical therapists to provide mobilization techniques throughout the entire musculoskeletal system.

Madam President, the definition in Senate Bill No. 1011 delineates how this technique is applied in physical therapy practice as contrasted to the use of manipulation/adjustment techniques utilized by chiropractic when treating. Although the techniques defined in Senate Bills No. 1011 and 1012 have certain similarities, they are nevertheless utilized by the two professions in practice for a different focus and reason. Senate Bills No. 1011 and 1012 establish the benchmark relating to these techniques and their focus for each practice.

Thank you, Madam President.

SENATE CONCURRENT RESOLUTION No. 97, ADOPTED

Senator BRIGHTBILL, without objection, called up from page 4 of the Calendar, Senate Concurrent Resolution No. 97, entitled:

A Concurrent Resolution memorializing Congress to honor Commodore John Barry as the first flag officer of the United States Navy.

On the question,
Will the Senate adopt the resolution?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Madam President, I urge the full Senate's support of Senate Resolution No. 97, which memorializes Congress to honor Commodore John Barry as the first flag officer of the United States Navy. Nearly two full centuries after his death, it is puzzling that Commodore Barry remains an unsung hero. It is puzzling because he not only was one of the great naval leaders of the Revolution, he played a lead role in building the new nation's Navy after the war. He served as head of the Navy under President Washington, President Adams, and President Jefferson. A native of Ireland who lived most of his life in Philadelphia. Commodore Barry volunteered his services during the Revolutionary War and was the first American naval officer to obtain a rank higher than captain. To many, he was the founder and founding father of the American Navy. During the Revolution, it was Commodore Barry who helped plan and supported George Washington's surprise crossing of the Delaware. He was the first American officer to capture a British war vessel on the high seas. He captured more than 20 ships. In fact, he captured two British ships during a battle in which he was wounded. He also fought on land, including the battles of Trenton and Princeton, and led America to victory at the last naval battle of the Revolution in 1783.

Following the war, he wrote a book that established a set of signals for communication between ships, and he recommended the creation of a separate Department of the Navy. A naval flag officer is an officer who attains a rank higher than captain. As the officer whom President Washington personally selected as the ranking officer when the United States Navy was permanently created, Commodore Barry must be remembered as our nation's first flag officer.

Madam President, historic journals are in agreement on Commodore Barry's contributions to the building of America. The Statue of Liberty museum has recognized Barry as one of six great foreign born American leaders for the War of Independence. The time is long overdue for Congress to bestow the honor of America's first flag officer upon the great patriot and hero, the Philadelphian and the Pennsylvanian, Commodore John Barry.

Thank you, Madam President.

What happens on these, we know that you can get many inexpensive devices in cars now that can track that vehicle, and there is talk of also having cell phones which are trackable now as well, that they can be located. We know the shock that all of us feel as parents when we stop and think about how something the size of a bus could disappear for so long, and so I am putting that resolution in so we would have that sort of peace of mind.
