Senator BOSCOLA. Mr. President, recently, I received an e-mail that I would like to preserve for posterity in the Senate Journal. It came from a woman, Lorraine, who is not just upset with her local school property taxes, but she is upset with all of us as well. Lorraine is obviously a very smart person who has a lot of common sense, and we could use a lot of common sense in this Chamber at times. You see, Lorraine has written to a lot of Senators and State Representatives about her local school property taxes, but she has noticed something fishy. A lot of elected officials wrote back, but not a lot was done. Even though Senators and Representatives wrote back to her in favor of eliminating property taxes, after all was said and done, there was a lot more said than being done. I think most people who work outside this building affectionately like to refer to this political phenomenon as the-check-is-in-the-mail treatment.

Lorraine writes: The problem is this. Everyone has a different idea how property taxes should be eliminated. This debate has been going on for years and years and years, she writes. In fact, she said, the debate has already passed by my parents' lifetime, they are 80 and 83 years old, and if this issue continues in the same manner that it has been, it will probably pass my lifetime too, and I am 56 years old. But here is the best part and here comes the common sense. She says: I find it hard to believe that Senators and Representatives cannot join together for the good of the citizens of Pennsylvania in this important matter. Why can they not join together in this important matter? Would it not be possible, she writes, to introduce a simple bill to solve the problem and everyone join together and get this done?

Well, I am here to say, yes, Lorraine, we do have a bill, and it is a bill that I introduced, which would simply eliminate local school property taxes, and it is simply called Home Free. This legislation I have introduced will repeal and eliminate local school property taxes across Pennsylvania, and it will eliminate those property taxes before the end of this year. Home Free is the first step and the most important step that we can take. Home Free removes the tremendous burden that property taxes place on our homeowners, especially our senior citizens, and it represents the only way we are going to make any progress in this legislature on devising a funding formula for basic education that is fair and equitable. Home Free eliminates school property taxes entirely, and it forces us to start from scratch to establish a more fair and equitable system of supporting public education.

I want to thank all those Members who cosponsored this proposal, which, by the way, is officially called the Home Owners Freedom Act to Repeal and Eliminate School Property Taxes. But I do not think it really matters to the people we represent what we call it or whose name is on the bill first. All that matters is that we repeal and eliminate local school property taxes so homeowners are not punished for having a nice home, and our senior citizens no longer have to struggle so hard just to be able to afford the home that they live in.

Mr. President, Home Free makes sense. It lets us join together, all of us, and do something that homeowners and senior citizens in all of our districts are begging us to do and something we all agree needs to be done. With a little effort and a little common sense, we can take this first step together.
