The Senate met at 10:30 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Robert C. Jubelirer) in the Chair.

The PRESIDENT. Prior to administering the oath of office to Senator-elect Pileggi, the Chair would like to recognize some special guests who are here, if you would hold your applause. We were hoping that the Speaker of the House would be here. We always enjoy having him over here, but he was unable to make it here today, so, Speaker Ryan, I know you are here in spirit.

I would like to introduce Representative Chris Ross; Representative Steve Barrar; Republican State Chairman Alan Novak; the distinguished chairman of the Delaware County Republican Committee, Tom Judge, Sr.; the distinguished gentleman from Delaware County, John McNichol; all members of the Delaware County Council, and I am not going to read all the names, you have a large council; a very special friend, Patrick Larkin; and the most important group, Senator-elect Pileggi's wife, Diana, their children, Elisa, Gabrielle, and Michael, and believe me, you are special, and his parents, Mary and Francis. May we give these wonderful people a round of applause.

(Applause.)

The PRESIDENT. A welcome to all of you who are here for this very special ceremony. We are delighted to welcome you to this beautiful Chamber in the Senate of Pennsylvania.

STATEMENT BY THE PRESIDENT

The PRESIDENT. For the record, the Secretary of the Commonwealth has also certified that the Senator-elect has filed

the accounts and affidavits as required by Section 1632(b) of the Pennsylvania Election Code.

ANNOUNCEMENT BY THE PRESIDENT

The PRESIDENT. The Chair would now like to take this opportunity to politely remind all of our guests that taking still pictures or videotaping in the Senate Chamber is not permitted. So I ask that during the administration of the oath of office no pictures be taken or videos be taped. At the end of the oath, however, the Senate will be at ease, Senator-elect Pileggi will remain at the bar of the Senate, and you may take as many pictures as you want.

ADMINISTRATION OF OATH OF OFFICE

The PRESIDENT. You know, it says here it is an honor and privilege to have with us today the Honorable Stephen J. McEwen. I cannot emphasize that those are not just words, they are certainly from my heart, and I think many people who have had the privilege of knowing and working and being a part of Steve McEwen's life would say that it is a privilege, an absolute honor and privilege, to have him with us today. He is the President Judge Emeritus of the Superior Court of Pennsylvania, and he has kindly consented to be with us today to administer the oath of office to Senator-elect Pileggi in accordance with Article VI, Section 3, of the Pennsylvania Constitution.

Would the Senator-elect please present himself, along with his Bible, at the bar of the Senate.

Judge McEwen will now administer the oath.

Judge McEWEN. Before the official message, let me thank Bobby for that sterling introduction.

Mr. President, Members of the Senate, a full measure of both honor and pleasure was afforded to me by your newest colleague, Dominic F. Pileggi, when he invited me to participate in this ceremony of the oath and to administer to him the oath of office as Senator of the Commonwealth of Pennsylvania. The awe which strikes any judge who has gained the ratification of this body in this magnificent forum renders this judge almost speechless, but only almost. Since I am compelled to advise that among Dominic's abundant personal characteristics and gifts is a special humility which finds him reticent to mention that it was within his Ninth Senatorial District that Pennsylvania began. This was 42 years before William Penn went ashore in Chester on his way to Philadelphia. The Swedes and the Dutch found his district such a paradise that they battled for sovereignty over it, and even with the passage of 360 years, the area remains a noble district because its men and women and children love their country, are proud of their varied heritages and ethnicities, appreciate their towns and counties, value their families and jobs, and support their neighbors and friends. And how worthy they are of such an astute Senator-elect who will prove, you may be certain, Senators, will prove to be very worthy of them.

Dominic, will you place your left hand on the Bible and raise your right hand and repeat after me:

I, Dominic F. Pileggi, do solemnly swear that I will support, obey, and defend the Constitution of the United States and the Constitution of this Commonwealth, and that I will discharge the duties of my office with fidelity. May I congratulate you, Senator Pileggi. (Applause.)

SPECIAL ORDER OF BUSINESS SUPPLEMENTAL CALENDAR No. 1

SENATE RESOLUTION No. 279, ADOPTED

Senator BRIGHTBILL, without objection, called up from page 1 of Supplemental Calendar No. 1, Senate Resolution No. 279, entitled:

A Resolution honoring all Pennsylvania veterans who served during war and peace on the occasion of Veterans Day, November 11, 2002.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Mercer, Senator Robbins.

Senator ROBBINS. Mr. President, in 1918, on the 11th hour of the 11th day in the 11th month, the world rejoiced and celebrated because after 4 years of bitter war, an armistice was signed that declared the "war to end all wars" over.

World War I did not really end all wars, but its conclusion did result in November 11 being set aside as Armistice Day. In 1953, townspeople in Emporia, Kansas, called the holiday Veterans Day, in gratitude to the veterans in their own town. Soon after, Congress passed a bill renaming the national holiday as Veterans Day. The latest observance is less than a month away.

In 2002, the role that military veterans have played in securing and defending our freedom is clearer than it has been in many years. Our servicemen and women are in Afghanistan, avenging last year's terrorist attack and breaking up the network responsible for it. At the same time, the nation is moving closer to sending military personnel to Iraq. Meanwhile, many men and women who serve in the National Guard and the Reserves are being called up to active duty. It is important that we recognize the vital contributions they are making to our national defense. We live in uncertain times, but what is certain is that America's military has proven itself ready to answer the call. On future Veterans Days, today's servicemen and women will take their place next to those who fought before them as objects of our gratitude.

I ask that the Senate approve Senate Resolution No. 279 in honoring all Pennsylvania veterans who served during war and peace on the occasion of Veterans Day, November 11, 2002.

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Mr. President, I urge all my colleagues on this side of the aisle to join in supporting this and making it unanimous.
