As required by the Public Employee Retirement Commission Act, this annual public report is issued to summarize the Commission's findings, recommendations, and activities for the year 2002.

During 2002, the Commission authorized the attachment of nineteen actuarial notes to eleven bills, four documents, two bills as amended, and five amendments at the request of the various committees of the General Assembly. This report contains a synopsis of each of these notes and contains a summary of the Commission's review of the State Employees' Retirement System and the Public School Employees' Retirement System. This report also describes research conducted during 2002 and summarizes the Commission's administrative activities under the Municipal Pension Plan Funding Standard and Recovery Act and Act 293 of 1972. On behalf of the Public Employee Retirement Commission and its staff, I am pleased to provide you with the twentieth annual public report of the Commission. The Commission hereby expresses its thanks and appreciation to all individuals, organizations, and agencies whose assistance and cooperation contributed to the work of the Commission during 2002.

# GUESTS OF SENATOR JAMES J. RHOADES PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Schuylkill, Senator Rhoades.

Senator RHOADES. Madam President, as you know, we passed Senate Resolution No. 24 designating February 9 through 15 as "Career and Technical Education Week" in Pennsylvania. In the Capitol today I think you saw many young men and women scurrying about demonstrating the projects which they brought with them from their vocational technical centers. I invite all of you, if you get a chance, to go into the Rotunda or the East Wing to see the demonstrations that the young men and women are putting on.

I have with us today from our Schuylkill Technology Center our Schuylkillbotics Robotics Team, who were here in 2001. It is an engineering initiative between our schools and businesses whose goal is to excite students about science and technology. In 2001 when they were here, they went down to Drexel University and competed with 42 other schools. They came in 15th in that regional competition at Drexel, but they also became the rookie team of the year. They went to the national competition at Epcot in Florida and came in 45th. In 2002, they received the Entrepreneurship Award recognizing strong business and education partnerships. They came in 3rd at regional competition and 15th at national competition.

Growing out of that initiative, because there are two groups here today, is another group, the Junior LEGO League from my county, and it consists of 14 middle school teams who are participating. As a matter of fact, they have been so successful that they have been chosen to host the State LEGO Tournament in December 2003 at Pottsville Martz Hall. The Blue Mountain LEGO Team is here today. If you go down, they did their project on a mine sweeper, or identifying mines, military mines that can explode. They have a LEGO machine that they put together, and did the math and science and all that goes with it, and they are also here.

The other thing which I want to bring onto the floor and welcome is a demonstration by our Schuylkillbotics Robotic Team. So on the floor is the Schuylkill Technology Center teacher and advisor, Mr. Jason Sharockman, and Mr. Jared Gerace, who is the Blue Mountain Middle School LEGO advisor. The high school students here on the floor are Adam Otto, Zach Bloch, and Matt Melochek. They are the boys who made the big robot. Again, they had to do the physics, the math, and all the things that go with it. They have about 5 weeks of work into this project, and it stacks containers. The middle school students who brought their LEGO project onto the floor are Tom Connors and Austin Siple. In the gallery are their advisors, Mr. Thomas Wiley and Mrs. Lisa Greenawalt. Also here are students Austin Langon, Tom Letarte, Tom Hrishak, Heather Faust, and Alex Lowmaster.

I would appreciate it if the Senate would extend its usual warm welcome to our young men and women on the fine job they have done and the robots they brought with them.

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Madam President, I want to personally thank the leaders of both Caucuses for acting so quickly on the Governor's nomination of Don Cunningham to be the next Secretary of the Department of General Services. Today's vote recognizes the unique position that Mayor Cunningham is now in. He has been a hands-on mayor of the city of Bethlehem since his first day in office. Thanks to his leadership and vision, our city is moving out of the shadows of what is left now of Bethlehem Steel and moving into a future that is bright and full of promise.

I know I speak for everyone back home when I say that we are so very proud of Mayor Cunningham and very proud that Governor Rendell has called him to serve as Pennsylvania's Secretary of General Services. We may be losing our mayor, but we are gaining a friend in this administration, and Bethlehem's loss is truly Pennsylvania's gain. I know Don Cunningham, and I know that he comes to this job fully prepared to do a good job. At a time when our Commonwealth is facing incredible fiscal challenges and a growing budget deficit, I have confidence that Don Cunningham will be able to put his experience as mayor to good use.

Senator COSTA. Madam President, I rise as the Democratic chairperson of the Committee on Judiciary to state that I am very pleased to recommend the confirmation of Dr. Jeffrey Beard as Commissioner of the Pennsylvania Department of Corrections. Clearly, Dr. Beard has advanced to this important position the

hard way, he has earned it. Dr. Beard has served in various positions within the Department of Corrections since 1972. His 31 years of hands-on experience uniquely qualifies him for this very demanding and crucial leadership post. He has earned the respect and admiration of his fellow Department of Corrections employees from his early days as a counselor in Rockview to his most recent assignment as a key administrator in the department's central office. Dr. Beard knows and understands the correctional system. His extensive qualifications transcend the normal partisan tug of war that intrudes on so many political appointees. A registered Independent, he has worked and thrived under both Democratic Shapp and Casey administrations during his lengthy and very impressive tenure. It is refreshing, Madam President, to see someone recommended who worked their way up through the ranks. It will be enormously helpful having someone leading the department who has an understanding of the department, and more importantly, its challenges from the ground up.

I personally had the opportunity to meet with Dr. Beard when he made his Senate rounds, and I had the opportunity to speak with him on various occasions in the past 2 years when he served as Secretary of Corrections, and I have always been impressed with his qualifications as well as his vision for the future of Pennsylvania's prison system. # SPECIAL ORDER OF BUSINESS LINCOLN DAY ADDRESS

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, I am honored to have the opportunity on this day to spend a few moments in reflection and in celebration of our cherished 16th President. And I must admit, as a relatively new Member of this body, I rise with some fear and trepidation, not so much by the fact that I have not received a warm welcome from all of you, indeed that has been the case, but my fear is grounded in a very awful memory from

the last time I spoke publicly of Lincoln. In the small town where I grew up, it was a tradition to select one high school student to recite the Gettysburg Address as part of the Memorial Day celebration, and in 1980, I was that student. I must confess, as a graduating senior in the spring of the year, the last thing that was on my mind was the Gettysburg Address, Lincoln, or laying a wreath. Let me just suggest that I had a healthy dose of spring fever. Well, the day arrived and the town gathered, and by circumstances it had rained, and so they moved the ceremony inside the junior high school auditorium, and the civic leaders of my community, the veterans, were all in the front row. The auditorium was packed and the high school band was up in the balcony in orange and black, and I began to recite the Gettysburg Address, and I recited the first three lines over and over and over and over again. And there was some rustling in the front row, whispers, and a sense of uneasiness in the room when finally my heart sank and I realized that I had blown it, that I was not prepared. I am not going to make that mistake twice, and I come here today fully prepared, not necessarily to recite anecdotes or quotes or speeches about Abe Lincoln, but to really speak from my heart, and to speak from my heart about three enduring principles that are part of the Lincoln legacy that I think today bind us all together as citizens of this Commonwealth and of this great country.

First, Abraham Lincoln was a fair man. He treated everyone with fairness and decency. There are countless stories of his early life in Illinois, when no matter if it was in business or through his law profession, he acted in a sense of fairness and decency, not necessarily related to profit motive or political consideration.

Second, Abraham Lincoln was a patient man, and he was patient on the matters of his day that mattered most. As a young State official from Illinois, he was very patient and focused on building this country in a post-agrarian age, in fact developed ties with the political, business, and civic community in this Commonwealth while still a very young man out west in Illinois. And as President, as he pored over battlefield reports and maps and communications from the field during the Civil War, he was patient. And that is not to suggest that he did not get frustrated from time to time, as we all do as we dispatch our duties. And he was known at one point in time to suggest that a General really did have the slows and ought to get moving, but he always kept his eye on the prize, and his patience was persistent, and the result was peace in a reestablished union.

Finally, what is in my heart about Abraham Lincoln is that he was prepared at the right time to act boldly, to act boldly and not with reckless abandon, but to act boldly on those things that are great on a grand scale, on all those things that matter so much to all of us today in this Commonwealth. Now, in the short time that I have been serving here, I make a habit of it when I come through that door to look up in that balcony, and I am really glad Mr. Weaver, my band teacher, is not up there today, I must tell you that. But I do have a slight fear about our future, ever so slight, that someday some citizen is going to be sitting up in that balcony disappointed in me, perhaps disappointed in other Members of this body, and disappointed not so much related to what votes we cast, and disappointed not rooted in the vigor of our debate on ideas or issues, but perhaps if we are not careful, disappointed that we have failed to remember and hold precious the

great democratic system of government that Abraham Lincoln preserved for us. At the time it was said of Lincoln's efforts that it is the last best hope on earth. Now I know, having spent a short time here, that we are all prepared, and I firmly believe within this body there are the principles of fairness and decency. Within our hearts and foremost in our minds, there are the principles of patience and bold action, and I am utterly convinced that as we move forward we will carry forward Lincoln's legacy, not only for today, but also offer the best hope for our citizens in this Commonwealth tomorrow and in the years to come.

Thank you, Madam President. (Applause.)

### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Dauphin, Senator Piccola.

Senator PICCOLA. Madam President, I come to the floor this afternoon to pay a compliment to Governor Ed Rendell for a position, or some remarks I should say, that he made yesterday in conjunction with a congressional hearing that was held down in Bucks County. Before I give the specifics, I would just like to give a little background. As you know, we are engaged in and have in this Commonwealth a medical malpractice crisis, and it is a crisis so great that it has caused the President of the United States to come to Scranton to speak out on the issue, because it is a national crisis, and it has caused the Congress of the United States, led by Congressman Jim Greenwood of Bucks County, to introduce legislation to address that crisis. We here in Pennsylvania, led by Senator Jake Corman, some of us in this Chamber have introduced a bill which would amend the Constitution of Pennsylvania to allow for the legislature to enact certain limitations, reasonable limitations, on noneconomic loss in certain civil justice cases. The hearing in Bucks County yesterday was held by one of the congressional committees chaired by Congressman Greenwood, the House Energy and Commerce Subcommittee. The Governor was a witness at that hearing, testifying on the issue of medical malpractice. And everything that I had read prior to that, and I believe all the press reports and, in fact, the article that was in today's Patriot-News indicates that my observation was correct, that the Governor, prior to yesterday, was opposed to the kind of legislation that Senator Corman and I and others have introduced here in the Senate of Pennsylvania. But during the course of the hearing, and I am quoting from the Patriot-News, and I look forward to getting a transcript from the hearing so that I can make sure this is accurate, but there are quotation marks around this sentence, "I am willing to consider caps," the Governor said. And I think the Governor is to be commended for taking that flexible position, that he is willing, as he said, to consider caps. In the course of his testimony he asked, "Do caps help? Of course caps would help."

Now, Madam President, you may recall that a couple of weeks ago I brought to the attention of the Senate a case over in Cumberland County, and in the course of some interplay and colloquy on that particular day between myself and Senator Mellow, Senator Mellow very eloquently described his position on this issue, and particularly on the issue of caps, caps on noneconomic damages. Senator Mellow took the position very similar to what I believe Governor Rendell's position was before yesterday and

said that he felt caps on noneconomic damages in any amount of money is highly discriminatory, and he later said that he, for one, would never cast a vote for that kind of discriminatory legislation. That was on January 29 of this year, and I am certain that Senator Mellow's remarks that day represented the views of a number of Members of the Senate, and that is certainly a justifiable position and he is certainly entitled to it. But apparently it was very similar to the position that the Governor had taken prior to yesterday.

The point that I am trying to make, Madam President, is that I think the Governor took a major step forward in a leadership position by indicating that he is willing to be flexible on the position that he had previously taken in opposing caps on noneconomic loss. He has indicated that he is willing to consider caps. He has indicated that he does, in fact, believe that caps would be helpful, that caps would help. I think, Madam President, that all of us in this Chamber and in the House of Representatives need to reflect on what the Governor did yesterday. I think he took a major step forward in trying to resolve this problem of the malpractice crisis in Pennsylvania by indicating that he was willing to consider a remedy which many of us feel is absolutely essential, which heretofore he did not have a lot of sympathy with. I commend him for doing that, and I encourage all Members of the Senate and all Members of the House who heretofore may have been hardened in their position against this initiative, reflect on what the Governor did and perhaps consider being a little bit more flexible on that issue. This problem is not going to be solved with one single silver bullet. It is not going to be solved with one single Member's idea or solution. It is not going to be solved by the Governor imposing his will on all of us. It is going to be solved by all of us working together, and I commend the Governor for taking a step forward in that direction.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Madam President, I rise very briefly to respond to the comments of my colleague from Dauphin County with respect to the position of Senator Mellow. Senator Mellow, unfortunately, is not here on the floor at this moment. However, my recollection of his comments was that he was not supportive of a damage cap on noneconomic damages of \$250,000. And I think that is an important distinction to make, because what the Governor has stated, based upon the news accounts that I have spoken about, in fact I would like to read the caption of the Morning Call article which reads, "Rendell: Jury Award Caps Fall Short," indicating in the very first paragraph, "Limiting jury awards for pain and suffering won't fix Pennsylvania's malpractice insurance crisis." My sense of the discussion indicates that caps on damages, in and of themselves, will not be the silver bullet that will address the medical malpractice crisis.

So I just wanted to put those comments on the record. I recognize that the Governor has indicated his willingness to consider caps. The amount of the cap, obviously, is where I think a lot of discussion will need to take place, if in fact we do go down that road. But most importantly, there is more than just one aspect to this crisis that needs to be resolved, and I am hopeful that we will have that discussion at some point in time.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Madam President, I just wanted to point out, as our previous speaker mentioned, Senator Costa from Allegheny County, that I agree with him. No one on this side who has been supportive of the issue of caps has said it is a silver bullet. It is not. A cap, in and of itself, will not solve our medical malpractice crisis. Act 13 that we passed last year was a very important piece of legislation that goes to that, that if we did not have that, passing caps would not be as effective as passing caps with that.

The other issues that we need to look at as far as maybe reducing the amount of insurance coverage will all be part of the solution. Our argument has been that caps are part of that solution as well, not a silver bullet. There is no one over here promoting this idea who thinks it is a silver bullet by itself.

So we are glad the Governor has joined the debate on this issue. We are glad to discuss it. No one here, again, is putting a number to that. I know the President of the United States put a number to it. We are not putting a number to it at all, whether it be \$250,000 or something else. We want to get it back in the hands of the legislature, through this constitutional amendment process, so we can discuss what that number may be, what exceptions we may want to put with that, so that we can come up with the right type of cap on noneconomic damages, so we get the amount that is right for Pennsylvania.

So we agree with the Senator who spoke before. No one here thinks that it is a silver bullet. No one here is putting a number on it. What we want to do is get it in the hands of the legislature so that we can together, through a debating process, through a hearing process, through a process in which we work so well in this body, come up with a cap that is reasonable for everyone so that we can bring some sanity back to our liability issues in Pennsylvania.

Thank you, Madam President.
