#### **SENATE**

TUESDAY, May 6, 2003

The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

#### **PRAYER**

The Chaplain, Reverend Dr. PAUL GEHRIS, retired pastor of the American Baptist Churches - USA, Shermans Dale, offered the following prayer:

We will take a moment for personal centering, and then I will say the words for the prayer for the Senate.

(Moment of silence.)

Almighty and everlasting God, who is called by many names and approached in many different ways, bless this honorable Senate by the empowerment of Your spirit. The PRESIDENT. The Chair thanks Dr. Gehris, who is the guest today of Senator Kukovich.

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for protective equipment for motorcycle riders.

SB 677 (Pr. No. 769)

Senator DENT. Madam President, I have two announcements today. First, at your desks are cookies from Nazareth, the Pennsylvania sugar cookie. As my good friend Senator Lemmond knows, this is an important issue. Many people believe sugar cookies should be made the official cookie of Pennsylvania, and I am proud that my friends from the Nazareth Area Chamber of Commerce delivered them to all of you.

#### SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR CHARLES W. DENT PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Lehigh, Senator Dent.

Senator DENT. Madam President, my second announcement deals with the young ladies seated in the gallery. They are the Parkland Girls' Swimming and Diving Team. They captured the 2003 PIAA Swimming and Diving Championship. They also captured the same championship in 2001. I would also specifically like to introduce Howard Lessel, who is the assistant principal from Parkland High School; Bob Clark, the head coach of the team; assistant coaches, Cary Lehman and Veronica Rosa; and the swimming captains, Jessica Lewis and Laura Dalla Palu.

The PRESIDENT. Would the guests of Senator Dent please rise.

#### GUEST OF SENATOR CHARLES D. LEMMOND PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Luzerne, Senator Lemmond.

Senator LEMMOND. Madam President, Wyoming Valley West High School keeps sending spectacular young men and women to Harrisburg to see us operate State government. Today Rob Edgerton, a junior from Wyoming Valley West, is with us. He is following me around today for a project in one of the all-star departments in the school to see what is happening in Harrisburg. He is a great student who is on the golf team, and he will be an intern in my office this summer. He is a spectacular young guy who is going to be interested in government in the

coming years, and I ask the Senate to offer a hello to Rob Edgerton from Wyoming Valley West High School.

The PRESIDENT. Would the guest of Senator Lemmond please rise so we can give you a nice welcome.

(Applause.)

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Madam President, at this time I ask for a recess of the Senate for the purpose of a Republican caucus, which will begin immediately in the Majority Caucus Room.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Madam President, I request that the Democratic Members report to our caucus room upon the recess.

The PRESIDENT. Senator Brightbill has requested a recess for a Republican caucus, and Senator Mellow has requested a Democratic caucus. Without objection, for those purposes, the Senate will stand in recess.

#### THIRD CONSIDERATION CALENDAR

NONPREFERRED APPROPRIATION BILLS ON THIRD CONSIDERATION, DEFEATED ON FINAL PASSAGE

SB 636 (Pr. No. 674) -- The Senate proceeded to consideration of the bill, entitled:

A Supplement to the act of April 1, 1863 (P.L.213, No.227), entitled "An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of Agricultural Colleges," making appropriations for carrying the same into effect; and providing for a basis for payments of such appropriations, for a method of accounting for the funds appropriated and for certain fiscal information disclosure.

Considered the third time and agreed to,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Madam President, Senate Bill No. 636 is the nonpreferred appropriation to Penn State University. It is the second time in a week that we were going to start to consider nonpreferred appropriations. I believe the first one that was being considered last week was the appropriation for the University of Pittsburgh. Madam President, in our discussion on the floor of the Senate on that particular day, I indicated that the 21 Members on this side of the aisle were not opposed to supporting nonpreferred appropriations. We have done it in the past and we certainly will do it again this year before the new fiscal year be-

gins on July 1. However, Madam President, a nonpreferred appropriation requires a two-thirds vote of the Members of the Senate. And based on the fact that as of yet we are not totally prepared to fund education, whether it be a preferred appropriation bill or a nonpreferred appropriation bill, and we have not finally agreed upon the kind of money that is going to be made available to all forms of education, whether it be primary, secondary, or higher education, and since this appropriation needs a two-thirds vote and here on May 6 there is no compelling reason why it should be voted today and not sometime at a later date when we are more certain as to what the fiscal data is going to be in Pennsylvania and what kinds of revenues will be available for the purpose of funding education, Madam President, I ask that the bill go over in its order.

I am going to once again ask the Majority Leader if he would be so kind as to agree to putting Senate Bill No. 636 over in its order, not because we are opposed to the bill on final passage at a later date, Madam President. We just do not think it is appropriate to put Members of this General Assembly in the position of having to vote "no" on a nonpreferred appropriation that we strongly support. The reason we would be voting "no" is because we do not know what kinds of revenues will be available for final passage of this nonpreferred, and also because we do not have to put this in place until July 1, the beginning of the new fiscal year. So my request to the Majority Leader is if he would agree to put over this nonpreferred appropriation and all the other non-preferred appropriations that go through the top of page 6, ending with Senate Bill No. 666.

The PRESIDENT. Senator Brightbill, is there an objection to the bill going over in its order?

Senator BRIGHTBILL. Yes, Madam President. We would like to vote it.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Madam President, if that is the case, I am not going to ask for a roll-call vote because I realize that we would not carry a roll-call vote for the purpose of putting the bill over in its order. I would just merely ask the Members on this side of the aisle to cast a negative vote, but only because we are not in a position to finalize the passage of nonpreferreds, which takes a two-thirds vote in the Senate. We do not know what the revenue implications will be. It would be more prudent for us to consider this later on, prior to the end of the fiscal year of June 30, so that we are certain exactly the kind of money we have available and the fact that we would be in a better position to vote in favor of not only this nonpreferred but all nonpreferreds.

So, Madam President, based on that, and based on that alone, I must ask for a negative vote. However, having said that, I believe that at some later date during this fiscal year this Caucus will be in a position of voting in the affirmative on Senate Bill No. 636, which is an appropriation to Penn State University.

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Madam President, I would just point out that these nonpreferreds are really part of Governor Rendell's budget, and my understanding is that when he presented a balanced budget to the General Assembly, it was these nonpreferreds in these numbers, and we are merely moving the

We are prepared at the appropriate time to vote for the nonpreferred appropriation for the University of Pittsburgh, and to do that prior to the start of the new fiscal year, which would be July 1. It is just that we are not prepared to do that today because we do not know what the revenue source may be.

Madam President, before that, I ask for a negative vote on the proposal.

lege campus" and inserting: "Campus"

Amend Sec. 1 (Sec. 2302-A), page 3, lines 2 through 24, by striking out all of said lines and inserting: education to establish a policy that regulates the marketing of credit cards on campus. The policy may prohibit any marketing of credit cards on the campus. In establishing the policy, the institution of higher education shall consider all of the following:

(1) Requiring registration of on-campus credit card marketers.

(2) Limiting credit card marketers to specific areas of the cam-

pus designated by the institution of higher education.

(3) Prohibiting credit card marketers from offering gifts to a student in exchange for completing a credit card application unless the student has been provided a credit card debt education brochure.

(4) Providing, at least quarterly, a credit card debt education

brochure with campus bookstore purchases.

(5) Incorporating into orientation programming a credit card debt education presentation. Section 2303-A. Construction.

Nothing in this article shall be construed to impose civil or criminal liability on an institution of higher education for any claim involving student credit card debt.

I strongly recommend that we welcome him with open arms. Again, I call for an expeditious and unanimous vote to confirm Dennis C. Wolff as Secretary of Agriculture.

Senator STACK. Madam President, this year marks the 55th anniversary of Israel's status as an independent nation. Over the years, Israel and the United States have enjoyed a strong relationship built on political, social, and economic ties of citizens of both nations. We must continue to nurture these ties by backing efforts to support peace in Israel and by encouraging Pennsylvania businesses to explore opportunities for expanding trade with Israel and its neighbors.

Americans and Israelis have much in common. We both have earned our independence the hard way. Many tough sacrifices were made for the freedom that we now have. Today this freedom still comes at a stiff price. Americans and Israelis alike have been subjected to the devastation wreaked by terrorists' attacks. While no American will ever forget the events of September 11, 2001, we must also remember that Israel has been the victim of more than 60 suicide bombing attacks in less than 3 years. No one should have to live that way in America, in Israel, or anywhere. We must dedicate and rededicate ourselves to working in concert with other pro-democracy nations to develop and implement effective measures to combat terrorism and bring about security. At the same time, we must never abandon efforts to achieve peace. Israel's government and citizens have demonstrated that they want terrorism to end and peace to begin. Peace treaties with Egypt and Jordan, the Oslo Agreement of 1993, and the Camp David Summit in the summer of 2000 all clearly reflect Israel's historical desire for peace.

Currently, the United States, the United Nations, the European Union, and Russia are backing a proposed road map to peace that is designed to end nearly 3 solid years of violence between Israelis and Palestinians. Madam President, let us all hope that this latest overture for peace brings a lasting end to a vicious cycle of terrorism and violence. Let us resolve ourselves to call upon the President and the Congress to continue their unflagging support

and involvement in the peace process by commemorating Israel's birthday and passing this resolution.
