(iv) For the 2003-2004 school year and each school year thereafter, no school district with total budgeted expenditures for that school year equal to or greater than \$14,000,000 and less than \$15,000,000 shall approve an increase in real property taxes unless it has adopted a budget that includes an estimated, ending unreserved undesignated fund balance less than or equal to ten and one-half per centum (10.5%) of its total budgeted expenditures for that school year.

(v) For the 2003-2004 school year and each school year thereafter, no school district with total budgeted expenditures for that school year equal to or greater than \$15,000,000 and less than \$16,000,000 shall approve an increase in real property taxes unless it has adopted a budget that includes an estimated, ending unreserved undesignated fund balance less than or equal to ten per centum (10%) of its total budgeted expenditures for that school year.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Madam President, I know everyone in the Senate is familiar with Megan's Law. I was a Member of the House of Representatives in 1995 when that bill was signed into law. Since that time, the legislature has struggled to keep Megan's Law on the books when the Supreme Court invalidated some of its provisions. Today, we can all be proud that Pennsylvania's Megan's Law is constitutional and is doing what it is intended to do, protect innocent people, especially children, from being victimized by known sex offenders. However, Megan's Law still needs to be improved, because Megan's Law here in Pennsylvania does not apply in juvenile cases. Today I am introducing legislation that would close Megan's loophole and bring juvenile sex offenders under Megan's Law.

Madam President, recently, the press reported on a case involving a 17-year-old juvenile. He admitted to charges of rape, involuntary deviate sexual intercourse, and aggravated indecent assault of a young girl in his home. The girl was 7 years old at the time. This juvenile refused therapy and fantasized about raping his own counselors. In fact, according to court papers, the juvenile listed a total of 44 individuals that he would rape if given the opportunity. The sentencing judge was appalled, as we all should be. In fact, the judge believed so strongly that this juvenile posed a threat to others that he issued a 12-page ruling. That ruling detailed this young man's refusal of treatment and lack of remorse for his rapes. But because Megan's Law does not apply to juvenile sex offenders, the judge's report was nothing more than a warning to the public. Basically, all the judge could do was say, watch out, watch out because a potential rapist would soon be free when he reached his 21st birthday. So unless we close Megan's loophole, that same convicted rapist could soon be living in your neighborhood or your grandchild's neighborhood, and neither you nor anyone else would even know until it was too late. My legislation would close Megan's loophole.

I want to also thank Senator Greenleaf for joining me in sponsoring this bill. Senator Greenleaf has a bill of his own, and it seeks to address the issue but in a different manner. And as a Member of the Senate Committee on Judiciary, I personally know how committed both Senator Greenleaf and my Democratic chairman, Senator Costa, are to addressing this serious situation. My legislation truly goes to the heart of the mission of Pennsylvania's juvenile justice system. According to the Juvenile Court Judges Commission, the first priority of our juvenile justice system is community protection. The citizens of Pennsylvania have a right to safe and secure communities. Unless we close Megan's loophole, some of our most vulnerable citizens will never be safe and secure from known sexual predators.
