WEDNESDAY, September 17, 2003

The Senate met at 10:30 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Madam President, along with others, including our emergency service caucus co-chairs, Senator Waugh and Senator Logan, I am today introducing legislation to help address the critical issue of a continuing erosion in the ranks of our volunteer firefighters across Pennsylvania. While we have enacted the restoration of the State's \$25 million grant program to help our volunteer fire companies with the purchase of necessary equipment and facilities, Pennsylvania must and can do more in partnership with our local communities to bolster the ranks of our volunteer emergency service responders.

Across Pennsylvania, Madam President, our volunteer firefighters are, in many cases, our first line of defense anytime there is an emergency. With Hurricane Isabel bearing down and about to hit our State and others with whatever force it might muster, it is our volunteer firefighters and fire companies in communities throughout Pennsylvania that are already preparing to respond to whatever lies in its wake. We are fortunate, Madam President, to have some 2,462 fire companies in Pennsylvania, 90 percent of which are volunteer, but what we need to recognize is that we have to do more, in partnership with our local municipalities, to address the issue of a steady decline in the ranks of those dedicated volunteers who give so much and upon whom we depend so much during every emergency, every crisis, every day.

As both an incentive to retain the volunteer firefighters we already have and to attract the new recruits we need, my bill proposes a modest State income tax credit of up to \$250 each year for active volunteer firefighters in our communities. Active status for tax credit eligibility would be determined by a service point system established by the State Fire Commissioner. My bill, Madam President, follows the lead of several surrounding States, most notably Maryland and Delaware, that have already decided that a tax credit is the best way to encourage recruitment and retention by providing at least a small token of financial

appreciation for the critical public service these dedicated volunteers provide day in and day out, 24 hours a day, 7 days a week, without pay.

While I recognize that Pennsylvania faces many other critical budgetary issues at present, issues that need to be addressed post-haste, I have chosen this time to introduce this bill in advance of the first meeting of the bipartisan 25-member Special Emergency Services Commission we created pursuant to Senate Resolution No. 60 to deal with the issue of helping our emergency service responder community in a comprehensive and ongoing way well into the future. It would be my hope that my legislation will be a part of the discussion and consideration as this important task force commences its duties and reports back to the General Assembly with its findings in the months ahead.

My volunteer firefighter tax credit bill will remain on the desk for the remainder of today's Session, and I invite all Members, if you have not already done so, to cosponsor this important piece of legislation.
