Senator KUKOVICH. Madam President, I think the amendments that Senator Scarnati and I have been able to work out have made an improvement in the bill, have invoked more of an element of fairness into the process. However, that being said, and also pointing out that the Senator who is the chair of the committee had said yesterday that he is more than willing to look into the OVR issue and the broader issue of how we can get injured workers rehabilitated and actually back to work is a crucial element of all of this, and I am hopeful we will continue to hold to that. That is not directly addressed in this bill. There is still a concern that I have about an inequity to injured workers that exists in this bill, and I am asking for a "no" vote.

The PRESIDENT. The Chair recognizes the gentleman from Jefferson, Senator Scarnati.

Senator SCARNATI. Madam President, I rise in support of this bill. As the gentleman stated, we have amended this bill with two amendments and have agreed to hold hearings on the issue of using the Office of Vocational Rehabilitation to help facilitate injured workers. This bill is one that needs to move. All it does, basically, is codifies the department's position that they have taken up in court and have argued in the Supreme Court. So, I ask for an affirmative vote on this bill and appreciate it.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Madam President, I would like to insert into the record the remarks of Senator Tartaglione.

The PRESIDENT. Without objection, the remarks will be submitted for the record.

(The following prepared remarks were made a part of the record at the request of Senator O'PAKE on behalf of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)

In 1996, this legislature passed an historic piece of legislation that reformed Pennsylvania's Workers' Compensation system. Passed during a Republican Administration and a Republican Majority in this body, that legislation has done irreparable harm to thousands of injured workers since its passage. Of the numerous portions of that original legislation that many Members took exception to, none were more egregious to injured workers than the section dealing with earning power.

Today, with House Bill No. 88, we are revisiting that statute and pouring salt on the wounds of our injured workers. Today, when we have an opportunity to make Pennsylvania's Workers' Compensation system fairer for our injured workers, we are considering legislation that continues the attack. It is once again a dark and shameful day in the Senate of Pennsylvania. Once again we find ourselves serving the interests of special interests rather than doing what is in the best interest of the workers of this great Commonwealth.

From its very inception, the Workers' Compensation Act was supposed to eliminate adversarial roles in cases between injured workers and employers in favor of a no-fault approach. The system was

supposed to be fair and reasonable, and ensure just compensation determinations and awards.

House Bill No. 88 ignores the premise of impartiality in the Workers' Compensation system and perpetuates a hostile environment with respect to the present use of vocational experts. The system of pick and pay fosters an inherent bias against injured workers. The remedy proposed by House Bill No. 88 fails to address the fundamental test of fairness. The procedure for approving vocational experts is unnecessarily broad and inadequate to ensure proper qualifications for these expert witnesses. The system proposed by House Bill No. 88 and the department's current regulations, for that matter, are very subjective. We ought to be exploring solutions that would promote the professionalism within the vocational evaluation field and protect injured employees by eliminating potential prejudice. As drafted, House Bill No. 88 does neither.

We should ensure and not ignore the underlying premise of fair and reasonable compensation determinations and awards for injured workers. Codifying a regulation that was promulgated in response to bad legislation, Act 57, does not correct the system that is unfair to injured workers. Support for this bill translates into support for the current provisions, allowing earning power assessments based on nonexistent jobs.

I cannot support proposals that simply manipulate the process without addressing the underlying issue of fairness to injured workers. I will vote "no" on House Bill No. 88 and once again do what I think is right for Pennsylvania's workers.
