# **SENATE**

TUESDAY, March 30, 2004

The Senate met at 1 p.m., Eastern Standard Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

#### **PRAYER**

The Chaplain, Rabbi SOLOMON ISAACSON, of Congregation Beth Solomon, Philadelphia, offered the following prayer:

Good afternoon.

I brought a bottle of wine and a box of matzo, and I know many of the Senators are not here, but I know they can hear this in their offices. This is going on record, so let them know on record that I brought enough for every Senator in the Senate, so nobody should think they are missing out on anything, even though if they miss my prayer, that is something to miss, and it is good matzo. And when you drink the wine, make sure it is chilled, it tastes much better.

As we stand now less than a week from a very important Jewish holiday in history, the holiday of Passover, which marks the freedom of people from physical and mental slavery after 210 years, we begin to look and respect and realize and try to appreciate the freedom that we now live in this great country of ours, this wonderful State that we live in, and we may have a better idea and appreciation of what it means to be able to vote, to be able to help our people. All of you, as Senators and Representatives of your individual constituents, are called upon many times to make wise and difficult decisions. So, with that in mind, with realizing that your positions are such that you look to serve your people to the best of your ability and to the best of what is good for your constituents, as Moses did for his constituents, the people whom he led out of slavery from the land of Egypt, God gave him that strength to be able to lead those people for 40 years. I do not know if all of you are planning to be Senators for 40 years, but for however long you plan to be and for however long the Almighty has in mind for you, may you always make the wise decisions and may God always be on your right hand to protect you and give you much health and happiness.

(Whereupon, a prayer was offered in Hebrew.)

For those of you who did not understand that, I will now translate it into English.

May He who grants salvation to kings and dominions, to rulers whose kingdom is a kingdom spanning all eternities, who releases David as servant from the evil sword, who places a road

in the sea and a path in the mighty waters, may He bless, safeguard, preserve, help, exalt, make great, extol, and raise high the Senators of our great State of Pennsylvania and all the other officials of this great State of ours. The King who reigns over kings, in His mercy may He sustain them and protect them from every trouble, woe, and injury. May He rescue them, may He gather people under their sway and cause their enemies to fall before them, and wherever they turn, may they succeed. The King who reigns over kings, in His mercy, may He put into their hearts and into the hearts of all their counselors and officials compassion to do good with us and all the people of our great State of Pennsylvania. In their days and in ours, may we all live together in peace. So may it be the will of the Almighty. Amen.

Notice that I said in the prayer that may He help them to conquer their enemies, so anybody here who is running for reelection, you have nothing to worry about.

An Act amending Titles 15 (Corporations and Unincorporated Associations) and 54 (Names) of the Pennsylvania Consolidated Statutes, further providing for associations; further providing for preliminary general provisions; further providing, in corporations, for general provisions, for corporate functions, for managers and owners, for fundamental changes, for registered corporations, for insurance corporations, for foreign business corporations, for domestic nonprofit corporations generally and for foreign nonprofit corporations; further providing, in partnerships and limited liability companies, for general provisions, for registered limited liability partnerships, for general partnerships, for limited partnerships and for limited liability companies; further providing for unincorporated associations generally; further providing for business trusts; making editorial changes; further providing for reenactments of nonprofit corporation laws; providing for transfer of funds; and repealing provisions relating to railroad condemnation procedures, to nonprofit corporations and to Young Men's Christian Associations.

Senator STACK. Madam President, I rise to submit this resolution that recognizes the month of April as Autism Awareness Month in Pennsylvania. The colorful ribbon that I am wearing recognizes this very important issue. Autism is an incapacitating, lifelong developmental disability. It can impair a person's ability to learn, to develop healthy interactive behaviors, or to understand verbal, nonverbal, or reciprocal communications. Its symptoms may be mild or severe. Right now, autism affects more than 25,000 Pennsylvanians, and 1 million people nationwide, and that number is on the rise.

Based on statistics from the U.S. Department of Education and other governmental agencies, autism is the fastest growing developmental disability, with an annual rate growth of 10 to 17 percent. If this trend continues, up to 4 million Americans could have some form of autism in the next decade. There is no cure for autism; however, the earlier the disability is diagnosed, the better the predicted outcome. Early diagnosis means earlier access to recent advancements in care, treatment, and educational opportunities that have vastly improved the abilities to cope, both for the afflicted individuals and for their families. Also, early diagnosis and intervention can decrease the costs associated with lifetime care by as much as two-thirds.

Autism knows no racial, ethnic, or social boundaries. A family's income or educational levels do not affect the occurrence of autism. However, children with autism can learn and function productively with appropriate education and treatment. This is a condition that challenges its victims, but it does not dehumanize them. Autistic individuals deserve our attention, our compassion, and our respect. Heightened awareness is the most direct path to understanding and confronting autism. That awareness must be tempered with vigilance that ensures adequate resources are available to continue to support early diagnosis and intervention

techniques that already have greatly improved the life of autistic individuals and those who support them.

Madam President, I ask the Senate's unanimous consent in recognizing April as Autism Awareness Month in Pennsylvania. Thank you, Madam President.
